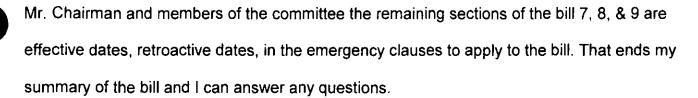

Minutes:

Roxanne Woesty: For the record my name is Roxanne Woesty, I am a fiscal analyst with the legislative council. In past interims we have had separate bills, however this time the commission chose to have just one bill. Section 1 amends section 44.08.04 to increase the state daily lodging reimbursement from \$55+ tax to \$60+ tax. This would be effective July 1, 2009 the estimated impact to the legislative branch would be \$20,300. Section 2 amends 54.03.02 to increase the regular special organizational sessions compensation from \$135 to \$140 per calendar day, effective July 1, 2009. Assuming a 77 day legislative session that cost approximately \$88,000. Section 3 addresses the maximum monthly lodging reimbursement that is allowed during legislative session. It would increase from \$900 to \$1,000 a month this change would be retroactive and effecting January 1, 2009. Section 4 amends 54.

03.20 to increase legislator's monthly compensation by 4% or of \$15 \$378 to \$393 effective July 1, 2009 the estimated cost of this increase approximately \$54,600. Section 5 amends 54.06.09 to make it equal to the federal rate of \$.85. Section 6 amends 54.35.10 interim compensation from \$135 to \$140 this change would be effective July 1, 2009 and the

Senator Nelson: The mileage rate, according to the fiscal note is \$226,700 from the general fund, is that only for legislative council or that statewide for all agencies?

Roxanne Woesty: That is our estimate for costs of the legislative branch. The statutory change does affect other state agencies but it depends on their travel.

Senator Dever: Section 1 & 5 affect all agencies and the other sections affect the legislature?

Roxanne Woesty: That is correct.

Mike Motschenbacher: See attached testimony #1.

Senator Cook: What is your special AARP rate?

Mike Motschenbacher: \$69.95+tax, which is approximately \$10 off a night.

Senator Cook: Is that the lowest special rate that you have now?

Mike Motschenbacher: The lowest rate we offer right now is \$64.95+tax a night. That is for our corporate/frequent members.

Senator Nelson: Do each of the hoelts that you are representing honor state rate and monthly rate during the legislature?

Mike Motschenbacher: I know everyone on this list is housing legislatures and is at this time charging the \$1,000. As far as a state rate, I can tell you for sure, I know Kelly Inn, Comfort Inn, Select Inn and Expressway Inn do honor the state rate of \$55 at this time.

Senator Nelson: Do you limit the number of rooms available to legislators?

Mike Motschenbacher: Yes we do, at our property we limit it to 6 and Expressway Suites

limits it to 12.

Senator Nelson: Are you usually full?

Mike Motschenbacher: During session we see an increase.

Senator Dever: Do the legislators that stay there vacate their rooms during the weekend?

Mike Motschenbacher: Some go home on the weekend but do not remove their things. We do not make the room available.

Bill Shalhoob: See attached testimony #2.

Senator Nelson: What is the average rent on a 2 bedroom apartment in Bismarck?

Bill Shalhoob: I do not know, in 2005 it was a separate rate for hotel versus houses. As it moved through the legislature it was melded into one.

Senator Dever: Wasn't there consideration given to the fact that some legislators share an apartment?

Bill Shalhoob: I believe in 2005 the rate called for an increase to \$700 if you were staying in housing and \$900 if you were staying in a hotel. I think that the numbers are about 50% that stay in hotels and 50% that stay in houses/apartments.

Senator Dever: Is it true that some hotels do not honor the \$900 rate they charge more but some legislators choose to stay there and pay the difference?

Bill Shalhoob: Yes that is true. I know that the Radisson's rates are around \$1350 or \$1400 a month. To make the record really clear when the legislators are staying with us, we told them we would charge them the state rate.

Senator Cook: What is your AARP rate? What is the lowest rate?

Bill Shalhoob: \$39.95 is the lowest business rate; \$59.95 is our AARP rate; \$44.95 is the next lowest rate.

Senator Ohelke: What is the Federal Rate? What is the average vacancy rate in Bismarck?

Bill Shalhoob: \$70 is the Federal Rate. Our average occupancy is 70.6% that was for 2007,

the reports for 2008 are not out yet.

Senator Dever: Are room rates across the state pretty consistent?

Bill Shalhoob: I would say overall, they have experienced the same kind of growth that Bismarck has, I didn't comment on that because at the rate that is there now the Select Inn is

generally below that.

Senator Cook: When we travel out of state to conventions where there is a block of rooms reserved and rather than make my reservation through that block of rooms I will make my own reservation and ask for the state government rate. Do you give our state rate to state employees that are traveling from other states?

Bill Shalhoob: We do not, but I would have no idea about the other hotels in the area.

Senator Dever: The amount of money for actual expenses I think in the public perception. legislators are paid that amount and then from that they pay for their costs. That is not true, actual expenses Bismarck/Mandan legislators are specifically excluded from that. Am I correct in my understanding that includes meals, they don't receive any additional expenses to cover

the cost.

Bill Shalhoob: This is intended to cover specifically housing costs.

Rudie Martinson: See attached testimony #3

Senator Nelson: Will this make it easier to find a state rate in Fargo?

Rudie Martinson: Yes it will, it's getting harder to find a state rate as it remains at \$55 across the state. There are several properties that are members of ours that would honor a state rate if it was \$60 that are not currently honoring it at \$55.

Jeff Larshus: I am Jeff Larshus I am with the fiscal management of OMB. I am here for OMB in support of section 1 and also the language in section 5 subdivision C in regards to the mileage rates. We currently use the GSA rates for out of state meal allowances and that we support OMB setting these rates for the mileage.

Senator Dever: How often does the federal government change their mileage rates?

Jeff Larshus: To be honest we have not paid that much attention because we have always had in statute what the mileage is. Currently it is \$.58.5 prior to that it was \$.55 and I think that was 6 or 8 months ago. So what we will do if this is past is we will be notified when the GSA changes their mileage rates and then we will adjust the OMB policy and let agencies know that the rate has gone up or gone down. Normally like in the meal situation, once a year they may change their out of state meal allowances and we have a link on our website that agencies are able to access to get the meal allowances for a particular city or state.

Senator Dever: Do you know what was factored in the fiscal note?

Jeff Larshus: I believe it was \$.58.5 I didn't prepare the fiscal note but I am pretty sure that is what they used.

Senator Cook: You say you are going to adopt rules, does that mean there will be an administrative rules hearing on the process you are going through here?

Jeff Larshus: I believe not, what we will do is set that in OMB policy and agencies follow the OMB policy on the mileage rates.

Senator Horne: As the federal change their mileage rates the state will automatically follow that pattern. Is this happening in other states?

Jeff Larshus: I believe so, I think that there are other states out there that follow the GSA rates for mileage and they would automatically adjust it if you are going to follow their rates.

Senator Dever: What are we currently reimbursing at?

Jeff Larshus: \$.45 a mile is what is in Century Code for mileage.

Senator Dever: What kinds of people, besides legislators, use their own vehicle?

Jeff Larshus: Basically any state employee can use their own vehicle. I know we encourage within OMB to use motor pool whenever possible and I think that most agencies do. Their rate Page 6 Senate Government and Veterans Affairs Committee Bill/Resolution No. 2064

is lower but they will charge back to the agencies, and I think their rate is \$.31 but again if there is a situation where motor pool is not available then an employee would have to use their own vehicle.

Senator Dever: Any other questions for Jeff? Anyone here to speak in opposition to SB2064? Anyone in a neutral position to SB2064?

Stuart Savelkoal: For the record I am Stuart Savelkoal I am the Executive Director of the North Dakota Public Employees Association. I wanted to offer some clarification on the federal mileage reimbursement rate because we have organizers that work on a national level and are reimbursed by American Federation of Teachers we follow the national rate rather closely. That rate does go both up and down, it recently went down from \$.58.5 to \$.55 with the start of the New Year. I thought for the purposes of your consideration today it might help to have that information.

Senator Dever: Anyone else to speak in a neutral position on SB2064? If not we will close the public hearing on SB2064.

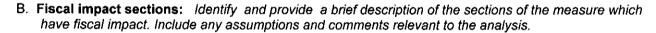

Increases legislators' monthly compensation from \$378 to \$393 effective July 1, 2009 - \$54,600 from the general fund for the 2009-11 biennium

Increases the compensation for regular, special, or organizational sessions from \$135 to \$140 per calendar day effective July 1, 2009 - \$88,000 from the general fund for the 2009-11 biennium

Increases the interim compensation rate from \$135 to \$140 per day effective July 1, 2009 - \$31,000 from the general fund for the 2009-11 biennium

Increases the maximum monthly lodging expense reimbursement allowed during legislative sessions from \$900 to \$1,000 per month effective January 1, 2009 - \$51,200 from the general fund for both the 2007-09 and 2009-11 bienniums

Increases the state daily lodging expense reimbursement rate per night from \$55 plus tax to \$60 plus tax effective July 1, 2009 - \$20,300 from the general fund for the 2009-11 biennium

Provides that the state mileage expense reimbursement rate be at the federal mileage expense reimbursement rate of 58.5 cents per mile - \$226,700 from the general fund for the 2009-11 biennium

Total - \$51,200 from the general fund for 2007-09 and \$471,800 from the general fund for 2009-11

Rep. Wolf: I do have a couple of questions for you. The way I look at this bill the section that deals with the increase in the monthly fee falls under the emergency clause of the bill.

Mike Motschenbacher: It was removed by the Senate. The retro-active clause was for the housing allowance was removed.

Rep. Wolf: Correct. But it still falls under the emergency part of this bill. Unless I'm completely wrong. The last Section on Page 6, Section 11, the emergency clause, it declares it to be an emergency, and in the Section 10 directly above it, sets forth the effective dates of certain sections but it does not include Section 4 of the bill which is the housing for the monthly fee. So I am assuming that that Section would fall under the Emergency Clause.

Mike Motschenbacher: Is that the amendments?

Rep. Wolf: No the bill.

Rep. Froseth: Rep. Wolf I believe the way the bill is, the Emergency Clause would take effect if it wasn't signed by the Governor which wouldn't include January, February and March. The rate would be \$900.

Rep. Wolf: But it would go into effect as soon as he would push it through and the Governor would sign it and it could go into effect as of April 1st.

Rep. Froseth: So at April 1st they would have one month of the \$1000 rates. There is no bill retro-active to this as of January 1, 2009.

Rep. Wolf: Some motels already do charge more than \$900 a month. I know several legislators in this room that are paying more than \$900, I paid more than \$900 last session, and some motels want \$2100, I have checked around. So you can go over and above the \$900 if you so choose with the motel, you just choose not to?

Mike Motschenbacher: I can tell you from a personal experience with some other hotels that I have spoke with on this, we all are charging a \$1000 with the assumption that it is what the Legislators are going to get reimbursed. When the retro-active clause was removed I have gotten, we have 18 Legislators staying at our places, the majority of them come up to me now and say "well now we are stuck paying \$100 out of pocket every month" and they want to know if we are

going to go down to the \$900. So from a business point of view I have two choices, I can stick with what we what we were planning on and what we were told we were going to get reimbursed and charge a \$1000 and upset 18 customers, which I really don't want to do in the meantime, or I can eat the \$7200 that is going to affect me and our business and hopefully keep the customer happy instead. There is the customer service aspect I have to deal with too.

Rep. Amerman: I guess from looking at your chart you say that the 2005 to 2008 payroll has gone up 22%, can you explain that. I'd like to know how your payroll has gone up 22% in three years?

Mike Motschenbacher: We have had two minimum wage increases over the past two years here. With the tight labor market we are forced to pay much higher wages than we did four years ago. As you can see there are several of the hotels on there that have put out numbers there and we are all very similar, we are all in the same boat, 22% over four years is about as (can't make out) increase.

Chairman Grande: Anyone else wishing to testify in favor of 2064? Favor?

Josh Churchill, Management, Comfort Inn and Comfort Suites: Well as a I missed my fellow hotel industry cohorts testimony just a moment ago. I am here on behalf of the Comfort Inn and Comfort Suites here in Bismarck and on behalf of every other interested hotel party in the City of Bismarck and surrounding

areas. My primary focus here is with regard to SB 2064 is the actual State Employee per diem and the \$55 as opposed to \$60 after this Legislative Session of course. I guess I just need to re-iterate all the facts that have come before you by Mike and just to re-iterate the need for incremental increases. They are completely necessary, just to cover are base increases on operational expenses, not to mention the State of ND and City of Bismarck in particular has encountered in the last couple of years a tremendous challenge in terms of labor, finding help, having to compete with other entry level service type industries, and of course the wages have adjusted accordingly there. The increases that are above historical annual increases for retainment and to recruit new staff and so a \$5 increase there is completely in line with the fees we have encountered on the labor side, not to mention the utilities and every other operational expense. The other thing I definitely would like to mention is that Armed Kelsch (not sure if spelled right) the company in particular, Expressway Inn, fall within the limited service world of hotels. This has kind of become the standard for your middle of the road traveler, the government traveler, or your corporate traveler kind of on a budget. What we have encountered in the limited service world is something that we call "amendy creep" and basically travelers have become more discerning as time goes on and we need to keep up with the times and maintain our competitiveness within the limited service market and nowadays when a new

limited service hotel is built the chance of that hotel taking on the State rate is zero. It is simply not possible for these operations to take it on. So in effect we have continued to maintain the State rate is a benefit to all the State travelers. I know that the Motel 6, Super 8's there on the budget side of things but we would prefer that we are able to accommodate State government travelers on the limited service side of things rather than having your State government travelers drop down to the budget side and having to stay at the Motel 6's and the Super 8's. It has become an amenity that everyone has become used to, the expanded breakfast, the exercise rooms, the indoor pools, etc, etc., and in order to maintain those things and be fixed expenses that go along with maintaining a facility offering these amenities we need to do these increases period. In order for us to keep all these things available and it is our belief that it is a State government in ND that are going to provide a facility for all the State travelers that will maintain a productive (can't understand) and one where you are not going to have to worry about noise, not worry about parties in the middle of the night, and again have all the amenities, have their (can't understand) so that they can get up in the morning and be on the road and again maintain productivity. To touch on retro-activity of the Legislators in particular, we were counting on it and we, speaking for the Comfort Inn, see it as a public service to offer this rate to the Legislators and nothing more to be completely honest. If you look at the

Josh Churchill: Generally speaking that rate is managed within the daily revenue management of the weekly forecast and the weekly revenue management. Our particular operation, no, but we are atypical, considering revenue management out there. So I guess the answer is yes. There are a limited number of rooms available. But there again, the lower the rate is, the lesser number of rooms that can be offered at any given time. So if we can steer that higher rate the lesser the likelihood that State travelers maybe staying at your lower end spectrum hotels, like the Super 8's and Motel 6's.

Froseth: The housing allowance, I think, I don't know whether the Senate took it out to raise it from \$900 to \$1000 but I think a lot of us were under the opinion that it was going to be raised to a \$1000. I know I had a commitment from the motel that I stay in that the rate would be \$900 and the first bill I got was a \$1000. I said I thought you told me \$900, well we are under the presumption it is going to be raised to a \$1000. I have long felt that we should have a dual rate for the people that provide the homes. I don't think that is a sacrifice on their part I think it is a money maker for most of them because they go South for the Winter and their homes are empty. So they really have a home sitter and it should be worth something to them and I don't think any of the Legislators cause much

wear and tear on the homes but I have always felt that by moving the rate we kind of direct or dictate what the rent in Bismarck is going to be. I have always felt that we shouldn't do that. In a motel you are offered daily room service, offered daily breakfast, and I think the rate should be different than a home. In a home you are doing your own laundry, your taking care of their driveway a lot of times, and I feel that that rate probably doesn't need to be adjusted. Maybe we can leave that rate at \$900 and increase the motel rates to \$1000 or the commercial rates to a \$1000. That is kind of my opinion or take on it.

Chairman Grande: About three sessions ago I had set up my contract with one of the hotels and they said well we see that there is a bill in for a rate increase and if the rate increase goes in place and it is retroactive at the end of my contract with you I will reimburse you back that direction. If we don't get that rate increase I still want my contract to be at \$800. That was agreed upon and that was how we worked it out. At the end we did vote it in and it was retro, I wrote him another check and covered those amounts, otherwise he wasn't going to charge me for it. But they know we as the Legislative body aren't guaranteeing those increases. Nobody ever told the hotels here that the rate would go up. I think they have been in business long enough in Bismarck here to do know that you can't go on the wind as to the Legislature is going to do. I understand they are wanting more money and understand that and am not arguing that point but I

do know a lot of you were offered contracts at different rates and stuff and I think that is something that you need to talk to the people you are renting from. I have been able to get a variable rate whenever I use the apartments. I agree with you on the housing though. This guy here they are probably making \$600 off of me because my rent compared to what the utility bill would be and that is all that they are paying if I wasn't staying there. So I see what you are saying Rep. Froseth. Any other discussion?

Rep. Wolf: Some of us selected to not stay in motels this session because they were going to do the \$1,000 and went to the one that would do the \$900 too.

That is the other flip side. I choose not to stay at Candlewood Suites because I paid a \$100 last session extra because that is what Kelly Inn charged and this session when they were going to do \$1,200 and came down to a \$1,000, I went to Fairfield Inn because they were cheaper.

Chairman Grande: If I was going to pay \$1,200 I personally would have went to the Radisson Inn because then my car is parked inside. I guess you shop it around. I shopped it around and I found different condos and different apartments. I worked out a deal with my renters because there was no way I was shoveling, that was included in my rent.

Rep. Kasper: The issue I don't think is the \$1,000. The issue is the retroactivity. We have SB 2353 that deals with the motels and the cost of lodging. I Hearing Date: 3/5/2009

have talked with our leadership and I don't know where you guys are at on your leadership but our leadership does not like the idea of that retro-active with lodging that will send a message that is retro-active with the Legislator's pay raise which is taken care of in SB 2064. I'd like to consider that we amend all the lodging into SB 2353 and deal with the hotel and motel thing in this bill and let SB 2064 be a stand alone on Legislative compensation. Then first of all we separated that issue on retroactivity, and I for one support retro-activity, I think our hotel people have been very, very good to us at least since I have been in the Legislature, they have taken less than what they should have but they do like the fact that we are there. I don't agree with leadership on our side but have you guys had a discussion or concern about any of that on your side.

Rep. Winrich: No, we haven't.

Rep. Kasper: Try to keep it totally non-partisan they can put all the lodging in 2353 and let it go with retro-active or not and let the committee come out with where we come out with and do it on the floor and see where we go. Then with 2064 it will be a Legislative Compensation bill.

Rep. Wolf: Even in Mike's testimony he talked about us being retro-active or Emergency Clausing our pay and we are not.

Rep. Kasper: That is right.

Rep. Wolf: So I agree with what you are saying about making it be a standalone because we get enough flack over it anyway and if we are doing anything with retro-activity, whether we do it or not. But if it is combined into a bill that has anything to do with our pay, I agree with Rep. Kasper.

Rep. Winrich: I thought Mike had a valid point to in that the Legislature has established a policy for this and through the Legislative Compensation committee and so on. They tried to follow that policy, they went to the compensation committee, they got a positive recommendation from that committee and so on, and then it gets to the floor and somebody's personal little point of view messes up the thing after all of that work and I think that is a consideration too.

Rep. Kasper: I am going to talk to our leadership and maybe you guys can talk to your leadership to see what their feelings might be on doing that. Maybe it will solve some heartburn at least on our side and let the bills go where they may.

Rep. Winrich: I think it will call for major negotiation in the Senate.

Rep. Kasper: That is where the problem is.

Rep. Froseth: Point of information, How did we get a pay raise in our pay check this session? We never approved it last time did we, two years ago?

Chairman Grande: Yes we did. So for these two bills let's put together the information and we will discuss them next Thursday.

Chairman Grande: We will discuss SB 2064. This is the Legislative

Compensation Commission and this is about the salary increases, the hotels, the

lobbying during the interim, and the travel reimbursement. The bill is in front of

us.

Rep. Conklin: Move for a Do Pass.

Chairman Grande: Discussion.

Rep. Winrich: On Page 3, Sect 5, Lines 15 and 16 where it says how much we are going to be paid the sum of \$396 a month which is payable every six months or monthly at the members option and then the same thing occurs again in Section 6 that deals with the following year and that is down on Line 31. When I was filling out the personnel forms at the beginning of the session this year with Karen Mund I was going to opt for the six month payment of the salary and Karen

talked me out of it. Because in order to pay that six month option they have to

make a manual entry in PeopleSoft and it takes staff time and they have to make special deductions because any deductions for health insurance or something like that has to come out in a lump sum ahead of time that PeopleSoft is so orientated to monthly payments to salary's that it is much cheaper especially if you have direct deposit that it runs automatically and I think we should consider removing the six month option because that is the system that we seem to be working with now.

Vice Chairman Randy Boehning: On Page 3, Line 14, would it be better to say \$96 a month period and then strike over the rest of that language.

Rep. Winrich: That is basically what I am suggesting yes.

Chairman Grande: We need to remove the motion off the table.

Rep. Conklin: Remove the Do Pass motion.

Rep. Winrich: I would just like to hear other people's idea's if the six month option is really crucial and important to anyone I don't know I will reconsider it. But I think it will be better to take it out.

Vice Chairman Randy Boehning: I agree with Rep. Winrich. If we come up for a Legislative meeting in between are they going to hold that for six months then too or are they going to take and pay that out monthly and then this will build up. I think it will probably be easier for them to do their monthly payroll without having a string of consecutive paperwork. I wish to 2nd the motion.

Rep. Wolf: I can tell you the reason for the every six months and that is because when we are only paid once a month there are no Federal taxes withheld. That monthly salary on its own does not qualify for enough to have Federal taxes withheld. So by lumping it to do it once every six months then you qualify to have Federal taxes taken out, if it is a high enough amount in the pay chart. There is an alternative and you could elect on your W-4 form to have a certain amount per month withheld. But I can tell you that is the reason that some of us do it every six months.

Rep. Kasper: You found out how very few people are using it?

Rep. Winrich: Yes. I thought I had a copy of that memo in my folder and I don't.

But as I recall it is something like 13 people in the House and nine in the Senate.

Chairman Grande: So 13 and nine, and that is all the people that is affecting. So she is making all this effort for just that small group of people.

Rep. Kasper: I would like to offer a different amendment for consideration on getting to the same thing because I am concerned if we don't make a statement it could be misconstrued as staying the same way. On Line 15, Page 3, I would like to have you consider, \$96 a month payable monthly, and now we know it is monthly and we are not going to question it if we have a choice. We are saying it is paid monthly. So we would strike "which is" and we would strike "every six months or" and strike "at the members option" and also on Line 31.

Rep. Bette Grande approached the podium to explain SB 2064 - legislator compensation and travel bill. Rep. Grande distributed "Summary of 2009 Engrossed Senate Bill No. 2064" (Attachment A). Section 1 takes the lodging from \$55 to \$60. Section 2 takes the daily pay for the interim and it has your effective dates. The legislative compensation regular special organized session goes up by \$6 per day. That breaks down then in the next section for the next part of the biennium goes up to \$7 per day. This Section 4 lodging piece is our legislative session lodging going from \$900 to \$1,000 per month. Section 5 deals with monthly compensation. It is going up 5% or \$18 for July 09 and then up 5%, another \$19 on July 2010. Section 7 gets into the mileage reimbursement and again you are going to see that tie into the federal. This one here plays into exactly how we are doing our taxes. Remember when we do our mileage and when you go to do your taxes, you have to do that amendment piece to get your federal. This would get rid of us having to do that amendment piece to our taxes. Section 8 deals with the interim compensation and that goes up in two different years. Section 10 sets the effective date for the various sections with 09-10, and the emergency clause pertains only to Section 4 and Section 7. Section 4 is our legislative session housing allowance so as soon as this was to get to the Governor if there is time, we would at least get that month at a \$1,000.

The mileage would also go into effect as soon as the Governor signs it. Initially this bill in the senate was heard with this being retroactive for lodging. The senate took out the retro.

Amendment .0304 was distributed (Attachment B).

Rep. Kempenich: On the mileage part, the feds go back and forth. They went from 58. They are at 50.5 now. Is that tied in or is it one rate set?

Rep. Grande: We would set this up with OMB and it would have to be done by rule.

Rep. Kempenich: It wouldn't necessarily be \$58 then would it?

Rep. Grande: This process allows OMB to make those adjustments when necessary.

Rep. Berg: None of these are retroactive?

Rep. Grande: That's correct.

Rep. Wald moved that we change all of the Sections that deal with legislative compensation and leave it as it is today with no increase. My reason is that if we are going to make cuts in the budget, we could do a good stroke of business.

Chm. Svedjan: I am going to seek clarification on the exact sections. Roxanne, could you help verify that for us.

Roxanne: It would be Sections 2, 3, 5, 6, 8, and 9.

Chm. Svedjan: The intent of this is to leave legislative compensation exactly where it is today. Rep. Kerzman seconds the motion.

Rep. Thoreson: I guess I am going to oppose that motion. We are also looking at increasing salaries in agencies. We should get an increase if we are doing our jobs as others are.

Rep. Wald: We're not settled with state employees' salaries yet. It's possible that will also be reduced. To be hypocritical would not wash with the public.

Rep. Berg: I don't like that we are bumping our pay 5 percent. I don't think we should tie our pay to state employees' pay. The average compensation for state employees is \$60,400 per

year. That includes their total package. That would work out to about \$260 per day. I don't think it's unjustified to have an increase as laid out in this bill. I would be opposed to this motion and support an increase in pay.

Rep. Delzer: OMB has to do this by rule. Do they have to go through the Administrative Rules process?

Rep. Grande: I think the rules are set within the agency.

Roxanne: That's correct. I believe OMB is exempt from Administrative Rules process. Legal counsel has recommended this particular process be set up.

Rep. Delzer: If we are concerned about delegation of legislative authority, how can we go to OMB? We are delegating to them too.

Roxanne: I could call Jon Bjornson on that.

Chm. Svedjan: Is there anything with this bill relative to lodging?

Rep. Grande: With the passage of SB 2353, Section 1 will need reconciliation.

Rep. Berg: I would move that Section 1 would be the same as we passed—90% of the federal rate.

Rep. Kreidt seconded the motion.

Rep. Berg: I think we need a formula to follow for the mileage and lodging.

Council and the budget section approve, some type of temporary measure or something until

we get back into session and change it permanently. The state fleet changed in mid-stream

legislative branch, I would move that the budget section must approve any changes in mileage

established by the Office of Management and Budget in relation to legislative mileage.

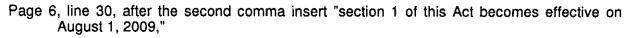

Chairman Dever called the conference committee to order, roll was taken and all members were present.

Representative Berg: Obviously it is hard issue when dealing with legislative pay. Over the years we have arbitrarily set the number and what section 1 does is provide rational for what we reimburse legislators for. Federal lodging reimbursement rate for North Dakota is \$70, our reimbursement is \$55. The discussion lead to saying that we amend it to say 90% of the federal rate and apply that, so if we have a changing market where rates go up we are not delaying it or if rates go down it is being reflected. That is what section 1 does, it refers to the lodging rate

Senator Dever: Senate bill 2353 had exactly the same provision and we did concur with that and passed it out on the Senate side.

Representative Berg: Section 2 is dealing with legislative compensation, currently we are at \$135 a day, you kind of have to go to the end of the bill to get the date, there is nothing retroactive in there; section 10 talks about the effective date. Section 2 would go up to \$45 in July of 2009. Section 3 would go up to \$148 effective July 2010.

Senator Dever: I think that those numbers were in the bill as we sent it to you correct? As I went through it the changes were to the daily lodging rate and to the monthly lodging rate, I am not sure if anything else changed.

Representative Berg: Section 4 relates to establishing a fair lodging rate, I think that currently the rate is \$900 a month which works out to \$30 a day for rooms, it has been fixed for a number of years. The thought here was to take a formula which would be the federal rate X 90% X 30 days X \$55. That would be current rate, again this is not retroactive. This would take effect when it passes again the objective here is to have a formula. As we move forward the monthly allowance is reflective of changes in the market.

Senator Dever: I had some conversations and if this session ended on the 30th of April it would be \$3,984 for the entire session. Part of the problem is when you get into May this would pay \$34.65 a day.

Representative Grande: This piece does not pertain to those days; we would be paid for the legislative day. I was going to draft amendments to address is. Council said that when you finish in April, when you submit the May dates the rate would be \$55.

Representative Berg: I think that is what we want to accomplish.

Senator Dever: This language also applies to organizational and special sessions.

Representative Berg: Not sure what this does to change current statues, but I think that the intention of the House is that it would remain the same as it has in the past. Partial months at the end of the session would be at the daily rate.

Senator Dever: When I visited with Karen Mund, she says they pay \$55 a day with a cap of \$900. The daily lodging rate now multiplied by that.

Representative Grande: I think that Legislative Council should explain that.

Representative Berg: If you support the concept of the formula, we need an amendment to make sure your concerns are addressed.

Senator Dever: I look at this as policy but it is also negotiation; the willingness of those people who provide housing and the ability of the legislature to be compensated for their cost of accessing that. I don't want legislators digging into their own pockets

Representative Berg: The reason for having an adjustment is critical. No one disagrees with the daily rate, partial month, ect. If you would like us to draft those amendments we can get those.

Senator Oehlke: In the current 0500 version, on line 15 on page2 it says that the rate may not exceed the rate provided.

Senator Dever: Right now it would go to \$63 as amended here

Senator Oehlke: Isn't that the daily rate?

Representative Berg: I would really like to sit down with council and have them read it. I think that what they are saying is that if we are in a partial month, they can't charge you \$1,000 for the 10 days you are there. I think that we should have the council look into this. The first issue is the formula.

Senator Horne: I don't know if I like this concept. I like \$1,000 a month. Why complicate it with the formula.

Representative Berg: I think that there are several factors. We can set it at \$1,000 and the average rate is \$75 a day for a hotel and then we can come back out here and the hotel will have raised their rate. And it may put some legislators in a difficult spot; we may end up doing that and trying to get it reimbursed or you would see a bill like this come through that is retroactive in nature. This issues can be very controversial and if we have an opportunity to do

what is appropriate. If we put something in place that creates fairness I think that it is worth doing.

Senator Horne: In your judgment this would be the best for both the legislators and the hotel proprietors over the long stretch?

Representative Berg: We are seeing 90% of that is what the fair rate is. Part of the problem is that the public views the reimbursements as benefits for legislators and they are really not. It gets to be a real mess by not thinking in the future and setting these.

Senator Horne: If we adopted this plan, and we come back in 2 years how do we explain what the rates will be?

Representative Berg: If we pass this bill, they will all know what the rate will be.

Senator Dever: Part of the problem is the legislative compensation commission put it together as retroactive and then they set the rate in anticipation of that

Senator Oehlke: Line 16 page 2 it says 'On August 1st of each even numbered year the director of OMB shall set the maximum monthly rate for the next 2 years.'

Representative Berg: I think that the point is that in August if they hotel doesn't like it the will not invite the legislators back. Some of these hotels charge that the important thing is not to do those retroactively.

Senator Dever: We set the mileage at the GSA rate.

Representative Grande: We changed that.

Representative Berg: What we did is change that to 90% of the GSA rate because if we get reimbursed that is higher than the GSA rate we may have to claim that as income. Maybe it is just trying to be more conservative, on the bottom of page 5. When we meet once every 2 years the gas prices goes up and down and I am not sure if there is concern as to what the formula will be. We don't expect people to gain or lose money by driving their vehicle. There

Senator Dever: I think that the federal rate was \$.58 that can be deducted.

Senator Horne: On the mileage, how often does the state re adjust the mileage payment?

Senator Dever: It is done every biennium

Representative Berg: What we did in the past is the mileage is changed by the legislature. If it was too low we would up it and then it is set by statue, and it would take legislative action to change it. Representative Grande had some amendments to go over

Representative Grande: Starting with section 1, 'amount not to exceed' we were told it was because if you paid less for a hotel room that is actually not how this stood. What it actually means is that OMB can set our rate at less than 90% and I thought that was not what we had intended.

Senator Dever: If you stay at hotel less than that then you won't be reimbursed for more than the actual expense.

Representative Grande: And this wouldn't allow for that.

Senator Dever: One of my concerns is that we passed SB2359 that has the same language.

Representative Grande: This will supersede it because this comes last. We will have to have council double check that this actually says that OMB can set the rate below 90%. You only are reimbursed what you have paid up to this amount. That is how counsel interpreted that.

That still all comes into effect, council says that if we put it in there OMB will set it at a lower ate that the GSA lodging reimbursement rate. I just want to be clear on that.

Senator Nelson: Even if we say 'shall establish'.

Representative Grande: That is why I want that amended language put in. On the 2nd section that is the setting of the monthly rate and we wanted to set it by a 30 day month. As the rate goes in and is being formulated out, it used to say per month and now it is 30 days. Section 3 deals with the travel portion, round trip reimbursement for mileage and it just sets it at whatever the federal rate is. Anything else that is there is currently what was amended and we are just keeping it that way. Those were the issues that we have discussed and that are in the amendment.

Senator Dever: The bill initially had the mileage reimbursement at the GSA rate and now it automatically comes out. What were we removing on page 3 lines 1-9?

Senator Oehlke: That is on a different version.

Representative Grande: That is being able to be paid every 6 months, I believe. The House had put the language on because of the manual work that is required for just those few people.

Senator Oehlke: That is actually on page 3 line 15 not line 1-9, they replace by paragraph B.

Senator Dever: As I read this is it appears to me that it applies to somebody that does not take the monthly lodging rate but they commute on a daily basis. Any questions regarding the amendments?

Senator Nelson: Were there any other points of discussion?

Representative Berg: The bottom line is to go at the federal rate for mileage. What the House did was look at setting up a formula that these items get reimbursed for; part of this says that ve are going to use the federal lodging amount and we are going to take 90% of it that is about \$70 now, get reimbursed for the 90% plus tax. Currently we are at \$55 a night, federal rate is

\$70 a night, 90% of that would be \$63+tax. We will never argue if it should be a certain amount, it will just go by the percent. The second thing that we change was the month-long

before that and now we are ate \$900 for the 3rd biennium. We have a committee that says

what the rate should be; many times we are in a position and we are voting for something that

is retroactive. If our rate is \$63 multiplied 30 days and multiply that by a factor of 55% then you

will get the monthly lodging rate.

Senator Nelson: Where did the 55% come from?

Senator Dever: That approximated 55% work out best. Now it will be indexed to the GSA.

Senator Nelson: We were going to go up to \$60 and then \$65 until we reached the GSA

rating?

Representative Berg: When I look at the Bismarck market and it is \$75 or \$80 a night. \$30 a night for a month is great. The only thing is maybe going from 55% to 60%. I think that it would then go up to \$1,100.

Senator Dever: If we index it to the GSA that is what will inflate it later.

Representative Grande: How often does the GSA change?

Representative Berg: It is not as fast as I thought, Right now it is \$.70, in 2007 it was \$.60, & 2003 it was \$.50 apparently that this would remain. When they set it they look at the area as a whole and they set the rates up to that.

Senator Dever: Part of the argument is that the Hospitality Association needs to raise their rate because the GSA is raising their rates. Then we have the automatic inflator because they are following what the market is doing.

Representative Berg: If there are a lot of vacancies they drop the rate,

Representative Schneider: I am comfortable with the 55%. Not everybody stays in a hotel.

Senator Dever: The only question I have is regarding the daily lodging rate.

Representative Berg: At the time taking 90% of the rates seemed like a prudent thing to do, is there rational as to why we should pay 10% less than the federal rate. Are you suggesting that we not have the 90%?

Senator Dever: Do we want to make it equal to 90% or up to 90%?

Senator Nelson: If we tell them it has to be 90% it has to be 90%. The upper limit is 90%, you can get something for \$30 a night at a cheaper estimate then that is all you get reimbursed at. Representative Grande made a motion to adopt the amendment and the House recede from it's amendments with a second by Representative Schneider. There was no discussion, roll was taken and the motion passed 6-0.

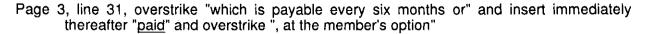

2009 TESTIMONY

SB 2064

Chairman Dever, and Committee Members

My name is Mike Motschenbacher. I'm part of the management team at Expressway Inn and Suites here in Bismarck. I'm speaking on behalf of several other hotels in Bismarck-Mandan besides ours, including Fairfield Inn North, Fairfield Inn South, Kelly Inn, Comfort Inn, Comfort Suites, and the numbers on the chart include Select Inn.

Each of you has a copy in front of you of this testimony. It includes actual numbers from each hotel for other increases each of our businesses has incurred over the past 4 years since the last time the legislature adjusted the monthly allowance for legislative housing. These numbers include ADR, which is the Average Daily Rate of which each hotel has increased over that amount of time. It also includes increases in payroll expenses and property taxes that have incurred over that same four years.

For example, since the 2005 session when the housing allowance was adjusted to \$900.00 per month, our ADR has gone up 22%, our payroll has gone up 24.80%, and our property taxes have risen 18.70%. Over that same time period, legislative reimbursement has remained stagnant.

Senate Bill 2064 Section 3 calls for the legislative reimbursement to be increased from it's current rate of \$900.00 monthly to \$1,000.00 monthly. This represents a 11% increase. As you can see, that is significantly less than increases we have seen in our actual expenses, and is even less than inflation. We think that is fair and would ask you to consider voting YES to pass this bill. Section 7 states that this be retroactive to January 1st, 2009, and we also ask you to keep that in place.

I would be happy to answer any questions you may have.

Testimony of Bill Shalhoob Select Inn Bismarck Managing Partner SB 2064

Mr. Chairman and members of the committee, thank you for the opportunity to appear before your committee. I am testifying on behalf of the Select Inn Bismarck to ask you to consider a legislator reimbursement item, namely the housing allowance a legislator not from Bismarck or Mandan receives during the session. The current allowance is \$900.00 per month and was raised to that level effective for January of 2005.

As background information I can tell you that the occupancy for Bismarck-Mandan for 2007 was 70.6% and the Average Daily Rate (ADR) was \$63.30. This means each occupied room produced \$1,899.00 in revenue each 30 day month. The current legislative rate is less than 50% of that average. Rack rates, ADR and DMA revenue have increased at a rate of a 6% average for the last four years. Since the last session there have been two increases to the minimum wage. More significantly, the success of our growth efforts has caused us to raise our wage scales to compete for employees. This is a good thing. Goods and services, spurred by rising fuel and manufacturing costs, have also increased. We understand these factors are part of the cost of doing business and must be factored into budgets and business plans. Rates are increased for customers but in this case we are not free to raise this rate and must rely on the legislature to make adjustments.

We are asking for two things. First is to raise the allowance. We support the increase to \$1,000.00 per month for hotels. This represents less than 67% of the ADR we achieve throughout the rest of the biennium. In addressing the Legislative Compensation Committee we suggested the appropriate rate be \$1,200.00 per month. The Select Inn has long term stay rooms. Our rate for these rooms averages over \$1,650.00 per month so the \$1,000.00 specified in SB 2064 represents a substantial discount. The second request is to support the emergency clause on this bill to make it effective for the 2009 session. Without this provision we increase the rate lag and compound the problem.

Thank you for your consideration. I would be happy to answer any questions.

Testimony of Rudie Martinson ND Hospitality Association Executive Director SB 2064

Mr. Chairman and committee members, thank you for the opportunity to appear before you today. My name is Rudie Martinson, and I am here on behalf of the ND Hospitality Association in support of SB 2064.

Section 1 of the bill addresses the state employee reimbursement rate for hotel rooms. In 2007, when the state per diem was last raised from \$50 to \$55, the Average Daily Rate in the more heavily populated areas of the state hovered just below \$65. In 2008, the Average Daily Rate in those same areas was just below \$71. The disparity between the state rate and the market value of a room has risen from \$10 to \$16 since the last legislative session.

The increase in ADR reflects our industry's attempt to keep up with rising business costs. The minimum wage alone has risen twice since the last legislative session. Industry wide, we have been forced to raise wage scales to compete with other employers in North Dakota's growing economy. Overall, our labor costs have increase 10-15% over the last two years. We have also experienced increases in expenses in terms of taxes, payroll expenses, and the general cost of goods.

We understand that increased costs are a fact of life in business. This \$5 increase for state employees will allow our industry to keep up with and manage those rising costs, while still allowing us to offer a discounted rate to agents of the state of North Dakota.

Section 3 of the bill addresses the housing allowance a legislator not from Bismarck or Mandan receives during the session. The ND Hospitality Association is also in favor of this change, for the reasons stated by Mr. Shalhoob and Mr. Motschenbacher.

I am here today to ask you to support the increase in both the state employee reimbursement rate and the housing allowance for state legislators by giving this measure a "Do Pass."

Madam Chair Grande and members of the committee,

My name is Mike Motschenbacher. I'm part of the management team at Expressway Inn and Expressway Suites here in Bismarck. I'm also speaking on behalf of other hotel managers from the Bismarck Mandan area, all of which are currently housing legislators. Some of them have joined us here today. Others wanted to be here but could not make it. We are suggesting a DO PASS recommendation on SB 2064.

Section 1 of the bill addresses the state per-diem that affects any state employee that needs lodging on a nightly basis while out of town. Currently that nightly rate is \$55.00 per night. SB 2064 would increase that to \$60.00 per night. Currently the \$55.00 nightly rate is the lowest rate we offer anyone. It is even lower than our best customers receive. If it is increased to \$60.00 per night, it will STILL be the lowest rate that we charge anybody. This will also make it easier for state employees to find state rate hotel rooms, as more hotels will then choose to honor that rate.

Section 4 of the bill refers to the increase in housing allowance for legislators to be increased from \$900.00 to \$1000.00 monthly. The requested adjustment of \$100.00 monthly is approximately a 2.7% increase annually or \$25.00 per year since our last adjustment four years ago. This is less than the rate of inflation, and SIGNIFICANTLY less than increases we have seen in our property taxes, our labor costs, and our cost of goods over that same four year period. Attached to this testimony is a chart showing actual percentage increases for several area hotels in some of those categories. As you can see, payroll has gone up approximately 22% and our property taxes have increased approximately 13%. Cost of goods has risen approximately 24% during that same four year period. I don't think a 2.7 percent annual increase is too much to ask.

The real problem however with this section is that the Senate removed the retroactive part of the bill which would have made it effective January 1, 2009, the start of this session, which is exactly what the Legislative compensation committee recommended.

What this means to the hotel industry, is that we won't see this increase until the 2011 session, making it 6 years since the housing allowance will have been adjusted.

The lodging industry feels that the senate literally pulled the rug out from under our feet. Let me explain. After the last increase in 2005, the industry was happy, and not only accepted the \$900 rate for that session, we did not seek any increase for the 2007 session. We knew however that one would be needed for the 2009 session (4 years later). We thus were going to present legislation during the 2007 session to address and establish a rate for this session 2009. We were told at that time, it would be best to go before the legislative compensation committee in the interim, and make our case for a rate increase for this session. We did what was recommended. We met with the LCC, made our case, they agreed, and put forth the recommendation for a \$100 increase for this session, making it effective on January 1, 2009.

The bill sailed thru committee unanimously, and then referred to appropriations, where to our astonishment, the retroactive clause was removed. Why? Because we were told that "they don't like retro clauses". Wait a second! This is what we were told to do, and how we were to handle it, and now they change their minds?

What is even more unbelievable, is at the same time the senate decided that the hotel industry can wait another 2 years to get their increase (which would now mean 6 years since our last increase), they elected not only to increase their pay, but to increase it over and above what the LCC recommended, and it INCLUDES an emergency clause so they get their money right away!

Take a look at the increase our business has incurred the last few years. How much has the State increased it's spending over the past 4 years?

We provide legislators with a safe home for four months. It is clean, comfortable, quiet, and peaceful. We have given legislators the best rates we offer, substantially less than even our best customers, saving the state thousands each session. This is the thanks we get?

We do however have confidence in the House, that you will do the right thing. We are asking you to please consider this amendment that will do two things. One, restore the retroactive date back to January 1, 2009 to the start of the session, which was the original intent of the LCC, and secondly to establish an increase which will be effective January 1st, 2011, and thus preventing us from dealing with this issue next session.

Our industry very much appreciates what you do as legislators for our State, and recognizes the tremendous sacrifices you make to serve the people of ND. We do not feel that you should be put into the situation of having to pay for lodging out of your own pockets, simply because some are not willing to allow reasonable increases. We simply can not afford to keep our rates at these levels. Please, all we are asking for, as a wage paying, and tax paying business is to be treated fairly by our own State.

We respectfully ask you to support SB 2064 with our proposed amendments. Like I said, our employees deserve a raise too.

"SECTION 5. AMENDMENT. Subsections 2 and 3 of section 54-03-20 of the North Dakota Century Code are amended and reenacted as follows:

- 2. a. Each member of the legislative assembly is entitled to receive reimbursement for lodging, which may not exceed a maximum of one thousand two hundred fifty dollars per calendar month for lodging in state, at the rates and in the manner provided in section 44-08-04 for each calendar day during the period of any organizational, special, or regular session.
 - b. Notwithstanding subdivision a:
 - (1) A member of the legislative assembly may elect to be reimbursed for less than the amount to which the legislator is entitled under this subsection by claiming the lesser amount on a voucher submitted with the receipt required by section 44-08-04.
 - (2) The legislative council may establish guidelines that may result in a reduced maximum reimbursement for a single dwelling in which two or more legislators share lodging and the total rent for that dwelling exceeds the amount to which a legislator is entitled under subdivision a.
- 3. a. Members of the legislative assembly who receive reimbursement for lodging are also entitled to reimbursement for travel for not to exceed one round trip taken during any calendar week, or portion of a week, the legislative assembly is in session, between their residences and the place of meeting of the legislative assembly, at the rate provided for state employees with the additional limitation that reimbursement for travel by common carrier may be only at the cost of coach fare and may not exceed one and one-half times the amount the member would be entitled to receive as mileage reimbursement for travel by motor vehicle.
 - b. A member of the legislative assembly who does not receive reimbursement for lodging and whose place of residence in the legislative district that the member represents is not within the city of Bismarck is entitled to reimbursement at the rate provided for state employees for necessary travel for not to exceed one round trip taken per day between the residence and the place of meeting of the legislative assembly when it is in session and may receive reimbursement for lodging at the place of meeting of the legislative assembly as provided in section 44-08-04 for each calendar day for which round trip travel reimbursement is not claimed, provided that the

total reimbursement may not exceed one thousand two hundred fifty dollars per month."

Page 6, replace lines 29 and 30 with:

My name is Mike Motschenbacher. I'm part of the management team at Expressway Inn and Expressway Suites here in Bismarck. I'm also speaking on behalf of other hotel managers from the Bismarck Mandan area, all of which are currently housing legislators. Some of them have joined us here today. Others could not make it.

The main concern we have today with SB 2064 is the emergency clause that would allow the housing increase for legislators to be adjusted from \$900.00 to \$1000.00 monthly, and be retroactive to January of 2009. As Senator Dever stated, the suggestion is to remove the emergency clause that will cause this to go into effect this coming summer, which essentially puts the housing allowance at six years without an increase. Due to that fact, we are asking that you consider NOT removing the emergency clause and to keep it in place.

The requested adjustment of \$100.00 monthly is approximately a 2.7% increase annually or \$25.00 per year, less than the rate of inflation, and SIGNIFICANTLY less than our increases in cost of doing business over that same time period. The amount that we are requesting is small compared to requests made from nearly every other organization or agency. Our property taxes have skyrocketed, costs of goods has skyrocketed, and labor costs have increased significantly over the past four years. Last session, state employees were given a 4% annual increase in wages for two years. Our employees would like raises also. A tight labor market has caused wages we pay to be increased at an average of 6% per year. I don't think 2.7 percent is too much to ask. Our employees deserve raises also.

When we met with legislative compensation committee this past summer, we wanted a \$1200.00 monthly rate that would be more in line with increases in costs we have incurred over the past four years. The committee told us that \$1,000.00 per month is realistically what we could succeed in getting for the 2009 session, and we decided we would compromise. We were disappointed with this amount, but decided to live with it. Our best customers that walk through the door and stay a month will still pay \$1300.00 or more a month. We believe that by offering legislators rates below that amount, we are essentially "doing our part" to help North Dakota. Now we are being told that we might not even get that? \$1000.00 a month equates to \$33.33 per day. I'm sure many of you travel. I would be curious to know when the last time any of you found a hotel room for that amount, or even \$50.00 per day. Not very likely.

The hotels have already compromised \$200.00 a month this session by accepting the \$1000.00 instead of the \$1200.00 allowance. We also don't believe it will be fair to the legislators staying in hotels that would now have to make up the difference and pay \$100.00 per month out of their pocket if this emergency clause is removed. I would also like to point out that during the committee hearing on this bill a couple of weeks back, not one person stood in opposition to this bill.



It seems that the main reason why they are stripping the emergency clause off the bill is due to the fact that in 2005, we received a fairly significant increase in housing allowance. I wanted to remind the committee of why that happened. Before 2005, it had been several years since the last increase. We were getting \$21.67 per day before 2005. Even the worst hotels could not break even at \$21.67 per day. The housing allowance had fallen so far behind, that it needed to catch up to a reasonable amount that the hotels could at least break even. In 2005, \$900.00 a month was acceptable. In 2007, thankful that the legislature was kind enough to give us a nice increase, we didn't even ask for an increase. Now, four years later, we simply cannot operate without this minimal increase. How many agencies did not ask for an increase in 2007? Not many I'm sure.

Mr. Chairman and committee members, the Bismarck-Mandan hotels are only asking to be treated fairly. A 2.7% annual increase is very reasonable and needed for us to continue to operate and treat our employees fairly as well. Please honor the recommendation of your legislative compensation committee and keep the emergency clause in place.

Amends NDCC Section 54-03-20(1) to increase the compensation for regular, special, or organizational sessions by \$6 per day from \$135 to \$141 per calendar day effective July 1, 2009

Amends NDCC Section 54-03-20(1) to increase the compensation for regular, special, or organizational sessions by \$7 per day from \$141 to \$148 per calendar day effective July 1, 2010

Amends NDCC Section 54-03-20(2) and (3) to increase the **maximum monthly lodging expense** reimbursement allowed during legislative sessions by \$100 from \$900 to \$1,000 per month. This section becomes effective the date the bill is signed by the Governor.

Amends NDCC Section 54-03-20(7) to increase legislators' monthly compensation by 5 percent, or \$18, from \$378 to \$396 effective July 1, 2009

Amends NDCC Section 54-03-20(7) to increase legislators' monthly compensation by 5 percent, or \$19, from \$396 to \$415 effective July 1, 2010

Amends NDCC Section 54-06-09(1) to provide that the director of the Office of Management and Budget adopt rules establishing mileage reimbursement for state employees, including legislators. The director is to amend the rules when necessary to set reimbursement at the same rate as established by the United States General Services Administration for privately owned vehicles. This section becomes effective the date the bill is signed by the Governor.

Amends NDCC Section 54-35-10 to increase the interim compensation rate by \$6 per day from \$135 to \$141 per day effective July 1, 2009

Amends NDCC Section 54-35-10 to increase the interim compensation rate by \$7 per day from \$141 to \$148 per day effective July 1, 2010

Provides that Sections 1, 2, 5, and 8 become effective July 1, 2009, and Sections 3, 6, and 9 become effective July 1, 2010

Declares the bill to be an emergency measure
