Chairman Cook: Opening the hearing on Senate Bill 2093

Lawrence Hawkins, Deputy Treasurer, Office of State Treasurer: See Attached testimony #1 in support of bill. In the Treasurer's Office we do 28 different tax distributions, and right now we currently have at least 10 that are due by the 10th work day of the month. I questioned why we have so many due by the 10th work day? , and I couldn't find any legislation that required it until I came upon this one. It is done annually, yet it has caused us to do 10 other tax distributions by the 10th work day. Not that this change would make me do it differently, but I want that flexibility. I want to be able do it within the month, with the right person, at the right time. We are trying to generalize to be more effective and efficient.

Chairman Cook: The rest of the distributions are those that speak to the issue, due by the end of the month?

Lawrence Hawkins: We do a group of them by the 10th work day, and we do another group by the 20th – 22nd.



SB2093 Testimony – Support of SB2093

Mr. Chairman, members of the committee:

For the record, I am Lawrence Hopkins, Deputy Treasurer for the Office of State Treasurer. I am here in support of Senate Bill 2093 the transfer of telecommunications carriers tax fund revenues.

Section 1 of this bill changes the timing of the transmission line tax distribution from "not later than the tenth working day in March" to "not later than March thirty-first." This change is being requested in order to allow the Treasurer's Office to group and distribute the office's tax distributions in the most efficient and effective manner.
