Minutes: **Senator Nething, Chairman**

Relating to applicants for licensure as a private investigator or private security service.

Bill Butcher – Chair of Private Investigation and Security Board. He explains the bill; and FBI audit said the old language did not work. So they need to change the language to comply.

Senator Olafson – Asks what the non-license member would be.

Butcher – Replies that it means a member of the firm, someone who is not licensed as a security officer with the state, yet owns a company that performs that service.

Senator Fiebiger - Unclear about what non-license member means.

Butcher – Replies this is the language recommended to them by the FBI. You don't have to be a license holder to work at an agency, like a secretary or computer person.

Senator Nething – Explains anyone doing investigations with the entity, whether they be a non-license member, a partner, an officer, or an owner of at least 10%, you have to make an application and go through the process.

Close hearing for 2113.

Chairman DeKrey: We will open the hearing on SB 2113.

Bill Butcher, Chair, Private Investigation & Security Board: Sponsor, support, explained the bill. Our board requires everyone who is licensed or registered with us, as well as owners of private investigative and security agencies to have national criminal checks. These reports are requested by our Board through the ND Bureau of Criminal Investigation from the FBI and the FBI sets the criteria for obtaining these reports. We were audited by FBI in 2008 and we were told that the wording in our statute was not sufficient to secure reports on owners or partners in the agency who are not licensed, upon whom we would want criminal background checks. They provided us with the wording that they thought was appropriate and we incorporated that language in the bill.

Chairman DeKrey: Thank you. Further testimony in support. Testimony in opposition. We will close the hearing. What are the committee's wishes in regard to SB 2113.
