Chairman Freborg opened the hearing on SB 2213. All members were present.

Senator Bakke introduced the bill. The bill attempts to raise the weighting factors for ELL, special education, pre-school special needs students and alternative high school students.

However, there is a bill in the house now that deals with weighting factors and she has decided it would be better for her to offer amendments for that bill. It was too late to withdraw the bill.

She recommends a Do Not Pass for the bill.

Senator Freborg asked what we will tell the body when the bill goes to the floor.

Senator Bakke said she will carry the bill and explain it on the floor.

Mari Rasmussen, Department of Public Instruction, said the department supports the bill. She had fiscal information and written testimony in favor of the bill. In light of Senator Bakke's recommendation, she will save the testimony for a later date.

Chairman Freborg closed the hearing on SB 2213.

Senator Bakke moved a Do Not Pass on SB 2213. The motion was seconded by Senator Lee.

The motion passed 5 – 0. Senator Bakke will carry the bill.

SB 2213 relates to factors for determining weighted average daily membership in the State School Aid formula. It increases the weights for special education, alternative education, and English language learner students.

The increase in weighting factors adds an estimated 3,546 weighted student units to the State Aid payment formula each year. The cost at the current per student payment rate of \$3,325 is \$11.8 million annually.

The cost for the 2009-2011 biennium would be \$23.6 million assuming no other changes to the State Aid to Schools program.
