Minutes:

Senator Lee called the Senate Transportation Committee to order. The clerk took attendance.

All committee members were present. Senator Nething is testifying in another committee but will be back soon. Senator Lee opened the hearing on SB 2339.

**Representative Vig** introduced the bill at a constituent's request relating to registration fees for farm trucks. This gives a reduction to the registration fee for farm trucks over twenty years old.

**Tom Schmidt**, a farmer from St. Anthony and a member of the ND Farmers Union testified in support of SB 2339. Written Testimony #1.

Senator Potter asked Mr. Schmidt how much money this would save him.

Schmidt didn't have that answer.

**Senator Lee** asked how often they used their trucks. Are they used throughout the year? **Schmidt** said he used it a couple months in the spring and couple in the fall. Our trucks are about 25 years old and have about fifty to sixty miles on them.

# **Opposing Testimony**

**Tim Horner**, Department of Transportation testified against the bill and urged a Do Not Pass for SB 2339. Written Testimony #2.

**Tom Balzer of** the ND Motor Carriers Association testified in opposition to SB 2339. He said current law already built into law a reduction for farm vehicles.

**Senator Nodland** said that he understood the situation for farm vehicles but the fiscal note is fairly substantial. He said he had a problem both ways.

Senator Potter felt it was odd that the ND Grain Growers or other farm groups didn't testify.

Senator Fiebiger had a problem with the fiscal note and the costs.

Senator Potter moved a Do Not Pass.

Senator Fiebiger seconded. Roll call vote: 6-0-0.

Senator Nething will carry the bill.

This bill adds a reduction in registration fees for farm trucks older than 20 years.

There are approximately 28,100 registered farm vehicles, 20 year old and older. The estimated average registered weight of such vehicles is 42,000 lbs. The current annual registration fee at this weight for a vehicle older than 20 years is \$103.00. The proposed annual registration fee at this weight is \$51.00.

The following figures are biennium figures:  $28,100 \times $103.00 \times 2 = $5,788,600$  (current fee) Minus  $28,100 \times $51.00 \times 2 = $2,866,200$  (proposed fee)= \$2,922,400 Rev.loss

Based on this, the loss of biennium revenue to the highway tax distribution fund under the current Highway Tax Distribution Fund allocation formula for each receiving entity is:

DOT: \$1,841,112 Counties: \$672,152 Cities: \$409,136

As a producer, transportation is an important part of my operation. I have multiple vehicles on my farm that are used for different reasons, and each is a necessity. They are used for transporting supplies and commodities to and from the farm. The way we use farm trucks has changed over the last decade. The farm trucks that will be affected by this bill are used only seasonally, and may not even get 1000 miles a year put on them. SB 2339 will help reduce some of the costs of registration for producers, and I hope that you will support the bill.

Good morning, Mr. Chairman and members of the committee. I'm Tim Horner, Deputy Director for Business Support for the North Dakota Department of Transportation (NDDOT).

The Department of Transportation is very supportive of measures that help our agricultural industries, including our hardworking farmers and ranchers. One of the most important ways that we, along with our transportation partners across the state, can contribute to their success is to provide a transportation system that safely moves people and goods.

A major focus during this legislative session is to provide an increased level of funding for transportation at all levels statewide so that we can progressively and responsibly meet the challenges we are facing. This committee has already considered one major proposal in this arena, Senate Bill 2177. The Department is committed to working with the legislature and our transportation partners to provide an appropriate level of funding to meet the transportation challenges ahead of us.

Unfortunately, this bill would reduce the funds available for transportation by nearly \$3 million dollars each biennium. As such, the bill is contradictory to a number of transportation funding proposals currently being considered by this legislature, including Senate Bill 2177, Senate Bill 2012, and House Bill 1407. For this reason, the Department of Transportation is opposed to this piece of legislation and we urge you to give this bill a "Do Not Pass" recommendation.
