Senator J. Lee opened the hearing on SB 2346 to provide for studies of the implementation of Indian treaty rights relating to education, health, and welfare.

Sen. Mathern (District 11) testified in support of SB 2346 as a sponsor. The bill came about because of the interim study which dealt with tribal and state relations. In the interim study

process they learned that the issues were so complex that as a legislature they couldn't figure

them out in the time frame they had. They really needed executive branch agencies doing the same kind of thing so they could come to a better policy direction.

Senator J. Lee conveyed the concerns of Wayne Sanstead from DPI that they don't have attorneys and that so much of this is a jurisdictional issue.

Sen. Mathern replied that they have access to attorneys through the Attorney General's office. They also have access to legislators who have access to attorneys through the legislative council. There are different ways to get that legal help. There is some need for legal counsel but it isn't just that.

He talked about the Bush Foundation and said that they have decided to have a specific funding pattern on Native American issues.

The hearing on SB 2346 was closed.

The Superintendent of Public Instruction, State Board of Higher Education, State Department of Health, and the Department of Human Services are to conduct a study of the implementation of Indian treaty rights as it relates to education, Indian health and welfare.

In order to conduct this study a consultant would be hired with this area of expertise. It is hard to predict how much legal work would be involved but we are estimating that the total cost would be around \$500,000. The Department of Human Services has \$100,000 of federal funds available; the balance would be general funds.

Chairman Lee, members of the Human Services Committee, I am Maggie Anderson, Director of Medical Services Division for the Department of Human Services.

I am here today to offer a suggested change regarding SB 2346.

The Department does not oppose a study of Indian treaty rights related to welfare; however, the Department does not have the resources or expertise to conduct this study. In addition, SB 2346 does not contain an appropriation for the Department to contract for the work to be completed.

We respectfully request the bill be amended to call for a legislative council study, rather than separate studies for education, health and welfare.

In addition, the Department would suggest a definition of welfare, as this could be as narrow as the Temporary Assistance for Needy Families (TANF) program, or could be interpreted to include all economic assistance programs such as Medicaid, Supplemental Nutrition Assistance Program (SNAP), and Fuel Assistance.

I would be happy to address any questions that you may have.

Madam Chairman and members of the committee:

My name is Dr. Wayne Sanstead and I am the State Superintendent for the Department of Public Instruction. I am here to provide information regarding SB 2346.

SB 2346 is a bill which addresses a study of treaties made between the U.S. Government and the Indian tribes. As the Interim Tribal and State Relations Committee reported to the 61st session, "Indian law is a very complex area of law." I don't know how the State Superintendent's office would be able to carry out this study mandate contained in SB 2346. This is a study requirement that needs to be done by attorneys. States didn't sign the federal treaties made with the Indian tribes, so there would be clear jurisdictional questions inherent to the study and any recommendations made to the legislative council by September 1, 2010.

The Department of Public Instruction does not have staff attorneys. Without the resources – human or fiscal – to deal with the legal work that would identify all the federal treaties or deal with all the disputes possible in what the treaty obligations mean, the department would need to hire attorneys or consultants with special expertise to address the enormity of this study assignment.

Madam Chairman this completes my testimony.
