language, I didn't want the county commission to run into other problems. I was concerned

Additionally they have meetings that are not in January, February, and October. Televised requires that the meetings be held at the courthouse.

**Senator Nelson**: You are switching from January, April, & July, to once a month. Are there counties that don't meet once a month?

Mary Kay Kelsch: Not sure. Most counties that I deal with meet every month.

**Senator Nelson**: I would think that you could delete that part and say have it be set by ordinance.

Aaron Birst: Association of Counties. Support bill even as amended it is an outdated law. 53 counties meet every month, and most meet more often. Originally came up with that bill we put in day of the week to format how current law was we don't think that this interfere with publishing meeting notices as long as they are following the other open meeting requirements.

**Chairman Wrangham** opened the hearing on SB 2359.

**Senator Cook:** Please bring your minds back in time to the 1877 and you are setting in these seats and the issue before you is when county commissioners should hold their meetings.

You have to give consideration to the time it takes to notify people in the county back in that era. You also had to give consideration to the time to travel to a county commission meeting if they wanted to attend and try to come up with the language that you want in this original statue that we are amending. I believe this is one of the oldest statues yet in the Century Code. We are now in the 21st century and it is time we update this statue and that is all this bill does. I urge you to pass this bill. The original law requires they meet the first week of January, April, July and October. So all we are doing here is bring this statue into the 21 Century so our commissioners might be able to conduct their business in a manner that is suitable for today. I would like to offer some amendments to consider since it was in the Senate I got an email from the county commission member regarding some challenges they were having with the makeup of the county park commission and when they meet so maybe we want to address that issue also somewhere. This would be an appropriate bill if the amendments are drafted.

**Rep. Nancy Johnson:** Is there other places in the statues that the regular meeting or when they meet?

**Senator Cook**: I don't believe so. (Handed out proposed amendment #1).

Aaron Birst, Association of Counties: This is an old statue. I was surprised that county commissioners would only require meeting quarterly. Every county right now is meeting monthly. There is no other statue that has a requirement in it. What it does say that in order to get paid the commission has to meet every month to approve the warrant so it is kind of saying you have to be there every month? We have on the bottom it has to comply with the statues. We did look at the amendment and I guess we don't have any objection to it.

**Rep. Jerry Kelsh:** The language says it has to be the same time every month. It can't be a different date?

**Aaron Birst**: We kicked this around a little bit. This says maybe there should be some consistency so the citizens know what is generally so. We thought the commission would establish basically a regular meeting date.

**Rep. Koppelman:** Did anyone every raise this point in law regarding commission meetings monthly? I think if we meet every other month people would notice.

Aaron Birst: I think the most important thing is that the public gets notice.

**Rep. Jerry Kelsh**: this would in no way then would prohibit the association when they had their academy a couple weeks ago; the counties that had their meetings during that week postponed them. Will this make it more difficult to postpone a meeting for a week with this law? It says it would have to be designated by the commission on a certain date.

**Aaron Birst:** The way I read that is the commission will go ahead and pass a resolution that says we are going to meet next month or two months down to road we will be meeting. The

intent is not to take away what now exists. If someone wants to word that a little better we certainly am OK with that. That is our intent.

Mary Rae Kelsch: Adjacent General's office: I will tell you how the amendments are suppose to work. There is something about how the county park boards convene and there are a lot of the parts of the law that refer to this and how they conduct their meetings. I took a look at it and talked to the Association of Counties and he said a lot of counties really like the way it works now. What I tried to do is had them open it up so if you are doing it the way you are now it is fine, but if you are a county where it doesn't work and if they wanted to increase the time or decrease it that is fine. We just wanted to add the probability if the county wanted to do it differently they were not violating the law. There are things in the old statue so I did take out some language and just do some updating so it corresponds with our current laws. I am surprised no county had come back from 11-11-05 because meeting must have been violated all over the place but nobody did that.

Rep. Koppelman: On the first page of the amendment it appears that purpose it to expand the size of the county park board because the law as I read it says two members of the county commission and two citizens and at least two. Is that the only change to make it larger?

Mary Rae Kelsch: Yes apparently the only concern was one county wanted a different number and they wanted to have it larger. It is my understanding that they wanted more citizen involved. I am not married to this and there can be flexibility.

**Rep. Koppelman:** I don't know how active they are in the counties and so on, but I don't think there is anything in the law that would prohibit citizen involvement or citizen interest or whatever else they wanted to do of citizens to accomplish various tasks, but seems all this does really is build the size of local government.

Mary Rae Kelsch: No one was beating down our door to do this.

Page 1, line 1, replace "section" with "sections" and after "11-11-05" insert ", 11-28-01, 11-28-02, 11-28-03, and 11-28-04"

Page 1, line 2, after "meetings" insert "and the board of county park commissioners"

Page 1, after line 16, insert:

"SECTION 2. AMENDMENT. Section 11-28-01 of the North Dakota Century Code is amended and reenacted as follows:

11-28-01. Board of county park commissioners - Appointment by county commissioners - Number. The members of the board of county commissioners and shall establish a five-member to seven-member board of county park commissioners consisting of at least two members of the county commission and at least two resident citizens of the county appointed by the board of county commissioners shall constitute the board of county park commissioners.

**SECTION 3. AMENDMENT.** Section 11-28-02 of the North Dakota Century Code is amended and reenacted as follows:

11-28-02. Eligibility for appointment - Term - Vacancy - Compensation. Any resident citizen of the county, including county, city, and township officers, is eligible for appointment to the board of county park commissioners. Each appointed county park commissioner shall hold office for a term of three years, or until a successor is appointed and qualified. Any vacancy in the board must be filled for the unexpired term by appointment by the board of county commissioners as soon as practicable. Each member of the county park board is entitled to receive the same compensation for services for each day actually engaged in the performance of the duties of the office as that paid a county commissioner but not to exceed a total of twenty-four days in any one year, and is entitled to reimbursement for actual necessary expenses incurred in the performance of the member's duties. The Unless otherwise agreed upon, the board of county park commissioners shall meet at the time of the regular meetings of the board of county commissioners upon the order of the chairman, and appointed members only are entitled to compensation for attendance at the concurrent meetings.

**SECTION 4. AMENDMENT.** Section 11-28-03 of the North Dakota Century Code is amended and reenacted as follows:

11-28-03. County auditor, county treasurer, and state's attorney shall serve board. The county auditor or other official designated by the board shall serve as secretary of the board of county park commissioners and the county treasurer shall serve as treasurer of the board and custodian of all its funds from whatever source received. Such funds shall be placed in a separate fund and shall not be diverted to any other use or purpose. The state's attorney of the county shall act as legal adviser to the board and shall prosecute and defend any and all actions brought by or against said board. Neither the county auditor nor official designee, the county treasurer, nor the state's attorney shall receive any additional compensation for acting in their respective capacities.

**SECTION 5. AMENDMENT.** Section 11-28-04 of the North Dakota Century Code is amended and reenacted as follows:

20/2

11-28-04. Organization of board - Quorum - Meetings. Within twenty days after the appointment of the board of county park commissioners, and within twenty days after any change in its personnel, the board shall meet in the courthouse of the ecunty and shall organize by selecting one of its members as chairman. Two-thirds of the members of the board shall constitute a quorum at any moeting thereof. One-half or more of the members constitutes a quorum of the board. The board shall hold such meetings as may be required for the transaction of its business and activities. Meetings shall If the board decides to hold meetings at a time other than the time for regular meetings of the board of county commissioners, the board shall draft a schedule of regular meetings to be held throughout the year. The schedule must be filed with the county auditor and the meetings must be noticed in accordance with section 44-04-20. A special or emergency meeting may be called by the secretary upon the order of the chairman, or upon the written request of the majority of the board with notice provided in accordance with section 44-04-20. Such order or written request shall be entered on the minutes of the meeting so called. Notice of such meeting shall be delivered or mailed to each member at least five days prior to the date of the meeting. A meeting of the beard may be called at any time by the chairman without notice and such meeting shall be legal and valid if attended by all members of the board."

Any resident citizen of the county, including county, city, and township officers, is eligible for appointment to the board of county park commissioners. Each appointed county park commissioner shall hold office for a term of three years, or until a successor is appointed and qualified. Any vacancy in the board must be filled for the unexpired term by appointment by the board of county commissioners as soon as practicable. Each member of the county park board is entitled to receive the same compensation for services for each day actually engaged in the performance of the duties of the office as that paid a county commissioner but not to exceed a total of twenty-four days in any one year, and is entitled to reimbursement for actual necessary expenses incurred in the performance of the member's duties. The Unless otherwise agreed upon, the board of county park commissioners shall meet at the time of the regular meetings of the board of county commissioners upon the order of the chairman, and appointed members only are entitled to compensation for attendance at the concurrent meetings.

**SECTION 4. AMENDMENT.** Section 11-28-03 of the North Dakota Century Code is amended and reenacted as follows:

11-28-03. County auditor, county treasurer, and state's attorney shall serve board. The county auditor or other official designated by the board shall serve as secretary of the board of county park commissioners and the county treasurer shall serve as treasurer of the board and custodian of all its funds from whatever source received. Such funds shall be placed in a separate fund and shall not be diverted to any other use or purpose. The state's attorney of the county shall act as legal adviser to the board and shall prosecute and defend any and all actions brought by or against said board. Neither the county auditor nor official designee, the county treasurer, nor the state's attorney shall receive any additional compensation for acting in their respective capacities.



On December 2, 2008, the Morton County Commission voted unanimously to initiate a change which would move the regular monthly meeting date from the first Tuesday of each month to the second Tuesday. Current language in the Century Code does not offer County Commissions the flexibility to make such a change. Thus, Senate bill 2359 was introduced at the request of the Morton County Commission.

This change to section 11-11-05 of the Century Code is requested for the following reasons:

- 1.) Conducting meetings in the first week of the month often does not allow ample time for receipt and verification of all bills by the Auditor's office for final approval by the Commissioners. Local vendors have complained about sometimes having to wait 45 or more days for payment. Meetings held on the second Tuesday of each month will alleviate this problem.
- 2.) The Morton County Commission has been encouraged by citizens to televise meetings. In order to consider that option, it will be necessary to move our meetings to the second Tuesday of each month to avoid conflict with schedules of the City of Mandan, the Mandan Park Board, and Mandan School Board, all of whom have entered into agreements providing for the telecast of their meetings.
- 3.) Meeting on the first Tuesday of the month conflicts with Mandan City Commission meetings. Since there are frequently joint concerns, commissioners of both elected bodies sometimes find it necessary to attend a meeting of the other. By meeting on the second Tuesday of each month, this conflict is eliminated.

The Morton County Commissioners respectfully request that Senate bill 2359 be amended to include the Emergency clause, and that it be sent to the floor of the Senate with a unanimous Do Pass recommendation.
