Minutes:

Senator Krauter : As the council addressed the bill draft we decided that this needs to be studied so we make sure that all political subdivisions that have different scenarios be it road construction or purchasing of equipment for school districts are handled properly. I have passed out the amendments and am asking that that be amended into the bill and sets up the process of being studied during the interim an including cooperatives.

Senator Dever: I imagine that there are barriers that will be studied.

Representative Dave Monson: District 10, I have been doing these types of bidding that have made use of these. When they asked me to sign on to the bill I said ok but when I looked at it I saw some things that made us go backwards, so I support the amendments and I will turn it over to my former colleague.

Senator Dever: It is school districts, places that may share equipment

Representative Monson: A small school could never buy in quantities to get bulk prices so we belong to a coop and they would bid. There were some problems that needed tweaking, but the bill added burden and put us backwards.

John Jankowski: See testimony #1.

Senator Horne: What are some of the things you can't do now that you want to do?

John Jankowski: Some of the new copy machines are \$40,000-\$50,000. The 3 year net costs can be \$100,000. As we go out we are not clear as to what the law is. What we don't want to happen is someone comes back later and says that we can't do that. as different groups come to you we want to make sure it is clear.

Senator Dever: It is interesting that it involves private schools. You are part of the coop

John Jankowski: Private schools can be an affiliate member, but they can't vote. My school and local colleges are affiliate members but they have to purchase them. I was the superintendent in Lamoure and since I have left public and entered private education they asked me to stay. When JPA idea came around a few years ago, where there is a governing board in MRAC

Senator Dever: Not talking about the ability for a school to go together with a small town.

John Jankowski: If Bismarck and Mohall want to go together. Do they have to sign a joint power to do that?

Senator Nelson: West Fargo and Fargo are not on the list but Fargo school districts are not on the list.

John Jankowski: Since list was created they have been added. We can save 12-18% on food and biding. A lot of purchasing can be done online. Fargo is reducing warehouse costs.

Senator Oehlke: Is there consideration given to North Dakota businesses?

John Jankowski: The contracts we have on a national level are with local vendors take shipment and set it up. Fireside Office is Kyocera vendor.

Senator Oehlke: You don't feel we are taking business away from ND business?

John Jankowski: We have that discussion all the time. The #1 provider of school supplies is based in Wisconsin. Fine line between staying local and doing right by the tax payers.

Aaron Burst: I am Aaron Burst from the North Dakota Association of Counties. We reviewed this bill and appreciate the amendment. We exist to get joint power agreement, we want to participate in the study and do whatever we need to in order to get the study through. If there is a chance we can create a larger pool. Create resources, pass on to tax payer.

Rodney Scherdenske: For the amendment and study. Advantages are the public schools to be able to bid for products. We are a very small school and this group would have that ability, puts us in the pool. We support the bill.

Jeffry Volk: See testimony #2.

Senator Horne: You would not oppose the study, just be sure to address your concerns.

Jeffry Volk: Yes, that is correct. When you get into the service side you bring things into that arena and are sure to not take existing statutes.

Senator Cook: You are here as a citizen?

Jeffry Volk: Yes. Moore Engineering and ACEC.

Senator Dever: Are you aware that legislative council will inform you of meetings if this goes forward.



Minutes:

Chairman Grande: We received a fax from MN dealing with a little bit of their issues and I just wanted to pass that out for your information regarding the first bill we heard. Open the hearing on SB 2422.

Rep. Lisa Meier, District 32: I am here just to present SB 2422 for you. I will not offer information about the bill so don't ask any questions. I know that Senator Krauter will be down here to offer information on the bill because it has been turned into a study.

Vice Chairman Randy Boehning: Any questions for Rep. Meier?

Chairman Grande: Is there anybody here interested in 2422?

Rodney Scherbenske, NDESC/CRI: It is a coop, North Dakota Education Service Cooperative Board, joint powers group that started approximately 10 to 15 years ago. In dealing with insurance and trying to bid insurance and that kind of lead to different things and the list of schools, you can see the list of schools, private schools and now we have expanded into the cities to cooperatively give,

find, and purchase things to save money for school districts, political subdivisions, and other things related to our kids. We do allow private schools to be part of our organizations, they don't have a voting member but they can use our services. That is what NDESC is. (See Attachment # 1). NDESC then joined a State affiliation an association of education purchasing agency, that is the AEP and that is kind of why we've asked this bill to be studied. NDESC is the representative of basically 23 States have joined together to triangle out and bid for services such as: resurfacing a field or a track, basically if ND would not have anybody that would bid it, it would allow us to bid that, does that mean a school district that wants that could overlook the rule of the 25 thousand. That is not our intent, our intent is to follow the rules that the State has set forth and to make sure that we do that.

Some of the contracts that we have are listed in the next page from athletic and fitness to audio visual to building and behind that you can see if it is AEPA contract or if it is NDESC contract and those contracts were bid out according to the ND State Laws as they have them now. I guess that is where we are at and we would definitely like the recommendation to study this to make sure that we are following the laws and we can continue to do business and provide services to the school districts.

Rep. Meier: Right now, currently, do you have an agreement with the State to do cooperative purchasing for like your copiers, fax machines, and some of the other things?

Rodney Scherbenske: Yes, we do. We have gone through and we have filed those things on a yearly basis so we have those things. The APA contract is a national contract that allows us to do copy machines, for example, that is one of the ones that is being used. It allows the school district to give the same bid as Scottsdale, AZ. But that doesn't mean we buy from them, it is purchased through that company and then serviced out. Like for example, Minolta, would be

Fireside Office Systems in Bismarck and then they would handle that but we have the (can't understand word) involved.

Chairman Grande: Any questions from the committee?

Rep. Nathe: The study looks at specifically for group insurance don't the schools already have kind of a group insurance?

Rod Scherbenske: We have tried that and we have gone out for bids and we didn't receive any bids and that is one of the things that we are continuing to work on. Our group will dictate what we want. But last time we went out and bid, Blue Cross and Blue Shield didn't bid, the only one that did bid was Humana at that time and then Humana pulled their bid at the last minute. So that is

something that we are still working on. Again, our diversity of every school district basically has a different policy that is where we are at.

Rep. Kasper: What impact is your organization having on local businesses as far as losing business compared to going out-of-State?

Rod Scherbenske: Basically, none. I am not going to say zero but every school district still tries to do there own stuff locally. I can use Mandan who just built a high school recently and they had access to our bids. They bid theirs and again it is a local decision. We are just trying to provide another tool for school districts to use and if they want to use it they can and if they don't, they don't have too.

Again, I think it is a driving force that we can try to keep things local because they are the people who scratch our backs and pay the taxes.

Chairman Grande: Any other questions? Senator, it is your turn.

Senator Aaron Krauter, District 31, Regent, ND: In front of you, you have Senate Bill 2422 and I think the gentleman from Goodrich has explained the process here and let me go back to day one. When we had the bill drafted, it had some wording in there that drew in more political subdivisions from the standpoint of having to publicly notify the (don't know the word) process and when it gets over a certain dollar amount it created some problems. As we talked about it before we had the hearing we decided to turn it into a study from a standpoint that there were so many potential opportunities out there that we

didn't want to mess anything up and we didn't want to have something drawn in or let's say a county wanted to bid on something or wanted to put together a process and it created a negative for them, so that is why we turned it into a study. But this whole concept of cooperative and working together is good economic sense. But being sensitive that you are not displacing your local business and getting supplies and purchases there but when you work together maybe you can work those things out. That was the emphasis behind it and I know that the schools have been doing this and in fact all schools in ND, public and non-public have kind of joined together to provide some of those cooperative purchasing agreements. In a nutshell, that is what it is all about and I am glad that the Superintendent from Goodrich is here and I would ask for your support because I think this a legitimate one that during the interim would be an issue that you could get a lot of input together for political subdivisions to come to the table and maybe we can save the taxpayers and those voters some money.

Rep. Kasper: Isn't this something that political subdivisions could be doing on their own right now without coming to the Legislature to ask our involvement?

Senator Krauter: Under current statute yes, but if we could make that circle of political subdivisions and political schools and other type of agreements and not just counties getting together and make that larger I think it is for the benefit.

Chairman Grande: Any other questions? Anyone else wishing to speak in favor of 2422? Opposition x 3? Neutral? Closed the hearing on SB 2422.

Chairman Grande: We will discuss SB 2422.

Rep. Kasper: I asked Sen. Krauter what would be wrong with or could the entities do the studies on their own without getting the Legislature involved and he said "Yes". I see no reason why the Legislative Council should study something that the political subdivisions who are outside of the Legislature could and should be studying on their own merits and so I would oppose this bill and move a Do Not Pass.

Vice Chairman Randy Boehning: 2nd.

Chairman Grande: We have a Do Not Pass motion by Rep. Kasper and a 2nd by Vice Chairman Randy Boehning. Any discussion?

Rep. Meier: Doesn't this open it up a little broader though than just for the political subdivisions to study for bidding?

Rep. Dahl: I think it would be a forum for all the political subdivisions and school districts and towns. I think that is what he meant.

Rep. Kasper: On Lines 5 and 6, goods and services by political subdivisions, it is open to any political subdivision, but again these political subdivisions, either separately or together could, and should be studying this on their own.

Legislative Council has no business studying something that another political arm of government could and should be doing it on their own.

Chairman Grande: I want to go down to Line 8; "The study should also address the participation of none governmental entities and cooperative agreements for the purchases of goods and services." That is where Rep. Meier is talking about the expansion area of that. Yet I am not sure that anybody is stopping these groups from getting together to do this. Further discussion?

Rep. Winrich: I am not sure that anyone is stopping the groups from doing that but I think that as we have seen in many of the bills that come before us. If you are talking about all the political subdivisions, you have a broad spectrum of different sorts of capabilities and people involved and so on. For the larger municipalities I suspect Rep. Kasper is correct there is no reason why they can't study it own their own but if we are going to extend some of the advantages of this sort of thing to smaller local units and so on I think it might be appropriate to have a Statewide program.

Chairman Grande: My question comes with non-governmental entities. Are we trying to get to where anyone and everyone throughout the State comes together for procurement issues?

Rep. Meier: The individual that had actually visited on me with this bill before it was turned into a study, was a Superintendent of a private school in Bismarck, and they wanted to be able to bid on some of these, like a fax machine or copier, so that they would receive a little bit of a less price than what they are currently receiving. So for that reason that is why the bill was actually brought forward instead of a study.

Rep. Kasper: All of the entities that are impacted by this study, private schools, political subdivisions, and any other entity that might get to come in here are supported by citizens and taxpayers of the State of ND with property taxes, sales taxes, contributions, charitable contributions and so on. This study is going to look at forming a huge buying club where a good amount of goods and services could be purchased from out of State and our taxpaying business owners get left holding the bag again if this gets put together. So I am saying if these groups wish to do it on their own, more power to them. The school boards have an association, the cities have an association, the counties have an association, the park boards have an association, and they could get together collectively and form this study and invite other participants. But let them do it on their own.

Chairman Grande: Any more discussion?

Vice Chairman Randy Boehning: I call for question.

My name is Jeffry Volk. I currently serve as President and CEO of Moore Engineering, Inc. and I am a Professional Engineer and Registered Land Surveyor in North Dakota. My testimony today is on behalf of the American Council of Engineering Companies/North Dakota and Moore Engineering, Inc. I have spent my entire professional career as an engineering consultant in North Dakota.


My testimony today is in opposition to SB 2422. While we understand the concept SB 2422 is promoting, we oppose the bill's requirement that cooperating political subdivisions "bid" services. While mandating political subdivisions to bid certain types of services, such as clerical, custodial, grounds maintenance, printing etc., may be practical, bidding professional services, legal, architectural, engineering, land surveying etc., has been found to not be in the public's best interest.

Federal and state agencies are required to use a Qualifications Based Selection (QBS) process to guide them when hiring professional engineers, architects and other related services. NDCC 54-44.7 outlines this QBS process for agencies in North Dakota. While we are not suggesting political subdivisions should be mandated to utilize the same QBS process outlined in Chapter 54, we think it is in the public's best interest to allow political subdivisions to utilize some form of a QBS process while hiring professional services.

My observation with over 30 years of providing engineering services in North Dakota is that many political subdivisions already utilize some form of QBS when hiring professional services. We simply ask that the QBS selection process remain as an option for political subdivisions that wish to coordinate with others when hiring professional services. Please send SB 2422 to the Senate with a Do Not Pass recommendation.

Testimony SB 2422

Chairman Dever and the Committee members:

My name is John Jankowski and I'm the Executive Secretary of the North Dakota Educators Service Cooperative. If I may I would like to give you some information about our cooperative. If you would look at page 4 of my testimony you will find a list of member's schools and other political subdivisions that belong to our cooperative. Our cooperative was the first joint powers organization in the state as we organized over 10 years ago at which time we had about 40 members. 10 years ago our sole purpose was to find a solution to the alarming rate of rising health insurance costs for our employees. As we worked on health insurance we started to offer other services to our members such as dental and vision insurance and help with their Flex benefits administration.



Over the past eight years we have expanded our services to include cooperative purchasing for our members. In December 2001 we were admitted to an organization called Association of Educational Purchasing Agencies or AEPA. I have included some information about AEPA in my testimony. We now have 24 member states in the organization and last year did a combined total of \$237,000,000. School purchasing is far more than buying pencils or pens.

We have combined the purchasing power of North Dakota with these other states to obtain better pricing that is available to the smallest school or city in our state. Because of involvement with AEPA our small schools are paying the same price as some of the largest schools in the country.

As you look at the list of products available we believe that we are offering the best prices to our North Dakota schools. We are able to obtain pricing that would not be available to one or two schools or even 30 schools working together. We are trying to help schools streamline and modernize their purchasing program. Our purchasing program allows schools to reduce inventory and reduce their


initial costs when buying items. The price that they receive is available whether they buy one or a hundred of an item. The day of the truck backing up to the school door in August with all the supplies needed for the school year is over. Let's buy what we need when we need it. And.. now most of the buying can be done on-line. Shopping is at your fingertips and because of belonging to our organization most of the shipping is included and items usually arrive in less than 48 hours. Schools no longer have to wait for that salesman to stop by or drop off the new catalogue. I like to use the example when speaking of the advantages of AEPA, the smallest school district in the state can receive the same price on a copy machine as the largest district in the state of Ohio. The school still works with the local vendor for delivery and service but the pricing is obtained from the manufacturer.

Besides our membership in AEPA, our cooperative is working with Montana, Wyoming, Nebraska, and Minnesota on trying to obtain volume discounts with food vendors, not with the vendor that delivers the product, but with the manufacturer.

So why was SB 2422 introduced and where do we need to go? We had consulted with our attorney about what legislation was needed to help us to achieve what is happening in other states. However because of timelines it just couldn't be produced fast enough. Now I'm the first to admit that I'm not an expert on volume purchasing. As I set at the table with 24 other states, (I'm the only active school superintendent) I realize that I have much to learn. But I do know that we need a coordinated effort between political subdivisions, joint power groups, higher education, and agencies of the state, even the state itself. It seems that are a few rules that are different between all groups. We would like to see statutes that will allow groups to take advantage of some of the modern purchasing strategies.

When I hear that one state in our national group is "piggybacking" off another states contract, or that one cooperative is that natural gas bidder of an entire state and checks pricing and sources each day to save schools money, or another state is buying vehicles through another state, well, the list goes on and

I'm not asking for changes today. I'm asking that the legislature help all of us by studying how we can more effectively use tax dollars to buy what is needed for use in our schools, and state. I believe that the North Dakota Service Cooperative can continue to be the organization for schools and eventually for many other agencies in the state. Help us by bringing others to the table to determine what is best for North Dakota. We need the help of your committee, OMB, cities, counties, higher education and other agencies. You can help to make this happen. This study can be one that saves money for the tax payer of North Dakota.

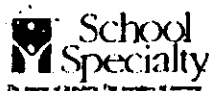

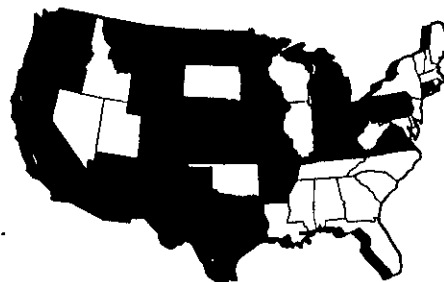

NDESC is the exclusive representative of North Dakota schools in the Association of Educational Purchasing Agencies (AEPA). AEPA is an twenty-one state consortium, representing 26 million students, which seeks to explore and solve both the present and future purchasing needs of AEPA members.

This is accomplished by collectively bidding for a wide variety of products, which are commonly used by schools and are often major purchases. These bids were completed in compliance with North Dakota bid law. Current contracts include office furniture, classroom furniture, technology equipment and modular buildings.
