**Senator Triplett** what good do you expect this resolution to do and can you describe what the American Kennel Club does when they receive resolution like this?

Cheryl Purdy- I am actually not a member of the Kennel Club. I think this is just a baby step.

North Dakota doesn't really have any laws for animal abuse or protection and this is kind of our

Senator Lyson I have to correct you, there are some pretty strict laws on abuse of an animal. I was recently at a long care facility visiting and as we sat there a big collie dog came up and laid his head on her lap. You could just about feel her responding to the kindness of this dog.

Senator Freborg what does it cost to have for a dog to go to obedience training?

Cheryl Purdy the local kennel club has a six week course for \$60 and Pet Smart does a course for around \$80. It differs with the level of training you do.

**Senator Lyson** opened the discussion on resolution 4005. One member was absent.

Senator Lyson let me give you some examples of the emails I have been receiving regarding this resolution. They say things like "what are you doing", "I have dogs and they are great dogs, friendly and well behave; now you are trying to tell me to have them trained?" That might be ok to do in Fargo or Grand Forks but not in smaller towns. I have had a dog all my life. I have never had anyone train one of my dogs and I have never had a dog bite or chase anyone either. I feel almost insulted when I have someone telling me I should do this.

Senator Triplett my concern is the woman who testified, Cheryl Purdy, who referred to this as a baby step. I always worry about people who tell us this is a first step. It implies to me that they have a long term plan. Then next session or down the road they will be back in and remind us that we passed this and then there will be a bill requiring dog owners to put their dogs in doggie school. If this was the end I wouldn't have a problem but when they come in and tell us it is a baby step towards some undefined thing it worries me.

Senator Hogue we have a bill in next week that is a requirement for the North Dakota

Department of Human Services. It states that when one of their employees goes into a home

for suspected child neglect it will also require them to report any suspected abuse of dogs. It is apparent to me that there is more of an agenda coming through this session.

SCR4005- Supporting the promotion of responsible dog ownership and encouraging the training and testing of dogs

Chairman Lyson and members of the Natural Resource committee, for the record my name is Senator JoNell Bakke and I represent district 43. I bring before you today SCR4005. This is a resolution that brought to me by one of my constituents who is a professional dog groomer and shows her own dog professionally.

This resolution is one that the American Kennel Club has sponsored in over 30 states and it promotes responsible dog ownership and encourages the owner of the animals to train and test the dogs. I think the resolution is pretty straight forward and self explanatory.

Thank you for your attend to this matter and I would stand for any questions at this time.

Mr. Chairman and members of the committee, my name is Cheryl Purdy. I am here today in support of Senate Concurrent Resolution 4005.

As a long-time dog owner and recent pet therapy provider, I would like to encourage you to support this resolution. Responsible pet ownership does not only include providing shelter and food for a pet, but training and exercise, discipline and love (in that order).

I have learned with my own "hand-me-down" dogs that my family and my dogs are much happier when they understand that I am the "pack leader". A year and a half ago, my husband and I adopted a pound puppy who was on his way to becoming a dog like "Marley". After a couple sessions of obedience training, he has settled into the family quite nicely. I hope someday he will become a certified therapy dog.

At the encouragement of my pet groomer, my other dog Chancey has taken obedience training, passed the canine good citizenship test and has been nationally certified as a pet therapy dog. We regularly visit patients at a local hospital.

There are many resources available in North Dakota for owners to train their pets. Here in the Bismarck/Mandan area, there are classes available through local kennels, the Bismarck Kennel Club, PetSmart and other private individuals.

In conclusion, we all know that dogs live to please people, so we, as responsible owners, should help them do just that with training, discipline and love. Thank you for your time. I would be happy to answer any questions you may have.
