Explanation or reason for introduction of bill/resolution:

Criminal history record checks for chiropractors

Minutes:

Chairman Bette Grande opened the hearing on HB 1081. All were present.

Dr. Carol Winkler, President of the North Dakota State Board of Chiropractic Examiners, appeared in support of this bill. Attachment 1.

Rep. Bill Amerman: Are these reports confidential?

Dr. Winkler: Yes they are.

Rep. Bill Amerman: On the fees, do you know what that might average for these

licensees?

**Dr. Winkler:** I think it depends on exactly how it operates, but my understanding is that it is somewhere between \$60 and \$100.

Chairman Bette Grande: I asked that question of another group earlier in the week, and those numbers come up very similar. It all depends on if you are just doing the fingerprinting, BCI portion, or if you have to do a national criminal background check. From what I understood from another group that is going to have this type of thing is that they are looking at that first and foremost BCI type thing, but if they are getting any flags or anything to that, they will proceed into that next level. It is averaged at about \$86.

**Rep. Ron Guggisberg:** I notice that it says the board may require an applicant. Who and how will it be decided whether the applicant has to have this background check?

**Dr. Winkler:** We intend on doing that on all new applicants. We are not planning on doing it on relicensure at this time unless we have reason to believe that someone is under investigation that we need to look at in that way. With people moving from other states, this is a criminal background check. There are professional data banks. If someone has something against their license, that information we already get.

**Rep. Glen Froseth:** Is your profession keeping up with the demand of chiropractors to meet the needs?

**Dr. Winkler:** Especially in North Dakota, it is. Somewhere in some of the states like California, they have 16,000-17,000 licensed chiropractors, and it is hard for the Board of Examiners to keep track of all that. In North Dakota, I wouldn't say there are an equal number of retirees compared to new licensures, but I also haven't seen that the numbers of the new licensees are having trouble getting started or that sort of thing. In North Dakota the thing that we have is the major cities and the outlying communities and some of the new licensees wanting to go out into the rural areas and live. That is more of an issue.

**Vice Chairman Randy Boehning:** With the criminal background checks, what are we looking for? What will disqualify them from becoming a licensed chiropractor in the state?

**Dr. Winkler:** What we are looking at is something that would be a flag to unprofessional conduct so that could be sexual misconduct, a prior conviction of some sort that would prevent them from practicing in a professional manner as far as our law goes.

**Vice Chairman Randy Boehning:** Is it a set standard? Do you have something in rules? Is it on a case by case basis? Do you have something actually in writing?

**Dr. Winkler:** We do have in writing in our rules what unprofessional conduct constitutes, but our Board basically works on a case by case basis. What we would want to do is be aware of the situation if it exists, evaluate the person or have the person evaluated based on what the red flag is, and then make a decision based on that. It is not a situation where once you have a problem, you are not going to get a license, but if it is a situation where they have not recovered, not done what they should do in terms of being able to practice professionally, then we would want to make that judgment.

**Rep. Bill Amerman:** Could you give me the makeup of your board? Is it all chiropractors?

**Dr. Winkler:** Yes. We have five chiropractors on our board.

**Rep. Karen Rohr:** Does your board then input this information into a database so that you keep track of the background checks that are done and or if there are any further infractions that occur?

**Dr. Winkler:** Yes, we do in of ourselves. Then, there are other databases that are available for healthcare professionals nationwide.

Rep. Karen Rohr: This is not transparent information that the public can go in and see?

**Dr. Winkler:** Correct. I don't want to sound like we are not transparent. What I am saying is we are not going to publish that information, but once it is ruled upon, we will follow the law as it goes to that.

Chairman Bette Grande: Just like any other physician that is brought up on any issues, there's transparency to a point, but I think what she is referring to it wouldn't be HIPPA but it is similar to a HIPPA type thing where some of these things where you are going to keep them here. If you have a physician that has the infractions that they don't bring about licensure for them, then that is going to become public out really on its own.

**Dr. Winkler:** After the decision is made, it is public record, correct.

**Rep. Karen Rohr:** My only concern would be is if you had a positive criminal background check, and I know it has happened in other professions, it is very likely or possible that individual could go to another state and practice before that would catch up to them and they realize that his license was revoked in say like North Dakota.

**Dr. Winkler:** Correct. That is a problem. There is a network in the federation of chiropractic licensing boards, and that is where that database is found. We are mandatory reporters to that. Once an infraction is upon a license, that automatically gets reported into that database. If we have a licensed chiropractor from some other state wanting to come to our state and even a new licensee out of school, we checked that databank before we issue a license. Before technology that happened quite a bit. There are the slippery, smart professional people that do tend to try to get around that. We haven't had that in our state. Some of the national meetings within the last year they have had a name change and haven't caught it. That sort of thing has happened, but we are on it as much as we can be.

**Rep. Karen Rohr:** That would be my concern—the patient. If they would have access, they could check it out themselves. If they hear rumors, and they can be deadly for any professional, and that is why they would be protected for both.

**Dr. Winkler:** Exactly right. That is the job of the board. We have third party people, patients and physicians, calling our board office asking questions like that even at this point. What we are able to give them, we do. If there is a current investigation in progress, we can't.

**Rep. Lonny Winrich:** If someone called and there was an investigation in progress, could you inform them that there was an investigation?

**Dr. Winkler:** We can. That is it. You can't divulge the details of the investigation until a ruling has been made.

**Ken Tupa, ND Chiropractic Association,** appeared in support. This is positive policy. It is good for the protection of the consumer and the public of North Dakota.

There was no one neutral or in opposition to this bill.

The hearing was closed.

Vice Chairman Randy Boehning made a motion for a Do Pass on HB 1081.

Rep. Ron Guggisberg seconded the motion.
