Chairman DeKrey: We will open the hearing on HB 1120.

Danita Wald, General Counsel, Office of State Tax Commission: The Tax Commissioner wanted this bill introduced to provide statutory authority so we could have the IRS offset ND income tax refunds to pay federal debt. We've been working with the IRS in the last couple of weeks. We have not come to a meeting of the minds as of yet; we're still going to work with them during the interim and hopefully come back to you next session with a bill that reflects what the IRS and Tax Dept. agree to.

Chairman DeKrey: Commissioner Fong wanted to pull the bill because he had anticipated an agreement with the IRS, and then the IRS dug in and so it was too late to pull it because it had already been scheduled for hearing; so he couldn't pull the bill so basically we're just going to put a Do Not Pass and wait until next session.
