Rep. Porter: We will the hearing for HB 1196

Rep. Dahl: I did have an officer come to me wanting some clarification, after reading the statue with regard to DUI's on snowmobiles. After your first offense of a DUI on a snowmobile with your BAC at a .1 which is higher than any other vehicle, it is a infraction, a fine of \$500.00. The statue sets out guidelines or mandatory minimum of what your fine is. The second offense within five years is also an infraction. That's what this bill does. It changes that second offense to a class B misdemeanor I believe a third offense is also a class B misdemeanor. In the 12.1 code which is the criminal code talks about infractions. The maximum fine of \$500.00 may be imposed. Any person with an infraction who has been convicted of an infraction who has within one year prier of the conviction may be sentenced as though convicted as a class B misdemeanor. Liability Insurance is only required if you are on state trails.

Rep. Kelsh: Does the court have an discretion in going beyond these guidelines?

Rep. Dahl: I am not sure that they would under these guidelines. With a class B misdemeanor I think they have more flexibility because you can hold some jail time over them.

Rep. Porter: On the motor vehicle side of things, what is the fine for the second offense?

Rep. Dahl: That fine would be the same. At least a \$350.00 fine, which could go up to \$1000.00 fine and thirty days in jail which is the upper limit of the class B misdemeanor.

Rep. Porter: We will close the hearing on HB 1196.

Rep. Hanson: Is a class B misdemeanor \$1000.00 fine and a year in jail or both?

Chairman Senator G. Lee opened the hearing on HB 1196.

Representative Dahl, District 42, introduced HB 1196. This bill is a relatively simple bill. It shifts a second DUI on a snowmobile, within five years, to a Class B misdemeanor. The way the law reads currently, the first offense is an infraction which is punishable by fine only and the second offense within five years is also considered an infraction. Her position is that the second offense within a five year period should be a Class B misdemeanor.

Senator Mathern asked what precipitated her to bring this bill forward.

Representative Dahl replied that she is a municipal prosecutor and one of their officers had a question regarding that enforcement and she started to look into how to interpret the penalty for the second offense. This bill would make the law more consistent for a second offense in a time period.

Senator Nething asked why she didn't want to change the fine for the second DUI.

Representative Dahl replied that she would interpret that to be that there would be a minimum fine of \$350 but with a Class B misdemeanor that would be left up to the court.

Senator Nething said that it has been \$350 as an infraction.

Representative Dahl replied yes. The minimum on a second offense is an infraction punishable by a fine only of \$350. The way she interprets the bill is that they will still have to pay \$350 with the possibility of jail time.

Senator Nething pointed out that as a Class B misdemeanor it could carry a fine up to \$1000.

Representative Dahl said that is correct.

There was discussion on if the DUI on a snowmobile would affect your operator (car) license. Eric Dietrich, ND Parks and Recreation said it would not affect your operator's license if you have a DUI with a snowmobile. Penalties are more serious for a car or vehicle DUI.

PROPOSED AMENDMENTS TO HOUSE BILL NO. 1196

Page 1, line 1, after "reenact" insert "subsection 11 of section 39-24-09 and"

Page 1, line 2, after the first "to" insert "snowmobile insurance and"

Page 1, after line 4, insert:

"SECTION 1. AMENDMENT. Subsection 11 of section 39-24-09 of the North Dakota Century Code is amended and reenacted as follows:

A person may not operate a snowmobile, and an owner of a snowmobile may not knowingly permit the snowmobile to be operated, upon any property maintained, leased, or owned by the state parks and recreation department to which the public has a right of access for snowmobile or other vehicular use or upon public property including a highway, without a policy of liability insurance which insures the person named, and any person using the snowmobile with the express or implied permission of the person named, against loss from the liability imposed by law for damages arising out of the ownership, maintenance, or use of the snowmobile within this state, subject to the following limits, exclusive of interest and costs, with respect to each snowmobile: twenty-five thousand dollars because of bodily injury to or death of one person in any one accident and, subject to the limit for one person, fifty thousand dollars because of bodily injury to or death of two or more persons in any one accident, and twenty-five thousand dollars because of injury to or destruction of property of others in any one accident. Upon request of a law enforcement officer, a person operating a snowmobile shall provide proof of liability insurance to that officer within twenty days."
