Representative Brandenburg, District 28, introduced HB 1200. He explained that this bill deals with a member of the Upper Great Plains Transportation Institute that would like to be removed from the Advisory Council. This would be the North Dakota Farm Bureau. They are just going through the procedure that would take care of this issue.

Sandy Clark, North Dakota Farm Bureau: We are asking to be removed from the Advisory Council of the Upper Great Plains Transportation Institute. See attached testimony #1.

Representative Onstad: You referenced other mediums. What kind of considerations is Farm Bureau having?

Sandy Clark: We will be using our own transportation committees and that sort of thing. If we decide that we need some transportation research done, that still doesn't preclude us from working with of the Upper Great Plains Transportation Institute to do some research. We traditionally have not, simply because we do not have the kind of money it takes to pay for those kinds of research projects. We can still work on transportation issues with other Ag. organizations.

Representative Delmore: Were there specific issues that made you decide that this committee was not a good fit; were there conflicts?

Sandy Clark: Not any more than there would be with any type of organization. We have had some philosophical differences on some things from time to time.

Chairman Ruby: Have you polled your membership on this or was it a board decision?

Sandy Clark: Our policy is member driven. We have fifty county Farm Bureaus, and they bring the policy through the counties to our House of Delegates. Every single resolution is

voted on. This policy did come through that process and was voted on by our House of Delegates. Let me reiterate that the Board did ratify the interpretation of the policy as well.

Jeff Enger, North Dakota Corn Growers: I am here to support an amendment to the bill which would include North Dakota Corn Council as a member of this Advisory Board.

Chairman Ruby: What is the avenue to get approval to be on this board? Or, is it just us putting everyone on?

Jeff Enger: I can't answer that.

Chairman Ruby: I'm sure it is, but I didn't know if the Council had a problem with more or less groups.

Representative R. Kelsch: We have had bills before us in previous session to try to add organizations to the Council. They haven't been very successful.

Chairman Ruby: I thought that one was attempting to thin down the number of representations.

Representative Gruchalla: Did the Corn Council attempt to go on here to replace the North Dakota Farm Bureau? Is that why you asked to get on now because there is a vacancy?

Jeff Inger: Yes, we knew that there was an opening. We decided that it was a perfect fit for our organization, especially with the infrastructure issues that we are dealing with today of the roads, railroads, and grain elevators. It is critically important for us to be involved in this.

Representative R. Kelsch: Wouldn't you be included in the North Dakota Grain Growers Association?

Jeff Inger: I don't believe we are.

Representative R. Kelsch: Isn't corn considered a grain, or is that only the wheat, barley, and flax?

Jeff Inger: I believe that it would be wheat, Durham,

Representative R. Kelsch: It just seems redundant. We have Grain Growers, which I thought that corn would be considered under that. Then we have the Wheat Commission, which also seems to be redundant because wheat is considered under the Grain Growers. I don't know just how that works.

Jeff Inger: I don't believe that soy beans are under the Grain Growers either.

Chairman Ruby: It is a good question. You don't have any affiliation with the Grain Growers at all?

Jeff Inger: No.

Chairman Ruby: Do you have an amendment drawn up with that?

Jeff Inger: No, we don't.

No further support for HB 1200.

There was no opposition to HB 1200

The hearing on HB 1200 was closed.

Representative R. Kelsch: We have had this subject matter in this committee before. We talked about adding new group members. You probably thought that this hearing would be more contentious than it was because that is the way it has been in the past. I thought that the Corn Growers would have been included in the Grain Growers, but if they are not it would be worth our consideration. Corn is being used extensively for ethanol and potentially has more transportation issues. I would like to have heard more justification about why they wanted to be a member of the Upper Great Plains Transportation Institute.

Chairman Ruby: I believe there was one more that was planning to request, but they couldn't get approval from their board in time. They may not be the only that want to be part of this Advisory Council. I think that corn is probably important because of the other uses.

Representative R. Kelsch: I guess if we are taking one off and putting one on, they may not be equal, but at least it would be new voice.

Representative Weisz: We tried a few sessions ago to look at the list to see what is reasonable. Those efforts failed. You could add everyone on there. I think we should open it to let everyone on by adding another 5-7, or leave it the way it is. The committee needs to decide if we add anyone and everyone. There are a lot of Agricultural groups, and every one of them needs to move their products. I would recommend that we accept the original bill, and I would be leery of adding other groups because I don't know how you turn anyone else down.

Representative Gruchalla: This is a voluntary organization. It doesn't cost any tax dollars to be on here. I think that groups want to be on here to have a voice in what is going on in transportation. I think that is what we should do.

Chairman Ruby: There is the question that Representative Weisz brought up. How many more do we add?

Representative Onstad: At this point there have been no additional requests, so, I think that we should honor the request of the Corn Growers. It is a voluntary situation.

Representative Hogan: I would be interested in knowing what the Upper Great Plains Transportation Institute thinks about the size of the Advisory Council. If you have any feedback from them about the use of the council, and if they think the size is right, I would be interested in knowing that.

Steve Stregee, North Dakota Grain Growers: The Institute was organized in 1967, and the focus then was agricultural commodities exclusively. It started out with the North Dakota Chamber of Commerce, the PSC, Farm Bureau, Farmer's Union, Wheat Commission, North Dakota Grain Growers, Motor Carriers, Stockmen who later asked to be taken off, and Aeronautics. The ones that have been added in the past ten or twelve years are Department of Transportation, Department of Ag., AGC, Association of Counties and League of Cities, Lignite Council, and the Dakota Transit Association. There is really no limit on the number of people that can be on it. It did start out all Ag., but now it has been diversified.

Russ Hanson, Associated General Contractors and serves on the Advisory Council of the Upper Great Plains Transportation Institute: The policy decision about the number is clearly in your hands. The Council has no position on this bill. In the last couple of years there has been no discussion about the size of the board.

Chairman Ruby: Do you think there will be a concern about the size of the board because of numerous groups wanting to be part of this?

Russ Hanson: I don't think so. We meet twice a year, and it is voluntary. There is no payment to those that meet.

Representative Gruchalla moved the amendment to add the Corn Growers.

Representative Onstad seconded the motion.

Representative Vigesaa: I am going to support the amendment. The corn industry in our state has grown at a tremendous rate in the past four to five years. They have transportation issues.

A voice vote was taken on the amendment. The motion carried.

Representative Heller moved a DO PASS as amended for HB 1200. Representative Hogan seconded the motion.

Representative Heller: In the bill it says that they may receive reimbursement. Does that ever happen, and if so, where does it come from?

Russ Hanson: For the time I have been on there, it has never been offered or discussed. I would assume it would come through the agency's budget, if it was paid.

Representative R. Kelsch: I think that the language was put in there in case there ever was money, but there has never been an appropriation. It was standard language when this was written.
