Explanation or reason for introduction of bill/resolution:

A resolution of no confidence in the NRCS's state conservationist and urging the United States Department of Agriculture 's NRCS to continue the cooperative agreement process at a \$10,000 funding level; allow continuation of local decision making, and to allow a coordinator with a regional council to maintain that collocation.

Minutes:

Representative Schmidt Co-Sponsor: (pamphlet #1)

have two Resource Conservation and Development councils in my area. I have been an NRCS employee for 33 years. In those 33 years, I was an RC&D coordinator. I was the RC&D program manager in Alaska for nine years and in North Dakota for four years. I now sit on the Dakota Prairies RC&D representing Morton County Commissioners. I was recently elected to be the State RC&D Association President. In that capacity I follow the direction of that association. We also have a regional association that covers about 13 states. There is also a national RC&D Association. In 2007 the NRCS received a national award for its cooperation with the RC&D program from the national RC&D president. There are eight RC&D councils in the State of ND. One of the values of me standing here is to inform you of this program and its value to the people. This is a federal program led by the local people. They receive a federal employee. As an RC&D council, they have the day to day direction of a federal employee. Having been the supervisor of those employees for 14 years, it was difficult because I didn't have control of those individuals for day-to-day activities. RC&D Councils do. The eight councils mirror the regional councils. In some cases four of those councils are the same: Minot, Grafton, Williston, and Fargo. The other four are stand alone. What has occurred as that part of that locally-led process, the NRCS has entered into cooperative agreements with the RC&D councils. Those funds received, about \$10,000 over the last five or six years, were used by the council.

(See attached #3) The RC&D councils took \$45,000 and used it to support and stimulate other activities, about 73 on the sheet. They assisted over \$2 million worth of projects. They are all locally led and determined by the council themselves. The RC&D councils have the state association. Each council has two representatives on the state association. The NRCS has decided to not enter into cooperative agreements with the RC&D council as it has been done in the past. The councils did not receive any cooperative agreement funding last year. We had no opportunity to proceed with projects. Most projects are

community development projects like those on reservations. Where there are four RC&D councils collocated with regional councils, we were going to move those four coordinators.

Those are the three scenarios:

- 1. Cooperative agreements
- 2. Ability to use community development funds
- 3. Keep those four coordinators with those councils unless the NRCS and the council decided jointly to move them.

In July at a state association meeting, the NRCS laid groundwork to not include cooperative agreements. I've given a packet of letters (See letters #2) sent from RC&D councils to Mr. Sweeny, State Conservationist, asking him to reconsider and to put the cooperative agreement funds back in.

The State of Montana, South Dakota, and Minnesota all do these cooperative agreements today. Two of those states were copied after North Dakota. Each state gets the same amount of money. Those three states can support cooperative agreements. But in ND we cannot. After those letters were written, I had discussions with the national office and was given direction by the RC&D council presidents in a vote of 7-0 to proceed, produce, and develop the resolution in front of you. The one council not present was from Jamestown. The other seven voted unanimously. I've been in contact with the NRCS national office. This is from the answers they gave us. The RC&D association works from the direction of the council presidents. The council presidents may or may not be communicative with their RC&D council members. They are elected representing those councils.

There was an effort by Mr. Sweeney and NRCS to meet individually with each council. He has met with five different councils. Out of the five councils, four of them want to continue to push the resolution. He met last night with the people in Minot. Margo Helgerson is their president. She emailed me after the meeting. (See attached #4)

Even though we have tried to resolve these issues, there has been nothing concrete done other that words to the council presidents. The council in my area, Dakota Prairies RC&D, sent an email. It is from Deborah Vollmuth. (See attached #5)

I've been an NRCS employee for so long and know what the program is, it is a situation where it is myself against Mr. Sweeny. I have a letter from Doug Graupe in Williston. (See attached #2d) (Read from first paragraph).

I don't want to take an agency to this type of activity. We can't come up with concrete with written documentation that resolves the issues of those council presidents.

Representative Mueller: It sounds like discontent in the camp. Anyone have a sense of what the plan is of the State Conservationist?

Representative Schmidt: His original discussion with the RC&D Association was that he wanted a granting process. The RC&D councils would submit projects to him that he would review and determine whether or not to fund. They thought that was in conjunction with the cooperative agreements. We found out later in a letter, that he sent to all the councils, that

it was not. It was just the grants. It was taking the decision making from the local councils and putting it in the hands of the federal government. The council presidents felt that was usurping the grass roots effort for which this was established by Congress since 1968. There is some conflict within some of the councils. That conflict needs to be resolved between them and their presidents.

We do not have any cooperative agreements for this fiscal year. Other states do.

Representative Conklin: Is this all of your funding?

Representative Schmidt: No. The RC&Ds get funding from other places. It is local decision making with those dollars. That is difficult for the federal government to accept.

Helen Schatz, Past President of the State Organization of RC&Ds and Past President of Dakota Prairies:

I am in agreement with Representative Schmidt. We do a lot with a little. We are helping with the ambulances, no-till, animal waste systems, etc. We are all volunteers.

Dan Wogsland, Executive Director of ND Grain Growers Assn: We support this resolution. Orderly development in rural ND is a good idea.

Opposition: None

Representative Schmidt: I visited with some of you this morning about this resolution.

(Reads from email of Thomas Christianson, Washington, DC who is the Supervisor of NRCS State Conservationist):

At this stage it is very important I leave the resolution a specific partnership and programmatic issue as much as possible to the State Conservationist in partnership with the RC&D council leadership. Given your previous career with NRCS in multiple locations, I know you recognize the critical importance of avoiding top-down mandates or decisions from regional or national leadership. I desire win-win solutions that accomplish the mission of the RC&D program, keeping with our authorities and responsibilities and meet the needs of local RC&D councils to best of our abilities.

Another words he is not going to do anything. We are to deal with the State Conservationist on our own. This resolution is to bring notice. We need your help.

Representative Boe: That paragraph indicates to me that this resolution is going to hit File 13.

Representative Schmidt: Where it goes, the program RC&D councils are designated by the Secretary of Agriculture. Only the Secretary of Agriculture can designate an RC&D council. Only the Secretary of Agriculture can eliminate a council. That is where the authority lies. I was told last night that the chief of the NRCS has not been told of this resolution at all.

Representative Mueller: I think there are other issues that go beyond some of what we have heard. One of the concerns I had voiced in an email is that the resolution isn't

speaking for all of them. But I don't think the resolution says that you are speaking for all of the councils.

Representative Schmidt: No it doesn't. As president of the association, that is our role to speak for all the members as directed by them. The email you reference to is from a council member. I have an email from that council president. His name is Bob Curl. (Reads from email)

Mr. Sweeney, our State Conservationist, has told us we can't use these support and stimulation funds for anything but soil and water conservation projects. You've seen the project list the other funds have been used for.

(Reads email from Bob Curl to Thomas Christianson, January 9, 2011)

Myself and the entire council are at our wits end not knowing what to do for funding in this new year. I would be thrilled to hear from your office as to what we might do to convince Mr. Sweeney that the system we are using works.

So while the resolution doesn't say it represents all of the councils, it is put forth from the association which does.

Representative Mueller: My position would be that it's better not coming from all of the councils. It isn't generated by the councils because not all are seeing it the same way you are. It is easier for me to support the resolution when it doesn't say all eight councils are talking about this.

Representative Schmidt: No it doesn't.

James Schmidt: Rep Dist 31 and Sponsor of House Concurrent Resolution 3027 (Attachment #1 and #2)

Senator Murphy: Any word out of Washington DC that some of these funds cut back for the RCSis that a possibility?

Schmidt: The idea to start cooperative agreements moving it into contribution agreements was done long before the situation with congress as we have it today. You will see in the resolution there is a line relates to they will continue with cooperative agreements (line 14) including implementation the community development projects for as long congress funds the program. So if congress does not fund the program, it is a different issue. The idea to go to contribution agreements was long before we are in the fiscal agreement we are in now.

Senator Klein; We have seen many resolutions throughout the years, I see we are sending this off to Washington and people who should have a concern....with you letter from you agency, you people worked this out. Do you feel confident enough that you are making a bold enough statement?

Schmidt: I feel we could/should make a more bold statement. This resolution is going to the Secretary of Agriculture because he is the only individual who can designate or withdraw RC&D authorizations. We have taken a cooperative position.

Senator Klein; There are other issues that arise as it relates to this organization in the fact could potentially possibility as MN has a better way of presenting; whereas ND is hinder by our actions of these spokes....why are the rules different from state to state? That is why I am going with "bolder".

Schmidt: In RC&D receives its dollars programmatically.....each program stands alone. The RCND program stands alone and you are correct as there are other issues There are 4; this is one of the four. This program deals with Resource Conservation and Development dollars....different programs and we are looking for to combine these four efforts into one, but had to keep this separate because of the different program.

Senator Murphy: What is Mr. Sweeny's rational in his decision?

Graupe: No answer.....no rational

Senator Heckaman; Will this resolution get you where you need to be.....will it make Mr. Sweeny change his the way he makes decisions?

Graupe: I can only be hopeful that he will change his mind. Some feel that once this is over, he will continue his plans. We can only hope he will do that. Asked the secretary to go back 20 to the cooperative agreements we had.....never has one of the state conservationists questioned the ability of the local board to make the decision. The local boards are given guidelines and make decisions on the federal guide lines.

Senator Klein; Have you been with this group for a long time? You see a lot of conservationist come and go....obviously this gentleman is new and things are beginning to slip.....and the new guy came to town?

Graupe: Yes ...came in with a new approach, completely different from previous conservationists. Perhaps other information you should know is Ag Commissioner Goehring approached him to use equip funds to help farmers with the barrier around the field tanks and he didn't get an answer. Therefore he went to national office and he was scolded by the state con....said if he wanted talk to him, you must go through me. All other state cons have been so cooperative.

Senator Klein; The conservationist from around the country didn't get together to approach this differently as national agenda?

Graupe: No change federally. State con Floory, who just left a short time ago...extremely cooperative.

Senator Klein; Mr. White in charge of the organization is coming to ND sometime this year to visit about issues. Is your organization planning time with him?

Graupe: I am sure we will and would appreciate the opportunity.

Duane Urlacker: President of Dakota West RE&D Council, Dickinson (Attachment #6)

Mary Stevens: Executive Director for Dakota Prairies RC&D Bismarck: I've been with the organization for 12 years, cover 10 counties. We have grants that we jointly manage for 18 counties. We had a state wide weed grant that we managed for all the RC&D in the state. We assisted in over 50 projects There are 4 core areas we can work in....one is community development grant and have the NRCS state conversations come in to we cannot fund those projects that is taking away something in our program. Our council is in full support of this resolution and voted to carry forward with this. By not moving forward, we are sending a message that all has been solved.....this is not happening. We urge you to vote in favor of this resolution.

Senator Klein; We have heard everyone is in favor of thisa few comments in oppositiondo you know why we would be getting any opposition? It sounds like a good resolution....why would we hear from anyone who would think we should continue on the same path?

Stevens: I have not seen the emails.....every issue has pros and cons....maybe the state conservation has negotiated with councils or individuals who we want to see the council involvement. That wasn't happening before this resolution.

Helen Schatz: Dakota Prairies RC&D Burleigh County (Retired County Commissioner) We are a 10 county wide council. Talked to a Commissioner from Grand Forks and asked what the bases of her email was to this committee or members in opposition to this resolution. She explained it was because the state con had been in there and discussed reason....budget and would not relieve them of their coordinator...moving them. Assumption the state con is going around and convincing the councils that he is will do the best he can....playing one council against another. Mr. Floores helped tremendously and other states modeled their program after ND. Support the HCR 3027 resolution.

Senator Klein; I am not looking at the down side and I am sure of where we are trying to go. Do you see any down side, retribution....?

Helen Schatz: No, I read it this morning....I don't see any down side......when I talked to the commissioner and she was concerned about forming an opinion without hearing both sides. I agree to putting more teeth in the letter.

Senator Larsen: What are his thought with him on dividing did you discuss this with him?

Schatz: Other states have modeled their programs after ND program. Haven't met him met him face to face. He avoided meeting with the group.....they asked him to meet with them and they want reasons why.

Answer as to why some are against the resolutionthe state conservation is promoting contribution agreements instead of cooperative agreements and the RC&D council does not understand the difference. He has been promoting those since September.....has not entered into one agreement since then. Hasn't drafted one or any other. The people in the RC&D council are not understanding or knowledgeable of the program to the depth to be able to discuss that. He has had experience peripheral with the program before he did this.




RC&D councils receive assistance from NRCS and many other partnering agencies and organizations. Priorities and policies are established by local people.

Mr. Sweeney:

I would like to take the opportunity, on behalf of the Upper Dakota RC&D, to communicate our discontent with direction you are attempting to impose on our District. After meeting with you and your colleagues last month, the RC&D Executive Board had time to reflect on the issues discussed and now at our most recent Executive Board meeting has asked to me express the unanimous feelings regarding the future actions you are attempting to impose. The Upper Dakota RC&D can be a valuable resource for the citizens of this area, and it is the Board's hope that can continue and even be enhanced in the future.

First, your proposal to physically relocate the office of the Upper Dakota RC&D is utterly without merit. It may be your prerogative to locate the Coordinator to a place of your choosing, but it is not your prerogative to relocate the offices of the RC&D. The Upper Dakota RC&D is a non-profit organization registered as such under the laws of North Dakota with a C-4 designation from the IRS and further designated by NRCS as the RC&D for this region of the State. Your planned actions over step any authority you think you have in this matter. It is the authority of the District Board, who are the Upper Dakota RC&D, to decide where to locate their office. While not consulting District prior to your proposed action, you may have found better alternatives. The RC&D recognizes the co-location of the office with the Regional Planning Council is the best alternative. Both staffs work with the development of the region's resources and have similar work plans and goals. The current situation promotes a partnership that is beneficial and effective to both organizations. If consulted you would have been advised of alternatives to office space in the current location. Relocating the Coordinator jeopardizes the achievements and future success of our organization.

With respect to your recent decision to "discontinue the present format of cooperative agreements", the District Board has determined that is not an action that is conducive to the continued success of the RC&D program in North Dakota. Your proposed actions totally remove the local decision-making process that has proven successful and transferred to it a more bureaucratic process. Our District Board does not believe that prioritization of projects conducted by federal government staff, with no tie to local input, will be effective. What has been effective and successful is allowing the District to determine the best investment of NRCS resources and the leveraging of those funds to develop and enhance local projects.



It is our hope that you will seriously consider the input of the Upper Dakota RC&D on these issues, and that your current plans can be altered. Our District at any time would be more than accommodating to discuss these issues further and offer any advice.

THAT HE WILL NOT RE-LOCATE THEIR RCD COORDINATOR, WHICH WAS HIS PLAN PRIOR TO THE RESOLUTION.



I would like to take the opportunity, on behalf of the Upper Dakota RC&D, to communicate our discontent with direction you are attempting to impose on our District. After meeting with you and your colleagues last month, the RC&D Executive Board had time to reflect on the issues discussed and now at our most recent Executive Board meeting has asked to me express the unanimous feelings regarding the future actions you are attempting to impose. The Upper Dakota RC&D can be a valuable resource for the citizens of this area, and it is the Board's hope that can continue and even be enhanced in the future.

First, your proposal to physically relocate the office of the Upper Dakota RC&D is utterly without merit. It may be your prerogative to locate the Coordinator to a place of your choosing, but it is not your prerogative to relocate the offices of the RC&D. The Upper Dakota RC&D is a non-profit organization registered as such under the laws of North Dakota with a C-4 designation from the IRS and further designated by NRCS as the RC&D for this region of the State. Your planned actions over step any authority you think you have in this matter. It is the authority of the District Board, who are the Upper Dakota RC&D, to decide where to locate their office. While not consulting District prior to your proposed action, you may have found better alternatives. The RC&D recognizes the co-location of the office with the Regional Planning Council is the best alternative. Both staffs work with the development of the region's resources and have similar work plans and goals. The current situation promotes a partnership that is beneficial and effective to both organizations. If consulted you would have been advised of alternatives to office space in the current location. Relocating the Coordinator jeopardizes the achievements and future success of our organization.

Some time ago I e-mailed you in regard to an issue here in ND with our state conservation coordinator, and his lack of funding the eight councils in ND.

Apparently I did not have your correct e-mail address, and I am sorry for the tech. problem.

Never the less the issue with funding is still at hand, with Mr Swneey, and none of the councils in ND have a handle on funding in this new year. To the best of my knowledge the funds for RC&D,s are in place, but for some reason Mr Sweeny will not release them to the councils. In the past ten years or more, each council has been allocated the total funding of \$10,000, no more no less, that we designated as support and stimulation funds. These funds were to be used for any projects, within the councils plan of work, that the councils deemed fitting. councils in our state work with small communities, as small as 50 to 70 people, that have problems with their small inferstructures that must mandate federal regulations, and have literally have no one to turn to, but they know RC&D is about community projects, and they ask for some help. To me community projects, big and ever so small, are what RC&D is all about. To us here in the great plains, PEOPLE are our greatest ASSET!!!. Mr Sweeny has told us we cannot use federal funding for community projects.

This is a fact. In the years of 2009 & 10, the eight ND councils turned \$42000 of S&S and coop agreements into 2.2 million dollars into the economy of our state. This was done with only 73 projects. I have an idea that at least a fourth or perhaps a third of the 73 projects were "Community projects".

Myself, and my entire council are at our wits end, not knowing what to do for funding in this new year. I would be thrilled to hear from your office as too what we might do to convince Mr Sweeny that the system were using works, and please let us carry on our work.

I volunteer to serve on them because I believe in what these organizations do for ND farmers and communities, and because I enjoy the opportunity to work with others who have similar beliefs.

The incredible irony in this resolution is that as it is being debated, the national RC&D Council program is in a fight for funding through the NRCS 2011 Fiscal Year Budget. As you are aware, the U.S. Congress can't seem to get its fiscal house in order and is financing agencies using continuing resolutions. At this time the House Budget has cut all funding for RC&D Councils. The Democrat version of the Senate Budget including a 50% level of funding. So all of the dollar amounts in this resolution are speculous at best!

I am incredibly disappointed in this resolution. And disappointed it made it to your Chamber!

Let me give you some background. The disagreements between Mr. Sweeny and the RC&D Councils revolve around internal policy disputes regarding office space and rent for a couple of Councils, and also use of grant dollars, both of which are provided to RC&D Councils by NRCS funds, which Mr. Sweeney administers. Councils were concerned, and a couple of them upset, by the decision of the State Conservationist to change the way "we had always done things."

I was part of a meeting with Mr. Sweeny on November 23, 2010 where members of several Councils met with him to express those concerns. After listening to us, Mr. Sweeny agreed to amend his decision on distribution of the grant dollars that are referred to in this resolution. ND RC&D Council President Jim Schmidt was directed by the group to continue working with Mr. Sweeny on the issues of concern so they could be resolved.

Instead of working towards resolution, letters and emails with accusations started flying around! Apparently a conference call of Council Presidents was convened in January where Mr. Schmidt discerned that he needed to introduce HCR3027. This resolution is just the wrong way to go about dealing with those disagreements. Rather, it may prove to be an embarrassment to our RC&D Councils, damage the working relationship we have with Mr. Sweeny, and needlessly impugn his personal and professional integrity. And it is hardly helpful in the goal of securing ongoing federal dollars for North Dakota's RC&D Councils.

In a phone conversation with Rep. Jim Schmidt, he insists he is pursuing this at the behest of 7 of 8 RC&D Council Presidents. I can assure you that the Northern Plains RC&D Council has never passed a motion supporting HCR3027. We met on January 24th and it was never brought to the meeting. After a few phone calls, I am not sure just which RC&D Councils, not just a president or officer, have in fact read this resolution as it written, had a meeting and discussion, and then taken a vote of support of it

Mr. Sweeny has visited with our RC&D Council at a meeting to listen to our concerns and discuss his goals for the ND RC&D Councils, and to give us suggested directions to pursue. He also had a follow up meeting with our Council President and a couple of other members. From discussions held with Council members in other states, Mr. Sweeny has been quite a champion of RC&D Councils through the years!

I did some research on NRCS operations in ND. Did you know that NRCS Conservationist Mr. Sweeny oversees about 302 employees in all categories of positions (permanent and temporary)? Eight of those employees are assigned to work with our RC&D Councils. In addition they have started a new recruitment effort at NDSU, DSU, BSC, UMary and Crookston and have a crop of about 16 new student interns that will be reporting to duty around the state this summer. That is a key part of finding good jobs for our young people and keeping them in our state.

Mr. Sweeny oversees an NRCS budget of over \$100 million. Because Federal agencies are operating under a Continuing Resolution, here are the final budget numbers from Fiscal Year 2010:

For FY 10 technical assistance (operating costs such as salaries, rent, computers, fleet, equipment, supplies, etc.) was \$30,917,486.

For FY 10 financial assistance (funds to program participants such as EQUIP, WSP, WHIP, and CSP) was \$86,761,486. That is funding that goes primarily to farmers in the state!

Just for some perspective, while our RC&D Councils do some excellent things in ND, the Councils' piece of the NRCS budget for the state, at about \$1 million, is less than 1% of the total annual NRCS expenditures!

Do you really think it is appropriate to ask the ND State Legislature, on behalf of the citizens of North Datkoa, to declare "no confidence" in the head of a Federal Agency that is so critical to conservation efforts in ND, and to the income of so many farmers, over an internal policy dispute regarding a couple of RC&D Councils.

Please give HCR3027 a Do Not Pass recommendation from the Senate Ag Committee.

Dear Members of the Ag Committee

Thursday morning I understand you will be holding a hearing on the resolution from the House in regard to the State Conservationist.

My name is Doug Graupe and I am a Divide County Commissioner. I have served in that capacity for 28 years. I am also a member of the Williston Basin RC&D council serving as it's President. I am writing in support of the Resolution and I will state my reasons why:

- 1. Mr. Sweeney proposed ending our Cooperative agreements and replacing them with competitive grants. We have worked many years through our State Association to have our Support and Stimulation be equal to each of the eight councils in the State of North Dakota. This has worked well and the local board members are able to make decisions that work best for their area. I asked our secretary to go back 20 years and all of the previous State Conservations have allowed our local Council to make the decisions based on the Federal Guidelines. Changing this policy would place the decision making in the hands of a federal bureaucrat. Our board members feel that they would no longer be needed.
- 2. Williston Basin RC&D shares office space with the Tri-County Regional Council. Tri-County Regional Council has spent \$80,000 to update the building to meet ADA requirements. This has worked so well in the past as our Coordinator and the Executive Director of Tri-County share ideas. This helps both organizations. It saves Williston Basin RC&D money as the rent is cheap and we use Tri-Counties Secretary when necessary. Mr. Sweeney last fall stated he was going to move our Coordinator. After confronting him last November 23 and again January 27 he has put that on hold. I haven't heard him say that we can stay in our office permanently.

I plan to be in Bismarck and attend the hearing. If you have any questions I will try to answer them. Thank you
