MINUTES:

Chairman RaeAnn Kelsch: We will open the hearing on HCR 3029.

Rep. Dave Weiler: Sponsor. The North Dakota Close-Up is something they do so kids can learn how government works. This is a resolution to proclaim February 14th as North Dakota Close-Up Day. It is a great program and I hope you will support it.

Chairman RaeAnn Kelsch: Why did you pick Feb 14th? It is Valentine's Day and I was wondering how it fit with that or was it just a random day you picked?

Rep. Dave Weiler: Every year leading up to session the person in charge of the program calls me up and asks me to sponsor this piece of legislation. They already have the dates chosen. You will have to ask him that.

Rick Heidt – Coordinator, North Dakota Close-Up Program: I am the coordinator for the North Dakota Close-Up Program and the reason for choosing that day was because of the scheduling conflicts with state basketball etc.

Chairman RaeAnn Kelsch: I think the only committee that has any hearings on Monday is the finance and tax committee. Otherwise everyone is done with their hearings. You might want to think about that in getting them in earlier.

Rep. Dennis Johnson: That was going to be my thoughts on picking a specific date. Rather than a specific date maybe the first Monday or the second Tuesday could work better.

Vice Chair Lisa Meier: Can you tell us a little history on Close-Up?

Rick Heidt – Coordinator, North Dakota Close Up Program: We are usually limited because of hotel space and activities. One time we were close to 200 kids coming. We have to look at that. Testimony attachment.

Doug Johnson – Executive Director, NDCEL: We are here to support HCR 3029. The NDCEL has sponsored this for the last ten years. DPI had run the program prior to that and decided they could no longer afford to take that on so we decided to take that on as a responsibility. It is a very comprehensive program that the kids are exposed to. You brought up the scheduling of this. We have had numerous discussions about this. Particularly on the odd number years we want to get to town and we realize it is important to get them here early but there are hotel conflicts and things like that. This is a very good exposure for the students that get together.

Chairman RaeAnn Kelsch: Questions?

Rep. Mike Schatz: I find it unusual that DPI doesn't sponsor this anymore. They claim they don't have the money. I bring this up because they used to also sponsor a quiz program for social studies and they got rid of that too. I'm looking at their budget and I'm think these were important things to me as a social studies teacher. Why has DPI chosen to get rid of them?

Doug Johnson – Executive Director, NDCEL: My understanding is the administrative side of that and costs they have incurred. We are getting some money but that money doesn't come directly to the NDCEL. I think there was a staffing issue for DPI. They are still deeply involved with sending people there help out with the program.

Chairman RaeAnn Kelsch: I can probably tell you a number of reasons and one was that we, starting in the 90s and 2000s, started cutting back and cutting back in that department and cutting staff from that department.

Rep. Mike Schatz: If I were going to remove some of those things those are some of things I would not remove because that affects kids.

Chairman RaeAnn Kelsch: And we had no authority on what they decided to give up. We as legislators took FTEs away from them.

Rep. Dennis Johnson: When we were considering changing the time frame when we were going to have this, what should we be looking at? Or what are your thoughts on that?

Doug Johnson – Executive Director, NDCEL: I think it will be driven by available hotel space here in Bismarck. We book those two years in advance. We've been backing up the dates. We were later in February and have moved up.

Rep. Bob Hunskor: Is there a National Close-Up Program and if so does each of our schools communities send delegates and how many?

Doug Johnson – Executive Director, NDCEL: Yes they do have National Close-Up. Any district is eligible to do that. We do have a fairly large contingency of students that go out to DC. More students went to the nation than the state.

Chairman RaeAnn Kelsch: It must be that not everyone goes at the same time.

Rick Heidt – Coordinator, North Dakota Close-Up Program: There are weekly programs and they sign up for a week. There are programs that last a little longer that include trips to New York and things like that. That is part of why we lose students in the state program. They make a choice because of money and other factors. I think we lost 20-30 students when they found out when regional basketball was. We've looked at other times and it hasn't worked.

Rep. Bob Hunskor: The expense for these kids to come here is taken care of by the district and when they go to Washington D.C. the district doesn't pay for any of that. Is that correct?

Rick Heidt – Coordinator, North Dakota Close-Up Program: Yes the school usually takes care of that. The money they send us for an enrollment fee goes to the fees. They get hotels for two nights and meals for Sunday, Monday, and until noon on Tuesday. All transportation is included in that. The national program is quite a bit more expensive so the kids do fundraising within their school district for that.

Chairman RaeAnn Kelsch: Questions? Support? Opposition? What are the wishes of the committee?

Rep. Phillip Mueller: I move a do pass on HCR 3029.

Rep. Joe Heilman: Second.

Chairman RaeAnn Kelsch: We will take the roll. We will close on HCR 3029.

dam Chairman and members of the House Education Committee:

My name is Rick Heidt, coordinator of the North Dakota Close Up Program. I am here to testify regarding the House Concurrent Resolution 3029. I would like to share some information about the Close Up program with you.

The North Dakota Council of Educational Leaders, in conjunction with the Tesoro Refinery and the National Close Up Foundation, are sponsoring North Dakota Close Up for its twenty-fifth program year.

Approximately 95 high school students and 17 teachers from around the state will be in Bismarck on Sunday, February 13 to participate in the 2 day event held at the State Capitol and the Doublewood Inn.

The purpose of the Close Up program, as this resolution states, is to ignite an interest in the democratic process and to instill young people with the desire to become active participants in government. Close Up North Dakota concentrates on the functions and structure of state government and defines the constitutional responsibilities assigned to each of the three branches of government. The media and special interest groups, both major influences affecting government policy, are also examined.

For democracy to succeed, it is vital for citizens to take an active interest in their government. One way to develop this relationship is by participating in Close Up programs. In 1972 the Close Up Foundation -- the nation's largest civic education organization -- began to sponsor such programs across the country and around the world, and has involved students, teachers, community leaders, and other adults. Close Up programs provide students and other participants with opportunities for citizenship education and direct involvement in the democratic process.

An impressive roster of speakers is scheduled to assist students to simulate the legislative process. Issues surrounding youth and their interest in North Dakota as a workplace and home are the basis for bills that are to be proposed to a mock legislative hearing committee on the final day of the program. The focus of the "mock hearing" this year will be the efforts of the legislature to address the "bullying" issue in ND schools and communities. A "Meet Your Legislators" hour will take place Sunday, February 13 at 7:00 PM at the Doublewood Inn; students will have a chance to meet and discuss these issues with their legislators.
