Senator G. Lee opened the hearing on SB 2061 relating to nonresident motor vehicle registration fees and motor vehicle excise tax and to amend the section relating to temporary registrations.

Linda Butts, Deputy Director for Driver and Vehicle Services at the North Dakota Department of Transportation (NDDOT) said that the NDDOT have been involved in this temporary registration process since last summer when they worked with Senator O'Connell, chairman of the Safety and Transportation Interim committee. When they met, there was concern expressed about the lack of temporary registrations that were being sold. The temporary registration was not of huge interest until North Dakota had the oil explosion activity going on in oil country. Senator Lyson introduced SB 2061 to address this situation and the NDDOT had also been working on a bill and a process to backup the bill. They have been working with Senator Lyson to merge the bills into one that addresses the issues that both Senator Lyson and NDDOT thought needed to be addressed. She said that she talked with him yesterday and his plan was simply to kill SB 2061 and present a merged bill that Legislative Council is presently working. That merged bill will be brought before this committee for a hearing in the future.

Ms. Butts stated for the record that she opposed SB 2061.

No additional testimony.

Senator Lee closed the hearing on SB 2061.

The committee will not act on SB 2061 until they see what the merged bill looks like.
