Chairman Keiser: Opens the hearing on 2243.

Representative Kreun: Introduces the SB 2243.

Cliff Keller~North Dakota State Board of Registration for Professional Engineers and

Land Surveyors: (See attached testimony 1).

Representative M Nelson: Could you explain how those are used in surveying?

Cliff Keller: They are used as additional tools in determining fixed points on the land. They are scientific methods that have been developed and the surveyors have been using them and they have not been in the legislation.

Representative M Nelson: If somebody wants to put drainage tile in a field, does that make them a surveyor, engineer or both?

Cliff Keller: Something like that could make the one or the other.

Chairman Keiser: Anyone else here to testify in support of SB 2243.

Curtis Glasoe~NDSPLS Legislative Company-Chairman: (See attached testimony 2).

Representative M Nelson: The education is required for a land surveyor, what would that

be?

Curtis Glasoe: What I understand now, there are no education requirements but there is education that counts as experience. You need 8 years of experience at a certain level in charge and that can be the 2 & 4 years schools with enough math and science that would qualify as experience.

Representative M Nelson: To get this experience, do you work under another surveyor?

Curtis Glosoe: Yes, you have to be in responsible charge but also working for someone who is licenses for that experience.

Representative N Johnson: The new section in 3, that's adding it to the exemption part of the legislation if you are using the GPS for your crops you are not considered an engineer or a land surveyor at all?

Curtis Glosoe: Yes, the intent is either you are an engineer or a land surveyor.

Representative Ruby: Under this language, am I allowed to do this on my own for slopes in my business?

Curtis Glosoe: Yes, but I would caution you to make sure that it's on your property and you are following your land permits.

Representative Boe: Do you know what the number of professional land surveyors we have in North Dakota?

Curtis Glosoe: Yes, approximately 300. There are 60 new ones and this is data from last fall.

Representative Boe: If we had a 10 year draft, would it be on the up or down grade?

Curtis Glosoe: On the upgrade.

Chairman Keiser: The states of Rhode Island and Connecticut are in a heated debate because the land surveyors missed the state line by a considerable margin, how far are we off in North Dakota.

Curtis Glosoe: In North Dakota, we are pretty good.

Chairman Keiser: With the satellite technology, do we now make a correction?

Curtis Glosoe: Where the corners were set originally are the rule.

Ken Link~North American Coal Corporation-Hazen-Mapping for 29 years: I do support this bill because the terms now used in the definitions are the terms that are used today in the surveying business. I ask that you pass this bill without any amendments. (See attached testimony 3).

SB 2243

Background Information

- There is a need for a new definition for the "Practice of Land Surveying".
 - a. The proposed definition brings the language in the North Dakota Century Code in line with national standards developed for the 21st century.
 - b. New technology has changed the method by which land surveying is practiced. The current definition was developed in 1957 at the time the law established the profession and revised in 1983 with almost the same intent but has never been updated to reflect evolving technologies. The 1983 definition remains the same today.
- The proposed definition does not affect other industries.
 - a. The proposed definition brings current practice into the technology being used today and reflects more clearly the technology and current methods the profession uses in today's work environment. Professional Land Surveyors have always performed and been charged with land boundary surveys so there is no new requirement to the public.
 - b. Resource industries such as the NRCS, USDA, US Forest Service, or North Dakota Game and Fish will not be affected by the definition change.
 - c. The agricultural industry will not be affected by this Land Surveying definition.
 - d. The proposed language does not expand on the scope of regulated activities so it will not affect the general use of Geographic Information System (GIS). GIS only falls under the regulatory requirements for professional land surveying if it is used for land boundary determinations or descriptions.
 -) The language of the proposed definition is language contained in a Model Law.
 - a. The language in the proposed definition is taken from the National Council of Examiners for Engineers and Surveyors (NCEES) Model Law. NCEES is an organization comprised of the engineering and surveying regulatory boards from all states and US territories. NCEES, in addition to promulgating and maintaining the Model Law, writes all of the national examinations used by every state and US territory for licensure.
 - b. The only changes to the Model Law language are minor terminology changes so the language is consistent with the rest of the North Dakota Century Code.

There is no effect on out-of-state land surveyors applying for licensure in North Dakota.

a. The language reflects the current practice of land surveying. The change does not preclude or prevent any individual from applying for licensure or create any unusual or burdensome requirement. The language comes from a Model Law promulgated by a national organization.

- 5) The change in the definition will not result in any additional costs to the public or government agencies.
- 6) The changes being proposed to section 43-19.1-27 clarify the areas where normal engineering activities and normal land surveying activities overlap. The change makes it apparent that a Professional Engineer performing normal engineering duties that a land surveyor may perform is not required to obtain a license as a Professional Land Surveyor to perform those duties. The same exemption is offered for Professional Land Surveyors who are engaged in normal land surveying activities that a Professional Engineer also performs.
- 7) There are four other statute changes that accompany the proposed definition change.
 - a. The change to the definition of "Practice of Professional Engineering" is to remove language that offers an exemption to engineering licensure within the definition itself. The Legislative Council has pointed out that this is an undesirable situation so the ND Board of Registration is correcting the language. This change is in 43-19.1-02 (7)-Definitions.
 - b. The exemption that is being removed from the definition of "Practice of Professional Engineering" is being relocated to 43-19.1-29-Exemption Clause.
 - c. The other change to 43-19.1-27 clarifies that there are some overlapping areas between engineering and land surveying. The change creates the ability for a professional to perform their duties without having dual licensure. This addition is in 43-19.1-27-Right to Practice.
 - d. To further clarify the differences between land surveys and engineering surveys, the definition of engineering surveys from the National Council of Examiners for Engineers and Surveyors *Model Law* has been added to section 43-19.1-02.

My name is Curtis Glasoe. I was born and raised in North Dakota, graduated from NDSU in engineering, spent two years in the US Army during the Viet Nam era. I have practiced engineering and land surveying for over 40 years in North Dakota, South Dakota, Montana, and Idaho. I have resided in North Dakota for over 50 years. I am currently licensed to practice Land Surveying and Engineering in Montana, South Dakota, and the Great State of North Dakota.

I am the National Society of Professional Surveyors (NSPS) Governor for North Dakota and the Legislative Co-Chairman of the North Dakota Society of Professional Land Surveyors(NDSPLS). This State Society is made up of over 260 members. There are approximately 300 Registered Land Surveyors and over 50 dual registrants in Engineering and Land Surveying in North Dakota. Some 170 of these registered people live and practice in the State of North Dakota.

I am here to testify in favor of SB2243 for the following reasons:

- 1. This Bill will bring the State of North Dakota survey definition in line with the Model Law for National survey definitions developed at the National level for all 50 States.
- 2. This Bill will also bring the survey definition up to date to include new technology like Global positioning sytems or GPS.
- 3. This Bill will clarify the limits of work done by either Professional Engineers and Land Surveyors, and the overlap of work within the professions.
- 4. This Bill will also clarify the use of GPS by all phases of industry, agriculture, recreation, and other users outside of Engineers and Land Surveyors.

I never really thought too much about overlap of the two professions. Being a Dual Registrant, I would be covered by one profession or the other during a project. This Bill makes it very clear to me which profession performs which tasks from planning to completion of a project.

Therefore, I urge this Committee to approve SB 2243 to update and clarify the Land Surveying and Engineering survey definitions, and bring them up to include today's technology. SB2243 will serve to get projects completed more timely and will result in a better, more economical product for the people of the Great State of North Dakota.

I am a Professional Engineer, registered in North Dakota since August 1986, a past president of NDSPE, and currently serve on the Licensure Qualifications and Practice Committee for the National Society of Professional Engineers (NSPE). I am, here today, on behalf of NDSPE to speak in support of Senate Bill 2243.

Our society was aware of the North Dakota Society of Professional Land Surveyors (NDSPLS) desire to update the definition of land surveying for some time. The North Dakota State Board of Registration for Professional Engineers and Land Surveyors (BOR) agreed to facilitate a discussion of these updates and formed a committee that included representation from all three entities. The result of this cooperative and collaborative effort is SB2243. NDSPE's president Dale Heglund and I both participated in this process. The discussions were exceptional as ideas were shared and everyone's concerns reviewed and debated. We started with draft language that contained many items included in the practice of the surveying profession, eventually opting to utilize the National Council of Examiners for Engineers and Surveyors (NCEES) Model Law language contained in SB2243. The committee process was very direct and deliberative, and I commend all who participated.

Concerns relating to cross over services between the engineering and surveying professions were debated and language revisions to address these concerns are included in SB2243. The result of this open communications process removed fences and established acceptable boundaries of agreement regarding our professional practices. On behalf of NDPSE we encourage the committee to give SB2243 a DO PASS recommendation.

Good Morning, my name is Dean Anagnost. I am the Chief Financial Officer, and Principal Engineer, for the firm of Kadrmas, Lee and Jackson. I am here today to speak briefly in support of SB 2243.

Our Council works closely with the State Board of Registration, and other professional organizations to insure that the registration laws governing professional engineering and professional surveying are compatible and complimentary, are written in the best interests of the public health and safety, and promote an ethical agenda consistent with our professions, as well as enabling the business of engineering and surveying consulting.

ACEC-ND was given the opportunity to be involved early on with the ND Board of Registration for Professional Engineers and Land Surveyors, offering input, while they crafted this proposed legislation found in SB 2243. As a result of the early interaction, we are able to support SB 2243 in the form presented. We believe that this legislation furthers the professions, and cooperation between engineering and surveying professionals by:

Implementing the Model Law language that structures the current laws in a manner compatible
with the growing technical and business needs of the 21st century. Model Law language is

- becoming universally used throughout the industry and across the other states and US territories. It is beneficial for the North Dakota professions;
 - Clarifies the definition of engineering surveys for engineers and surveyors and stresses that the
 primary role of the professional surveyor is to perform <u>boundary surveys</u> and related work;
 - Insures that there is no confusion regarding registration requirements in those instances when
 an overlap of duties and responsibilities occur on projects involving engineering, making it
 apparent that a Professional Engineer is not required to be a dual-licensee in order to perform
 services, other than boundary surveys, that may also be performed by a surveyor.
 - Eliminates unnecessary duplication in the law regarding exemptions.
- 10 In addition, as a leader of a firm that provides engineering and surveying services in over thirty-five
- 11 states, I would like to reiterate the importance of aligning definitions and standards, in the way that



a. The language reflects the current practice of land surveying. The change does not preclude or prevent any individual from applying for licensure or create any unusual or burdensome requirement. The language comes from a Model Law promulgated by a national organization.

- 5) The change in the definition will not result in any additional costs to the public or government agencies.
- 6) The changes being proposed to section 43-19.1-27 clarify the areas where normal engineering activities and normal land surveying activities overlap. The change makes it apparent that a Professional Engineer performing normal engineering duties that a land surveyor may perform is not required to obtain a license as a Professional Land Surveyor to perform those duties. The same exemption is offered for Professional Land Surveyors who are engaged in normal land surveying activities that a Professional Engineer also performs.
- 7) There are four other statute changes that accompany the proposed definition change.
 - a. The change to the definition of "Practice of Professional Engineering" is to remove language that offers an exemption to engineering licensure within the definition itself. The Legislative Council has pointed out that this is an undesirable situation so the ND Board of Registration is correcting the language. This change is in 43-19.1-02 (7)-Definitions.
 - b. The exemption that is being removed from the definition of "Practice of Professional Engineering" is being relocated to 43-19.1-29-Exemption Clause.
 - c. The other change to 43-19.1-27 clarifies that there are some overlapping areas between engineering and land surveying. The change creates the ability for a professional to perform their duties without having dual licensure. This addition is in 43-19.1-27-Right to Practice.
 - d. To further clarify the differences between land surveys and engineering surveys, the definition of engineering surveys from the National Council of Examiners for Engineers and Surveyors

 Model Law has been added to section 43-19.1-02.

SB 2243 Testimony

March 21, 2011

Chairman Keiser and Committee Members:

My name is Curtis Glasoe. I was born and raised in North Dakota, graduated from NDSU in engineering, spent two years in the US Army during the Viet Nam era. I have practiced engineering and land surveying for over 40 years in North Dakota, South Dakota, Montana and Idaho. I have resided in North Dakota for over 50 years. I am currently licensed to practice Land Surveying and Engineering in Montana, South Dakota, and the Great State of North Dakota.

I am the National Society of Professional Surveyors (NSPS) Governor for North Dakota and the Legislative Co-Chairman of the North Dakota Society of Professional Land Surveyors (NDSPLS). This State Society is made up of over 260 members. There are approximately 300 Registered Land Surveyors and over 50 dual registrants in Engineering and Land Surveying in North Dakota. Some 170 of these registered people live and practice in the State of North Dakota.

I am here to testify in favor of SB2243 for the following reasons:

- 1. This Bill will bring the State of North Dakota survey definition in line with the Model Law for National survey definitions developed at the National level for all 50 states.
- 2. This Bill will also bring the survey definition up to date to include new technology like Global Positional Systems or GPS.
- 3. This Bill will clarify the limits of work done by either Professional Engineers and Land Surveyors, and the overlap of work within the professions.
- 4. This Bill will also clarify the use of GPS by all phases of industry, agriculture, recreation, and other users outside of Engineers and Land Surveyors.

I never really thought too much about overlap of the two professions. Being a dual registrant, I would be covered by one profession or the other during a project. This Bill makes it very clear to me which profession performs which tasks from planning to completion of a project.

Therefore, I urge this Committee to approve SB2243 to update and clarify the Land Surveying and Engineering survey definitions, and bring them up to include today's technology. SB2243 will serve to get projects completed more timely and will result in a better, more economical product for the people of the Great State of North Dakota.

Chairman Keiser, members of the Committee, I am Michael Gunsch, Chairman of the Legislative Committee for the North Dakota Society of Professional Engineers (NDSPE). I am a Professional Engineer, registered in North Dakota since August 1986, a past president of NDSPE, and currently serve on the Licensure Qualifications and Practice Committee for the National Society of Professional Engineers (NSPE). I am, here today, on behalf of NDSPE to speak in support of Senate Bill 2243.

Our society was aware of the North Dakota Society of Professional Land Surveyors (NDSPLS) desire to update the definition of land surveying for some time. The North Dakota State Board of Registration for Professional Engineers and Land Surveyors (BOR) agreed to facilitate a discussion of these updates and formed a committee that included representation from all three entities. The result of this cooperative and collaborative effort is SB2243. NDSPE's president Dale Heglund, who is a Professional Engineer and Land Surveyor, and I both participated in this process. The discussions were exceptional as ideas were shared and everyone's concerns reviewed and debated. We started with draft language that contained many items included in the practice of the surveying profession, eventually opting to utilize the National Council of Examiners for Engineers and Surveyors (NCEES) Model Law language contained in SB2243. The committee process was very direct and deliberative, and I commend all who participated.

Concerns relating to cross over services between the engineering and surveying professions were debated and language revisions to address these concerns are included in SB2243. The result of this open communications process established clear and acceptable boundaries of agreement regarding our separate professional practices. On behalf of NDPSE we encourage the committee to give SB2243 a DO PASS recommendation.
