Senator Nething – Chairman

Senator Triplett – Introduces the bill and explains booking fees.

Brett Burkeholder – Grand Forks County Jail – Provides written attachment. He describes the booking process and the expenses involved. He says there is not a daily per diem fee in ND.

Senator Lyson — Questions when "weekenders" get out on weekends for whatever purpose do they keep any of the person's personal things till he gets back. He asks if his soap, toothbrush and things are replaced when he gets back.

Burkeholder – Responds that when he has people come in for weekends the numbers would not allow him to do that. He may have 19 plus commitments in a weekend.

Senator Lyson – Replies he is talking about being released for the weekend.

Burkeholder – Replies yes but typically it is the opposite of what the Senator has described.

Senator Lyson – Wonders why they would replace it. He asks if they have talked to the judges about imposing a fee on the offender for this.

Burkeholder - Said no they have not.

Senator Lyson – Asks if it wouldn't be better for the courts to order some of this rather than putting it in law.

Burkeholder – Says there are a number fines the court does assess, it this were done in that manner the payment would have to go to the court the court would then have to do the paperwork in some manner to pay the correctional facility.

Senator Olafson – Asks if the money will remain in the department or be transferred into the county general fund. What will this net flow do to the county budget and how will that be handled?

Burkeholder – Said a lot of the people he gets will not have the funds to pay. He has a number of inmates that have balances due to the Grand Forks county in excess of \$5000 for numerous medical bills and such. He does not expect to see 100%. He said any funds received for this would wholly go for operations.

Senator Olafson – Asks if he has a figure of what percentage of people that are being processed into your facility would be in a position to pay the fee.

Burkeholder – Replies the way the bill is written it would give them the ability to deduct funds if they have it immediately. Percentage wise it would probably be less than 50%.

Senator Lyson – Asks if in ND doesn't all money taken in go into the general fund.

Burkeholder – Replies yes it would but anything he does to enhance operations has to come out of his budget.
