Senator Andrist opened SB 2283 relating to drainage project expenditures in excess of the maximum levy.

Senator Tom Fischer District 46 introduced this bill, support of SB 2283.

Mike Dwyer: Representing the North Dakota Water Resource Committee. See written testimony.

Senator Andrist: One section provides for it right now? **Mike Dwyer**: Three sections provide for the \$2.00 and the one on this bill still assesses a \$1.50 per acre fee.

Senator Olafson: Can you give us a brief overview of the four sections and what they cover?

Mike Dwyer: There are two chapters in the Century Code whereby water resource districts can bill an assessment project. In Chapter 61:21 for assessment drains only, Chapter 61.16.1 is for flood control, dikes, levees, other kinds of projects. They both have the same procedure for levying assessment and they both have similar statutes for maintaining the project. The three statutes deal with, one section deals with maintaining federal projects and the other three deals with maintaining local water service projects. They all are very similar in they are for maintenance of water resources.

Closed hearing on SB 2283.

Committee Discussion:

The committee requested information from our Intern relating to the title of those sections of the Century Code that was left out relating to this bill. The committee then discussed how these sections relate to a fee acre, not to an urban setting. This is all agriculture, both 61:21.46 and 47.

Mr. Dwyer: For non-agricultural property, the assessment is \$2.00 per \$500 of value of evaluation. So if there is an assessment, these assessment projects have to be initially voted on by the property owners, but once they are in place if it's non agricultural property its' \$2.00 per \$500.00 of evaluation, if its agricultural property its \$2.00 per acre.

The committee asked Mike Dwyer how the Drain Districts were established, and how the powers apply to the Drain Boards. They kept the powers by just eliminating the Drain Boards, and gave those powers to the Water Resources Districts. So that is why there are two separate sets of authorities.

Senator Andrist: Are there situations in the western part of the state where they drain land? **Mike Dwyer**: There are limited situations. In Williams County, there is a couple of drain projects near Tioga; near Williston, there is a couple; in Ward County there is a few; up in Bottineau County there are a few more. As you go east you just continue to have more and more, but their limited.

Chairman Johnson: Opened the hearing on SB 2283.

Rep. Hofstad: This bill was brought forward at the request of the water resource boards. If you could refer to the code 61-21-46 it says that a levy in any year for cleaning out and repairing a drain may not exceed \$2 per acre. What this does is make 61-21-47 consistent with the previous chapter.

Rep. Koppelman: Is that for a different type of legislation or what?

Rep. Hofstad: The maximum that you can assess for a cleanout is \$2 per acre. In 61-21-47 if the cost of maintenance, cleaning out, or repairing of any drain shall exceed the amount of produced by the maximum levy and this one had \$1.50 so it simply was not consistent with the previous section.

Rep. Klemin: Whenever they revised Section 46 they overlooked 47.

Rep. Hofstad: That is exactly right.

Rep. Koppelman: This just refers back to that. This doesn't establish a different amount of levy. It deals with other issues. It is just a a reference back to the previous section.
