They can't even talk to each civilly. I know what resolutions mean and I know where they go. It is probably an effort in futility other than it makes me feel better that I can vent.

Chairman Dever: I think I might have said this when you were here for the bill, but I appreciated Senator Heitcamp's comments on the floor about how much more functional the state legislature is than Congress. I think one of the things that makes a difference is that in our legislature, seniority only gets us a preference in the parking lot and a seat in the

They are not going to do it. I know it is venting, but it is embarrassing. It is unlikely to

happen and frankly right now they are not passing any legislation and they are acting like

children.

Testimony on HCR 3027

Rep. David Monson, Dist. 10

Chairman Dever and members of the Senate GVA Committee, for the record I am Rep. David Monson of Dist. 10 in northeastern ND. This is another "venting" bill for me. It addresses three things that have been in the news a lot in recent years and frustrating me.

- 1. Excessive use of executive orders when Congress has not passed the idea. Ruling by administrative rule by agencies can be added to this, too.
- 2. The partisanship and gridlock of Congress has made them ineffective.
- 3. The overstepping of Presidential authority and the willingness of Congress to seemingly give up its authority.

This resolution is the culmination of years of seeing the power of the executive branch keep growing while the power of Congress and the people keeps being eroded. This country was founded on the idea of checks and balances and the separation of power so that no one person or group of people can take charge. The Constitution is supposed to be our master plan and roadmap. For over two hundred years people have trying to do end runs around it when it gets in the way of what they want to do. Every time they get away with it the next power of the Constitution is eroded. After years of compounding the problem, we have seemingly come to a point where Congress is completely ineffective. The President has had to fill the void. Today the gridlock and partisanship in Washington has, in my opinion, rendered Congress almost useless. They can't even pass a budget! Someone needs to tell all of them to do their job and don't let others do it for them or grab power away from others just because you can. That's what this resolution is trying to do.
