Anne Green, Attorney with Workforce Safety and Insurance: Said she is here to provide information on 2134. She said as a general rule legislation is effective on August 1 of 2013 however if the bill is declared to be an emergency or has fiscal or budgetary impact it will be effective on July 1, which is of course the beginning of the biennium. She said that on this bill the amendment effective date is July 1, 2013 to coincide with WSI's rate making process. She said that any change in the rate of any rate class is effective on July 1. Because the change in this particular law will change the premium owing for those individuals who are now covered under the presumption law, there will be a change in their premium. The premium will go up for those who are now covered by the presumption.

2:09 **Chairman Keiser:** Tim or Anne, will you please explain the presumption clause and how it is regulated and enforced.

2:29 Anne Jorgenson Green, Workforce Safety and Insurance: Under North Dakota Workers Compensation law, the presumption clause is a little bit of an anomaly. It is a presumption, a law that presumes that certain conditions with which a full-time, paid law enforcement or firefighter is diagnosed are presumed to arise out of the employment. Gave examples of conditions or diseases. Under certain criteria specified in the statute, if a full-time peace officer is diagnosed with these conditions, they are presumed to be compensable, and WSI pays for them.

3:33 **Chairman Keiser:** If you are in one of the covered groups for the presumption clause and you are removing snow and have a heart attack...

Anne Jorgenson Green: That would not be compensable. It arises out of what you are doing at home.

Chairman Keiser: But if you are driving on the road as part of your job and you have a heart attack...

Anne Jorgenson Green: If you are an officer and are on patrol, that is potentially a compensable event.

4:17 **Representative Ruby:** How do you calculate for the risk for premiums?

Anne Jorgenson Green: The premiums that are calculated for law enforcement officers go through the regular rate-making process that is done annually by our actuaries. We take all of the claims costs associated with those particular risks, and the claims costs will include claims and medical expenses that have been attributable to conditions that we're paying under the presumption clause. All of those claims costs are crunched by the actuaries, and the ultimate premium is a reflection of that analysis.

5:09 **Representative Ruby:** Would an experience rating of a certain agency also play into the calculation of the premium?

Anne Jorgenson Green: Asked for clarification.

Representative Ruby: If there are past claims for that employer...

Anne Jorgenson Green: Absolutely.

Chairman Keiser: This group has a general classification, but if the Bismarck police department has an unusually high of claims relative to everyone else, their rate would be different than all of the other police departments in the state.

6:01 Anne Jorgenson Green: Their premium would likely be higher.

6:08 **Representative Vigesaa:** You answered that an officer driving down the road on patrol could potentially have a compensable situation. What determines whether it would be or not?

6:20 **Anne Jorgenson Green:** Any issue of compensability is always open to interpretation. WSI takes the facts and applies them to the law. In terms of the presumption, there are certain statutory elements that have to be met before a law enforcement officer would be potentially eligible for benefits. Gave examples. Referenced our state Supreme Court.

7:08 **Chairman Keiser:** Once they have met all those criteria, the ruling is going to be that it's compensable, that heart attack while driving down the road.

Anne Jorgenson Green: My experience is that typically presumption claims are compensable.

7:38 **Chairman Keiser:** Requested that Eric Dietrich come forward. Please review the two specific cases you mentioned. You named two officers or people.

7:51 **Eric Dietrich:** With the deaths of Officer Kenner and Deputy Sleeper, that particular clause came into view.

Chairman Keiser: Officer Kenner was with the Bismarck Police Department, not the Parks Department.

Eric Dietrich: Deputy Sleeper was with the Burleigh County Sheriff's Department. That was the reason everything came to light. We did some background searching on it, and our agency is the only one not included in that clause.

Policemen are in the line of fire on a regular basis. For your park service, what is the level of risk? Where is the high risk?


