

Relating to North Dakota foster care scholarships

Minutes:

Chairman Flakoll opened the hearing on SB 2148

Senator Judy Lee: I wish to testify in support of SB 2148. Rather than giving my comments only I would like to read the testimony from a professional in the field (See attachment # 1 from Tara Lea Muhlhauser, child welfare professional in North Dakota, for written testimony)

Senator Judy Lee: We should help them move their education forward and become successful citizens of the State of North Dakota or wherever they may go.

Vice Chairman Schaible: The testimony said there are other resources available.

Senator Judy Lee: I don't have that information but can get it to you. My intention is not to pull these dollars from others but direct some towards students who have an interest. I would just like them to be what they can be.

Vice Chairman Schaible: This is scholarships just for the foster kids that meet this criteria.

Senator Judy Lee: Exactly. Maybe it is just a small amount but I don't have a plan.

Chairman Flakoll: They would be eligible for other needs based still?

Senator Judy Lee: I would be comfortable with that. Maybe you need to say up to a certain amount or an alternative.

Chairman Flakoll: Is it implied that they graduated in North Dakota or not?

Senator Judy Lee: I think it should be a North Dakota High School. Any kid in the North Dakota foster care should be able to apply.

Chairman Flakoll: There is no reference to campuses in that this is needs based. Should we ask that they go to a campus in the North Dakota University System?

Senator Judy Lee: I would not have any problem with that at all.

Senator Luick: What about someone who is not officially in foster care but is voluntary in a situation similar to foster care.

Senator Judy Lee: I think it is worthy of discussion seeing if you can come up with something that will help these people.

Vice Chairman Schaible: Would you have any idea how many kids this could be?

Senator Judy Lee: I will get that later for you.

Sandy Bendewald, Stutsman County Social Service Director: I do support this bill. We have children in foster care that choose to stay in foster care after age 18 and it is those kids that recognize they need more support. A number of them want to go to college but don't have the resources and this would help them.

Laura Glatt, Vice Chancellor for Administrative Affairs, North Dakota University System: I wish to testify in opposition of SB 2148 only based on the fiscal impact, not the philosophy of the program. (See attachment #2 for written testimony)

Senator Poolman: You mentioned it is expected to grow in excess of \$250,000. Where do those numbers come from?

Laura Glatt, Vice Chancellor for Administrative Affairs, North Dakota University System: Those are based upon our estimates. Once the student gets into the program they have four full years and a new crop of freshman come every year. That is where the cost accumulates over time. The \$65,000 for the first biennium is for two classes of freshman and one class of continuing sophomores.



Senator Luick: I offer these amendments (see attachment #1) **I move a do pass on the Luick Amendments to SB 2148.**

Senator Heckaman: I am not opposed to these but how would this change the fiscal note?

Chairman Flakoll: Senator Luick, doesn't a parent have a legal guardianship of their child?

Senator Heckaman: There is another issue of adult guardianship too. I could be a guardian for an older parent. They probably wouldn't want to go to college but we have to be careful on wording.



Chairman Holmberg opened the hearing on SB 2148, a rereferal from Education. All committee members were present.

Senator Judy Lee, District 13, testified in support of SB 2148.

She explained the foster care system and the fact that foster kids age out of the program on their eighteenth birthday. This bill creates a program that would set aside a scholarship for kids aging out of foster care. It would be a North Dakota student from a North Dakota high school. She read comments from Tara Mulhauser, a former foster kid and present social worker.

Chairman Holmberg said that in there other scholarship programs they have exemptions for students that live in ND but go to high school in bordering states. This will go to a subcommittee and it will be looked at and it is his hope that they will apply the same exemption as other scholarship programs.

Senator Lee said that she would be very supportive of that. Her original goal is to serve kids in the ND foster care system.

Chairman Holmberg replied that might cover it.

Vice Chairman Bowman asked if currently there are no scholarships available to foster kids if they graduate from high school in North Dakota.

Judy Lee said that others could answer that better but there are scholarships available to kids with all sorts of criteria. She said that if the kids knew that if they remained in the foster care program and graduated from high school, they might have an opportunity at a

scholarships, it could make a difference. Between now and next session we will know the demand and see the results if it is working.

Vice Chairman Bowman asked if there was anything in the bill that would follow this up with an evaluation of its successfulness.

Judy Lee replied that she would be receptive to that idea. She added that we all want to know if there is a return on investment.

Senator Warner asked what the maximum amount of time a child can stay in foster care system.

Judy Lee replied that at the age of 18 they don't have to stay in foster care but there are transitional services until the age of 21.

Jack McDonald (Lobbyist # 304) representing the state association of none public schools testified in favor of SB 2148

He strongly encouraged the use of language that included students with a North Dakota resident but are going to a high school out of state. He gave an example of students from Grand Forks that go to St. James School in East Grand Forks. It is his understanding that the subcommittee would take care of that amendment if needed and he urges that.

Opposing testimony

Laura Glatt, Vice Chancellor for Administrative Affairs, NDUS testified against SB 2148 because it is not fully funded.

Written testimony # 1

Chairman Holmberg asked if she had testify before the Education committee.

Laura Glatt said that she did and it was virtually the same testimony with one exception being some numbers in the fiscal note.

Chairman Holmberg said that it was suggested they provides X number of scholarships.

Senator Warner asked if the money was appropriated would it be in human services or education system.

Laura Glatt replied that they were flexible. She does see the value of having it in the Foster Care Unit so they can coordinate all the resource for those individual in one location. They are open to whatever is decided.

Chairman Holmberg said that he sent that bill up to NDUS to look at because he had the same question.

Vice Chairman Bowman asked if they had a tracking system for evaluation of these students.



Chairman Holmberg: asked for a voice vote from the subcommittee. It passed and will go back to the full committee.



00:27 Senator Lee, District 13: Passed out testimony of Tara Lea Muhlhauser. See attachment 1. Explained the bill. It is to provide scholarships for kids who are aging out of foster care. These kids don't have the resources or skills to get established in something that would carry them on beyond high school. This is intended to allocate some of those scholarship dollars that are available in the state for kids who are aging out of foster care, who have graduated from a ND high school, and would be enrolled full time in one of our educational institutions and keep a GPA of 2.75. These youth and young adults deserve our attention and resources to assist them with creating a path to their future as citizens of the state.

6:35 Representative Meier: Do you know how many foster children we have in the state?

Senator Lee: We have no accurate number because records aren't kept that way necessarily. I do have a number but left it behind.

Representative Meier: Will this be a first-come first-serve basis? How would you distribute these scholarships?

Senator Lee: The Board of Higher Education would lay out the procedure/rules.

Chairman Nathe: Why offer this foster care?

Senator Lee: It seems appropriate. If we let these people know we recognize them because they have challenges beyond the ordinary family living student has, it might be an incentive for them.

9:47 Representative Heilman: Is it your intent that if they qualified for the academic based scholarship and this they would get both?

Senator Lee: This wouldn't preclude anyone from applying for other scholarships as well.

Representative Heilman: Noted to the committee about Fiscal note section 3.

10:30 Representative Koppelman: Page 1, line 7, if someone over the age of 18 voluntarily stays in, do those foster parents continue to get paid for providing foster care?

Senator Lee: Everyone ages out at 18 but if they wish to make use of some of the additional services they can totally volunteer. The Department of Human Services would look at and address.

12:33 Representative Koppelman: This is designed to encourage a person to go to school rather than stay in the foster care system. Is that individual who has probably been in the foster care system a long time, how do they determine their scholarships eligibility on things that are based on income?

Senator Lee: That's why the rules of the university system would probably be developing but I would anticipate that they wouldn't look at the foster care family's income.

13:37 Chairman Nathe: Are there any who voluntarily remain in foster care?

Senator Lee: No.

14:51 Representative Kelsh: According to the Fiscal note, this is a waiver rather than a scholarship. There are no appropriations on the bill. Would that mean that this has to go to Appropriations to provide the money?

Senator Lee: That was done in the Senate committee, which is not my committee that heard it.

16:17 Representative Koppelman: This Fiscal note says unfunded scholarship mandate. The way I read the bill there is no limit to the number of students that participate but a limit to how much money the legislature takes in and rest would have to be treated as a waiver by the colleges.

Senator Lee: I can't recall the details but I can get that information for you.

17:42 Chairman Nathe: Any opposition to SB 2148?

18:02 Laura Glatt, Vice Chancellor for Administrative Affairs, ND University System Office: See attachment 2. I'm here in opposition to this bill unless it is amended to include additional state funding to support its cost.

20:27 Representative Meier: How would this program be distributed and added additional funding to it? Is this first-come, first-serve or based upon GPA?

Senator Lee: We haven't gotten that far in our thinking in discussion yet. It depends in part if the bill were passed in its present form and there were no funding in the bill

we would have to treat that as a waiver. Since there are no ties to financial need or academic ability in the bill, it would likely be a first-come first-serve.

22:17 Representative Kelsh: You talked about scholarships are considered for financial aid purposes. Would this reduce then other scholarships available for other students?

Senator Lee: If you weren't to fund this program, we would be doing is foregoing revenue that we would otherwise collect from some of these individuals.

23:39 Representative Rust: Paragraph 4 of your testimony, for that particular foster student it's possible that if they got this scholarship that they may have some other grant aid reduced by a similar amount?

Senator Lee: That's possible, yes.

Representative Rust: In the next paragraph, this program really isn't needed?

Senator Lee: That's been the experience of our campuses now. We must recognize the fact that foster care students or any student has other living expenses that they have to cover while they are attending college.

25:02 Representative Hunskor: Are the federal programs secured or would that dry up and be a need in the future?

Senator Lee: The federal funding for scholarships is always at risk.

25:44 Representative Meier: Do we know how many students take opportunity of your federal grants of the foster kids per year? Does the Board of Higher Ed keep any records?

Senator Lee: Are you talking specifically about the Chaffee program? I believe that Human Services folks will know the Chaffee program statistics.

26:20 Representative Rust: The Fiscal note talks about unfunded scholarship mandate. Are there other state mandates of unfunded scholarships?

Senator Lee: There are currently statutes on the books that require us to waive tuition for certain subsets of students.

27:28 Representative Heller: In paragraph 4 is there any way we could find out if that's really true or which ones would be and by how much so we know what we are talking about?

Senator Lee: It's difficult because every grant program has different stipulations and rules and every individual applicant depending on their circumstances the outcome can be very different.

28:44 Representative Meier: Did you testify in opposition to this bill on the Senate side?

Senator Lee: I testified both in Senate Education and Senate Appropriations basically the same testimony in support of the concept that would certainly ask for funding to support the program.

Chairman Nathe: Any opposition to SB 2148?

29:29 Dean Sturm, Foster Care Administrator, Department of Human Services: No written testimony but provided clarification to some questions asked. We have 1100 foster care children daily. We have an 18+ voluntary program. We put it in the Century Code 47-20 which is the Uniform Juvenile Court Act. This allowed North Dakota to draw federal "E" dollars for that care rather than using general funds. We have 30 youth who volunteered to stay in care over the age of 18. Reduction for youth could happen. The federal program mentioned is up to \$5,000 a year, \$2,500 per semester, with a maximum of \$20,000 lifetime. In 2012 41 individuals were served with this. In 2011 45 youth received 59 scholarships. In 2010 42 youth received 58 scholarships. We have a number of states who do offer waivers who are aging out or remaining in foster care.

36:41 Chairman Nathe: Where is there a difference from what you mentioned regarding the number of students receiving scholarships the past few years compared to the Fiscal note?

Dean Sturm: That has to do with children who voluntarily remain in care past the age of 18. This federal program doesn't apply to children who voluntarily stay there.

37:28 Representative Wall: Could you tell me how long the Chaffee program has been in existence?

Dean Sturm: Since 2004.



Mr. Chairman, members of the Senate Education Committee. Good morning. My name is Laura Glatt, Vice Chancellor for Administrative Affairs, North Dakota University System. I appear today in opposition to the bill, unless it is amended to include additional state funding to support its cost. I would also like to offer an amendment which I will address later in my testimony.

SB2148, would mandate a scholarship of \$750 per semester for individuals who voluntarily remain in foster care after age eighteen and attend college full-time. However, no funding is provided in the bill to cover the cost of the scholarship. Thus, we would ask that you amend the bill to include a general fund appropriation to cover the cost of the scholarship.

The ND Department of Human Services estimates that about 15 individuals over age eighteen annually volunteer to remain in foster care. If these individuals all take advantage of the scholarship the estimated loss of revenue to the NDUS in the 13-15 biennium is \$65,000, but is expected to grow to in excess of \$200-250,000+ when fully implemented.

It should be noted that a “scholarship” is considered a resource for financial aid purposes. A scholarship would not cause a student to become ineligible for a federal Pell grant, but could reduce other forms of grant aid.

In addition to being eligible for federal Pell and SEOG grants, foster care children also have access to a special federal program to assist foster care children who wish to pursue their education and training after high school. The Chaffee Education and Training Grant Program provides up to \$5,000 per year or \$20,000 over their lifetime. It is our experience that with this added program, most, if not all, of the cost of education for foster care children is covered through existing federal and state financial aid sources.

Lastly, with all new programs there are many detailed eligibility and administrative rules that need to be defined. For example, how many credits must a student complete each term to remain eligible; is there a probationary period for not meeting either credit hour or GPA requirements; and, what documentation is required, etc. Instead of trying to anticipate and define these details in the legislation we would ask that you consider amending the bill to provide the NDUS with the authority to adopt rules for program administration so that all students are treated fairly. This rule-making authority has been provided for several other programs. I have noted a suggested amendment below.
