Chairman Lee opened the hearing on SB 2243.

Senator Mathern introduced the bill to the committee and provided proposed amendments. See attached testimony #1.

Senator Anderson asked about the usage of "must" vs. "may".

Sen. Mathern told him that the word "must" is strong language and becomes the law. It signals to the people of ND that they mean it.

Sen. J. Lee asked if it would make a difference if it was a resolution as opposed to a bill.

Sen. Mathern replied that it is not a difference in terms of legislative management.

A short discussion between **Sen. Anderson** and **Chairman J. Lee** followed about committee representation on Legislative Management and studies being moved forward. **Chairman J. Lee** felt it was important to put "must" in.

John Vastag, Health Policy Consortium, spoke in support of SB 2243. (Meter 0:13:20) He has heard a lot of concerns and provided examples. A solid plan in place is needed for behavioral health services. This study will give everyone the opportunity to express concerns, as well as a formal committee to address the concerns. A system is needed that helps families develop accountability and a support system.

It would be nice to have a well oriented professional on the study.

Chairman J. Lee asked if he had any observations about proposed amendments.

Mr. Vastag replied that he supports them.

Sen. Axness thanked John for his work on this. This study would provide a step by step plan on how to improve our mental health services. He urged a follow through.

Sen. Larsen asked if he knew what the previous investment in this was.

Mr. Vastag replied that those who participated donated their time to the committee. They tried to meet quarterly and bring in law enforcement. The group that wasn't an active participant that should have been was education.

Sen. Larsen went back to page 1, line 9 of the amendment. He asked if "institutions" would be the umbrella of law enforcement, the courts, and the educators.

Chairman J. Lee and **Mr. Vastag** responded that it would primarily be the Development Center, and the State Hospital, which are defined as institutions. They certainly need to involve corrections and law enforcement.

Mr. Vastag wanted to assure the committee that should this study go forward, the Health Policy Consortium is dedicated to providing the expertise from their area of individuals that would be very active in this study.

Sen. Dever was concerned about the use of the word "must" on line 7 of the bill.

Sen. J. Lee stated that would be something for committee discussion. Her concern would be that, however it is established, nobody is left out that has been a player in talking about this. It doesn't mean everyone would be on the task force but that they would provide input.

Mr. Vastag said that Scott Davis from the governor's staff was active in their task force - from Indian services.

Representative Fehr, District 36, spoke in support SB 2243. See attachment #2.

Corinne Hofmann, Director of Policy and Operations for the Protection and Advocacy Project (P&A), supports bill. See attachment #3.

Ms. Hofmann also presented testimony from **Nancy McKenzie**, Public Policy Director for Mental Health America in ND, who supports the bill. See attachment #4.

Courtney Koebele, Director ND Medical Association, supports bill and dittos others testimony.

Senator Judy Lee proceeded to the podium to offer support for SB 2243 and presented testimony on behalf of **Mike Reitan**, Assistant Chief, West Fargo Police Department. See attached testimony #5.

Sen. Axness referred to access and reasonable distance of travel and said he was wondering what is available in the western part of the state.

Senator Judy Lee, District 13, spoke as a Bill Sponsor:

They added \$45,000 for a consultant. This is a huge issue. She consulted with law enforcement, school administrators, special ed directors, and found it was an absolute critical need in the schools because of the number of children coming in with various behavioral issues. They have autism spectrum disorders, or mental health issues of some sort. It all fits under the umbrella of behavioral health. This is an enormous area of concern. How do we best provide these services? The study was amended to add the consultant.

Chairman Holmberg asked what they are getting for the consultant services.

There was discussion about what they got for the money that was paid to a consultant for Human Services last session and what this consultant could offer that would be helpful. (Ends at 03:56)

Senator Kilzer: You used the words "shall study". Does that mean they are mandated to include this as one of the studies?

Senator Judy Lee: Yes, It's a critical need in the state and needs to be studied.

Senator Gary Lee: Working in health care in the state for a long time, this is a significant need across the state. There are not the beds nor the care, and the population is only growing. Someone could come in and ask for a lot of money, but something like this is a better approach.

Chairman Weisz opened the hearing on SB 2243.



Sen. Judy Lee: From District 13 West Fargo introduced and supported the bill. This bill calls for a much needed study. This has been brought to my attention by several different professionals. Our assistant police chief, Mike Reitan has been involved with our discussion about behavioral health and what police officers do when they first get the call of someone in crisis. The pick them up and take them to the hospital. The hospital may not have clinical beds or enough of them. They can't take them to the jail because they don't have a place for them either. I had a meeting with our superintendent of schools in West Fargo and the director of special education who emphasized the increasing challenges that school professionals have with behavioral health needs from students. It is a never ending increase. We have included in appropriation \$45,000 for consultant to help us with this work.

Chairman Weisz: Is it your contention that behavior health needs are special enough that they wouldn't fall into the other study in the other bill?

Sen. J. Lee: I would be comfortable if you want to amend this into the other bill. I don't see it as unique that it shouldn't be in there. Maybe the best thing is to combine them together.

Rep. Alan Fehr: From District 36 testified in support of the bill. (See Testimony #1)

Rep. Mooney: Looking at both of the bills do you think behavior should be separate from the other?



Rep. Fehr: The lack of integration is a significant problem we have. In some cases it would be good to put both together and on the other hand it may be lost with both together. I have mixed feelings about that.

Rep. Silbernagel: Do you envision would include eating disorders and prescription drug abuse?

Rep. Fehr: What I would like to see studied is far beyond what any study will do. It will probably only hit 90% of what I would love it to hit. I don't know specifically what will be in the study. I hope I get to be on the committee.

Chairman Weisz: When we get into the rural areas is it possible to have the two together?

Rep. Fehr: Four years ago there was a licensure bill that came before this committee that didn't make it out of the House and it was for medical psychologist licensure. It is my intent to get support and bring it back in a couple of years. If we had such a thing this person could be hired at clinics anyplace in the state. They also have prescription authority, but primarily trained as behavioral professionals, that would be one example of someone who could integrate into a primary care setting.

Mike Reitan: Assistant Chief, West Fargo Police Dept. testified in support of the bill. (See Testimony #2)

27:08 Chairman Weisz: How many of your calls are behavioral related?

Reitan: I'm in the process of getting that data now. I'd say 75% of our calls from the school are behavioral issues. From the street I'd say half.

Rep. Fehr: Does the Fargo and West Fargo area have transitional living homes (TL homes), or crisis residential units that are accessible other than going to a hospital?

Reitan: Not at this time. The human service center have been proactive and have been able to be a pilot to a number of programs that have been sponsored by this body. Last session it was medical detox. We can take those that need help to the medical detox center rather than emergency room. We have a wet house in Fargo that houses alcoholics. There are other behavioral health programs and no place to take them, but they are based on referrals. Our options are the jail or emergency room.

Rep. Fehr: It seems the Fargo police had developed crisis intervention teams under the Memphis model with the intention of getting people in a mental health crisis into treatment opposed to putting them in jail. Can you talk to that a little bit?



Reitan: The Fargo area currently trains officers, ambulance personnel, people from southeast human service center and other service provide to include hospitals in how to deal with people having a mental health crisis. The training allows the individual to recognize somebody who is having a chemical or behavioral health issue and how to handle them and get them into treatment in a less agitated state. Our prior option was to





beat them down to get them to the treatment. The program we are providing through the CIT is a more humane way to handle individuals that are in crisis. Our jail has hired a full time clinical psychologist where she evaluates people in the jail who have been flagged with behavioral or chemical issues. Those people can be diverted into a program where they are not entering the criminal justice system, but a treatment program. Southeast has started a program where if the officer goes to a scene he will stabilize the person to the CIT program. Then they can contact southeast and then southeast will send out two case workers and sit with the person in their home and work through the process. They will determine whether they can stay in the home or need to be transported for treatment.

Rep. Fehr: How many other communities are doing the CIT around the state?

Reitan: Minot held a class and I understand they trained a number of people and have not held a class since then. Two individuals from Bismarck had attended that class and that is the extent of the other agencies.

Rep. Fehr: Fargo is the only community doing this program?

Reitan: That is correct.

Rep. Porter: Do you have a comment on the \$45,000 to hire a consultant and how that fits into a legislative study? Is that component necessary giving the fact there is a \$200,000 study that we heard two bills earlier? I don't have an issue with having a study, I just wonder if a consultant needs to come into a legislative study.

Reitan: In the past human services had gone across the state and talked with individual disciplines on individual type settings and I don't know how that came back together. My personal view is an independent group coming in without a bias would be the best option.

Rep. Porter: That doesn't bring any independent groups together it only allows a consultant to be hired by the committee to work with the committee to do their work. It already ties in all the players in the study portion of the bill.

Reitan: I assumed that would be an outside contractor because it didn't direct a particular agency to do that study.

John Vastag: The Executive Director for the Health Policy Consortium which is made up of Trinity Health Systems in Minot, Altru Health System in Grand Forks, and the Sanford Health Systems across the state: I am testifying before you today in favor of SB 2243. During the last interim HPC worked with NDHA and we put together a taskforce that studied behavioral health and substance abuse. We met quarterly and brought together all the experts in the field, but missed out on the education folks. We found a couple of key things; case management and initiating and getting behavioral health integrated in with primary care. We haven't developed in ND a solid continual care with the proper safety nets in place if someone has a crisis. I urge you to support 2243 and keep as an independent study.



Nancy McKenzie: Representing Mental Health America of ND testified in support. We are very supportive of the study moving forward and want it to remain an independent study.





SB 2243 Testimony

Good morning, Madam Chairman and members of the Committee:

I am Representative Alan Fehr, District 36.

I am here to testify in support of SB 2243 for a legislative management study of behavior health needs.

I'm a clinical psychologist and have spent the past 30 years working in ND. Although I currently work for the ND National Guard, in my career I have worked for 4 of the 8 Human Service Centers, I worked at a regional hospital, and I owned and managed a behavior health clinic for many years.

I would like to offer some comments about our system of behavior health services in ND and why I think that a study is long overdue.

First, I'd like to make the point that our public system has not had major changes or reorganization for 25 plus years.

The biggest reorganization was in the early 80s when the Area Social Service Centers, the Regional Mental Health Centers, and other programs were merged into the umbrella concept of the eight Human Service Centers.

This put acute and long-term behavior health services, services for the developmentally disabled, addiction services, vocational rehabilitation, and aging services into one center.

As a general statement, we have a twin system of behavior health provision in ND: public and private. The public system through the Department of Human Services serves people with more severe problems and least ability to pay. People with less severe problems, such as adjustment issues and relationship issues, are more likely to seek assistance in private settings, especially if they have insurance or the ability to pay for services.

Whether or not we have a twin system of care, there is a need to creatively manage care for those with the most severe, long-term problems. A few people with severe needs can consume a disproportionate amount of resources. This may include repeated hospitalizations, recurring crises and trips to an emergency room, self-destructive behavior, and health care visits without an identifiable health care





diagnosis,

More times than not, the public and private systems do not communicate or work together in a meaningful way – the public system focused on sustaining itself and the private system focused on reimbursable services. Neither system seems able to make transformational changes in behavior health programming.

In conducting a study of behavior health needs, we need to ensure that we ask about solutions, not just problems. We need to ask about creative approaches that are evaluated to demonstrate their effectiveness.

This bill asks for "... consideration of access, availability, and delivery of services."

Regarding this, here's a point to consider:

Currently, there is a disconnect between physical health care and behavior health care, both from the viewpoint of consumers and providers. As a general rule, a person with a physical health condition will seek medical services as long as they have the ability to pay for the care.

But with behavior health, there are several likely courses of action that will result in incomplete behavior health outcomes. A person needing help could:

- 1. Be unaware of their need for behavior health services and therefore not seek help,
- 2. Be aware of their need but delay or avoid seeking help due to concerns about what other people might think of them,
- 3. Seek care from their physician and receive medication only, or
- 4. Seek or be referred for behavioral health care but discontinue prematurely.

A person is more likely to receive help if behavior health is in the same clinic as primary care. Physicians are more likely to refer and patients are more likely to accept a referral if the behavior health provider is down the hall from the primary care physician. While this may seem common sense, there is no current initiative in this state to integrate behavior health into primary care.

Furthermore, an ideal system of comprehensive behavior health care would also include:

1. Prevention, to try to strengthen resources and reduce risk factors before





behavior health problems begin, and

2. Early intervention, to provide services early and "nip problems in the bud,"

In summary, our current system of behavior health care leaves many unmet needs. But if we ask about needs without looking for creative solutions, I expect to hear that the needs are enormous, heart-breaking, and the need for funding unlimited. The questions we ask will make a difference.

I am asking for your support of SB 2243 and I would welcome your questions.



The resulting descriptions are very different, based on the part of the elephant examined. The story illustrates the illusive nature of truth, a possible reason for the conflicting positions of experts, and the need to respect different perspectives.

This bill fosters a "whole elephant" approach in an area where the approach is too often "tail of the elephant". That is refreshing and overdue.

We have seen a number of bills, in this and previous legislative sessions, seeking to change mental health commitment statutes based on the concerns of a limited number of stakeholders. It is a cause for concern. The behavioral health system in North Dakota is complex, with many stakeholders, each with a piece of the truth. We wholeheartedly support seeking input from all stakeholders to determine needed changes and avoid unintended consequences.

The mission of Mental Health America is to promote mental health through education, advocacy, understanding and access to quality care for all individuals. This bill impacts the care delivery system in North Dakota.


Behavioral healthcare, like other aspects of the healthcare delivery system in general, is undergoing change on a number of fronts: research is identifying a number of evidence-based practices leading to effective recovery; growing emphasis is being placed on the integration of medical and behavioral healthcare services; and, healthcare reform is driving change in mechanisms to access care and insurance coverage.

The system of care has many strengths, but there continue to be gaps in access and coverage. Our state, rural in nature, has additional complex challenges due to changing demographics and workforce issues.

The behavioral healthcare system in North Dakota depends upon strong partnerships between public and private sectors for maximum effectiveness and access to care. A comprehensive study of behavioral healthcare that involves these multiple stakeholders is a timely investment of resources for future planning.

MHAND strongly supports SB2243, and urges your passage.

Chairman Holmberg and Members of the Committee, my name is Corinne Hofmann. I am Director of Policy and Operations for the Protection and Advocacy Project [P&A]. P&A supports Senate Bill 2243.

Individuals with behavioral health needs interact with many different entities receiving public funds, including medical providers, social service agencies, our school systems, our state institutions, emergency services, law enforcement, the court system, and correctional facilities. Studying the behavioral health needs of adults and children would help optimize the use of state dollars within these systems.

The interplay of systems and stakeholders serving those with behavioral health issues is complex. There are strengths in our system, but there are also gaps in coverage and access that need to be analyzed.
