Vice Chairman Bowman called the committee to order on Tuesday, February 05, 2013 at 10:00 am in regards to SB 2326. All committee members were present. Brady Larson from Legislative Council was also present.

Minutes:

It's been a since we've made changes in the license plates issue. Senator Holmberg 2013 we have the money in the bank to reissue a new license plate for ND. Approximately 45 states have newer plates than us. North Dakota does not have a policy for reissuing license plates. The bill before you would allow the re-issuance of new plates. One of the positive effects of reissuing new license plates would be immediately flagging non registered vehicles. You will pick up some folks that are not following the law. Some plates are so old, they lost their reflectivity and you can't read them. This bill does not contemplate setting a schedule for reissuance of plates this leaves it up to the legislature and leaves open as to the design. We would not increase the fees to the public. It is a onetime thing. For the subcommittee it would be prudent if they had more time to finish. To have it done by 2015, you have to be sure. I don't think the sponsors of the bill don't have a problem with that. As long as we put the money on the plate, we spend money on design and all that; it is a "we need to pay upfront" process. You'll hear testimony about the number of different plates that we have. We want to look at other language there. regarding trying to track all those different plates. The fiscal note is \$6.2M you might hear from some there may be additional costs in the area of Rough Rider. The subcommittee needs to address that, they might recommend, if they like the bill, to fold it into the DOT bill.

Ed Gruchalla District 45 here in support of this bill I was on the last bill with Senator Nething. This is long overdue. 20 some years of the same design plate. The reflectivity is gone, from the law enforcement perspective there are a lot of license plate readers, the cameras that catch the plates and need a good reflectivity.

Tom Kelsch, on behalf of 3M in support of this bill Testimony attached # 1 which includes pictures of degraded plates. The 3<sup>rd</sup> page shows state by state license plate replacement.

Plates lose fifty percent of their reflectivity after a seven year period. Having the customer choose the same alpha numeric would be difficult for North Dakota Department of Transportation (DOT) and Rough Rider. If the committee would want to keep that option, one of the suggestions I would make would be to charge a fee for that. North Dakota Department of Transportation (DOT) and Rough Rider would need additional time to do it We would not be opposed to the delay, from 2 years to 4 years, and the money be set aside now we do recommend a do pass on 2326 or if it is folded in to the DOT budget, we are agreeable to that.

Senator Kilzer On your last page you recommend a move to digital plate production.

Tom Kelsch Digital plate production is a flat plate, stamped by a stamping machine. Plates now are embossed; the machinery they use goes back to WWII days. There has been talk whether the machine should be replaced or repaired, that is up to North Dakota Department of Transportation (DOT) and Rough Rider. We are not going to tell them what process to use. One of the advantages of digital plates is that we are getting more of the specialized plates.

Chairman Holmberg is the reflectivity life span of the digital plate more or less than the embossed plate?

Tom Kelsch because of the process of stamping it makes it a little bit weaker, in areas of water and salt, if you have a flat digital plate, sheeting is the same, and reflectivity is the same, probably a little stronger, not stretched. What the lessoning it would be. Of course over 20 years all of it would be somewhat degraded.

Chairman Holmberg you are not the one that will make that determination and neither, according to this bill, is the Legislature. It would be North Dakota Department of Transportation (DOT) to follow within the dollar amounts that they receive what is the best thing to do.

Senator Krebsbach: do you know if the appropriation amount covers the new machine for the digital plate.

Tom Kelsch I don't know if that is built in there. I know there are ways to fund that process. On the fiscal note, DOT figured their costs, and put a cost in for Rough Rider.

Senator Krebsbach: would it be easier to duplicate the plate, if someone would want to manufacture (other than the state) with digital equipment?

Tom Kelsch: I am not aware of counterfeit plate problems. Embossing machine is an unwieldy piece of machinery that most people would not have. The research that 3M has done on states that have done the reissue, a lot of going with digital plates, more people are being caught that are not paying for their renewals, because you have a new plate with a somewhat different design.

Senator Wanzek: I am assuming that the requirement would be that when your annual renewal would come in, at that point you would get your new plates?

Tom Kelsch: I assume that would be so. That would be up to North Dakota Department of Transportation (DOT) to make that determination the bill does not require that. You would get your new plate as your annual fee come up you pay your registration.

Chairman Holmberg I think Linda will mention the sticker shock. If they do not put them where they are supposed to, it would be a class B misdemeanor but I don't think people are getting arrested. .

Tom Kelsch they are all supposed to be up in the corner, one of the things is that if you get a new vehicle, if you sell your old vehicle you can transfer that license plate over to the new one, I kind of hate to put the old plate on your new vehicle. More people are keeping their same plate.

Linda Butts, Deputy Director for Driver and Vehicle Services at the DOT we asked if Roughrider industries could be here. I am favor of this legislation. Getting new plates is far more complex than anyone can think. It is not only that we have to fight the hurdles of the ugly plate; we all know beauty is in the eyes of the beholder, another thing is that you dropped the price of a special letter plate from \$100 down to \$25. We are one of the states that have the largest number of that type of plates in the nation per capita. The flat special letter plate is 42 thousand. The other thing is that you allowed organizational plates. Now we have organizational plates and special letter organizational plates. We issue 63 different kinds of plates, on different vehicles, by the time it gets all mixed into our computer we have 382 combinations of choices that we need to make for the purpose of attaching registration fees. We need new plates. (She passed used plates around to the committee as examples of deterioration and loss of reflectivity). We recognize that after twenty years the degradation of the plates is probably significant. The plate with owner law had the unintended consequence of "can I have my old number back", yes and we'll charge you \$5. Theoretically it is a special letter plate at that point because it no longer is a random number. The way this current bill is worded, is basically any person that likes their old number can keep it, so the population of special letter plate could be even far greater that the 42 thousand that we have already got on the book. We wanted to wrestle with that a little bit. We also asked consideration for time. One of the things we desperately need is a replacement for our registration system. The current system does not have the accounting package; auditors are always writing us up for reconciliation, the money collected we can't get it the right piles, so to speak. We would like the new DRTS system. Another thing coming down the pipes is e-titling and e-liens, so when we sat down to request budget we thought long and hard about the new plate. We thought we would like to get the computer system up and running and then next legislative session we would come back and address the new plates. The other thing, with this tremendous amount of growth, is trying to deliver services in the manner in which have grown accustomed to doing. We are looking to outsource more of our services, in addition to that we are struggling with delivery from our branches, they have experienced tremendous turnover right now this snapshot in time there is a lot that is being placed on Motor Vehicles from an expectancy and delivery point of view. We ask for the gift of time, lets fund it, so that we got it set aside and we'll continue to develop a work-out plan. Regarding the fiscal note, we have met with Rough Rider, they would have significant. Costs that is not included in our fiscal note. plate production, after being in the market, some states are going back to the embossed

plates, from a readability standpoint. Now we would do more investigation and do what, long term, is best for the state.

Vice Chairman Bowman; with all the people doing business in ND what is the requirement for them to have a license plate in ND, why shouldn't they purchase ND plates. In Montana you have to have a plate on

Linda Butts The law says if you are employed in ND, you need to be plated in ND. In an effort to accommodate the oil patch, we created an on line renewal or temporary registration you can go online 6 or 12 month renewal, it is a yellow sticker that goes in the window. The problem is enforcement; in ND it's a secondary offense, so Highway Patrol (the only ones authorized right now to sell these temporary registrations). They have pull some one over for some other reason, and query them to find out if they are working in the state, if they are they can ticket them, they can swipe it right in the car and make the sale. It comes in as a batch overnight and we will get that to them. At the end of last biennium we did an extensive media campaign. Because it's a secondary offense we though knowledge was the way to get them to get in compliance; we had billboards, we sent out letters, went to their corporate offices. We saw a significant increase this biennium we are at we are making progress, after that campaign, some look at the regulation and saw it is cheaper to plate it in North Dakota, so we saw the plating and titling activity increasing more rapidly that the temporary registration. I know there is significant frustration in the oil patch, but trying to pass a blanket piece of legislation is difficult.

Rick Gardner, Director of Rough Rider Industries testified in a neutral position regarding SB 2326 and provided Testimony attached # 3 outlining their concerns with this bill: the timeframe of July 1, 2013 to June, 30 2015 which puts a heavy burden on RRI and the retention of old plate numbers/letters which would be considered specialty plates that slow down the manufacturing process; last the financial investment .RRI is proud to have the opportunity to manufacture license plates for the state of North Dakota.

Senator Warner you would be getting new equipment for the embossed plates, regardless?

Rick Gardner: Yes, on a general re-issue we would need a dedicated brake press just assigned to do the license plates themselves. We still need the other equipment to continue with the other metal fabrication.

Chairman Holmberg would you provide a cost estimate of the embossed plates and then the digital plates. So we can have that for our consideration.

Senator O'Connell: what kind of income will this generate for RRI, above your expenses?

Rick Gardner Looking forward I can't say what it will generate, I can say last year we profited a little over \$15,000, it does employ inmates, we provide a valuable service to the state.

Senator O'Connell: I assume this issue for motorcycles, trailers, everything.

Chairman Holmberg: yes, this is all license plates that are manufactured in the state.

Linda Butts: there are some plates that have a white background, they are fleet plates, and they would be subject to renewal. If it has the art work you would see, the buffalo plate and Lewis and Clark (general issue plates would not be changed)

Chairman Holmberg could you over the next days any research that other states had when they have the new issue of picking up the folks when they didn't register.

Senator Robinson: did we not have a later issue of the Lewis and Clark plate? Would those plates be replaced at the tail end?

Linda the Yes With regards 2<sup>nd</sup> question, that is a possibility.

Chairman Holmberg there are 630,000 active buffalo plates right now, and roughly 15, 699, Lewis and Clark plates enacted in 1999.

Senator O'Connell: if you work in SD, would you want the subcommittee maybe changing the law for ND.

Linda Butts the transportation committee, Senator Lyson, introduced a bill last session that clarified the conditions under which one was to be plated; they did an exhaustive study on that. I might suggest, maybe visit with Senator Lyson and see what his thoughts are on it.

Chairman Holmberg: Closed the hearing.

**Chairman G. Lee** called the subcommittee hearing in regards to SB 2326 at 10:30 am in the Harvest Room. All subcommittee members were present: Senator Gary Lee, Senator Holmberg, Senator Wanzek and Senator O'Connell. Brady Larson from Legislative Council and Tammy R. Dolan from OMB were also present.

**Chairman G Lee** what we asked is for from the original meeting the Rough Rider Industries to provide a cost estimate.

(0:01:27) Rick Gartner, Roughrider Industries: I broke this down under the assumption we would be replacing 1.2 Million plates, taking financing out over a 7 year period, the reissue of 900,00 plates over a five year period. 2.1 million Plates over 7 years. Brake down of equipment needs, \$680 thousand for embossing equipment, and 3.6 million for material costs.

(0:02:55) Senator Holmberg wanted an explanation of the 6.2 million in the other budget and what are they buying.

Chairman G. Lee also is asking what the difference is between the motor vehicle section.

**Rick Gartner**: this is what it would cost to buy the raw materials, and equipment needs.

Chairman G. Lee so your request is 4.28 million

(0:03:56) Dave Krabbenhoft, Dept. of Corrections. (DOC) It is duplicate, we would need that increase in our appropriation authority, to purchase the materials, and then Motor Vehicle would buy the plates from Rough Rider. He is not sure what the 6.2 million is for Motor Vehicle but the 4.2 to increase for production costs in for SB 2015

(0:04:35) Senator Holmberg that is your production costs would that be figured in if we in this budget put in to DOT budget, 4.2 for production, that is run through this budget. It's

nice to keep things together, that goes to Roughrider for production. Are we spending 4.2 million, what are we spending 6.2 on? We don't want to tell the legislative ten and half million dollars when we are only...

(0:05:32) Dave Krabbenhoft: Rough rider is a business, the cost to produce and what they would sell the plates to Motor Vehicle that would be my guess the profit would be in there the 4.2 does not include the profit to rough rider. It is not the revenue side, which would be what we would bill per plate.

**Senator Holmberg** the 6.2 the amount of money that DOT needs to buy the plates?

(0:06:19) Chairman G. Lee is Rough Rider saying they need 4.2 to do the job to get them ready for sale; you sell them to Motor Vehicle for that amount or whatever.

(0:6:28) Rick Gartner The big part of the cost is the material costs, our capital investment, embossment equipment, all our raw material costs, that will be ongoing, so it will be a revolving, pay as you go. I don't know if it's an additional cost that is the cost it will take for Rough Rider to produce these plates. They will generate a profit off these plates.

(0:7:18) Chairman G. Lee discusses the breakdown of costs and profit for Rough Rider.

**Senator Holmberg** the 3.6 coming from the 6.2?

(0:07:39) Dave Krabbenhoft DOT will have their own costs. What we are looking for on the expenditure side to buy materials and update equipment. The revenue side is different.

(0:08:32) Brady Larson: This option you could appropriate the general funded dollars directly to Rough Rider and a portion to DOT for their costs.

(0:08:51) Senator Holmberg I don't like double counting. It makes it a lot easier to explain on the floor. What I see we have the 6.2 plus 680 would get us started, then you have this money flow back and forth, and part of the cost, the plate is your material.

(0:09:34) Dave Krabbenhoft you have general fund one time in MV budget, it would be special funds in ours. There are no other costs. The costs of materials in the DOC budget general funds then that number would decrease in MV. We would bill them back. We do this with the State Hospital and pay them directly. It's general funds for our budget it's special funds for the State Hospital budget.

(0:10:50) **Senator Holmberg** special funds and general funds is in both pots.

(0:11:08) Chairman G Lee (to Brady Larson) if the numbers would be 6.2 in production and material costs, it would really only be 6.8 you would only be spending that amount of money?

**Brady Larson** I believe you are correct. The money would only be counted once and not have to flow through both general fund and the eventually the special funds.

(0:11:49) Senator Holmberg we end up having a concept which we may put in DOT budget, we are lucky we have 2 out of the 3 on the Corrections budget. What will it cost for the new issue? What are the actual general costs?

Chairman G. Lee so they understand how much is being spent on the project.

(0:12:57) Senator O'Connell: how many workers now doing the plates, will it increase your number?

**Rick Gartner:** currently 6 workers, it would increase, with the additional equipment. It would be an increase of 2 or 3 workers.

(0:13:45) Senator O'Connell: What are the costs of the plates right now? Manufacture and sell.

**Rick Gartner**: manufacture price for plates its \$3.27 per plate, and current sell rate to MV is \$3.95

(0:14:21)Senator O'Connell What would be the new cost for reissue?

**Rick Gartner** looking at a pay back over 7 years. It would add 35 cents to embossing, and digital printing method 70 cent increase.

(0:14:59) There is a discussion about the sell back rate to MV. About a 75 cent markup.

(0:15:20) Chairman G Lee the original language, everyone having original plate back was that factored in?

**Rick Gartner**: We would be a specialty plate, in terms of reissue process it would slow the process down. The time frame in the bill would be hard to accommodate the time frame.

(0:15:59) Chairman G. Lee discussed the language change and the quicker method if that was considered and the process and plates.

**(0:16:19) Rick Gartner:** we factored the additional costs on to the specialty plates. If you are presented with keeping the plate you have or take a new issue plate without any finical tie personally I would keep the plates that I have for no reason if there is no tie to the plates to take the plates because I think that it would add to the time frame.

(0:17:07) Senator Holmberg the committee needs to make a decision on embossed or digital and let that be known, it will determine the cost of the equipment. My opinion is embossed.

**Chairman G. Lee** Mr. Ziegler brought some examples of flat and embossed, embossed more visible there is an advantage to the embossed.

- (0:18:17) Senator Wanzek asked if there was a suggestion of a personal or vanity plate that or if we do charge.
- (0:18:38) Rick Gartner we charge a higher rate for that plate. It is not a problem to do that but the time frame is a problem. That is under the embossed format. We can do 300,000 plates a year. The digital process is a faster less tedious process.
- (0:19:44) Senator O'Connell I like new technology. I like the embossed plates though.
- (0:20:14) Senator Wanzek I am not sure yet, I do like the embossed it takes more time for the personal plates. I am surprised there is no technology out there that it would change the dyes itself.

Senator O'Connell the new tech the plates should last longer last longer?

- (0:21:00) Rick Gartner: there is advantages and disadvantages. The digital are harder to read, the graphics are not as good, the embossed is a sturdier plate, we incorporated that, some states don't have that, they don't have that special rim dye around the edge.
- (0:21:49) Senator Holmberg as I understand it the challenge of allowing the issuance of the same number is really a separate question because if we remove that language, if we took that language out, anyone coming in to buy the vanity plate but they would have to pay the extra fee.
- (0:23:02) Chairman G. Lee I may have been remembering some states said the flat plates did not work as well,
- (0:23:21) Rick Gartner they stopped in Florida a stayed with the embossed plates. Rough Rider we don't care which one, the flat plates were easier to counterfeit. Cost wise, they say there is a savings, the cost will be almost the same for us. Investment in initial equipment.
- (0:24:12) Senator Holmberg the history of the ND legislator, 22 years, since we dared to do it I would hope we would take the sturdier plate.
- **(0:25:06)** Chairman G. Lee anything else, we are looking towards the embossed. Agreeable with all committee members. We had a request for DOT for the SCOFFLAW.
- (0:26:13) Linda Butz, Dep. Director of License Division of DOT we did go through the state of Nebraska to talk to, they picked up about 1 to 2 percent of the population, the other advantage each year when there was an expiration the highway patrol was able to pull individuals over to enforce the new plates. In 21 years it could be significant larger than that in North Dakota.
- (0:27:00) There is a discussion about the Highway Patrol pulling individuals over that had expired plates, and the percentage rate of 1 to 2 % was a very conservative number.

**Chairman G. Lee** any additional info or questions.

(0:28:18) Chairman G. Lee: you could do about 300,000 a year; we are looking at 3 to 4 years to do a million plates.

(0:28:36)Rick Gartner we can work extended hours. With the new equipment will speed up process. 2 years.

(0:29:10)Senator Holmberg would pushing the date back help. And I know DOT feels pushing the date back would help. We wanted to be sure the money is in the budget this year. We should dedicate the money now, spend it.

(0:29:54) Rick Gartner if we say from whenever we chose, if there is a two year time frame, we can accomplish that. From our perspective we could meet that.

(0:3018) Senator Holmberg not as big an issue then with Rough Rider than with DOT

(0:30:30) Linda Butz I asked for the gift of time, new computer system transitioned, talked to the tax department, gave themselves a year, give yourself 18 months, by pushing that out to June 30 of 17. Then we could live with that time line.

(0:30:13) Chairman G Lee expected to be done, June 30, 2017.

(0:31:25) Senator Holmberg in that time line when would the first new plate hit the street?

(0:32:04)Linda Butz we have to start sometime in May or June of 15, the preplanning and the prework,

(0:32:40) Chairman G Lee where would all the money be in this budget or the next one?

(0:32:56) Rick Gartner we would be the one to get the ball rolling, I would assume we make that decision, it wouldn't take us that long, getting the leg work done to manufacture these plates.

**(0:33:19)** Senator Holmberg it will take a little time, if there is going to be a change in the design of the plate. It seems quite reasonable that the gift of time should be considered. The money has to be appropriated now. For example you buy it, and then the leg tells you won't get the money.

(0:34:18) Chairman Lee it needs to be here now to start the process.

(0:34:25) Senator O'Connell what kind of bottle neck will there be when the new equipment comes.



### North Dakota Department of Transportation Linda Butts, Deputy Director for Driver and Vehicle Services

#### **SB 2326**

Mr. Chairman and members of the committee, I'm Linda Butts, Deputy Director for Driver and Vehicle Services with the North Dakota Department of Transportation (DOT). Thank you for allowing me the opportunity to present information to you today.

The DOT recognizes the need to replace the current general issue plate or often referred to as the "buffalo plate" with a new design. The current plate has been in use since 1991 and features can degrade over time, affecting reflectivity and other markings on the plate.

We have concerns in respect to the amount of time designated for the process. Currently, the Motor Vehicle Division has many priority projects to work on over the next biennium to meet the growing demand for timelier vehicle services including: upgrading an old computer software system (VRTS), as well as enhancing central office and branch office processes across the state.

Replacing and issuing license plates is a complex project, therefore we would like to respectfully ask to work with the sub-committee on this process and to potentially extend the timeline for completion to June 30, 2017.

While the department's fiscal note is \$6.2 million, we are concerned that our cost estimate doesn't reflect all the costs for a plate issue. In visiting with Rough Rider Industries, they informed us they will incur significant costs which are not included in this number.

Good morning Chairman Holmberg and members of the Appropriations Committee. My name is Rick Gardner and I am the Director of Rough Rider Industries. I am here on behalf of the Department of Corrections and Rehabilitation to provide neutral testimony regarding Senate Bill 2326.

Rough Rider Industry welcomes the opportunity to develop and manufacture license plates for the State of North Dakota. This work allows Rough Rider Industries to employ inmates teaching them valuable job skills which will aide in their rehabilitative process.

North Dakota's last license plate general issue was in 1991-1992. Many of the existing vehicle license plates currently in use have lost reflectivity, making them very difficult to read. Others plates, such as the ones on my 1998 vehicle, have a very large buildup of registration tabs. A general re-issue would resolve these problems.

Senate Bill 2326 does cause some concern for Rough Rider Industries. First, the bill's timeframe of July 1, 2013 and ending June 30, 2015 for completion of this process, puts a heavy burden on our manufacturing process. We estimate this timeframe would require RRI to generate approximately over 1 million pairs of license plates. Rough Rider Industries would recommend looking at other more workable time options.

Second, SB 2326 allows for the registered owner of a vehicle to retain the distinctive combination of numbers or letters, or both, on present plates for that vehicle. This poses a problem in the current production process in that, Rough Rider Industries would consider these plate requests as specialty plates, which severely slow down our current manufacturing process. Specialty plates don't allow us to make long, uninterrupted runs of alpha numeric plates, which is necessary to meet the given re-issue timeframe. We feel that if motorists are



given a choice, with no financial obligation tied to meeting this request, many motorists will choose to retain their current combination. RRI proposes adding a fee, or financial obligation to accommodating this request. We feel this will limit the number of requests for retaining their combination, which will in turn, speed up the manufacturing process.

Finally, RRI, which is a self-funded division, is concerned with making a huge financial investment in our current production line which produces embossed license plates. There are currently two commonly accepted practices for the manufacturing of license plates. These two processes are embossed license plates, which North Dakota currently uses, and digital flat license plates, which many of our surrounding neighbor State's use. Both of these processes have advantages and disadvantages to them. Both would also require an additional financial investment on the part of Rough Rider Industries. Rough Rider Industries would ask what ever method of production is used, that the State of North Dakota will stay committed to this method for the foreseeable future. This would give RRI a return on its investment to support this general re-issue.

In closing, Rough Rider Industries is proud to have the opportunity to manufacture license plates for the State of North Dakota. We are willing and able to make a financial investment to accommodate the States decision on this bill.
