Explanation or reason for introduction of bill/resolution:

A BILL for an Act providing an appropriation for defraying the expenses of the legislative branch of state government; to provide for applications, transfers, and cancellation of unexpended appropriations; to amend and reenact sections 54-03-20 and 54-35-10 of the North Dakota Century Code, relating to legislative compensation; to provide an effective date; and to declare an emergency.

Chairman Thoreson: Opened the hearing on HB1001.

Senator Holmberg, Senate Appropriations, ND Legislative Assembly: Explained the changes to the budget for HB1001.

Chairman Brandenburg: So the money we were putting in would be to help defray costs of having our members attend.

Senator Holmberg: That's part of it.

Senator Holmberg: Continued explaining the changes to the budget.

Representative Al Carlson, House Majority Leader, ND Legislative Assembly: Testified in support of HB1001.

Jim Smith, Director, ND Legislative Council: See testimony attachment A.

Chairman Thoreson: What is that being used for and what would the upgrades be?

Jim Smith: Part of that \$50,000.00 is for a one-time license/maintenance fee. The \$140,000.00 would be for consulting and implementation. They would update the new client and server components, there'd be an open office update, performance improvements.



Kyle Forester, Information Technology Manager, ND Legislative Council: This is the core drafting system; but it also maintains our daily journal from the chambers and bill status. We'll see definite improvements on the drafting side; where we're having some memory issues on the client and on the server.

Chairman Thoreson: When you say memory issues are you running into not having enough memory?

Kyle Forester: It's a memory leak. With the upgrade we'll get a new open office version and our client that we use for the drafting that will have an update also. One of those updates will allow us to do a better job coding these scripts.

Representative Skarphol: Do you see yourself or legislators utilizing the cloud more? If so, what kind of security issues give you?

Kyle Forester: At this point, the only thing we're using right now that's in the cloud is drop box; and that's on your IPads and laptops. We purchased a different product called Citrix mobile enterprise and it allows us to manage your IPads. There's another product that came with that purchase and it's called Citrix Share File and our plan is to move out of the cloud.

Representative Skarphol: As far as security are you seeing indications of increased activity that you're having to guard against?

Kyle Forester: As far as the legislative council side we really haven't seen that. Some of our systems are hosted at ITD; so ITD has gone through and they're doing intrusion detection on the network. It's our understanding that they are seeing an increase in attacks and things that are going on. So far it hasn't really affected us.

Jim Smith continued with his testimony.

Chairman Thoreson: I've sat in on that before where you bring in some of the vendors with the products.

Jim Smith: We have a four year replacement cycle on those.

Jim Smith continued with his testimony.

Representative Skarphol: What do we pay CSG bi-annually?

Jim Smith: This is the Midwest conference and we don't pay dues for that conference other than registration fees that we pay for legislators or staff to attend their annual conference. They do get money from the national CSG.

Chairman Thoreson: That's in a different budget.

Allan Knudson, Fiscal Analyst, ND Legislative Council: You're correct it's in the OMB budget. The amount they've included for the 2015-2017 biennium for CSG is \$188,000.00.

Jim Smith: That goes to support all the efforts of CSG. I think there's a separate fee for the national governor's association.

Chairman Thoreson: I recall that was put there because they're a function of all 3 branches of government.

Jim Smith continued with his testimony.

Chairman Thoreson: Have they looked at the Brynhild Haugland room and have kind of an idea of what's going to be done with it?

Jim Smith: I'd think we'd have to have that discussion. We work with the legislative procedure and arrangements committee on that. There has to be some decisions about the use of that. A permanent table would enhance the room; but it would also create problems with multiple uses.

Chairman Thoreson: How much input does John Boyle and the people with facilities management have with that? Are they involved in the process when we do the upgrades to the various facilities?

Jim Smith: We've taken the lead on that. We've included on discussions as far as electrical service, etc.

Jim Smith continued with his testimony.

Chairman Thoreson: Do you have a list of those?

Jim Smith: I can get that.

Representative Skarphol: Do all states pay the same?

Jim Smith: There's a two part formula. I think the first half of the rate is based on population and then the other half is more equalized than the population part of it. I can get you some background information on that as well.

Representative Skarphol: Can you provide us with information for the amounts paid by state?

Jim Smith: The chart lists each state, the dues, and the status of their dues.

Representative Skarphol: Is there any way that NCSL tracks the utilization of their services so that states that use it more could conceivably be paid more? The same thing applies with CSG, is there any kind of feedback that you get from them as to utilization so that we can find out if we're getting value as opposed to other states?

Jim Smith: NCSL does have documents and they do track utilization services; both in terms of contact from legislators and staff back to NCSL. Attendance at conferences would



be another item they track. NCSL is available to come out to states and speak on different issues; so they track that as well.

Representative Skarphol: It is being utilized somewhat equally by everyone?

Jim Smith: There are some states that you would expect to utilize it a lot that don't utilize it very much; and there are other states that utilize it quite a bit. Typically it's the smaller states that have smaller staff that utilize it proportionately.

Jim Smith continued with his testimony.

Representative Hogan: Have you much staff turnover?

Jim Smith: We have had some turnover; several retirements. Recruitment has been a problem.

Representative Kempenich: Who is our major competitor?

Jim Smith: When we look at how our salaries compare, we do look at state government. I think we consider state government and the private sector both as areas that we compete with.

Representative Kempenich: Where are you getting your applicants from?

Jim Smith: It depends on the position.

Representative Kempenich: Are we close on salaries?

Jim Smith: We're in a fairly good position right now. It's something you have to address constantly.

Jim Smith continued with his testimony.

Chairman Thoreson: Are you done with the remodeling of your offices?

Jim Smith: We are pretty much done. I think some of that \$50,000.00 could be used for new office furniture.

Jim Smith continued with his testimony.

Representative Skarphol: Does HB1199 have to do with renting apartments? Do they feel they need to pay that rent up front and they'd like to get compensated for it then?

Jim Smith: That is exactly the issue. It would allow them to be paid on the 5th of the month.

Representative Skarphol: It would almost have to be that because most of the motels don't give you the bill until the end.

Chairman Thoreson: Opened the discussion on HB1001

Jim Smith, Director, ND Legislative Council: See attachment A.

Chairman Thoreson: At the bottom of page 2 it says 90.5% of total; that would be all the associated states and other entities? That would be about the average of all the states belonging to the organization are paying about 90.5% of their dues?

Jim Smith: It's about 90.5%. That leaves about 9.5% that they don't plan on collecting. The previous year it was 16% and prior to that it was 12%.

Chairman Thoreson: Florida has \$360,000.00 that they don't expect to get from them?

Jim Smith: Yes.

Vice Chairman Brandenburg: I know there's some discussion about the ones that aren't paying and still letting them vote.

Representative Kempenich: How do they vote? Are their votes prorated?

Chairman Thoreson: Don't all the states come together and your delegation decides which way you're going and each state gets one vote?

Jim Smith: For each state present each state gets one vote.

Jim Smith continued with his presentation.

Chairman Thoreson: That base number is the same for us vs Florida?

Jim Smith: Right.

Vice Chairman Brandenburg: What is the association saying?

Jim Smith: NCSL's position is that they're trying to keep some of these states that are in arears active so that they do have a 50 state participation.

Chairman Thoreson: This document is just for fiscal year 2015? Is that correct:

Jim Smith: That's correct.

Chairman Thoreson: Was California short in 2014, 2013, 2012 and that's still outstanding or do they just wipe that off the books?

Jim Smith: They were in arrears for the previous 5 years. I don't think they try to go back and collect that.

Representative Kempenich: I don't know why there aren't rules to at least pay half.

Chairman Thoreson: If you have been short a number of years and there's no penalty for not paying it back, there should be a penalty.

Representative Hogan: Do you know what percentage of the overall operating cost of NCSL is covered by dues?

Jim Smith: I don't know that off hand. They do get specific grants for studies and programs.

Chairman Thoreson: The annual meeting is going to be in Seattle; and according to this they're still short about \$54,000.00 on their dues.

Jim Smith: See attachment B.

Chairman Thoreson: Our budget is for how many days again?

Jim Smith: Seventy-seven.

Representative Skarphol: If we go beyond 80 days, we do not get paid. Is that correct?

Jim Smith: There's no provision to go beyond 80 days.

Representative Skarphol: We came really close last time.

Jim Smith: You would be done at 80 days.

Representative Skarphol: We can't do business after that even if we don't get paid?

Jim Smith: Right. The governor would have to call you back in and then there would be a special session; where there's no limit to it and we would need to find the funds for that.

Chairman Thoreson: If that did happen where we used up 80 days and we were still debating bills, do those bills die at the end of the 80th day? Do we have to come into a special session and start anew on those?

Jim Smith: We did that in 2003. What we did in that situation was the legislature had concluded its work and we had 3 bills introduced and the number sequence started from what we had left over from the last session.

Chairman Thoreson: If we were still fighting over the OMB bill and the 80th day and we ended, would we have to start over.

Jim Smith: We would have to figure that out.

Chairman Thoreson: The \$700,000.00 is assuming were 78 days. How much a day extra would it take if we run over 78?

Jim Smith: \$77,000.00/per day.

Representative Boehning: Where does CSG come in to our equation in here?

Jim Smith: CSG is in the OMB bill. The reason for that is they have all dues for agencies that affect all of state government; CSG is for all three branches.

Chairman Thoreson: Are we still members of Western?

Jim Smith: I don't know.

Jim Smith continued with his presentation.

Chairman Thoreson: How much was budgeted for travel this biennium for legislators?

Jim Smith: We have two categories; we have out of state and then we have the interim committees.

Chairman Thoreson: I'm looking for the out of state; how much as authorized and how much has been spent?

Representative Skarphol: Have you ever looked at what it would cost if every legislator were to attend 2 conferences during the interim?

Jim Smith: That has come up in the past and we've had amendments to our bill that would allow that. It's just a matter of calculating out per legislator.

Representative Skarphol: Can you tell us how many trips were made by how many legislators?

Allan Knudson, Fiscal Analyst, ND Legislative Council: For out of state travel we budgeted \$1.7 million through December and we spent \$1,335,000.00; and that's for travel and per diem.

Chairman Thoreson: That was through December. The period left is just until the end of the biennium.

Allan Knudson: We really don't budget anything during the session.

Chairman Thoreson: Does money come out of that if you're on NCOIL or one of those other organizations?

Allan Knudson: Yes. That comes out of there as well.

Representative Vigesaa: Do the number of interim committees stay fairly level through interim; or is management trying to keep it at a certain number?

Jim Smith: We budget for 26, that includes the legislative management committee as well; that's been pretty stable for the last few years.

Representative Skarphol: Do you turn back the money or do you carry it forward?

Jim Smith: We have the authority to carry over what's unspent in the bill.

Representative Skarphol: If you carry it forward, does it carry forward in the same category or do you have the flexibility to move it anywhere you want?

Jim Smith: It carries forward in the same category; but once that happens we can move it in the line items.

Jim Smith continued with his testimony.

Vice Chairman Brandenburg: There's a bill to pay for motels or apartments for legislators up front. What's happening with that?

Jim Smith: I think the House passed it.

Representative Vigesaa: Is there much left to do in the wing for refurbishing?

Jim Smith: I did identify a few items in my testimony. Some of those would be the press studio area, we're looking at different sound systems in the rooms.

Chairman Thoreson: You never could hear a thing in the Prairie Room.

Jim Smith: It helps the members hear each other as well as the people in the audience can hear the members.

Chairman Thoreson: In the press studio, the actual lighting would be changed?

Jim Smith: Yes.

Representative Vigesaa: Are we passed the major renovations in the wing?

Jim Smith: I think that's fair. At some point you have to start looking at carpet replacement in the chambers, chair replacement, etc.

Representative Glassheim: Let's say you have carryover of \$1 million. Wouldn't we subtract that from your request of next biennium's money? How does that get noticed on the green sheets?

Jim Smith: What we do with that money is spend it on things that aren't anticipated. It's fairly limited; but, we can't subtract it from our budget for the next biennium because we don't know what that turn back is going to be.

Representative Skarphol: When you gave your original presentation you talked about considering remodeling the Brynhild Haugland Room. I understand that the fire code says 149 people max; and they've had well over that at times. We have a request from the courts to remodel in the area that ITD had and they'd have a room that's capable of holding over 200 people. It would seem logical to me that that room would also be available for some of these hearings. Do you see that as holding potential value?

Jim Smith: That's not something I've thought about. If it would work with the court and they would make it available it would be great to have access to an additional larger room.

Chairman Thoreson: That's a bigger question. The rooms in the horseshoe behind us; those rooms are always standing room only.

Representative Skarphol: Has it ever been looked at expanding the size of those rooms?

Jim Smith: We've never looked at that.

Representative Skarphol: If that wing down the way gets remodeled there are going to be multiple rooms there.

Chairman Thoreson: I agree with that.

Representative Vigesaa: In regard to the IPad and computer replacements; where are these at right now?

Jim Smith: We're on a 4 year cycle for both laptops and IPads. Those will be replaced in 2016 and we would involve a legislator computer task force.

Representative Vigesaa: I know you're on that cycle; but can it be a longer cycle? Could it be 6 years before we did that laptop replacement?

Kyle Forester, IT Manager, ND Legislative Council: We're on a 4 year replacement plan for the laptops. Right now we're about 3 years into that and we're seeing some hardware failure. Once we go beyond that warranty period we would be responsible for paying for the cost to fix that issue. The warranty on the laptops will expire in 2016.

Representative Vigesaa: I know we're going to be looking through every budget for places we can save; and that's why I asked the question.

Kyle Forester: I wouldn't recommend

Representative Skarphol: Will the legislators be able to purchase the old legislative laptop or IPad?

Kyle Forester: Yes. In statute it does state that legislator's may purchase those. Last time after the recycle, we talked to surplus property to find out what they were going to sell them for and then we offered that same price to the legislators.

Representative Skarphol: Do you have any how much?

Kyle Forester: No.

Representative Skarphol: When will you know?

Kyle Forester: Last time we didn't know that until we replaced them. Last time it was \$100.00 for the laptops.

Representative Skarphol: Do you reformat them before you send them out after we turned them in?

Kyle Forester: Yes. We zero out the drives. They are completely empty of any data or anything. When we surplus them, the power supply and the laptop goes out; we don't send any media along.

Chairman Thoreson: Closed the discussion.

Chairman Thoreson: Opened the discussion on HB1001.

Representative Skarphol: To better understand the 3% and 3%; could you walk through and explain what happens?

Adam Mathiak, Fiscal Analyst, ND Legislative Council: Explained attachments A.

Representative Kempenich: This isn't going to affect us for two years.

Jim Smith, Director, ND Legislative Council: This will affect your legislative pay for the 2017 regular session as well as the 2016 organization session.

Representative Kempenich: I don't like treating us like other employees because we're not.

Representative Skarphol: The same thing applies to the state employees.

Representative Kempenich: They'll realize the increases or decreases.

Representative Skarphol: The first of July the change in the compensation takes place.

Representative Kempenich: I'm arguing about the \$211, 287.00.

Representative Skarphol: I don't disagree with Representative Kempenich that we are different than state employees.

Representative Glassheim: I think the point of this was to depoliticize this.

Chairman Thoreson: If you're up for re-election the next year, it's hard to vote yourself a pay increase.

Representative Skarphol: I didn't do this to make that motion; but I wanted it to happen in a clear environment so we could understand what needs to move across on the rest of the budget. I'd like Adam to do it on the council as well.

Adam Mathiak: Explained attachment B.

Chairman Thoreson: Exactly \$312,000.00?

Adam Mathiak: \$312,460.00.00

Adam Mathiak continued with his explanation.

Chairman Thoreson: So we would move across something that isn't there.

Adam Mathiak: Correct. Since you have been pulling out the market equity payments, there would have to be a reduction in this case.

Representative Vigesaa: Why was it combined in the base on this budget and not on others?

Adam Mathiak: Offhand I'm not sure.

Representative Glassheim: It's not in the base payroll changes; where is it at?

Adam Mathiak: It's in the \$12,487 million.

Representative Kempenich: Why do we have \$1.00 there?

Adam Mathiak: Sometimes the way IBARS calculates things, there end up being some rounding discrepancies.

Representative Kempenich: We have to move the dollar also?

Adam Mathiak: That's correct.

Jim Smith: That relates to NCOIL out of the insurance regulatory trust fund.

Representative Skarphol: Are you familiar with the remodeling work that the supreme court's talking about doing in the judicial wing?

Jim Smith: You referenced that at our work session awhile back.

Representative Skarphol: Those renovations are primarily to Brynhild Haudland? Then you talked about carpet and the press room?

Jim Smith: Those are the 2 or 3 main areas that we would look at doing.

Representative Skarphol: As far as technology, all the meeting rooms have the technological upgrades that we were anticipating?

Jim Smith: In this room we would look at bearing some of these rooms. The other issue is speakers in committee rooms. The Harvest and Roughrider have speakers in the ceiling as well as the Prairie Room and the Missouri River Room we did some upgrades.

Chairman Thoreson: In this room we can hear ok.

Jim Smith: We'd look at having speakers in the ceiling.

Chairman Thoreson: As for the bearing wires, if that's possible, that's good.

Representative Skarphol: As far as the chambers, to the best of your knowledge, both of them are upgraded to the level that you're anticipating for now?

Jim Smith: We replaced the sound systems. In the Senate there's a closet that houses some of the computer systems. I mentioned the possibility of upgrading the carpet as well as chairs.

Chairman Thoreson: I came here in 1999 and I think the chairs were new or maybe one session old then.

Representative Skarphol: Do you know what the fire code is for the Brynhild Haugland room is? Mr. Boyle told me it was 49 people and we've had as high as 170.

Jim Smith: I've never heard reference to the fire code. There's no posted maximum occupancy.

Representative Hogan: On the assembly budget the increased funding for monthly lodging expenses; in most budgets would that just be part of the routine operating but because of the unique characteristics of the assembly it has its own line item?

Jim Smith: The other significance is the cost. It's a calculated statutory formula and what this number represents is the expected increase two years from now.

Representative Hogan: We may want to move those over like the rest of those.

Adam Mathiak: I did ask Sheila Sandness about the \$100,000.00 decrease related to market performance. She said that the 2013-2015 biennium it was not identified as one time; and that Senator Holmberg had approved it to be included in the 2015-2017 base level amount.

Adam Mathiak continued with his presentation.

Chairman Thoreson: What were the office improvements for \$50,000.00? Was that general upgrades or replacement of some things?

Jim Smith: The \$30,000.00 was for replacing a copier and the \$50,000.00 was for replacing desks, etc.

Chairman Thoreson: It's just general upkeep for things.

Jim Smith: Yes. I mentioned the new office space that we remodeled. Four or five offices just have the old style desks and we've gone to more of a contemporary desk.

Chairman Thoreson: Are some of those empty and not being used?

Jim Smith: We use them all during the session.

Representative Glassheim: Aren't these one-time things normally in everyone's budget?

Jim Smith: Relative to the computer replacement; we only do that every four years. We wouldn't want them to be part of our base two years from now.

Representative Glassheim: I don't remember seeing line items for computer replacements; everyone is on a four year replacement cycle.

Lori Laschkewitsch, Fiscal Analyst, ND Office of Management and Budget: The reason you don't see that as one time in most budgets is that they only replace 50% of computers at one time.

Jim Smith: We would advise that we never get into a situation where we're replacing half the computers every biennium.

Chairman Thoreson: You do twice the work for half the replacement.

Adam Mathiak continued with his presentation.

Chairman Thoreson: We would have to move those over on page 2 also?

Adam Mathiak: Yes,

Representative Boehning: In the budget for the CSG event coming up this summer; do we have anything in the budget?

Chairman Thoreson: It's under the one time funding for \$350,000.00.

Representative Boehning: That's the payment for the CSG to get them here; do we have any extra money for all the legislators to attend in here?

Jim Smith: We've budgeted for 110 legislators to attend the conference in July in Bismarck. That's in addition to the \$350,000.00

Chairman Thoreson: Is that where you still have to get approval from legislative management or is it anyone who wishes to attend can?

Jim Smith: Both. I'm working with Senator Holmberg to set up an allocation of the 110. The House Republicans would have 55 slots.

Chairman Thoreson: It would be my hope that anyone that wished to attend could.

Representative Boehning: I would like to see the whole 141 put in there.

Chairman Thoreson: You're saying the 110 based on an estimate. You're thinking that's the top number?

Jim Smith: That's 10 more than we had in Fargo. That's not an absolute limit.

Chairman Thoreson: If you hit the 110 or the dollar amount for that and some others would like to attend you'd be able to find the money for that?

Jim Smith: We would accommodate that.

Chairman Thoreson: That's in mid-July sometime?

Jim Smith: The 12th-15th.

Representative Skarphol: On the green sheet for legislative council, I'm confused by the top box where it says other funds. Why is there \$70,000.00 in other funds? That wasn't money coming was it; wasn't it an expenditure and why would it be in that box?

Jim Smith: That's the money we budget for NCOIL activities from the insurance regulatory trust fund. What was in the budget last biennium was the 69,999.00; that's the rounding issue. Now we're asking in our appropriation for \$70,000.00.

Representative Skarphol: I didn't realize it's revenue; isn't it an expenditure?

Jim Smith: It's both. We need the authority to spend from that special fund.

Representative Skarphol: Where are the special fund dollars coming from? Is that coming out of the insurance department?

Jim Smith: The insurance regulatory trust fund.

Representative Vigesaa: The \$500,000.00 for the renovations on the assembly budget; you have a carryover from this current biennium. Is that included in the \$500,000.00 or would that be added to what you're going to carry over?

Jim Smith: The carryover that we have from legislative wing improvements would be in addition to this \$500,000.00

Representative Vigesaa: What is the likelihood that it could be expended in the next biennium? That's going to be between \$700,000.00 and \$800,000.00 total.

Jim Smith: Not too likely. The reason for the carryover is due to unexpected things that come up. One of those could be a special session. We'd either need an additional appropriation or we'd need to use carryover. There are some uncertainties that we could be faced with.

Representative Skarphol: Do you have full transfer capability between line items?

Jim Smith: Yes we do. On page 1 of the bill it appropriates money for the 64th and 65th legislative session.

Representative Kempenich: Why do we have an emergency measure on the bill?

Jim Smith: It allows us that flexibility if we need to make some payments before July 1st.

Chairman Thoreson: I can't remember if our bills carried an emergency clause previously.

Jim Smith: It has.

Representative Hogan: In this biennium's budget we had \$250,000.00 for studies for education and higher education. You don't have anything budgeted in studies; will that come later?

Jim Smith: Last interim we had some special funding money for the higher education committee as well as the education finance funding committee. Some of that money was spent; but, in addition to that we have other un-earmarked study funds for \$300,000.00 in the budget.

Representative Hogan: Where would that be?

Jim Smith: There's a total of \$315,000.00 for professional services and that includes \$300,000.00 for these consulting services that we might need for interim committees; and then \$6,000.00 for the audit of our office and \$9,000.00 for an audit by the state auditor's office.

Representative Kempenich: Is the compensation 4% and 3% with the 1%?

Jim Smith: We ran this by the legislative procedure and arrangements committee and at that time we had no idea what the governor's budget recommendation was going to be.

Representative Glassheim: That means the employees are really getting 3% and 2%?

Representative Kempenich: They're getting 3% and 3%.

Representative Glassheim: I wonder if we should take out the \$500,000.00 for updating our committee rooms; and then if the forecast in March is more positive, we can put it back in.

Representative Skarphol: We have to allow to legislative council and legislative management some flexibility in the event of a special session or an unusual expenditure.

Representative Glassheim: When you have a line item for a specific purpose I understand you have flexibility to move it.

Representative Skarphol: I want to add some money to this budget and not subtract. I'd like to see every legislator attend two conferences during the interim.

Jim Smith: At our last hearing Allan responded to your question saying there was a certain amount in our budget for out of state travel for legislators. The amount is \$1.259 million and that includes out of state travel, registration fees, the per diem, hotels and airfare.

Representative Skarphol: What do you envision the number of legislators traveling would be? How many legislators attend a conference with \$1.2 million?

Jim Smith: What we do is we take each of the major meetings that we identify and we come up with an estimate of the numbers of legislators that might attend and try to project the cost.

Representative Skarphol: If we belong to an entity such as the energy producing states, Representative Wardner and I are the only ones that attended the meetings. Any legislator should be able to attend two. If we were to authorize, how much money would it take?

Jim Smith: If you look at the \$1.3 million; it's \$8,900.00 for every legislator for the biennium. When we talked about the status of our budgets and how we're having some projected turn back one of the major items is the savings that we have in out of state travel for legislators.

Representative Skarphol: Part of what I'm trying to get at is that I understand management likes to control who goes. I think legislators that want to go to conferences should have some options available to go to a conference if they so desire. If we want to do the right thing, we could double the amount of money you have and then we'd have both options available. I would make that motion to put some additional money in the budget.

Representative Kempenich: If you're going to double it, it would be \$2.6 million.

Representative Skarphol: I don't necessarily think we need to double it; I think some number short of doubling it would be fine.

Chairman Thoreson: If you have a number or if you want to wait to have an amended drafted, we can do that.

Representative Skarphol: Let's just do \$2.1 million.

Jim Smith: Are you talking \$2.1 million in total or additional?

Chairman Thoreson: In total.

Representative Kempenich: Would you need to increase the fees and professional services also?

Jim Smith: That would be budgeted in operating; professional services would be separate. The pay would be in salaries and the travel would be in operating expense.

Representative Boehning: We'll have to correct the compensation from 4% and 3% to 3% and 3%.

Lori Laschkewitsch: I believe there's a question about the compensation. The executive recommendation included a 4% and 4% salary increase with the 1% retirement the first year of the biennium.

Chairman Thoreson: It was a 4% and 4% to really a 4% minus 1% plus 4%.

Lori Laschkewitsch: Right. There's some confusion about the retirement being 1% by the employee and 1% by the employer. By removing the retirement out of the first year, there will be no retirement payment by anyone. Changing the first year to 3% would be no change, however reducing the second year to 3% is a 1% reduction.

Chairman Thoreson: The 1% was in the first year and the second year was just a full 4% increase.

Lori Laschkewitsch: Correct.

Representative Glassheim: So we're going from 4% to 2%?

Lori Laschkewitsch: We're going from 4% to 3%.

Representative Skarphol: Can you put something on a piece of paper that would help me understand what we're getting at here?

Lori Laschkewitsch: We can do that.

Representative Boehning: I'm a little confused on the 1%. I'm not sure exactly when the 1% for the increase in retirement starts; does that start the first year vs the budget cycle?

Lori Laschkewitsch: The biennium starts on July 1st and the retirement increase would have gone into effect in January of 2016.

Representative Boehning: So we're looking at .5% and .5%.



Lori Laschkewitsch: That's correct.

Chairman Thoreson: Closed the discussion.

Chairman Thoreson: Opened the discussion on HB1001.

Representative Vigesaa: That \$350,000.00 for CSG will be offset by whatever funding is obtained from industry?

Allan Knudson, Fiscal Analyst, ND Legislative Council: Correct. The national CSG does provide some funding that's considered in the budget for CSG. In addition, there's a committee set up in state to raise money. The total amount we need from instate is the \$350,000.00; so whatever they raise will reduce the amount of the \$350,000.00 we need to provide.

Representative Vigesaa: Do you know what's usually raised through that effort and what the net might be to the state?

Allan Knudson: No. Jim has those numbers.

Representative Vigesaa: I'd like to not move over the \$500,000.00 for committee room renovations for this biennium. Then we'd be making a very meaningful reduction on this particular budget.

Representative Vigesaa: Made a motion to adopt the further amending the \$500,000.00 out on the renovations.

Representative Boehning: Seconded the motion.

The motion carried.

Allan Knudson: We had discussion at your last meeting about adding \$800,000.00 for out of state travel for legislators.

Representative Skarphol: I'm going to take that up in full committee.

Representative Vigesaa: The office equipment replacement; that was going to be one large copy machine that was going to be purchased.

Allan Knudson: Correct.

Representative Vigesaa: It's cheaper to buy rather than lease?

Allan Knudson: There's a comparison that we do between leasing vs buying. We did lease about 10 years; but lately it's been more efficient to buy.

Representative Vigesaa: The office improvements; could you remind us what the \$50,000.00 was?

Allan Knudson: Over the last couple of bienniums we've been upgrading the office furniture, desks and shelves.

Vice Chairman Brandenburg: On the desktop computers and the IPad replacement; the \$135,000.00, could you explain?

Allan Knudson: In the assembly budget there's money to replace the computers and IPads for legislators and staff.

Vice Chairman Brandenburg: It's actually computers?

Allan Knudson: Yes.

Chairman Thoreson: Does that cost just include legislators or also some other computers in the assembly?

Allan Knudson: It's for more than legislator's it's for the staff during the session as well; the computers the committee clerks will be using next session.

Chairman Thoreson: There was a question as to how much per legislator was being budgeted for a laptop and IPad.

Allan Knudson: We do have those numbers, I don't have them with me.

Chairman Thoreson: We might want that when we go to the full committee.

Vice Chairman Brandenburg: We had that conversation that computers were on a 4 year replacement and we're on the third year and if we go past the 4 years it ends up costing us more.

Allan Knudson: Our IT staff talked about that and they're under warranty for the four year period so after the four years they're no longer under warranty.

Vice Chairman Brandenburg: It just costs more.

Representative Skarphol: Obviously there's some new technology computers and some look to me like they'd provide the advantages of both in one device. Why wouldn't we ask if a legislator wants both?

Allan Knudson: Our IT staff would be much better to speak about this than I am. I know when we move forward with the replacement there will be a legislative committee involved in the determination of what's chosen. I don't know if the staff in coming up with this proposal looked at the idea of just buying one device or having one or the other.

Representative Skarphol: I'm assuming that this purchase won't take place until early 2016?

Allan Knudson: Right.

Representative Boehning: In the office improvements; how much carry over is left?

Allan Knudson: In regard to the \$50,000? I believe by the end of the biennium all of that will be spent.

Representative Vigesaa: Does the money that's received when you sell the old laptops; does that offset your budget or is that in a different area?

Allan Knudson: That's surplus property we transfer the laptops to and then they receive those funds when they sell them.

Representative Vigesaa: Made a motion to move the amendments.

Explanation or reason for introduction of bill/resolution:

A bill providing an appropriation for defraying the expenses of the legislative branch of state government; relating to legislative compensation; and to declare an emergency.

Minutes:

Proposed amendments #1, 2

Representative Vigesaa: Distributed proposed amendments .01002. See attachment #1. Explained the amendments. This is a budget for the legislative assembly and legislative council. They are divided into two sections on the bill. In the assembly there are no full time employees and the only thing we removed \$500,000 from the capital assets line which was for renovations to the legislative wing. The project they are looking at is the Brynhild Haugland renovation but at this point we felt we needed to take out that \$500,000 to show some effort to reduce the numbers. There's a significant amount of one-time spending in the legislative assembly section of this budget. Without the one-time spending the increase is 7.3% over last time. Explained page 5 to the committee. There's an increase in the monthly lodging for next session.

Chairman Jeff Delzer: Where did they expect that to be?

Representative Vigesaa: They expect the monthly lodging for next session to be \$1,680.

Chairman Jeff Delzer: 75% of the federal rate?

Representative Vigesaa: I'm assuming they kept that the same. \$603,050 is for upgrading our laptops and iPad; they are on a four year cycle and once the four year cycle ends the service contract also ends and there are issues then with hardware then. They felt strongly that they needed to remain on that four year cycle. There is \$191,760 for upgrades to the Legend program. There is \$350,000 for the CSG Midwest Conference being held in Bismarck in July. There is a fundraising committee that is looking to raise funds from within and outside the state and any monies taken in will offset that amount.

Chairman Delzer: So you didn't give them any authority for special funds on top of that if they happen to raise more than that?

Representative Vigesaa: On the bottom it states what the daily session pay, monthly session pay, and monthly compensation goes to in the next two years based on the three and three.

Chairman Delzer: I see we are funding Legend upgrades, not necessarily Legend improvements. I wish it was the other way around.

Representative Vigesaa: On page 6 it refers to the Legislative Council. The cost to continue is greatly reduced with ongoing information technology, data processing, and professional services all decreased from last time. In this section of the budget it has the legislative travel and the per diem which shows the increases they are expecting for the next biennium. They need a new copier for \$30,000; we asked them about leasing rather than buying but they found it was better to purchase the copier. The one-time IT is also for new computers, iPad, and laptops at \$50,000. For Legislative Council that is a 4.2% increase over the base.

Representative Vigesaa: Motioned to move the amendment .01002.

Representative Skarphol: Seconded

Chairman Delzer: Did we get into the number for 75% of the legislators for the Midwest and probably the same numbers for all of the other conferences we've had in the past?

Representative Vigesaa: Yes. They went back and looked at the history to see how many people attended those conferences and used those same percentages going forward.

Voice vote: Motion carries.

Representative Skarphol: Distributed amendment .01005 and explained it. See attached proposed amendments #2. I feel legislators are elected to serve their constituents and part of that service is dependent on them being as familiar as they can with the issues. In that capacity I've learned a great deal in networking with legislators from other states. Although there is money in the budget and we didn't change anything in the budget with going to conferences, amendment 1005 proposes to allow a legislator in their first term to attend one conference of their choice and any legislator in their second term or more to allow them to attend two conferences of their choice during an interim. It doesn't take away the ability of leadership to pick the people they want to go to different conferences. I realize it's an increase in cost but I think it's something we need to discuss occasionally and that's why I brought it forward. It's estimated to cost \$743,000 and that's based on an average number of first term legislators then after that it's \$2,850 per year for the number of legislators that would qualify under this category.

Chairman Jeff Delzer: Is that over and above what is currently in the budget; you're just adding that on to the current numbers?

Representative Skarphol: That's correct.

Chairman Jeff Delzer: \$743,000?

Representative Skarphol: That's correct.

Chairman Delzer: Does it name the conferences; is it limited to what we're talking about with the organizations that the other travel is for because they are basically limited too?

Representative Skarphol: I did not limit it because while we have money in the budget for energy producing states we do not pay any dues or anything to that organization and I wouldn't want to prohibit anyone from going to that one because it is a valuable resource in communicating with other energy states. I'm not sure we should select the conference; as long as it appears to be legitimate and council agrees.

Chairman Jeff Delzer: Do you have this limited to so many dollars per legislator?

Representative Skarphol: I allowed Legislative Council to make that estimate of dollars; we didn't discuss the incredible costs that could be incurred. I would assume to make that selection there would be an evaluation.

Chairman Jeff Delzer: What about the idea of them being able to pick two of their own and still possibly go to two or three of the current ones?

Representative Skarphol: If leadership felt that was appropriate but leadership has the option of deciding.

Chairman Jeff Delzer: Who has the ability to say yes or no to this?

Representative Skarphol: I would have no issue having it amended to give management the ability to say yes or no but they can't say no to someone who wants to go to a conference if they qualify and are under that maximum number.

Chairman Delzer: Somebody has to be able to approve it; is it going to be the Chairman of the Legislative Management Committee the way it is for others?

Representative Skarphol: I would ask council if there was anything in the existing statute or rules that would give us guidance.

Allen Knudson, Legislative Council: The Legislative Management Chairman approves them working with all the other leaders to determine who goes to which conference. I would assume that would be handled in a similar manner. Longest serving legislators would get \$2,850 each year for two years and \$2,850 for the biennium for first term legislators. We would just do it similar to this unless we get different direction.

Representative Thoreson: I believe now if travel takes place you do need to turn in receipts and a form to complete post travel explaining what the conference was and what was learned there. There is a level of identification as to whether you attended and what the issues were so if someone were to question the event it would be documented.

Representative Monson: Your intention is a minimum; one for new legislation and two conferences for veteran legislators so there could be two or three if they were appointed to something?

Representative Skarphol: That would be correct but we wouldn't require anyone to go.

Chairman Jeff Delzer: That's the question. The way you have it worded its wide open with a minimum of two. The way I see it in the amendment it's just a dollar figure. I don't think there's any language limiting that.

Representative Skarphol: My intent was that they could go to two. **Motion made to approve amendment .01005.**

Representative Thoreson: Seconded.

Chairman Jeff Delzer: I understand the purpose of it but I think we have quite a bit of travel in there. I don't know how many have requested but have been turned down. It's an additional amount of \$743,000. What was the current amount?

Representative Vigesaa: Travel increase was \$84,000.

Allen Knudson: Currently for out of state it is \$1,250,000.

Chairman Jeff Delzer: The Midwest would be considered in state?

Allen Knudson: That would be part of out of state. The other is the interim committee travel and that's about \$1,550,000.

Chairman Delzer: That's eight meetings for almost every interim committee?

Allen Knudson: We have a budget for seven meetings.

Representative Skarphol: Allen, how much out of state travel has been used?

Representative Nelson: Representative Skarphol, this is an interesting concept and I think it has some validity but given the fact that we have the Midwest Conference in Bismarck this year how does that relate to the people going as delegates but I'm assuming the rest of us are encouraged to attend that conference.

Chairman Delzer: They are planning on 75% of the sitting legislators going to that conference.

Representative Nelson: Would that count in your quota system?

Chairman Delzer: The money is in there for that.

Allen Knudson: We budget \$1.7 million and we spent about \$1,350,000.

Chairman Jeff Delzer: People would have to ask for this. Leadership should make sure and fill all the spots but I think in some ways it's meant to be asked for already.

Representative Skarphol: Some people don't' feel they should have to ask.

Chairman Jeff Delzer: I understand. This is only for two years, correct?

Allen Knudson: Correct.

Representative Silbernagel: Would this include the Williston Basin Petroleum Council? That rotates between Bismarck and Regina. That's a great event but it's an international event so how does that fit in?

Representative Skarphol: It's a choice you can make as a legislator. This provides you with options.

Chairman Jeff Delzer: Seems pretty generous. This is a pretty major issue because it changes things a lot. When we do this and if it's wide open you're going to have things asked for that politically somebody else is going to object to so how do we handle that?

Representative Skarphol: If I want to go to a specific meeting then why shouldn't I be able to go just because somebody else doesn't approve?

Chairman Delzer: It's going to happen. There will be instances when its questioned as to the value to the citizens.

Representative Thoreson: I think that's where I was going with the idea to file some paperwork afterwards as we do now. If we have a transparent processes where we put down where we went and how much we spent so if someone has an issue with that they could go to Legislative Council and get a copy of the report. If dollars are spent and we go to a meeting at least we'll know where it is.

Chairman Jeff Delzer: There currently are opportunities for people to go to some meetings that are not on any of the national lists; sometimes you're invited from your positions or past service.

Representative Skarphol: There have been times in my tenure that I've been appointed to committees and I didn't go to the meeting because I didn't know I could or should. I think I asked once and they didn't send me. Leadership has the ability to set the amount of money they want to spend on this.

Representative Monson: Have we ever paid anybody's expenses to go to ALEC?

Chairman Jeff Delzer: No. This would be wide open that you could pick whichever one you wanted to go to but you should be smart enough to pick something you can justify to your citizens.

Representative Skarphol: There would be nothing to prevent a legislator from going to the National Governor's Association meeting. The options are open so you could pick something that wouldn't typically qualify.

Chairman Delzer: I think we'll do a roll call vote on this because we'll want to have an idea if we take this to the floor what kind of support or non-support we have.

Roll call vote for motion to further amend 1001 with amendment 1005 which is the same as 1002 with an additional \$743,000 for travel: 9 YES 12 NO 2 ABSENT MOTION FAILED

54-03-20. Compensation and expense reimbursement of members of the legislative assembly.

- 1. Each member of the legislative assembly is entitled to receive as compensation for services the sum of one hundred seventy-twoseventy-seven dollars for each calendar day during any organizational, special, or regular legislative session and for each day that member attends a meeting of a legislative committee between the organizational session and the regular session as authorized by legislative rule.
- 2. a. Each member of the legislative assembly is entitled to receive reimbursement for lodging, which may not exceed per calendar month the amount established under this subdivision by the director of the office of management and budget for lodging in state and which may not exceed the rate provided in section 44-08-04 for each calendar day during the period of any organizational, special, or regular session. On August first of each even-numbered year, the director of the office of management and budget shall set the maximum monthly reimbursement for the subsequent two-year period at an amount equal to thirty times seventy percent of the daily lodging reimbursement in effect on that date as provided under subdivision d of subsection 2 of section 44-08-04.
 - b. Notwithstanding subdivision a:
 - (1) A member of the legislative assembly may elect to be reimbursed for less than the amount to which the legislator is entitled under this subsection by claiming the lesser amount on a voucher submitted with the receipt required by section 44-08-04.
 - (2) The legislative management may establish guidelines that may result in a reduced maximum reimbursement for a single dwelling in which two or more legislators share lodging and the total rent for that dwelling exceeds the amount to which a legislator is entitled under subdivision a.
- 3. a. Members of the legislative assembly who receive reimbursement for lodging are also entitled to reimbursement for travel for not to exceed one round trip taken during any calendar week, or portion of a week, the legislative assembly is in session, between their residences and the place of meeting of the legislative assembly, at the rate provided for state employees with the additional limitation that reimbursement for travel by common carrier may be only at the cost of coach fare and may not exceed one and one-half times the amount the member would be entitled to receive as mileage reimbursement for travel by motor vehicle.
 - b. A member of the legislative assembly who does not receive reimbursement for lodging and whose place of residence in the legislative district that the member represents is not within the city of Bismarck is entitled to reimbursement at the rate provided for state employees for necessary travel for not to exceed one round trip taken per day between the residence and the place of meeting of the legislative assembly when it is in session and may receive

reimbursement for lodging at the place of meeting of the legislative assembly as provided in section 44-08-04 for each calendar day for which round trip travel reimbursement is not claimed, provided that the total reimbursement may not exceed the maximum monthly reimbursement allowed under subdivision a of subsection 2.

- 4. The amount to which each legislator is entitled must be paid following the organizational session in December and following each month during a regular or special session.
- 5. If during a special session, the legislative assembly adjourns for more than three days, a member of the legislative assembly is entitled to receive compensation during those days only while in attendance at a standing committee if the legislator is a member of that committee, a majority or minority leader, or a legislator who is not on that committee but who has the approval of a majority or minority leader to attend.
- 6. A day, or portion of a day, spent in traveling to or returning from an organizational, special, or regular session or a legislative committee meeting must be included as a calendar day during a legislative session or as a day of a legislative committee meeting for the purposes of this section.
- 7. a. In addition, each member is entitled to receive during the term for which the member was elected, as compensation for the execution of public duties during the biennium, the sum of four hundred eighty-eneninety-five dollars a month, paid monthly.
 - b. If a member dies or resigns from office during the member's term, the member may be paid only the allowances provided for in this section for the period for which the member was actually a member.
 - c. The majority and minority leaders of the house and senate and the chairman of the legislative management, if the chairman is not a majority or minority leader, are each entitled to receive as compensation, in addition to any other compensation or expense reimbursement provided by law, the sum of three hundred fortyfive fifty-five dollars per month during the biennium for their execution of public duties.
- 8. Attendance at any organizational, special, or regular session of the legislative assembly by any member is a conclusive presumption of entitlement as set out in this section and compensation and expense allowances must be excluded from gross income for income tax purposes to the extent permitted for federal income tax purposes under section 127 of the Economic Recovery Tax Act of 1981 [Pub. L. 97-34; 95 Stat. 202; 26 U.S.C. 162(i)].
- Before each regular legislative session, the legislative management shall make recommendations and submit any necessary legislation to adjust legislative compensation amounts."

Each member of the legislative assembly is entitled to receive reimbursement for lodging, which may not exceed per calendar month the amount established under this subdivision by the director of the office of management and budget for lodging in state and which may not exceed the rate provided in section 44-08-04 for each calendar day during the period of any organizational, special, or regular session. On August first of each even-numbered year, the director of the office of management and budget shall set the maximum monthly reimbursement for the subsequent two-year period at an amount equal to thirty times seventy percent of the daily lodging reimbursement in effect on that date as provided under subdivision d of subsection 2 of section 44-08-04.
 - b. Notwithstanding subdivision a:
 - (1) A member of the legislative assembly may elect to be reimbursed for less than the amount to which the legislator is entitled under this subsection by claiming the lesser amount on a voucher submitted with the receipt required by section 44-08-04.
 - (2) The legislative management may establish guidelines that may result in a reduced maximum reimbursement for a single dwelling in which two or more legislators share lodging and the total rent for that dwelling exceeds the amount to which a legislator is entitled under subdivision a.
- 3. a. Members of the legislative assembly who receive reimbursement for lodging are also entitled to reimbursement for travel for not to exceed one round trip taken during any calendar week, or portion of a week, the legislative assembly is in session, between their residences and the place of meeting of the legislative assembly, at the rate provided for state employees with the additional limitation that reimbursement for travel by common carrier may be only at the cost of coach fare and may not exceed one and one-half times the amount the member would be entitled to receive as mileage reimbursement for travel by motor vehicle.
 - b. A member of the legislative assembly who does not receive reimbursement for lodging and whose place of residence in the legislative district that the member represents is not within the city of Bismarck is entitled to reimbursement at the rate provided for state employees for necessary travel for not to exceed one round trip taken per day between the residence and the place of meeting of the legislative assembly when it is in session and may receive

reimbursement for lodging at the place of meeting of the legislative assembly as provided in section 44-08-04 for each calendar day for which round trip travel reimbursement is not claimed, provided that the total reimbursement may not exceed the maximum monthly reimbursement allowed under subdivision a of subsection 2.

- 4. The amount to which each legislator is entitled must be paid following the organizational session in December and following each month during a regular or special session.
- 5. If during a special session, the legislative assembly adjourns for more than three days, a member of the legislative assembly is entitled to receive compensation during those days only while in attendance at a standing committee if the legislator is a member of that committee, a majority or minority leader, or a legislator who is not on that committee but who has the approval of a majority or minority leader to attend.
- 6. A day, or portion of a day, spent in traveling to or returning from an organizational, special, or regular session or a legislative committee meeting must be included as a calendar day during a legislative session or as a day of a legislative committee meeting for the purposes of this section.
- 7. a. In addition, each member is entitled to receive during the term for which the member was elected, as compensation for the execution of public duties during the biennium, the sum of four hundred eighty-oneninety-five dollars a month, paid monthly.
 - b. If a member dies or resigns from office during the member's term, the member may be paid only the allowances provided for in this section for the period for which the member was actually a member.
 - c. The majority and minority leaders of the house and senate and the chairman of the legislative management, if the chairman is not a majority or minority leader, are each entitled to receive as compensation, in addition to any other compensation or expense reimbursement provided by law, the sum of three hundred fortyfive fifty-five dollars per month during the biennium for their execution of public duties.
- 8. Attendance at any organizational, special, or regular session of the legislative assembly by any member is a conclusive presumption of entitlement as set out in this section and compensation and expense allowances must be excluded from gross income for income tax purposes to the extent permitted for federal income tax purposes under section 127 of the Economic Recovery Tax Act of 1981 [Pub. L. 97-34; 95 Stat. 202; 26 U.S.C. 162(i)].
- Before each regular legislative session, the legislative management shall make recommendations and submit any necessary legislation to adjust legislative compensation amounts."

On August first of each even-numbered year, the director of the office of management and budget shall set the maximum monthly reimbursement for the subsequent two-year period at an amount equal to thirty times seventy percent of the daily lodging reimbursement in effect on that date as provided under subdivision d of subsection 2 of section 44-08-04.
 - b. Notwithstanding subdivision a:
 - (1) A member of the legislative assembly may elect to be reimbursed for less than the amount to which the legislator is entitled under this subsection by claiming the lesser amount on a voucher submitted with the receipt required by section 44-08-04.
 - (2) The legislative management may establish guidelines that may result in a reduced maximum reimbursement for a single dwelling in which two or more legislators share lodging and the total rent for that dwelling exceeds the amount to which a legislator is entitled under subdivision a.
- 3. a. Members of the legislative assembly who receive reimbursement for lodging are also entitled to reimbursement for travel for not to exceed one round trip taken during any calendar week, or portion of a week, the legislative assembly is in session, between their residences and the place of meeting of the legislative assembly, at the rate provided for state employees with the additional limitation that reimbursement for travel by common carrier may be only at the cost of coach fare and may not exceed one and one-half times the amount the member would be entitled to receive as mileage reimbursement for travel by motor vehicle.
 - b. A member of the legislative assembly who does not receive reimbursement for lodging and whose place of residence in the legislative district that the member represents is not within the city of Bismarck is entitled to reimbursement at the rate provided for state employees for necessary travel for not to exceed one round trip taken per day between the residence and the place of meeting of the legislative assembly when it is in session and may receive reimbursement for lodging at the place of meeting of the legislative assembly as provided in section 44-08-04 for each calendar day for which round trip travel reimbursement is not claimed, provided that the total reimbursement may not exceed the maximum monthly reimbursement allowed under subdivision a of subsection 2.
- 4. The amount to which each legislator is entitled must be paid following the organizational session in December and following each month during a regular or special session.

- 7. a. In addition, each member is entitled to receive during the term for which the member was elected, as compensation for the execution of public duties during the biennium, the sum of four hundred eighty-oneninety-five dollars a month, paid monthly.
 - b. If a member dies or resigns from office during the member's term, the member may be paid only the allowances provided for in this section for the period for which the member was actually a member.
 - c. The majority and minority leaders of the house and senate and the chairman of the legislative management, if the chairman is not a majority or minority leader, are each entitled to receive as compensation, in addition to any other compensation or expense reimbursement provided by law, the sum of three hundred fortyfive fifty-five dollars per month during the biennium for their execution of public duties.
- 8. Attendance at any organizational, special, or regular session of the legislative assembly by any member is a conclusive presumption of entitlement as set out in this section and compensation and expense allowances must be excluded from gross income for income tax purposes to the extent permitted for federal income tax purposes under section 127 of the Economic Recovery Tax Act of 1981 [Pub. L. 97-34; 95 Stat. 202; 26 U.S.C. 162(i)].

Chairman Holmberg called the committee to order on Thursday, March 05, 2015, at 10:00 am in regards to HB 1001. All committee members were present. Sheila M. Sandness, Legislative Council, Becky Keller, OMB and Allen Knudson, Legislative Council were also present.

Jim Smith, Director of Legislative Council: Testified in favor of HB 1001 and provided written testimony attached # 1) Engrossed HB # 1001. (9.28)

Senator Mathern: I was disappointed to see that \$500,000 for capital projects. I think we have been making positive progress. I am wondering if we were to reinstate that \$500,000, how is it specifically determined which room. You were talking about the press studio but the actual room where the journalists are should really be upgraded so that they have proper tools in there. It is difficult for people to have staff here from these newspapers. If we had a better facility it would be helpful. Who makes those decisions if we were to get that \$500,000 back?

Mr. Smith: Basically the interim Legislative Procedure and Arrangements Committee have authority between sessions to deal with the preparations that are necessary to the upcoming session. We would take ideas to them for their approval. That would be in the list.

Senator Heckaman: There is \$214,000 left, do you need all the additional \$500,000, or are you looking just to supplement the difference between the two.

Mr. Smith: That is difficult to say; the history is that we have had \$500,000, so we don't have specific budgets for some of these upgrades. My personal opinion is we would need

all of the \$500,000. We do need some money for maintenance for things that come up expectedly. We had an issue in the Senate on Monday with the electrical panel; those things have to be updated. (He continued with his testimony regarding the appropriation.) Legislative Management and Legislative Council: Leg. Management is a 17 member committee that oversees our office, especially during the interim. The appropriation is just over \$13 million. Most of that is from the general fund. We are requesting the same number of employees, 37 FTE positions. The size of the interim committees was reduced. House bill 1199, 1015 and SB 2222 and 2012 are listed in his testimony they are related to the legislative branch. (19.38)

Chairman Holmberg: The mileage went down, it was 57.5 cents and now it's down to 56 cents. Is that an estimate?

Mr. Smith: The current rate is still 57½ cents per mile. We budgeted 56 cents/mile not knowing what is going to happen; it is subject to change by OMB, based on gas prices. The budget is based on 56 cents.

Senator Robinson: I want to commend you, you folks have done a great job, good people, great services, we are fortunate as a legislature to have your folks to work with.

Mr. Smith: We do have a lot of employees that put in a lot of time; we don't pay overtime. Hopefully the salaries reflect the demand that they have to put in during the session and other times. Some our support staff we do pay overtime.

Senator Robinson: The professional staff, regarding no overtime, are you in a position to provide some flexibility in terms of hours after the session? Are you able to do that?

Mr. Smith: We do that, except for 6 months; 2 months ahead of the session and 4 months of session. We try to provide some flexibility with comp time, holidays, at the end of the session we try to provide some comp days, it is done conservatively.

Chairman Holmberg: Anyone else is going to testify. Tell them about the new lpads and that kind of information.

Kyle Forester, IT Manager: For the Legislative Assembly, there is \$603,050 budgeted for computer and IPad replacement. We do a four year life cycle on your equipment. Your laptops have four year warranty on them. New equipment will be significantly better performing. Later this fall we will request that leadership identify a committee that will designate what new equipment we should need. Ultimately that committee decides what equipment the Assembly will get. This isn't just for legislators; it is for Assembly staff, clerks, and chamber staff have the exact same laptops as the legislators have. Basically the budget for the tablets or IPads will move from 32 gb to 64 gb memory. There is additional cost there, more electronic document access for legislators. We want to push testimony and legislative documents onto your devices. This is a little increase for hardware and software from the 2012 budget. You all have 17" laptops and weigh 8.5 lbs. So the committee has to decide what we want to do there.

Senator Mathern: Is there any thought to have dummy terminals for laptops, better notepads?

Mr. Forester: We talked about virtual terminals in the chambers. Some of the difficulty is you have to have the back-end infrastructure to support that. You are running on a server someplace. You legislators have a personal use fee; a lot of the membership expects a device you can take home. It would cost us more money, because of the infrastructure that we would need to put in place. If the legislators didn't have the personal use, then it might make sense?

Senator Mathern: What if we just did the personal use with the iPads?

Mr. Forester: That is an option. We did monitor during the last interim to see what usage was on the laptops and about 85-90 legislators regularly used their laptops at home. The usage was high.

Senator Kilzer: These phish warnings come out pretty often, could you comment on those.

Mr. Forester: Yes they are often. The state IT department manages that and basically the way it works, identity thieves are trying to get access to your account, those attacks are never going to stop. When we see them or they report them to us, we report it to the state IT department and they block the outside website in that link. If someone did click on it, they can't get to the site anymore. They also block the sender's email address so they can't come into the state. ITD is hoping to implement some new technology in about a month or so. They hope it will decrease the phishing emails that actually make it into the state email system.

Senator Wanzek: We get certain emails, we don't recognize, do we just delete it?

Mr. Forester: Yes. If it is a phishing email, you can send it to us and we can look at it.

V.Chairman Bowman: What is the total amount of money we are spending on this biennium for technology? Every budget seems like it is loaded with money for technology. Are we taking money away from other things that we could be using those funds for.

Mr. Forester: I do have those numbers.

Senator Robinson: One of the issues that have increased the size of the budget is years ago when we moved into ITD, we combined a lot of services, such as phone services, we put that all under technology. We can't compare apples to apples, going back 15 years. The services are growing, but we keep asking for more capacity, that drives the cost up.

V.Chairman Bowman: How much is technology costing us this biennium?

Mr. Forester: That comes into the full budget, 2013-15 for budget for assembly was \$1.8M. That includes continuing to have staff at the ITD Dept. We want to enhance the drafting systems, created a new bill tracking system, starting next week we are rolling a

mobile app to legislators. We are continuing to make improvements. The room improvements are done through the wing improvements fund. Part of it is equipment, server infrastructure, storage, a lot of components that goes into the IT budget.

V.Chairman Bowman: In Human Services there were a lot of big requests for money for these programs; this goes back many years ago, when they first introduced this technology and we were going to have a program that was going to cost us \$20 million and now up to \$60-\$70 million. Do we ever have a limit on how much we are going to spend so that we can take care of some of the other needs that we have that might be more important than another report getting out a day early?

Mr. Forester: When we put in our budget, which essentially is what is needed to support the Legislative Assembly and the Council for the next two years. We do have some money in there to continue to make enhancements to systems and software, but we are not on the same scale as Human Services.

V.Chairman Bowman: I use the service myself, I get reports and it's nice to get them when you want them, but I'm thinking about the overall budget and how many dollars we're spending now on technology for everything and how many budgets were short of money to really take care of people's needs.

Senator Robinson: It would be interesting to see an analysis of how the technology budget has grown, and yet we have almost no one in the bill room anymore. Paper products have to be way down. When I first got here, we had any number of Legislative Pages on the floor, so that is an offset.

Senator Sorvaag: During the interim, I know Leg Council was feeding us information electronically. I didn't need the piece of paper people were handing out. I got it off the IPad. Was there much feedback. I enjoyed not having the paper. Did many committees use it?

Mr. Smith: That is something we started during the last interim. It was successful. Some people prefer the paper, we are making progress.

Senator Sorvaag: That is nice to see, we'd like to see the session go electronic.

Mr. Smith: We'd like to get there as well. It's a work in progress.

V.Chairman Bowman: Thank you. Any other testimony on this bill? The hearing was closed on HB 1001.

Chairman Holmberg called the committee to order on Thursday, April 02, 2015, at 11:00 am. All committee members were present. Adam Mathiak, Legislative Council and Sheila Peterson and Nick Creamer, OMB were also present.

Chairman Holmberg presented amendment #15.8007. 02001 and explained what the amendments would do. It does not have any of the merit and it had no targeted equity money in it. It adjusts the premium for health insurance, which we have done in all the budgets, and it adds one time funding for committee room renovations. If you recall, the original budget from legislative council was to have \$500,000 but they do have some reserves they can do. I don't know the specifics on everything they are doing; they are looking at sound systems and lighting. They are looking at Brynhild Haugland room. They did get an agreement with facilities management regarding some electrical work they are going to be doing. Other changes in here, the accrued leave payment is something we did last time and it was put in to all budgets. Then it ran into truble, it couldn't be, and it was still in this budget so that was changed.

Adam Mathiak, Legislative Council: The accrued leave added by the legislative assembly last time to all the budgets. It was a separate line item. The governor vetoed a statement in the OMB bill at the end, based on the information that was provided that was determined that the accrued leave could be spent without being specifically subject to the requirement that it actually be accrued leave, it could be then spent as normal salaries and wages. (5.04)

Chairman Holmberg: This is the only budget that still had that line item in and they are putting it back in to salary and wages because that was the determination that is where it is was and that's where it should be.

Senator Mathern: Did we have the study here in the Senate?

Chairman Holmberg: That came from some legislators asked if we would consider putting this in here to look at the study. It is to study all kinds of bonding, to finance all kinds of projects. It came from Senator Laffin and someone else and they ask for your consideration. It is not a required study. It says shall.

Senator Mathern: We ought to actually be doing bonding when the economy is down. I don't know why we need a study. It was in the Moody's report. Every one suggests this when the economy is down.

Senator Kilzer: I have a question on the Council of State Government meeting this summer, there is a \$350,000 appropriation. Is that the only appropriation or are there other bills or other monies that will go into that?

Chairman Holmberg No. this is the only location of funding for that. Part of the reason it is there is because the host state encourages legislators to attend, registration fees are paid, we put in the budget an estimate of 110 legislators would attend, the registration fee is 3 or 4, I don't know the exact number. Not all of this money may be spent. There is a fund raising committee for this event that Senator Carlisle is head of. It would be great if they would raise money as some states do from all kinds of entities, corporation,, companies. The registration has to be spent, but none of the other has to be spent.

Senator Carlisle: We have about 70 entities in state and out of state, there will be some national folks that normally contribute. I am working in state, I've got 10,000, we'll have a little gift bag. Every dollar we raise goes against that too. In the next few days we will start making more personal calls. The bankers are in; the stockmen's are in; KLJ's in; and some are at \$2,500. That's what I have been pushing for instate. the REC's are putting together a package. That is what we are doing. We have a lot of corporate interest in this. We bank the money. 22 years ago we had it in Bismarck, 12 years ago we were in Fargo, we didn't have enough money, we want to do it right, so we want to raise the money. The figure will be less. (10.42)

Chairman Holmberg: We had to put this together. We had no idea how successful the fund raising would be. This appeared to be the number the committee agreed on.

Senator Carlisle: It was bipartisan. They did a motion and accepted it.

Chairman Holmberg It was put in the budget. OMB did not pass on it.

Chairman Holmberg: Could we have a motion on the amendment?

Senator O'Connell moved the amendment. 2nd by V. Chairman Krebsbach. A voice vote was taken. It passed. V. Chairman Krebsbach moved a do pass as amended. 2nd by Senator O'Connell.

If we do so much every two years, we're always going to have a nice facility to be proud of. If we wait two or three bienniums and we then we don't have the money to do it, then we're really in trouble.

Representative Thoreson: I think at some point we need to look at the space needs for the legislative assembly; especially with committee rooms. If you go into some of these committees, they're nice rooms but there's really never a case where it's not standing room only. At some point if there is a way to possible reconfigure some of those rooms to have some more space for the general public, or doing video.

Chairman Vigesaa: I want to point out one major project that was completed during this legislative session, there was a shield that was put over that particular cooling because Representative Brandenburg had to wear his coat during committee; it was so cold.

Senator Heckaman: In legislative procedures and arrangements or in the council is there a list of priorities of projects that need to be done? Has it been prioritized someplace along the way?

Chairman Vigesaa: Not to my knowledge. As a committee we have not set any priorities as far as projects.

Jim Smith, Director, ND Legislative Council: We work with legislative procedures and arrangements for all these kinds of improvements. We bring to the committee various projects that we see and get their approval; we don't have a list of things that haven't been completed other than the ones I've talked about in presentations to both appropriations committees. We develop a list at the start of the interim, bring it before the LP committee and decide how much work can be accomplished during an interim.

Chairman Vigesaa: Does anyone have any questions about the study that was added?

Representative Thoreson: Could we have some explanation by the Senate? I do notice that it is a mandatory study; not permissive language.

Senator Holmberg: I noticed that this was a mandatory study. If we were going to make any amendments to this bill I would support changing the language so that it gives legislative management the option; when you look at all the different studies that come in, rather than putting this particular one at the head of the line.

Representative Thoreson: So something like shall consider studying?

Senator Holmberg: Yes.

Chairman Vigesaa: Any questions about the study itself; what the goal is?

Representative Thoreson: We can read it and it may be worthwhile. I would be comfortable with the language otherwise.

Chairman Vigesaa: Any objections to agreeing with the Senate on the changes they made?

Representative Thoreson: I think I would like to see that change to make the study permissive language.

Chairman Vigesaa: See attachment A.

Senator Holmberg: You'll find the training that legislative council people get makes them a very valuable commodity to the headhunters that may be looking. I think this gives the director some flexibility that he needs to react to the market here.

Senator Holmberg: Made a motion that the Senate receded from its amendments and further amended to put in the Senate amendments plus the suggestion that it be a "consider" study and then add this amendment in.

Senator Bowman: Seconded the motion.








STATEMENT OF JIM W. SMITH, DIRECTOR, NORTH DAKOTA LEGISLATIVE COUNCIL, REGARDING HOUSE BILL NO. 1001, JANUARY 19, 2015

Mr. Chairman and members of the Government Operations Division of the House Appropriations Committee:

I am here this morning appearing on House Bill No. 1001 on behalf of the members of the Legislative Assembly and the members of the Legislative Management to explain the budget requests for the Legislative Assembly, the Legislative Management, and the Legislative Council for the 2015-17 biennium.

The budget requests for these agencies are prepared using zero-based budgeting, meaning all amounts requested are calculated from a starting point of zero.

The financial statements for the fiscal years ending June 30, 2013 and 2012, for the Legislative Assembly and Legislative Council had unqualified opinions. The Legislative Council had one finding in its 2012 financial statements relating to general ledger reconciliation. The finding was corrected.

LEGISLATIVE ASSEMBLY

Subdivision 1 of Section 1 of the bill contains the 2015-17 biennium appropriation for the Legislative Assembly of \$16,056,565 from the general fund. This amount includes \$1,644,810 of one-time funding requests. The Legislative Assembly "ongoing" request is \$14,411,755, an increase of \$1,187,784, or 9.0 percent more than the 2011-13 "ongoing" appropriation of \$13,223,971. The amount requested is considered necessary for the organizational session and a 77-legislative-day (111-calendar-day) regular 2017 legislative session. The following schedule presents the number of legislative days for previous sessions:

The Legislative Assembly in 2013 provided funding for an estimated 77-legislative-day 2015 legislative session.

Salaries and Wages

The salaries and wages line item of approximately \$10.2 million includes funding for:

- Legislative employees' pay for the 2017 legislative session based on the number of employees anticipated to be employed for the 2015 legislative session of 84 and compensation increases equivalent to a 4 percent first year and 3 percent second year increase.
- Legislators' salary of \$179 per day for a 77-legislative-day regular session (111 calendar days). This includes a 4 percent first year and 3 percent second year increase as provided for in Sections 6 and 7 (an estimated cost of \$211,287).
- Continuing the additional compensation of \$15 per calendar day for the legislative leaders and \$10 per calendar day for chairmen of the standing committees and assistant legislative leaders. These compensation rates were each increased by \$5 by the Legislative Assembly in 2011.
- Legislators' monthly compensation of \$486 per month for the first year of the biennium, a \$19, or 4 percent, per month increase and \$501 per month for the second year of the biennium, a \$15, or 3 percent, per month increase (an estimated cost of \$96,536). These increases are provided for in Sections 6 and 7.
- Additional monthly compensation for House and Senate majority and minority leaders of \$348 per month for the first year of the biennium, a \$13, or 4 percent, per month increase and \$358 per month for the second year of the biennium, a \$10, or 3 percent, per month increase (estimated cost of \$10,980). These increases are provided for in Sections 6 and 7.
- Health insurance coverage for 133 legislators, three more than the number budgeted for the 2013-15 biennium. Current information indicates that 133 legislators have requested health insurance.

Operating Expenses

The operating expenses line item of approximately \$5.0 million includes funding for:

 Legislators' travel costs for 16 trips at 56 cents per mile during the 2017 regular session and one trip for the 2016 organizational session. The mileage rate is currently 57.5 cents per mile

- Lodging costs for 127 legislators for four months during the 2017 legislative session at an estimated reimbursement rate of \$1,680 per month. The reimbursement rate for the 2015 legislative session is \$1,569. The budget includes an additional \$84,520 relating to lodging.
- Contribution of \$10,000 annually to the Legislator's Forum (Manitoba, Minnesota, North Dakota, and South Dakota).
- Ongoing information technology data processing of \$1,262,790, a decrease of \$10,850 compared to the 2013-15 biennium.
- Professional services of \$77,000, \$30,000 less than the 2013-15 biennium budget. The amount includes \$60,000 for the continued privatization of legislative secretarial, bill and journal, and telephone operations.
- One-time funding of \$191,760 for information technology consulting and software relating to LEGEND system upgrades.
- One-time funding of \$603,050 to replace legislator's laptops and iPads.

CSG Midwest Conference

The request includes one-time funding of \$350,000 for the CSG Midwest Conference to be held in Bismarck in July 2015. The Legislative Procedures and Arrangements Committee, Representative Al Carlson, Chairman, approved the following motion on September 24, 2014:

It was moved by Senator Wardner, seconded by Representative Onstad, and carried on a roll call vote that the committee support the inclusion of funding of \$350,000 in the Legislative Assembly budget request for the 2015-17 biennium in support of the 2015 Council of State Government's Midwestern Legislative Conference to be held in Bismarck in July 2015, with the expectation that the amount budgeted will be reduced by any additional funds that are raised. Representatives Carlson, Devlin, Mock, Onstad, and Vigesaa and Senators Heckaman, Holmberg, Schneider, and Wardner voted "aye." No negative votes were cast.

Attached as Appendix A is a copy of a) a letter; b) supporting budget information; and c) the 2015 Host Team from Senator Tim Flakoll, chair, 2015 Midwestern Legislative Conference, explaining and supporting the request, Senator Ron Carlisle is the chair of the fundraising team which has identified 62 potential sponsors. Contracts have been entered into for major speeches and events.

Capital Assets

The capital assets line item of \$516,800 includes one-time funding of \$500,000 for continuing legislative wing improvements. Areas of possible use include Brynhild Haugland Room upgrade, press studio upgrade, committee room sound upgrades, chamber improvements, and other renovations.

National Conference of State Legislatures

The National Conference of State Legislatures (NCSL) line item of \$241,263 is an increase of \$7,977 from the 2013-15 budget of \$233,286. This represents North Dakota's contribution to NCSL, and the amount is based on NCSL's estimate of North Dakota's share of the NCSL budget for fiscal years 2016 and 2017.

LEGISLATIVE MANAGEMENT AND LEGISLATIVE COUNCIL

Subdivision 2 of Section 1 contains the 2015-17 appropriation for the Legislative Management and the Legislative Council of \$13,343,620, of which \$13,273,620 is from the general fund and \$70,000 is from the insurance regulatory trust fund. The 2015-17 "ongoing" general fund request is \$13,058,160, an increase of \$570,685, or **4.6 percent more** than the 2013-15 "ongoing" general fund appropriation of \$12,487,475.

The \$70,000 is from the insurance regulatory trus fund and is for expenses relating to legislator involvement with the National Conference of Insurance Legislators (NCOIL).

The Legislative Council is requesting 37 full-time equivalent (FTE) positions, the same number authorized for the 2013-15 biennium. The organizational chart reflecting the current staff structure is attached as Appendix B.

Salaries and Wages

The salaries and wages line item of approximately \$9.7 million includes funding for:

- Thirty-seven authorized FTE positions.
- Funding for the Governor's recommended salary increase for state employees of \$417,774 (annual performance increases of from 3 to 5 percent).
- The Governor's recommended health insurance premium increase and retirement contribution increase of \$200,076.
- Funding for market equity salary increases of \$100,000, the same as the 2013-15 biennium.
- Temporary employees' pay for the 2017 legislative session.
- Legislators' per diem for meetings during the interim of \$1,088,809, \$85,117 more than the 2013-15 budgeted amount of \$1,003,692. This request is based on the same number of committees (26) budgeted for the 2013-14 interim and assumes an 87 percent attendance



rate at committee meetings. The budgeted amount includes a proposed increase for legislators' interim meeting pay from the current level of \$167 per day to \$174 per day effective July 1, 2015, and \$179 per day effective July 1, 2016 (an estimated cost of \$34,594). These increases are provided for in Sections 8 and 9.

- Funding of \$147,843 has been reallocated from the salaries and wages line item to an accrued leave payments line item in accordance with the action of the 2013 Legislative Assembly to designate a portion of salaries and wages funding for paying accrued leave.
- Our goals are recruitment of high quality employees, staff retention, and succession planning to address retirements of long-term employees. A challenge occurs when resignations and retirements happen near a legislative session.

Operating Expenses

The operating expenses line item of approximately \$3.5 million includes funding for:

- Travel expenses relating to meetings during the interim of \$1,722,239, which is \$66,167 more than the 2013-15 budget of \$1,656,072. The funding request is based on the same number of committees (26) budgeted for the 2013-14 interim and assumes an 87 percent attendance rate at committee meetings. The increase is primarily related to anticipated increases in lodging reimbursement rates.
- Dues of \$38,400 annually to the Energy Council.
- Information technology consulting totals \$100,800, \$102,355 less than the 2013-15 budget.
- Professional services of \$315,000 is \$250,000 less than the 2013-15 budget due to removal of one-time funding provided for assistance with education funding and higher education

studies during the 2013-15 interim. Legislative Management chose not to hire a consultant for the higher education study; therefore, this amount was not spent. The \$315,000 includes \$300,000 for consulting services to assist with interim committee studies when required, \$6,000 for contracting for the Legislative Council audit, and \$9,000 for contracting for the State Auditor's office audit.

- One-time funding of \$135,460 for replacing the staff's laptops and iPads.
- One-time funding of \$50,000 for office improvements.
- Other operating expenses changes are based on the Office of Management and Budget's guidelines as they are applicable and anticipated needs in other areas.

Capital Assets

The capital assets line item of \$30,000 includes one-time funding for replacing a copier.

OTHER AREAS

Sections 4 and 5 relate to authorizing line item transfers as necessary and the cancelation of previous unspent appropriations. Attached as Appendix C is information regarding major budget changes.

RELATED BILLS

Other bills under consideration that may affect the budget of the legislative branch include:

- House Bill No. 1199 relates to legislators receiving lodging reimbursement earlier.
- House Bill No. 1342 provides for annual legislative sessions.
- Senate Bill No. 2222 relates to open records requests of legislators and the Legislative Council.

North Dakota is hosting the CSG Midwestern Legislative Conference in Bismarck next summer, July 12-15, 2015. The event will bring 500 to 600 legislators, spouses, and others from 10 states and 4 Canadian provinces to North Dakota. North Dakota has this opportunity every 12 years or so and the event was last held in Fargo 13 years ago and in Bismarck 23 years ago. We plan to have a premier event, showcasing the successes of North Dakota and focusing on energy and agriculture. Featuring these two areas will be vital for e ongoing support by state and provincial leaders as well as building a strong base for those who move on to deral positions, including Congress or agencies, such as the Environmental Protection Agency. The plan is tie in local tourist destinations with the event for pre- or post-conference vacations. This conference will have significant economic impact on the area.

Planning efforts are well underway. North Dakota is responsible for planning the evening events, as well as the spouse and youth events. Main events are planned at the Heritage Center on Sunday evening, Fort Lincoln on Monday evening, and a state dinner on Tuesday evening. Attached is a summary of expense budgeted and income projected. The events in Nebraska and Minnesota for the last 2 years had a budget of around \$500,000. The Council of State Governments' out-of-state fundraising efforts should generate approximately \$90,000, as do the registration fees, for a total of \$180,000 from those sources, leaving around \$350,000 to be raised in North Dakota. We are beginning fundraising efforts, headed up by Senator Ron Carlisle. To have a premier North Dakota event, I believe we need state general fund support in the Legislative Assembly's budget for the 2015-17 biennium, and I request that the committee support, by motion, the inclusion of \$350,000 in the budget as a starting point, to be reduced by any funds raised by North Dakota's fundraising team.





Each member of the legislative assembly is entitled to receive as compensation for services the sum of one hundred seventy-twoseventy-seven dollars for each calendar day during any organizational, special, or regular legislative session and for each day that member attends a meeting of a legislative committee between the organizational session and the regular session as authorized by legislative rule.
- 2. a. Each member of the legislative assembly is entitled to receive reimbursement for lodging, which may not exceed per calendar month the amount established under this subdivision by the director of the office of management and budget for lodging in state and which may not exceed the rate provided in section 44-08-04 for each calendar day during the period of any organizational, special, or regular session. On August first of each even-numbered year, the director of the office of management and budget shall set the maximum monthly reimbursement for the subsequent two-year period at an amount equal to thirty times seventy percent of the daily lodging reimbursement in effect on that date as provided under subdivision d of subsection 2 of section 44-08-04.
 - b. Notwithstanding subdivision a:
 - (1) A member of the legislative assembly may elect to be reimbursed for less than the amount to which the legislator is entitled under this subsection by claiming the lesser amount on a voucher submitted with the receipt required by section 44-08-04.
 - (2) The legislative management may establish guidelines that may result in a reduced maximum reimbursement for a single dwelling in which two or more legislators share lodging and the total rent for that dwelling exceeds the amount to which a legislator is entitled under subdivision a.
- 3. a. Members of the legislative assembly who receive reimbursement for lodging are also entitled to reimbursement for travel for not to exceed one round trip taken during any calendar week, or portion of a week, the legislative assembly is in session, between their residences and the place of meeting of the legislative assembly, at the rate provided for state employees with the additional limitation that reimbursement for travel by common carrier may be only at the cost of coach fare and may not exceed one and one-half times the amount the member would be entitled to receive as mileage reimbursement for travel by motor vehicle.
 - b. A member of the legislative assembly who does not receive reimbursement for lodging and whose place of residence in the legislative district that the member represents is not within the city of Bismarck is entitled to reimbursement at the rate provided for state employees for necessary travel for not to exceed one round trip taken per day between the residence and the place of meeting of the legislative assembly when it is in session and may receive

reimbursement for lodging at the place of meeting of the legislative assembly as provided in section 44-08-04 for each calendar day for which round trip travel reimbursement is not claimed, provided that the total reimbursement may not exceed the maximum monthly reimbursement allowed under subdivision a of subsection 2.

- 4. The amount to which each legislator is entitled must be paid following the organizational session in December and following each month during a regular or special session.
- 5. If during a special session, the legislative assembly adjourns for more than three days, a member of the legislative assembly is entitled to receive compensation during those days only while in attendance at a standing committee if the legislator is a member of that committee, a majority or minority leader, or a legislator who is not on that committee but who has the approval of a majority or minority leader to attend.
- 6. A day, or portion of a day, spent in traveling to or returning from an organizational, special, or regular session or a legislative committee meeting must be included as a calendar day during a legislative session or as a day of a legislative committee meeting for the purposes of this section.
- a. In addition, each member is entitled to receive during the term for which the member was elected, as compensation for the execution of public duties during the biennium, the sum of four hundred eightyeneninety-five dollars a month, paid monthly.
 - b. If a member dies or resigns from office during the member's term, the member may be paid only the allowances provided for in this section for the period for which the member was actually a member.
 - c. The majority and minority leaders of the house and senate and the chairman of the legislative management, if the chairman is not a majority or minority leader, are each entitled to receive as compensation, in addition to any other compensation or expense reimbursement provided by law, the sum of three hundred fortyfive fifty-five dollars per month during the biennium for their execution of public duties.
- 8. Attendance at any organizational, special, or regular session of the legislative assembly by any member is a conclusive presumption of entitlement as set out in this section and compensation and expense allowances must be excluded from gross income for income tax purposes to the extent permitted for federal income tax purposes under section 127 of the Economic Recovery Tax Act of 1981 [Pub. L. 97-34; 95 Stat. 202; 26 U.S.C. 162(i)].
- Before each regular legislative session, the legislative management shall make recommendations and submit any necessary legislation to adjust legislative compensation amounts."

In addition to the compensation provided in subsection 1, the chairman of the legislative management is entitled to receive an additional five dollars for each day spent in attendance at sessions of the legislative management and of its committees, and the chairman of each of the legislative management's committees is entitled to receive five dollars for each day spent in attendance at sessions of the legislative management or of the committee which the person chairs."

- 1. Each member of the legislative assembly is entitled to receive as compensation for services the sum of one hundred seventy-twoseventy-seven dollars for each calendar day during any organizational, special, or regular legislative session and for each day that member attends a meeting of a legislative committee between the organizational session and the regular session as authorized by legislative rule.
- 2. a. Each member of the legislative assembly is entitled to receive reimbursement for lodging, which may not exceed per calendar month the amount established under this subdivision by the director of the office of management and budget for lodging in state and which may not exceed the rate provided in section 44-08-04 for each calendar day during the period of any organizational, special, or regular session. On August first of each even-numbered year, the director of the office of management and budget shall set the maximum monthly reimbursement for the subsequent two-year period at an amount equal to thirty times seventy percent of the daily lodging reimbursement in effect on that date as provided under subdivision d of subsection 2 of section 44-08-04.
 - b. Notwithstanding subdivision a:
 - (1) A member of the legislative assembly may elect to be reimbursed for less than the amount to which the legislator is entitled under this subsection by claiming the lesser amount on a voucher submitted with the receipt required by section 44-08-04.
 - (2) The legislative management may establish guidelines that may result in a reduced maximum reimbursement for a single dwelling in which two or more legislators share lodging and the total rent for that dwelling exceeds the amount to which a legislator is entitled under subdivision a.
- 3. a. Members of the legislative assembly who receive reimbursement for lodging are also entitled to reimbursement for travel for not to exceed one round trip taken during any calendar week, or portion of a week, the legislative assembly is in session, between their residences and the place of meeting of the legislative assembly, at the rate provided for state employees with the additional limitation that reimbursement for travel by common carrier may be only at the cost of coach fare and may not exceed one and one-half times the amount the member would be entitled to receive as mileage reimbursement for travel by motor vehicle.
 - b. A member of the legislative assembly who does not receive reimbursement for lodging and whose place of residence in the legislative district that the member represents is not within the city of Bismarck is entitled to reimbursement at the rate provided for state employees for necessary travel for not to exceed one round trip taken per day between the residence and the place of meeting of the legislative assembly when it is in session and may receive

reimbursement for lodging at the place of meeting of the legislative assembly as provided in section 44-08-04 for each calendar day for which round trip travel reimbursement is not claimed, provided that the total reimbursement may not exceed the maximum monthly reimbursement allowed under subdivision a of subsection 2.

- The amount to which each legislator is entitled must be paid following the organizational session in December and following each month during a regular or special session.
- 5. If during a special session, the legislative assembly adjourns for more than three days, a member of the legislative assembly is entitled to receive compensation during those days only while in attendance at a standing committee if the legislator is a member of that committee, a majority or minority leader, or a legislator who is not on that committee but who has the approval of a majority or minority leader to attend.
- 6. A day, or portion of a day, spent in traveling to or returning from an organizational, special, or regular session or a legislative committee meeting must be included as a calendar day during a legislative session or as a day of a legislative committee meeting for the purposes of this section.
- a. In addition, each member is entitled to receive during the term for which the member was elected, as compensation for the execution of public duties during the biennium, the sum of four hundred eightyone ninety-five dollars a month, paid monthly.
 - b. If a member dies or resigns from office during the member's term, the member may be paid only the allowances provided for in this section for the period for which the member was actually a member.
 - c. The majority and minority leaders of the house and senate and the chairman of the legislative management, if the chairman is not a majority or minority leader, are each entitled to receive as compensation, in addition to any other compensation or expense reimbursement provided by law, the sum of three hundred fortyfive fifty-five dollars per month during the biennium for their execution of public duties.
- 8. Attendance at any organizational, special, or regular session of the legislative assembly by any member is a conclusive presumption of entitlement as set out in this section and compensation and expense allowances must be excluded from gross income for income tax purposes to the extent permitted for federal income tax purposes under section 127 of the Economic Recovery Tax Act of 1981 [Pub. L. 97-34; 95 Stat. 202; 26 U.S.C. 162(i)].
- Before each regular legislative session, the legislative management shall make recommendations and submit any necessary legislation to adjust legislative compensation amounts."

STATEMENT OF JIM W. SMITH, DIRECTOR, NORTH DAKOTA LEGISLATIVE COUNCIL, REGARDING ENGROSSED HOUSE BILL NO. 1001, MARCH 5, 2015

Mr. Chairman and members of the Senate Appropriations Committee:

I am here this morning appearing on Engrossed House Bill No. 1001 on behalf of the members of the Legislative Assembly and the members of the Legislative Management to explain the budget requests for the Legislative Assembly, the Legislative Management, and the Legislative Council for the 2015-17 biennium.

The budget requests for these agencies are prepared using zero-based budgeting, meaning all amounts requested are calculated from a starting point of zero.

The financial statements for the fiscal years ending June 30, 2013 and 2012, for the Legislative Assembly and Legislative Council had unqualified opinions. The Legislative Council had one finding in its 2012 financial statements relating to general ledger reconciliation. The finding was corrected.

LEGISLATIVE ASSEMBLY

Subdivision 1 of Section 1 of the bill contains the 2015-17 biennium appropriation for the Legislative Assembly of \$15,500,927 from the general fund. This amount includes \$1,144,810 of one-time funding requests. The Legislative Assembly "ongoing" request is \$14,356,117, an increase of \$976,146, or 7.3 percent more than the 2011-13 "ongoing" appropriation of \$13,379,971. The amount requested is considered necessary for the organizational session and a 77-legislative-day (111-calendar-day) regular 2017 legislative session. The following schedule presents the number of legislative days for previous sessions:

The Legislative Assembly in 2013 provided funding for an estimated 77-legislative-day 2015 legislative session.

Salaries and Wages

The salaries and wages line item of approximately \$10.2 million includes funding for:

- Legislative employees' pay for the 2017 legislative session based on the number of employees anticipated to be employed for the 2015 legislative session of 84.
- Legislators' salary of \$177 per day for a 77-legislative-day regular 2017 session (111 calendar days). This includes a 3 percent first year and 3 percent second year increase as provided for in Sections 6 and 7 (an estimated cost of \$176,072).
- Continuing the additional compensation of \$15 per calendar day for the legislative leaders and \$10 per calendar day for chairmen of the standing committees and assistant legislative leaders. These compensation rates were each increased by \$5 by the Legislative Assembly in 2011.
- Legislators' monthly compensation of \$481 per month for the first year of the biennium, a \$14, or 3 percent, per month increase and \$495 per month for the second year of the biennium, a \$14, or 3 percent, per month increase (an estimated cost of \$76,500). These increases are provided for in Sections 6 and 7.
- Additional monthly compensation for House and Senate majority and minority leaders of \$345 per month for the first year of the biennium, a \$10, or 3 percent, per month increase and \$355 per month for the second year of the biennium, a \$10, or 3 percent, per month increase (estimated cost of \$10,593). These increases are provided for in Sections 6 and 7.
- Health insurance coverage for 133 legislators, three more than the number budgeted for the 2013-15 biennium. Current information indicates that 133 legislators have requested health insurance.

Operating Expenses

The operating expenses line item of approximately \$5 million includes funding for:

- Legislators' travel costs for 16 trips at 56 cents per mile during the 2017 regular session and one trip for the 2016 organizational session. The mileage rate is currently 57.5 cents per mile.
- Lodging costs for 127 legislators for four months during the 2017 legislative session at



an estimated reimbursement rate of \$1,680 per month. The reimbursement rate for the 2015 legislative session is \$1,569. The budget includes an additional \$84,520 relating to lodging.

- Contribution of \$10,000 annually to the Legislator's Forum (Manitoba, Minnesota, North Dakota, and South Dakota).
- Ongoing information technology data processing of \$1,262,790, a decrease of \$10,850 compared to the 2013-15 biennium.
- Professional services of \$77,000, \$30,000 less than the 2013-15 biennium budget. The amount includes \$60,000 for the continued privatization of legislative secretarial, bill and journal, and telephone operations.
- One-time funding of \$191,760 for information technology consulting and software relating to LEGEND system upgrades.
- One-time funding of \$603,050 to replace legislator's laptops and iPads.

CSG Midwest Conference

The request includes one-time funding of \$350,000 for the CSG Midwest Conference to be held in Bismarck in July 2015. The Legislative Procedures and Arrangements Committee, Representative Al Carlson, Chairman, approved the following motion on September 24, 2014:

It was moved by Senator Wardner, seconded by Representative Onstad, and carried on a roll call vote that the committee support the inclusion of funding of \$350,000 in the Legislative Assembly budget request for the 2015-17 biennium in support of the 2015 Council Government's Midwestern State Legislative Conference to be held in Bismarck in July 2015, with the expectation that the amount budgeted will be reduced by any additional funds that are raised. Representatives Carlson, Devlin, Mock, Onstad, and Vigesaa and Senators Heckaman, Holmberg, Klein, Schneider, and Wardner voted "aye." No negative votes were cast.

Attached as Appendix A is a copy of a) a letter; b) supporting budget information; and c) the 2015 Host Team from Senator Tim Flakoll, chair, 2015 Midwestern Legislative Conference, explaining and supporting the request, Senator Ron Carlisle is the chair of the fundraising team which has identified 62 potential sponsors. Contracts have been entered into for major speeches and events.

Capital Assets

The capital assets line item of \$16,800. The bill as introduced included one-time funding of \$500,000 for continuing legislative wing improvements; however, the House did not include this funding. Areas of

possible use of this funding could have been Brynhild Haugland Room upgrade, press studio upgrade, committee room sound upgrades, chamber improvements, and other renovations.

National Conference of State Legislatures

The National Conference of State Legislatures (NCSL) line item of \$241,263 is an increase of \$7,977 from the 2013-15 budget of \$233,286. This represents North Dakota's contribution to NCSL, and the amount is based on NCSL's estimate of North Dakota's share of the NCSL budget for fiscal years 2016 and 2017.

LEGISLATIVE MANAGEMENT AND LEGISLATIVE COUNCIL

Subdivision 2 of Section 1 contains the 2015-17 appropriation for the Legislative Management and the Legislative Council of \$13,086,236, of which \$13,016,236 is from the general fund and \$70,000 is from the insurance regulatory trust fund. The 2015-17 "ongoing" general fund request is \$12,800,776, an increase of \$313,301, or **2.5 percent more** than the 2013-15 "ongoing" general fund appropriation of \$12,487,475.

The \$70,000 is from the insurance regulatory trust fund and is for expenses relating to legislator involvement with the National Conference of Insurance Legislators.

The Legislative Council is requesting 37 full-time equivalent (FTE) positions, the same number authorized for the 2013-15 biennium. The organizational chart reflecting the current staff structure is attached as Appendix B.


Salaries and Wages

The salaries and wages line item of approximately \$9.4 million includes funding for:

- Thirty-seven authorized FTE positions.
- Funding for salary increases for state employees of \$312,460 (annual performance increases of from 2 to 4 percent).
- The Governor's recommended health insurance premium increase of \$155,442.
- Funding was removed by the House for market equity salary increases of \$100,000, which was the same level of funding as the 2013-15 biennium.
- Temporary employees' pay for the 2017 legislative session.
- Legislators' per diem for meetings during the interim of \$1,081,373, \$77,681 more than the 2013-15 budgeted amount of \$1,003,692. This request is based on the same number of committees (26) budgeted for the 2013-14 interim and assumes an 87 percent attendance rate at committee meetings. The budgeted amount includes a proposed increase for legislators' interim meeting pay from the

- Funding of \$147,843 has been reallocated from the salaries and wages line item to an accrued leave payments line item in accordance with the action of the 2013 Legislative Assembly to designate a portion of salaries and wages funding for paying accrued leave.
- Our goals are recruitment of high quality employees, staff retention, and succession planning to address retirements of long-term employees. A challenge occurs when resignations and retirements happen near a legislative session. We plan to address salary levels as necessary to recruit and retain quality employees to serve the Legislative Assembly and its committees and members.

Operating Expenses

The operating expenses line item of approximately \$3.5 million includes funding for:

- Travel expenses relating to meetings during the interim of \$1,722,239, which is \$66,167 more than the 2013-15 budget of \$1,656,072. The funding request is based on the same number of committees (26) budgeted for the 2013-14 interim and assumes an 87 percent attendance rate at committee meetings. The increase is primarily related to anticipated increases in lodging reimbursement rates.
- Dues of \$38,400 annually to the Energy Council.
- Information technology consulting totals \$100,800, \$102,355 less than the 2013-15 budget.
- Professional services of \$315,000 is \$250,000 less than the 2013-15 budget due to removal of one-time funding provided for assistance with education funding and higher education studies during the 2013-15 interim. Legislative Management chose not to hire a consultant for the higher education study; therefore, this amount was not spent. The \$315,000 includes

\$300,000 for consulting services to assist with interim committee studies when required, \$6,000 for contracting for the Legislative Council audit, and \$9,000 for contracting for the State Auditor's office audit.

- One-time funding of \$135,460 for replacing the staff's laptops and iPads.
- One-time funding of \$50,000 for office improvements.
- Other operating expenses changes are based on the Office of Management and Budget's guidelines as they are applicable and anticipated needs in other areas.

Capital Assets

The capital assets line item of \$30,000 includes one-time funding for replacing a copier.

OTHER AREAS

Sections 4 and 5 relate to authorizing line item transfers as necessary and the cancelation of previous unspent appropriations.

RELATED BILLS

Other bills under consideration that may affect the budget of the legislative branch include:

- House Bill No. 1199 relates to legislators receiving session lodging reimbursement earlier.
- Senate Bill No. 2222 relates to open records requests of legislators and the Legislative Council.
- House Bill No. 1015 includes a \$50,000 general fund appropriation to obtain consulting services to assist with a Legislative Management study of incarceration issues.
- Senate Bill No. 2012 includes a \$50,000 general fund appropriation to obtain consulting services to assist with a Legislative Management study of the delivery system for children with special health care needs.

DATE: September 24, 2014

North Dakota is hosting the CSG Midwestern Legislative Conference in Bismarck next summer, July 12-15, 2015. The event will bring 500 to 600 legislators, spouses, and others from 10 states and 4 Canadian provinces to North Dakota. North Dakota has this opportunity every 12 years or so and the event was last held in Fargo 13 years ago and in Bismarck 23 years ago. We plan to have a premier event, showcasing the successes of North Dakota and focusing on energy and agriculture. Featuring these two areas will be vital for the ongoing support by state and provincial leaders as well as building a strong base for those who move on to federal positions, including Congress or agencies, such as the Environmental Protection Agency. The plan is to tie in local tourist destinations with the event for pre- or post-conference vacations. This conference will have significant economic impact on the area.

Planning efforts are well underway. North Dakota is responsible for planning the evening events, as well as the spouse and youth events. Main events are planned at the Heritage Center on Sunday evening, Fort Lincoln on Monday evening, and a state dinner on Tuesday evening. Attached is a summary of expense budgeted and income projected. The events in Nebraska and Minnesota for the last 2 years had a budget of around \$500,000. The Council of State Governments' out-of-state fundraising efforts should generate approximately \$90,000, as do the registration fees, for a total of \$180,000 from those sources, leaving around \$350,000 to be raised in North Dakota. We are beginning fundraising efforts, headed up by Senator Ron Carlisle. To have a premier North Dakota event, I believe we need state general fund support in the Legislative Assembly's budget for the 2015-17 biennium, and I request that the committee support, by motion, the inclusion of \$350,000 in the budget as a starting point, to be reduced by any funds raised by North Dakota's fundraising team.





PROPOSED AMENDMENTS TO ENGROSSED HOUSE BILL NO. 1001

That the Senate recede from its amendments as printed on pages 1422-1424 of the House Journal and pages 1143-1145 of the Senate Journal and that Engrossed House Bill No. 1001 be amended as follows:

Page 1, line 3, after "54-03-20" insert ", 54-35-06,"

Page 1, line 4, after "compensation" insert "and expenditures"

Page 9, after line 18, insert:

"SECTION 8. AMENDMENT. Section 54-35-06 of the North Dakota Century Code is amended and reenacted as follows:

54-35-06. Officers - Accept funds - Expenditures.

The legislative management shall select a chairman and a vice chairman from its own members and may prescribe its own rules of procedure. The legislative management may appoint a secretary who need not be a member, and shall appoint a director who must be in charge of the legislative council and who must be paid such salary as the legislative management may determine. The director may employ such persons and obtain the assistance of such research agencies as determined necessary. The director may use available funds for salary adjustments to assist with staff recruitment, retention, and recognition of exceptional performance. The legislative management and the legislative council may accept and use any funds made available through the terms of any agreement made with any agency whatsoever for the accomplishment of the purpose of this chapter. Expenditures of funds made available by legislative appropriation must be made in accordance with rules or motions duly approved by the legislative management."
