Explanation or reason for introduction of bill/resolution:

Relating to big game and turkey hunting licenses for youth with a life-threatening illness.

Minutes: Attachments #1, 2 & 3

Chairman Porter opens hearing on HB 1081.

Representative Nelson: This would allow some hunting licenses for youth with severe illness. This is a bill that Representative John Wall that wanted to see through, it an honor for me to represent and introduce this bill. It would provide hunt elk moose and turkey licenses for young people with serious health issues. It's great that we have people in the state of North Dakota that are willing to spend time providing these types of services.

I will turn this over to Brian and his group.

Chairman Porter: On page 2, section c, line 14, was there any reason we were going with 21 as definition of an adult. A lot of other things we have done with Game and Fish chapters, we've used 18 as an adult for supervision purposes. You're saying that the individual using the tag is under 18, then the person supervising has to be over 21. This isn't consistent with what we've done in the past.

Nelson: Tim Dawson drafted this bill and that issue didn't come up. Maybe Mr. Steinwand has some perspective on that. I wasn't aware that this is different from other licenses.

Chairman Porter: On line 17, the qualified youth definition is up to twenty-five years of age.

Representative John Nelson: I believe that was the request of the Outdoor Adventure Foundation. Possibly Mr. Solum can respond to that.

Brian Solum, Founder & President of The Outdoor Adventure Foundation (Attachment 1 & 2)

Rep. Bob Hunskor: What about ages between 18-25?

Brian: All recipients are up to age 25. If they're under the age of 18 they have to have an adult with them on one our hunts.

Rep. Mike Nathe: What is the process when someone contacts you that they have a youth that has cancer.

Brian: A lot of kids come through the hospital They find us on the internet, they contact us, we send information and request client profiles about their disease and a doctors statement. We keep liability wavers and information on file. It starts the process. We find out from the kids what their favorite hunts are. Many kids wheelchair bound aren't able to participate in sports, and this gives them something big to look forward to, and it's life-changing for some of them.

Rep. Mike Nathe: Does anyone get turned away?

Brian: No. We deal with all kinds of illnesses.

Rep. Mike Lefor: This is fantastic. You should be commended for what you are doing. How did you arrive at the number of tags for turkey, elk, moose, etc?

Brian: We currently have 8 deer tags, lowered down to 7. Currently 4 antelope tags, we lowered down to 2. We like to do 2 spring turkey hunts, 1 elk hunt, and 1 moose hunt.

Rep. Mike Lefor: Is this number sufficient for what you are looking for?

Brian: It is. We also send kids to Montana for mule deer hunts. And we send one to Wyoming that we have set up. We do other hunts and fishing groups up to 30 at a time. Our pheasant group is about 25. We get the heads mounted and the meat processed for our recipients. We have a lot of good sponsors.

Rep. Bob Hunskor: Do you receive any state money?

Brian: No, but we could sure use some. It's all by private donation and corporate sponsors. I also write grants.

We do have a CD that is emotional.

Rep. Mike Lefor: Who made the decision to reduce the deer and pronghorn licenses? And, why?

Scott: That may be better addressed to the sponsor of the bill.

Rep. Curt Hofstad: Do we have any other organizations asking to do the same thing?

Scott: We do have other organizations asking for licenses, not necessarily for youth life threatening diseases. I have a list of the organizations: 1 spring turkey tag to the National Wildlife National Turkey Federation, 1 bighorn sheep tag to the Foundation for North American Wild Sheep, 1 moose tag to the Wildlife Enforcement Museum, 1 elk tag to the Rocky Mountain Elk Foundation, 1 mule deer tag to the Mule Deer Foundation, and up 8 pronghorn tags available to terminally ill children, up to 4 of any deer and 6 any whitetail tags available to the Injured Military Wildlife Project.

Rep. Mike Nathe: The groups you listed, are they listed in code?

Scott: Yes, those are specifically listed in code.

Rep. Bob Hunskor: It seems something of this importance, that the number of pronghorn and deer should not be diminished. From the sponsors, I would like to hear why the numbers are reduced to compensate for the moose, turkey and the elk.

Scott: I can only speculate and cannot speak for the sponsors. The point is well taken, though.

Rep. Bob Hunskor: Mr. Vice Chair, can we get an answer to that?

Vice Chairman Damschen: We will call on Mr. Solum.

Brian: I asked to reduce the numbers. Having an elk and a moose tag would be very important to us. We don't' have to reduce the numbers for the antelope tag or the deer tags from 8 to 7, or from 4 to 2. We voluntarily did that. We are a volunteer organization.

This would also be a showcase for North Dakota. We film the hunts for national TV. There will be a lot of exposure about North Dakota itself, incorporated into our stories about our kids and their plight.

Mike Donahue, Wildlife Federation: We are in support of the bill.

Rep. Bob Hunskor: After the meeting closed, I visited with a couple folks. One person who deals with this indicated that last year there were 8 deer licenses available to young people who had a life threatening disease, and only 3 were used. There were 4 pronghorn available and non were used.

Chairman Porter: I don't think we had season last year (in the Governor's Proclamation). Unless it was opened up last year by Amidon. It may have been a limited season last year. That area is very difficult to get access because of the land situation.

Rep. Bob Hunskor: I talked to Game and Fish about leaving the number of dear and antelope license available for youth, they said that small number would be irrelevant to them.

Chairman Porter; This is what they wanted and I don't know if it's worthy of amending numbers. It's their bill.

Rep. Curt Hofstad: Motioned Do Pass.

Rep. Mike Nathe: Second the Motion.

Chairman Porter: Discussion?

Rep. Mike Nathe: Is anybody up to age 25 years old eligible for this?

Chairman Porter: That is correct. Their mission is of their 501 (c) (3) from ages 25 on down. This bill is written accordingly.

Chairman Porter: No further discussion. Clerk will call the roll on a Do Pass on HB 1081.

Chairman Schaible called the committee to order, roll was taken and all members were present.

Representative Jon Nelson: I am here to introduce HB 1081 which adds several licenses to the outdoor adventure foundation which is a group that has provided hunts for young people with mostly terminal and serious illnesses. These groups have worked with game and fish and have a good working relationship with them. It provides the experience for these young people and we would hope that you look favorably and pass this bill.

Senator Triplett: When would it be time to ask game and fish to ask them to take care of it on their own?

Representative Jon Nelson: That is a good point that would be another avenue to determine who is eligible and who isn't. They had concerns about where they fit into state law. There are some groups that have more or less standing than others. From a practical standpoint the department could make the distinction. We want that to filter through the process in some cases as well. I do not have a strong feeling either way.

Mike Donahue: North Dakota Wildlife Foundation. Support the bill.

Scott Peterson: See attachment #1. 7:53-9:24

Chairman Schaible: What percentage would be where it would get to be not a good idea?

Scott Peterson: It is a good question, even though these are good causes where do you draw the line? I am not sure if we are prepared to answer that because I do not know.

Chairman Schaible called the committee to order.

Senator Triplett: I think that there almost all the suggestions are good ones except for number 2, grandfathering in of organizations. If we are going to cut if off then maybe there is an argument for opening it up every 3 or 4 years to do an open process for other organizations for the right to do raffles.

Senator Laffen: Didn't the original bill deal with wild turkeys? I do not see them on the list, is this an all-inclusive list?

Senator Armstrong: Do we know how many are in code now?

Senator Laffen: The license wanted to add wild turkeys and this doesn't say anything about wild turkeys.

Chairman Schaible: If we are going to do this is should be all species and all hunting. I would say we do not want to exempt that. If you are going to give away a license for profit or fundraising there should be criteria. There was also a suggestion that if we are going to do this than maybe direct what kind of fundraising it can be and where that money should go. If we want to go down this road we would need to work on some amendments, I am just hoping to promote discussion.

Senator Laffen: No more than 2% of big game licenses, do you think that means 2% from each of those?

Vice Chair Unruh: You had mentioned that these licenses were not trying to make money for these organizations. Would that include raffles?

Chairman Schaible: My thought was 'for profit' rather than for money. They will all be

generated for something, be it fundraising or reinvesting into the habitat for the species. Those seem to be reasonable requests but if you are having a raffle to promote a foundation that uses that for administration and expenses that would be more of a concern that I would have.

Senator Hogue: The only concern that I have is if we are going to go down this road we should require game and fish to have some control over how the organizations pend this money. I think we should make clear that we expect the organizations invest it back into the appropriate use of those funds.

Senator Armstrong: I would like to see some kind of statement that says that preference will be given to organizations that use the money to give it back to hunting habitat and outdoor related activities. You don't want it too tight but some of the organizations that have asked for these special permits in the past it is not really germane for hunting and fishing. I wouldn't want it too specific.

Chairman Schaible: Maybe we should have game and fish come in and we can talk about it. His suggestion was that we provide intent but they allow them to enforce.

Senator Triplett: Reinvest in habitat or for charitable purposes or something like that. A majority of these permits are used to get disabled people in the field to hunt and I think that charitable purposes related to hunting or the outdoors is a good idea.

Chairman Schaible: If we put that down as intent it gives it the idea and can revisit it if we needed to.

There was no further discussion and Chairman Schaible closed committee work on HB 1081.

Senator Robinson: Do we have an up-to-date schedule of subcommittees for the week, or will it go day to day?

Chairman Holmberg: It will go day to day but there is one that's been refined. We have more meetings this time with the House on various issues so I have changed and Senator Wanzek is going to go on the DOT budget and I am going off that one.

Senator Carlisle asked if we will meet on Commerce at 8:00 on Friday in this room.

Chairman Holmberg: Yes. I am the Chair, even though I won't be here. We will schedule that at 8:00 on Friday morning. I would suggest you don't schedule necessarily yet, until you see how things are going. You might find that Health Dept or DOT has done it's work so that the other ones can get scheduled for Friday. Kim Kary: I believe this is the one that first went through as a license for youth with life-threatening illness, they amended it; they wanted to do a study, where it got confused, the legislative management shall study, (not G& F) when they originally were going to make us pay for it, but now I am not sure who is paying for the study.

Senator Carlisle: It's pretty much a policy bill.

Chairman Holmberg: It is a policy bill. We have to do something with it. Energy and Natural Resources have to carry it anyway.

Senator Mathern it is a required study. I think it is a great idea to pass it out Without Committee Recommendation. I make that motion. 2^{nd by} Senator Carlisle.

Chairman Holmberg: Call the roll on a Without Committee Recommendation on HB 1158.

A Roll Call vote was taken. Yea: 13; Nay: 0; Absent: 0. Senator Mathern will carry the bill on the floor. The hearing was closed on HB 1081.

There was further discussion regarding HB 1005 by Senator Carlisle at the end of this recording, however, no action was taken. 





We also provide hunting and fishing adventures for combat disabled veterans under the age of 40 that are wheelchair bound caused by injury during active service or who have lost a limb during active service.



PROPOSED AMENDMENTS TO HOUSE BILL NO. 1081

Page 1, line 3, after "illness" insert "; and to provide for a legislative management study" Page 5, after line 5, insert:

"SECTION 5. LEGISLATIVE MANAGEMENT STUDY. During the 2015-16 interim, the legislative management shall consider studying game and fish department licenses provided to entities for the purpose of fundraising. The study must include a review of the present law in this and other states and of allowing the game and fish department to issue these licenses through certain procedures and with certain limits created by the legislative assembly. The legislative management shall report its findings and recommendations, together with any legislation required to implement the recommendations, to the sixty-fifth legislative assembly."
