Randy Christmann, Commissioner- Public Service Commission Written testimony #1

Rep. George Keiser: The 111d rules on carbon emissions have been promulgated, are they in the comments period what is the time frame of the development for those rules?

Christmann: Right now they are evaluating the comments. They thought they would issue a final rule in June. I expect the final rule to come out next summer.

Representative Vernon Laning, District 8 Written testimony #2

Tyler Hamman Director of Government Affairs- Lignite Energy Council Written testimony #3

Rep. George Keiser: What are we doing, from a research stand point and management stand point, to deal with these rules?

Hamman: Over the last couple of decades utilities have invested about 2 billion dollars to make their plants more efficient and to scrub out some of the criteria pollutants like mercury and sulfur. As far as the future, we are looking at technology that is 100% carbon capture. It's a whole new type of power plant, new technology that would turn coal into syn gas, which is turned into super critical carbon dioxide that is used in a turbine as opposed to steam. It's in the early development stages; we're a decade out from doing this. Whereas,

some of these regulations being pushed by the EPA are being implemented now. We're not opposed to it; we just need time to develop the technology.

Dale Niezwaag, Basin Electric Dakota Gas Co.

Going back to Rep. George Keiser question, the technology that Mr. Hamman talked about is something we think has real promise. We are also supporting research at the EERC to see how carbon dioxide can be used in the Bakken Formation to produce oil.

Rep. Glen Froseth: Carbon dioxide is presently being used in oil fields from the gasification plant in Beulah.

Niezwaag: The carbon dioxide that is shipped to Canada is used for tertiary oil recovery but it's used on the vertical wells. In the Bakken, with the horizontal wells, it's a whole new situation. EECR has determined that pressurized carbon dioxide put into a horizontal well, has the potential to get out up to 90% of the oil, instead of the 5% or 6% we're getting now.

Representative Laning: They are continually under watch and urged to get incompliance. If they do not make efforts they are facing fines and are restricted on further development.

Randy Christman: Public Service Commission. See attachment #2. (5:19-9:32)

Senator Triplett: Isn't it a fact that a fair amount of push for what the EPA is currently doing with carbon comes from the Supreme Court and the interpretation of the Clean Air Act?

Randy Christmann: That is their angle in going after it but to the extent to which they regulate the rules they promulgate to enforce that are not defined by the Supreme Court and not any law.

Senator Triplett: Congress could at any time redirect the attentions of the EPA.

Randy Christmann: The agency is going to answer to the president. Laws can be changed at which time the issue is determined that the CO2 we exhale is a pollutant. More years will pass but in the meantime they will interpret it that way.

Senator Triplett: If we are going to do something then it ought to be more specifically directed to Congress as it is talking about regulations. The EPA is doing what the court is

willing them to do. If we are going to do this it should be directed pointedly at Congress who makes the rules in the first place.

Randy Christmann: I would disagree, the fine detail that they are set to release to this summer. The Supreme Court, any law, no one ever when into the detail of what they are promulgating. They choose to look at the whole year and see how it impacts how it affects our utilities.

Senator Triplett: More concerned about getting it there guickly.

Randy Christmann: Quickly and keep repeating it as long as it is under discussion.

Jason Bohr: Lignite Energy Council. See attachment #3. (15:29-17:27)

Dale Niezwaag: Basin Electric. Back in 2010-2012 we looked at capturing CO2 from plants. We have a \$100,000,000 grant and wanted to take a portion of the gas and use it for this. At the time we could not get a guarantee and we are encouraged that elite has performance guarantees. The industries are working towards the goal. Currently to move us towards that we are looking for some funding for the ADAM cycle, how we can use CO2 to recover more oil from the Bakken. Our concern and support for the resolution is that if we walk away from Lignite then we walk away from Coal.

If we didn't want to Attorney General to be engaged we would cut him off but that is our job to make sure that the office of the Attorney General has adequate resources. Our agencies work together with the governor's office and analyze policy to make sure its fine. We have also passed specific legislation regarding the oil industry which we said that the act of fracking was considered an acceptable process within North Dakota and it was much discussed in the country. In my opinion, the coal industry in North Dakota I think that our coal and coal fired has been slow to accept regulations and there has been a holdup for 15-20 years and are finally going into effect this spring. #### **TESTIMONY**

The North Dakota Public Service Commission supports passage of House Concurrent Resolution 3024. The Public Service Commission agrees with the bill sponsors that the federal government should refrain from imposing regulations and other administrative actions that limit the ability of our utilities to continue providing low-cost and reliable power. We have been working on these issues for some time already, and along with encouraging passage of HCR 3024 I want to give you a very brief update on the Commission's efforts.

One of the primary threats to the electric power system in North Dakota is the EPA's proposed regulations on carbon emissions. The Commission held a symposium on EPA carbon regulation in January of last year in Bismarck. Then in September we did a conference in Fargo titled "Electric Reliability: Keeping the Lights on in North Dakota." We received excellent information at these sessions, not only from North Dakotans but also from people from around the region and nation, including FERC Commissioner Tony Clark. An additional comment period was held in October which gave electric utilities, electric cooperatives, other interested stakeholders, and the public a chance to share their comments with the PSC. We then filed our comments on the EPA's 111d proposal. One of the

major concerns outlined in the Commission's comments was our belief that the proposed rule is not authorized by federal law and takes away the Commission's authority to regulate utilities, oversee planning of resources, and address the projected significant increases in demand for electricity.

I personally believe that the President, through the EPA, will dismantle our dependable and affordable electric system if these rules are adopted. They will replace the system of today with arbitrary objectives based on false facts. Sadly, they seem more concerned about appearing the environmental activists than about maintaining the proper functioning of the electric system.

Another threat to our electric system is a lawsuit demanding a more intense look at new leases of federal coal, as well as any changes to existing federal coal leases. We believe that this lawsuit could delay all leasing activity for many years. This would devastate North Dakota power producers who rely on coal because federally owned coal tracts are mixed with privately owned tracts. If we have to mine around those federal tracts costs will skyrocket. The Commission has filed as an intervenor in that case.

These are just two of the many areas where federal action threatens our electric system.

While the Commission continues its efforts to protect consumers, we commend these sponsors and encourage the Legislature to add its respected voice to the chorus of people imploring the federal government to reconsider their actions.

The coal industry is not anti-regulation, and the State of North Dakota has proven that government can balance responsible coal development with environmental stewardship and the needs of the people. We believe that the federal government should follow the example set by this state and its commonsense regulation of the lignite industry, and this resolution would effectively deliver that message.

The Lignite Energy Council appreciates Representative Laning, the cosponsors of this resolution, and the North Dakota legislature for their continued support and recognition of the lignite industry's strong track record of success in providing affordable and reliable electricity, 17,000 jobs, and billions in economic activity to the State of North Dakota and the region.
