Gary Paur, North Dakota State Representative District 19, testified in support of the bill. (see attachment 1)

Chairman Armstrong: "This is to get consistency in the code, correct?"

**Representative Paur**: "Correct. In 2015, this section was changed four times. In 2011 it was changed three times."

**Chairman Armstrong**: "Do you know if changing it from 5-3 will make it more consistent in other areas of the code?"

Representative Paur: "I do not."

**Dallas Carlson, Director of North Dakota Bureau of Criminal Investigation**, was called up to answer some of Chairman Armstrong's questions.

**Chairman Armstrong**: "Will changing five to three make it more consistent throughout the code?"

Dallas Carlson: "I believe so. It does make it more consistent throughout."

**Chairman Armstrong**: "Representative Paur mentioned it is provided in writing, is that necessary? How else can you do it besides writing?"

**Dallas Carlson**: "We are moving toward electronic monitoring but we are not quite there yet. So to answer your question I don't know for sure." Senate Judiciary Committee HB 1058 3/6/2017 Page 2

**Chairman Armstron**g: "Should we change it from "writing to law enforcement" to "register to law enforcement?"

Dallas Carlson: "I'd be ok with that."

**Chairman Armstrong** began the discussion on HB 1058. **Senator Luick** absent during discussion but came back to vote after the hearing was closed and the recording was off.

Proposed Amendment was handed out and reviewed by the committee. (see attachment 1)

**Chairman Armstrong**: "Essentially all this bill does is change a five-day registration requirement to a three-day registration requirement for consistency."

Chairman Armstrong briefly went over the Amendment. (see attachment 1)

**Senator Larson**: "If the bill I testified on today passes they are moving to have them all on computers because my bill was on sex offender registration being at the jurisdiction where you reside. So that would be certainly in line with that same thing."

**Chairman Armstrong**: "This still requires that 3-day registration, it just allows it to be done in the manner in which they are doing it. I think we will begin to move out of this "in writing" part much more significantly anyway."

Senator Myrdal motioned to Adopt the Amendment. Senator Larson seconded.

Discussion followed:

Senator Nelson asked to go over the Amendment again.

**Chairman Armstrong** discussed the Amendment. "The purpose of this is to make it consistent with other language."


