For the 2017-19 biennium it is anticipated up to 25 guardians ad litem would need background checks for a total cost of \$1,000 (25 x \$40.00 rate for check). Chairman K. Koppelman: Opened the hearing on HB 1060.

Rep. Meier: Sponsor of the bill. Handed out (Testimony #1) and read it.

**Senator Matheron**: This bill permits these entities that use this service to have the background checks for the volunteers done by the BCI. We are asking you to use that entity to have those background checks done. I am open to the amendments that the DOC might bring; that Youth Works might bring to make this a workable affair. Essentially we are all benefiting when we have volunteers involved in the services that we deliver to young people in our state. We want to use the entity that is in place because they would pay the fee involved.

Wayde Sick, Director of the WDD: (See Testimony #2,3,4) (5:37-9:12).

**Representative Nelson**: Who are doing these background checks today?

**Wayde Sick**: Many of the projects use a vender to do the background checks. There is a lag in getting them to the FBI or whoever is doing the background. We want to go directly to the BCI.

**Representative Nelson**: Have you checked with BCI? Other people are saying they are waiting a long time for these background checks. I am hearing from allot of people they are waiting a long time for the Attorney General's to do these background checks?

Wayde Sick: I did talk to BCI yesterday and it is about 2-3 weeks now?

**Chairman K. Koppelman**: The last section of the bill; why is that deleted?

**Wayde Sick**: We felt it did not belong in that section of the century code. We agree that the agency should be paying for that background check and that language should be in the Subsection of 12-60-24. It should also say the projects are responsible for the fee.

**Chairman K. Koppelman**: with respect with you naming AmeriCorps by naming it in statue will that restrict us in the future if that program goes away or there is another way you want to accomplish this same goal by simply naming the program are you fencing that in?

Wayde Sick: We have to look at other options.

**Lauren Bosch, Youthworks Program Manager** (See testimony #5)(15:14-25:30) We are in support of this bill.

**Representative Vetter**: Under AmeriCorps's program language so you are saying if you change that to a broader term. Is that what you are saying?

**Lauren Bosch**: This is a complicated discussion. We are talking about two distinct services. One of them deals with AmeriCorps volunteers through the DOC. My second concern is about Guardian ad Litem that are contract agents of the Supreme court and I feel they should be separate section in the century code.

**Lauren Bosch**: Explained the century code. We are staying there should be two additional entities that have excess.

**Chairman K. Koppelman**: This would be an addition to that anyone that contracts with the supreme court guardian services.

Representative Klemin: (28:04-) Explain the history on this.

**Chairman K. Koppelman**: No law requirement for BCI background check so explained how it came about.

**Representative Magrum:** Why has the background checks not become more efficient with the technical we have now?

**Lauren Bosch**: Results is because we are last in line with the FBI. BCI is first in line now. Explained how it works now.

**Chairman K. Koppelman**: These come from the FBI and we have to use them. BCI is now the best way to do that now.

**Lauren Bosch**: We are seeking this because it would be very beneficial to have this done.

**Representative Johnston**: The 16 weeks you mentioned; is that the worst case scenario?

**Lauren Bosch**: It is usually 12 weeks.

Representative Magrum: The money where is it coming from?

**Chairman K. Koppelman**: The fiscal note is just an appropriation and it is showing spending money and we are given the authorization to spend that money.

Representative Paur: I still uncomfortable with it.

Representative Magrum: Do you think this will add an extra burden on BCI?

**Chairman K. Koppelman**: No. Explained how the fiscal note works. Referred to the fiscal note 2 b.

**Vice Chairman Karls**: AmeriCorp is a federal grant program. So the money is funneled through the DOC and these people are paid a small living wage. It helps them pay off their college loan. These people are volunteers basically so they fall under that federal program. Youthworks is another program and they work side by side in the DOC. They are called grantees.

Representative Simons: Background checks. What are they looking for?

**Chairman K. Koppelman**: This is a federal program so there are probably rules set up for people working in the AmeriCorp program. We are eliminating old section 2 and putting in a whole new section 2.

Rep. Lisa Meier, North Dakota State Representative District 32, introduced and testified in support of the bill. (see attachment 1)(:51-2:02)

Senator Luick: "Is there a fiscal note to this?"

Representative Meier: "No." Because the payment is paid through the court system.

**Senator Nelson**: "Why would it be quicker through the Department of Commerce and why would turnaround be faster?"

**Representative Meier**: "Quicker because it's a larger department. They are able to obtain the background checks quicker and it would be less time for Youthworks.

**Sen. Tim Mathern: North Dakota State Senator District 11**, briefly testified in support of the bill. No written testimony. (3:20-4:00) 1060 is really an attempt for government and non-profit organizations in North Dakota, to work together as efficiently as possible to get back ground checks done. So I hope you support the bill. It is a partnership effort to be efficient.

Wayde Sick: Director of the Workforce Development Division, testified in support of the bill. (see attachment 2) (4:20-7:56)

**Senator Larson:** 8: Since the AmeriCorps program has already been under the Department of Commerce, why haven't you done the background checks before sending them out

anyway? Has that just been an oversight? Have you had authorization to do the background checks or what?

**Mr. Wayde Sick**; The checks have always been done by a third party vendor or directly thorough the FBI. This legislation would allow these projects to utilize the BCI which would stream light and expedite the process. So the background checks have always been done. It just takes a long time to get the results.

**Senator Larson**: But why haven't you as the home agency been doing them? Is that with following up with Senator Nelson's question is it a funding problem that has happened or what?

**Mr. Wayde Sick**: No. The projects are built into their budget funds to do the background checks. It does have to go through either the FBI or North Dakota BCI to do those checks.

**Lauren Bosch**: Youthworks Program Manager, testified in support of the bill. (see attachment 3) (10:10-15:19)

**Senator Osland**: Can you explain what Youthworks does? What kind of people are these grantees, AmeriCorps grantees?

**Mr. Lauren Bosch:** Youth works is a grantee of the Department of Commerce. It's federal money which comes to the Department of Commerce. It's granted out to agencies like Youth Works.

Senator Osland: I still don't know what you do.

**Mr. Lauren Bosch:** Youthworks is a private non-profit organization that works with at risk youth and young adults. Across the state of ND, we have about 150 employees across the state. We provide a whole mess of services that I would just as soon not confuse the committee with, but it's all services designed to assist youth and families. Primarily to keep youth and families in their homes if at all possible. Keep them out of the foster care system. That is our over-arching goal. We have employees all across the state that do lots of different things; over 40 different funding sources doing all different kinds of programs. We've been in existence since 1986.

**Chairman Armstrong:** You wouldn't be opposed to any language in here saying that the fee may be assessed to, I think they are like \$40.

**Mr. Lauren Bosch**: "I'm more than happy to pay it. It's something already in the statute." Any reasonable fee is something we would be more than happy to pay.

**Chairman Armstrong**: Okay. Do you know the dollar amount in the statute or does it say just a reasonable fee?

**Mr. Lauren Bosch**: It does say \$15 dollars. But it depends on your status as a non-profit organization.

**Chairman Armstrong**: We don't like specific dollar amounts due to it devaluing every day. A term of a more reasonable fee sounds better.

**Mr. Lauren Bosch**: Senator Armstrong I understand the fiscal state that the state of ND is in and I am not certain what it cost the BCI to accomplish some of the records check, but whatever that amount would be we would be more than happy to pay it.

**Chairman Armstrong**: In the fiscal note, it actually says that the Department of Human Services processes these background checks, so is that accurate?

**Mr. Lauren Bosch**: No it isn't. This was in regards to my initial bill, and it's really complicated. I really can appreciate that Senator Osland was saying because the reason that it's that bill is that it really pertained to Youth Works as an entity and one of its licenses that is licensed by the Department of Human Services. So, once the Dept. of Human Services found out that this had something to do with Youth Works in this license, they assumed that they would have to accomplish all these records checks, and we are not requesting any of these records checks be accomplished by DHS. We would prefer they be accomplished by BCI that is the easiest and most direct path to getting this accomplished.

Chairman Armstrong: The fiscal note actually went up in payment. It didn't go away.

**Mr. Lauren Bosch**: The easiest way to understand this, if you look at this section of Century Code, there are a whole bunch of entities that can access these records checks.

**Senator Larson:** (20:50-22:07) I'd like to explain something real briefly. I've worked with Youth works in the past. What Youth works does historically is they look for gaps in services for youth, that the community doesn't provide. They step in and establish that attendant care program, or they help with the tutoring. I think Youth works has a great reputation of doing what best fits the community.

Senator Osland: Can you tell me about how many employees you have in North Dakota?

Mr. Lauren Bosch: 150.

Senator Osland: What kind of employees are they? Are they young and old, and volunteers?

**Mr. Lauren Bosch**: Most are licensed professional social workers, teachers, counselors, that work on a full time basis. There are a number of para-professional staff, 50 college age folks of those 150 that provide 24hr a day care to kids. So it's a real mix between professionals that are social workers, counselors, teachers and college students that are trying to figure out how to get into social work and education fields.

Senator Osland: (23:40): Do you utilize a lot of retired teachers or no?

**Mr. Lauren Bosch**: That's a demographic that could provide some value for us, but at this point that's not a huge component of who's working for us or volunteering for us.

Senator Myrdal: (24:30) Representative Meier, are you in support of these amendments?

Representative Meier came back up to podium.

Rep. Lisa Meier: Yes, I would be in support of these amendments.

**Senator Myrdal**: It seems to remove old references to youth, is that correct? I find that interesting. Can commerce explain that?

**Mr. Wayde Sick**: Came back to podium. The purpose for the amendments is to allow any AmeriCorps project access to the BCI background checks. We don't want the only specific projects to have access. So for those that are working with as the legislation currently states, "at risk youth and homeless young adults", we have projects that are helping in schools with 2<sup>nd</sup> and 3<sup>rd</sup> graders on reading. It is evidence based practices.

**Chairman Armstrong**: (26:25) This amendment makes it based on who the employee and the volunteer is and not who the end user. Isn't that what this amendment does? Who is the employer and the volunteer, that is getting the background check as opposed to who is getting the ultimate service.

**Mr. Wayde Sick**: Correct. It is the project or the non-profit that is doing services the government has access to the background checks. So as the legislation is written, only agency like Youth Works would have access. The amendment would open it up to any agency or organization that applies and is granted funds through the Department of Commerce. We are not trying to specifically remove the youth we just want to allow any of our projects access to BCI background checks.

**Lindsey Neusma:** Staff attorney for Supreme Court, briefly testified in support of the bill. Just want to say the Supreme Court is in support of the bill. We would appreciate streamlining the process.

Chairman Armstrong closed the hearing on HB 1060.

Chairman Koppelman and members of the committee, my name is Wayde Sick and I am the Director of the Workforce Development Division of the North Dakota Department of Commerce.

I am here to testify in support of HB 1060, which would allow sub-grantees of the North Dakota State Commission on National and Community Service to utilize the North Dakota Bureau of Criminal Investigation to conduct Criminal History Background (CHB) checks on their prospective AmeriCorps volunteers and employees.

The AmeriCorps program is a federal funded program which is administered by the North Dakota Department of Commerce, Workforce Development Division, with oversight from the North Dakota State Commission on National and Community Service. Representative Meier and Senator Mathern are both Commissioners. AmeriCorps funding is granted out to public and private nonprofit organizations to provide assistance to recruit, train and supervise AmeriCorps volunteers meeting critical community needs in the areas of education, disaster services, health, environmental stewardship, economic opportunity and service to veterans and military families. Historically, most North Dakota projects have focused on education. AmeriCorps volunteers earn a small living allowance while serving and upon completion receive an educational award which can be used to pay tuition or pay off current student loans.

In order for AmeriCorps employees and volunteers to serve, they must first pass a CHB check. Using the approved processes, background check results can take between two weeks and four months to be processed. While a project is waiting for CHB check results, according to Corporation of National and Community Services (CNCS) guidelines, AmeriCorps employees and volunteers can serve, but must be constantly accompanied by a cleared employee. This is a hardship for the project as neither the AmeriCorps volunteer or the employee can be utilized to their full potential. Secondly, consistency is an issue when utilizing non-state methods. A CHB check may not go back far enough historically or review histories in all places the individual may have resided. The top audit finding that requires AmeriCorps funded projects to return funds to CNCS is discrepancies in the CHB check process.

The Department of Commerce does have recommendations for amendments to HB 1060. Please refer to the attached document.

These amendments would allow all AmeriCorps projects, current and future, funded by the North Dakota State Commission on National and Community Service to utilize the North Dakota Bureau of Criminal Investigation for their CHB checks, in turn expediting the process and providing more accurate results.

This concludes my testimony and I would be happy to answer any questions at this time.

# Testimony Regarding HOUSE BILL NUMBER 1060

Chairman Koppelman and members of the Committee, my name is Lauren Bosch and I am a Program Manager at Youthworks. I am primarily responsible for both the AmeriCorps and Guardian ad Litem programs at the agency. I am here at the request of Representative Meier to provide information regarding the amended version of House bill 1060. Furthermore, I am seeking support from the committee regarding the potential expansion of this bill to allow for criminal history records checks for Guardians ad Litem.

Youthworks is a private, non-profit agency that provides services to at-risk youth and homeless young adults and their families. The agency began providing services in the Bismarck area in 1986 and expanded services to Fargo in 1992. I have been an employee of the agency since 1994 and a member of the management team for the last several years. Youthworks employs approximately 150 full and part-time employees that provide services across the state. Youthworks maintains grants and contracts with several state agencies to provide necessary services to its clients, including; the ND Department of Commerce, Department of Public Instruction, Supreme Court and Attorney General's office. Many of these state agencies require a criminal history records check for employees and volunteers hired with grant/contract funds. However, Youthworks cannot access a thorough criminal history records check through either the ND Bureau of Investigation (ND BCI) or ND Department of Human Services (ND DHS) for some of its employees because the services provided through the state grant/contract are not listed in NDCC 12-60-24.2.

Youthworks has been an AmeriCorps grantee since 2002. Federal AmeriCorps fund are awarded to the ND Department of Commerce and then granted to private entities across the state. These entities enter into a 12-month agreement with the Department of Commerce to provide specific services. Approximately 10-15 AmeriCorps volunteers serve clients at the agency's Bismarck and Fargo offices.

AmeriCorps grantees, per federal guidelines, are required to conduct both a statewide (ND BCI) and nationwide (FBI) background check for all AmeriCorps volunteers.

Youthworks is able to access a thorough criminal records check through ND DHS for its AmeriCorps volunteers. This is because AmeriCorps volunteers have access to youth sheltered at the agency's Short-Term Care and Assessment Centers in Bismarck and Fargo. ND DHS licenses these Centers in accordance with NDCC 50-12 (Child Placing Agency) and requires the criminal records checks. Youthworks supports the amended version of HB 1060, as it would provide the agency a means to access a criminal history records check for its AmeriCorps volunteers if its Child-Placing Agency license with ND DHS would end.

The most urgent need for Youthworks pertains to its contract with the ND Supreme Court to provide Guardian ad Litem (GAL) services. Youthworks maintains a roster of between 40-50 full and part-time GALs that live across the state. GALs represent the best interests of deprived children involved in juvenile court proceedings. These children have often been removed from the custody of their parents due to allegations of abuse or neglect. Referrals for GAL services are made by the juvenile courts across the state. Once assigned to a child through a court order, the GAL gathers facts from interested parties, including: the child, the child's parents, relatives, foster parents, school personnel and treatment providers. A report is then written by the GAL and submitted to the court to aid the judge or referee with dispositional decisions. GALs are assigned to represent approximately 1000 deprived children annually. Youthworks hires between 10-15 new GALs each year.

North Dakota Rule 17 requires a criminal records check for all GALs. However, Youthworks currently has no statutory authority to access a timely FBI check for GALs through ND DHS or ND BCI. Instead, the agency is forced to interface directly with the FBI and receives criminal record results in approximately 12-16 weeks. Historically, criminal records checks for GALs were completed by ND BCI, with assistance from the ND Court Administrator's Office (CAO) of the ND Supreme Court, and results were retuned to Youthworks in as little as two weeks. In early 2015, the CAO informed Youthworks that it was no longer comfortable managing the background checks because the GALs were employees of Youthworks and not of the "judiciary". Following

this decision, Youthworks staff reached out to ND DHS, ND BCI and the ND Supreme Court in an effort to develop a timely option for completing FBI checks for GALs. All of these agencies were sympathetic to the problem, but could no provide access to an established criminal records check process because they did not have the statutory authority to do so. The current "last in line" arrangement with the FBI has resulted in an extensive time lag that jeopardizes Youthworks ability to assign GALs as required by Rule 17.

In summary, Youthworks supports the amended language to HB 1060 as it pertains to criminal history records checks for AmeriCorps volunteers. The agency also requests that language be added to Section 1, allowing any agency that contracts with the ND Supreme Court to provide GAL services the ability to access a criminal history records check through ND BCI for all prospective GALs. Sample language that could be included into Section is as follows:

"The supreme court, for the employees of a contract organization that are providing Guardian ad Litem Services to the supreme court."

Youthworks further supports the insertion of language into the bill regarding a reasonable fee to be charged for any requested criminal history records check.

The reason for placing this requirement under the Department of Commerce is it will be cost savings and the turnaround time will be faster.

Sen. Mathern and I serve together on a Governor appointed Board that is directly related to Amer-Corps volunteers and community service.

We were notified by Youth Works Director Lauren Bosch that background checks that used to be done by the ND Supreme Court for Guardian Adlitems are no longer being done since 2015, because they are not employees of the ND Supreme Court.

The responsibility is now Youth Works responsibility.

Obtaining thorough criminal record checks, including FBI finger-print based checks for these employees has been a struggle for Youth Works.

By placing this responsibility under the Department of Commerce it would be a better process for this requirement.

Chairman Armstrong and members of the committee, my name is Wayde Sick and I am the Director of the Workforce Development Division of the North Dakota Department of Commerce.

I am here to testify in support of HB 1060, which would allow sub-grantees of the North Dakota State Commission on National and Community Service to utilize the North Dakota Bureau of Criminal Investigation to conduct Criminal History Background (CHB) checks on their prospective AmeriCorps volunteers and employees.

The AmeriCorps program is a federal funded program which is administered by the North Dakota Department of Commerce, Workforce Development Division, with oversight from the North Dakota State Commission on National and Community Service. Representative Meier and Senator Mathern are both Commissioners. AmeriCorps funding is granted out to public and private nonprofit organizations to provide assistance to recruit, train and supervise AmeriCorps volunteers who meet critical community needs in the areas of education, disaster services, health, environmental stewardship, economic opportunity and service to veterans and military families. Historically, most North Dakota projects have focused on education. AmeriCorps volunteers earn a small living allowance while serving and upon completion, receive an educational award which can be used to pay tuition or pay off current student loans.

In order for AmeriCorps employees and volunteers to serve, they must first pass a CHB check. Using the approved processes, background check results can take up to four months to be processed. Currently projects work through a third party vendor or directly with the Federal Bureau of Investigation for CHB checks, which delays the process. Utilizing the North Dakota BCI would expedite the process as the BCI has higher priority. While a project is waiting for CHB check results, according to Corporation of National and Community Services (CNCS) guidelines, AmeriCorps employees and volunteers can serve, but must be constantly accompanied by a cleared employee. This is a hardship for the project as neither the AmeriCorps volunteer or the employee can be utilized to their full potential. The top audit finding that requires AmeriCorps funded projects to return funds to CNCS is discrepancies in the CHB check process.

The Department of Commerce does have recommendations for amendments to HB 1060. Please refer to the attached document.

These amendments would allow all AmeriCorps projects, current and future, funded by the North Dakota State Commission on National and Community Service to utilize the North Dakota Bureau of Criminal Investigation for their CHB checks, in turn expediting the process and providing more accurate results. As the legislation is currently written, only projects

providing mentoring and youth engagement to at risk youth and homeless young adults would be able to utilize the North Dakota BCI.

# Testimony Regarding HOUSE BILL NUMBER 1060

Senate Judiciary Committee

Chairman Armstrong and members of the Committee, my name is Lauren Bosch and I am a Program Manager at Youthworks. I currently serve as the Director of the Guardian ad Litem and AmeriCorps programs for the agency. I am here at the request of Representative Meier to provide information regarding the amended version of House bill 1060.

Youthworks is a private, non-profit agency that provides services to at-risk youth and homeless young adults and their families. The agency began providing services in 1986. I have been an employee of the agency since 1994 and a member of the management team for the last several years. Youthworks employs approximately 150 full and part-time employees that provide services across the state. Youthworks maintains grants and contracts with several state agencies to provide necessary services to its clients, including; the ND Department of Commerce, Department of Public Instruction, Supreme Court and Attorney General's office. Many of these state agencies require a criminal history records check for employees and volunteers hired with grant/contract funds. However, Youthworks cannot access a thorough criminal history records check through the ND Bureau of Investigation (ND BCI) for some of its employees because the services provided through the state grant/contract are not listed in NDCC 12-60-24.2. Testimony Regarding Section 2

The most urgent need for Youthworks pertains to Section 2 of this bill as it relates to its contract with the ND Supreme Court to provide statewide Guardian ad Litem (GAL) services. The language in this section will allow GALs employed at Youthworks access to a timely FBI criminal records check through ND BCI.

Youthworks maintains a roster of between 35-40 full and part-time GALs that represent the best interests of deprived children involved in juvenile court proceedings. These children have often been removed from the custody of their parents due to allegations of abuse or neglect. Once assigned to a child through a court order, the GAL gathers facts from all interested parties. A report is then written by the GAL and submitted

to the court to aid the judge or referee with dispositional decisions. GALs are assigned to represent approximately 1000 deprived children annually. Youthworks hires between 10-15 new GALs each year.

North Dakota Rule 17 requires a criminal records check for all GALs. However, Youthworks currently has no statutory authority to access a timely FBI check for GALs through ND BCI. Instead, the agency is forced to interface directly with the FBI and receives criminal record results in approximately 12-16 weeks. Historically, criminal records checks for GALs were completed by ND BCI, with assistance from the ND Court Administrator's Office (CAO) of the ND Supreme Court, and results were returned to Youthworks in as little as two weeks. In early 2015, the CAO informed Youthworks that it was no longer comfortable managing the background checks because the GALs were employees of Youthworks and not of the "judiciary". Following this decision, Youthworks staff reached out to ND DHS, ND BCI and the ND Supreme Court in an effort to develop a timely option for completing FBI checks for GALs. All of these agencies were sympathetic to the problem, but could not provide access to an established criminal records check process because they did not have the statutory authority to do so. The current "last in line" arrangement with the FBI has resulted in an extensive time lag that jeopardizes Youthworks ability to assign GALs as required by Rule 17.

## Testimony Regarding Section 1

Youthworks has been an AmeriCorps grantee since 2002. Federal AmeriCorps fund are awarded to the ND Department of Commerce and then sub-granted to private entities across the state. These entities enter into a 12-month agreement with the Department of Commerce to provide specific services. Youthworks supports Section 1 of the amended version of HB 1060, as it would provide a direct path to access a criminal history records check for its AmeriCorps volunteers.

In summary, Youthworks supports the amended language being proposed by the ND Department of Commerce for Section 1 and the current language in Section 2 of HB 1060. Youthworks further supports existing language in NDCC 12-60-16.9 regarding a fee to be charged for any requested criminal history records check. The fiscal note attached to this bill by ND DHS resulted from language that has since been removed from the bill.
