Beechie: Our board meetings are always open. Most of the plumbers out there probably don't even know that we are looking at increasing licenses fees.

Rep Ruby: There are a lot of bills that raise the fee & sets the amount, but having the ability to go much further putting that into statue is something a little different. Are you familiar with other boards that have that kind of leeway?

Beechie: I don't know.

Rep Ruby: I'm wondering, when you advance to that level but yet is still says in statue what will it be? It says that you have the authority, then you almost have to have a bill that would come back to remove the lower level that you are no longer charging. Would the higher level would be temporary until you cover cost & then it would go back to that lower level?

Beechie: The whole bill will be in statue, not just in rule. I don't think it will go up in my lifetime. We had them put it back in the bill, by motion, if our funds are back to where they should be, we can lower that license fee. If the day comes & the way this legislation is written, that we need to go higher, closer to the cap, that can be done by administrative rule.

Rep Bosch: Since most of your costs are associated with "cost of employment" & you are talking about increasing the rate, is the attempt to add additional employees or increase the pay of the individuals that are currently employed or is it catch up?

Beechie: It's the catch up. We are losing money. We see no need for more inspectors.

Rep Beadle: You have a 25% increase, is all the increase in expenditure, assuming that your revenue stays flat, is it because you hire full time inspectors or you anticipate seeing some costs go up? What caused those costs, the differential, to increase by 25% differents in your loss & how you will keep that from happening again.

Beechie: We don't hire. We are updating with a website.

Chairman Keiser: What is your current annual budget and reserve?

Beechie: Budget for fiscal year 2016-2017 is 681,001.57. Excessive revenue, over expenditures 158,251.57.

Beechie: We have \$300,000 in CD's, \$187,000 in the money market, \$11,000 in checking & \$29,000 in savings.

They came in asking for the increase & they gave themselves up to the maximum. I don't have a problem with the increase, but we could remove the authority to raise it up without coming back to us.

Rep Ruby: Motions to remove language throughout the bill. Dennis, intern, will make the changes & present them to the committee during a work session.

Rep Magrum: They gave up the rights for the inspections by the health dept. Sewer & water contractors pay for a separate license to the state plumbing board & they have to go to the local health unit & apply for a permit which is usually a \$100. Then they provide the inspections.

Rep Lefor: All these categories you described, the inspections were previously done by the plumbing board?

Rep Magrum: Yes.

Rep Louser: The plumbing board testified that they had a 6 figure deficit in 2016 & a larger figure projected for 2017. We were told there were no increases since 1987 & some cases

in 1992. By your testimony there has been some substantial increases in licenses fees, where is the discrepancy?

Rep Magrum: My increase to me is huge. For the same right I had in 1985 of \$65, now I'm paying for the same rights, I'm paying over \$800. They didn't increase fees but they took on less work. The board is doing less work & I'm paying more money because there are more entities to pay. It's costing me which I'm passing on to my consumers.

Rep C Johnson: The part of the increase is the one licensing fee to the plumbers, but now you only paying to the state, but also to the counties. Are you providing services to those communities?

Rep Ruby: Rep Magrum talked about the increases but the board hadn't increased in a long time. Their finances didn't look like they're in the best shape. He said that if doing some things to produce, how many times they have to go out & do their inspections, maybe they could reduce some of that. Most of the increase he talked about were the other permits from other subdivisions.

Chairman Keiser: That is correct.

Chairman Keiser: Reopens the hearing of HB 1114.

Rep Louser: As I understand it, there another inspector hired during 2008-2015, that may not be necessary anymore. That's is contribution to their deficit.

Chairman Keiser: The reality is that the boards are the official agencies of the state of ND. They are appointed by the governor, they have an assistant, the attorney general as an attorney. They only have two functions, licensing & regulation and we give them the rights. The boards are typically made up of people from within the industry. They have an obligation to prosecute in represent the people of ND in a legal action. We have to be careful to not to make the boards too small. This board is reporting to us, that they are in a deficit position. They can't increase the fees without us, I don't know how we can make them whole without cutting costs. We don't want it to come under the general fund to prosecute.

Rep Kasper: From the perspective of the industry, this board has acted the wrong way; they have farmed out which is why they are in the financial pickle. I'm going to resist this bill.

Rep Bosch: When a board is making wrong decisions, who polices them?

Chairman Keiser: I don't know.

Rep Ruby: It would go to the governor's office.

Chairman Keiser: It is usually stated in the legislation for a board, like a "must inspect each facility each once a year", so that's the law on one hand & if you don't have the man power to do it & live within the law, you are going to have to subcontract that work. This is not easy; they are policing themselves.

Rep Lefor: If we are going on the information that is in front of us, they are deficit spending. Rep Magrum made some comments, that they are given up a lot of the regulatory authority to the health department.

Chairman Keiser: We did that, not the board.

Rep Lefor: I don't feel I have enough information to make a decision. In my mind, they have to come & defend the fee increase.

Chairman Keiser: Of all the bills we have heard, we had the least quality representation at the podium to address our concerns on this bill. We don't have to take action.

Rep Dobervich: There was comments of deficit spending & not acting responsibly, before we would weigh those things into consideration, I would like more information are they disgruntled? I want evidence from someone other than them.

Rep Bosch: I would like the number of inspections over the past 10 years.

Vice Chairman Sukut: I have a couple of concerns. When he was talking, they added on a 4th inspector, now the activity isn't near as much, do they need the inspector? The other thing, they didn't survey their membership about raising the fees.

Rep Lefor: By taking our time to get to the root of this, I think we should invite the plumbers.

2017 TESTIMONY

HB 1114

House Bill 1114

The North Dakota State Plumbing Board (NDSPB) would like to raise license fees for sewer and water contractors and plumbers doing work in the State of North Dakota. The proposed bill would also increase exam fees and license renewal late fees. The NDSPB has been operating under a budget deficit for 2 years now. Our budget cycle runs from July 1st to June 30th of each year. As with many other boards, commissions, and agencies, the NDSPB recieves no funding from the states general fund. The majority of our revenue comes from License fees and license renewal fees.

In our 2014-2015 budget cycle we had a \$ 35,300 dollar budget deficit. The 2015-2016 budget cycle showed a \$ 126,800 dollar budget deficit. Our estimated budget for fiscal year 2016-2017 shows

A \$ 158,000 dollar budget deficit. The 5 members of the NDSPB have been very frugal over the years, and only now after more than 2 years of budget deficits have they given me approval

To request a license fee increase. The sewer and water license fees have never been increased since their licensing law went into effect in 1987 (30 years). Apprentice plumber license fees have also not been raised in 30 years, and burneyman and master plumbers license fees have not been raised since 1992 (25 years).

The projected revenue increases, which have been added up for you on the fiscal note, was formulated using the amount of current plumbers and sewer and water contractors we presently have now. A lot of contractors are from out of state, and we anticipate a sizable amount of those contractors will not be renewing their licensure as the work load has decreased in North Dakota, especially in western North Dakota. This bill would also give the 5 members of the NDSPB the authority to lower the license, exam, and late fees by motion as they see fit.

HI Chairman Keiser and committee members.I apologize for not being aware of this bill till very recently.I am a Master Plumber licensed under the state of N.D..I was the youngest Master plumber in the state in 1988 being 23 years old at the time .before that I attended college at Whapeton NDSSS and went through the apprenticeship ,and passed the journeyman plbg.test at 22 years of age.

I have invested my entire adult life in being on the front lines of the health care industry so to speak as plumbers have a very important role in protecting the health of our state and nation.

I am opposed to hb1114 as last session my license fee was increased by \$150. The plbg board released part of our business to the health dept. forcing us full service plumbing contractors to purchase another permit to do the same work that we were doing

before. That was a 91% increase in one year.

I will explain. When I became a plumber we had a full service licence .We were able to do sewer and water lines, septic systems, indoor plumbing and sewer vacuum services. Now they have released the septic systems to the health dept. city sewer and water to the cities and now septic vacuuming to the health dept. I disagree that the plbg. Board has not had an increase because they have taken on a diminishing role and have never lowered our license fee. They have recently increased our permit fees. The plbg board also receives fees when someone takes a plbg. or sewer and water test. My company now works in many different areas and in each city and local public health unit we have an extra fee that we never had when I started. I may be off a little bit as I don"t have access to the exact fees at the moment so I will list them as I can recall. N.D. state plbg board 165\$. Central Valley Health 125\$, Custer Health 100\$, Mandan city 100\$, Bismarck City 100\$, Burleigh County 100\$ and as stated before N.D. health dept. 150\$. The total would roughly be this does not include any extra bond requirements. So as you can see we have had many license fee increases to do the same work. The total increase is roughly 840\$- the 65\$ we started out with for the same rights. The total increase in licensing fees would be approximately 1250%. A 4% inflator increase x 30 years would be roughly 80\$ if one would add that to the fee of 65\$ we would be at 145\$. I agree with the fee they are getting now.

Chairman Keiser and committee members I respectfully ask for a do not pass on hb1114.

There have been five more questions that have been brought to my attention by the committee members of Industry, Business, and Labor. I would like to address these questions and any other questions the committee may have for me.

1) Question: The NDSPB has less responsibility as a result of the Health Department assuming some inspections and duties. Does this result in savings for the NDSPB?

Answer: The State Health Department does not do any inspections or assume any duties for the NDSPB. I believe this comment may have come up regarding the District Health Units and private sewage disposal systems (HB 1331). The State Health Department is committed to helping the District Health Units with public sized disposal systems.

2) Question: Did the NDSPB survey the membership about the fee increase?

Answer: The NDSPB asked the (NDPHMC), North Dakota Association of Plumbing, Heating & Mechanical Contractors to survey their entire membership. It was done for us by Dave Romine-Executive Vice President of the (NDPHMC), and the results are a positive response, (see handout).

3) Question: With the decrease in western ND construction, does the NDSPB need four full time inspectors?

Answer: We feel our inspector situation is adequate enough to assure good statewide coverage for plumbing inspections. Typically we try to do three inspections on every job, an underground plumbing inspection, an above-ground plumbing and water line inspection, and a final inspection after all fixtures and appliances are installed. Our inspector for SE North Dakota also inspects all of West Fargo, which is a full-time job in itself. Then we have our Minot inspector who covers most of the northern tier in North Dakota. Our inspector out of Beulah covers western North Dakota (everything south of Lake Sakakawea and west of the Missouri River. I would actually consider myself as a part time inspector even though I have a sizable area to inspect also. With my office duties and responsibilities I am able to get out on inspections an average of two to three days a week. I cover far NE North Dakota down through Devil's Lake and central North Dakota and down to the South Dakota border. In summary, when you consider that our eastern inspector is almost full-time in West Fargo, and with my schedule and duties, it is almost as though we only have 2 and ½ inspectors. The NDSPB will also be taking over all of the City of Jamestown plumbing inspections starting March 1, 2017.

4) Question: There was testimony with complaints that the NDSPB keeps charging fees and "taking away rights" of plumbers. Has there been any formal complaints about the Board and if so what are you doing to improve that situation.

Answer: There have been no formal complaints about the board since I started in 2008, and none before then that I know of. I spoke with Representative Magrum after his testimony on HB 1113 (Criminal history background checks) where he stated that the NDSPB is "picking on plumbers, and wants to put more regulations on plumbers, and we don't want the NDSPB to be too over-regulatory". I explained to him that the Board's intent was not to do background checks on all new applicants and all existing licensees, but to do checks on individuals who mark

on their application or renewal form that they had been convicted of a felony, and to possibly do background checks on individuals that we would receive complaints on, depending on the complaint. That actually seemed to make pretty good sense to Representative Magrum, and I now wish I would have talked to him about it sooner.

5) Question: Why is the Board deficit spending? A list of the causes of deficit spending would be helpful.

Answer: We now have the inspectors to properly cover plumbing inspections for the citizens and businesses in the State of North Dakota, which was explained in item #3. Of course that comes at a cost. The NDSPB is an autonomy, we receive no funds from the general fund. We have all the expenses of running any other kind of business. We do our own payroll, rent office space, hire employees as needed, travel expenses, vehicle replacement and repairs, office equipment, supplies, insuranceetc. We are now almost complete with launching a web-site and online content management system so our licensees can apply, renew, request inspections and order code books online and so on. The NDSPB has been spending some of our reserves to keep up with our expenses. I personally would have liked to been doing a license fee increase two years ago, but our board preferred we draw down reserves until they felt it was absolutely necessary to increase fees.

Here are other items I would like to tell you

- 1) First year apprentices (pro-rated)
- 2) Salaries (follow state mandates)
- 3) Enforcement (need for inspectors)
- 4) Audit (Brady Martz) every other year
- 5) Current licensees (817 less then on fiscal note)
- 6) License fees have not been increased in 25 and 30 years, but the cost expenses have increased (payroll salaries and benefits, taxes, rent, supplies, printing, postage, insurances, vehicles, fuel, lodging, etc.)
