Representative Kempenich: Testifying for HB 1161

This bill is changing one word; it puts in reductions instead of allotments into the code for how we're dealing with what happened here this last year.

Representative **Boe**: If we are calling this reductions, do they have to be equal or can they be unequal?

Representative **Kempenich:** It wouldn't change anything for how things are done today, it would read the same way, just a change of allotments.

Chairman **Delzer:** I would have a question for you Brady; with the bill to change the 3% and 3%, do we need to change line 18 on page 1 to 6%?

Brady Larson, Legislative Council: First page I don't think that would change allotment, I believe this would just refer to cash flow financing of the state

Chairman **Delzer** I believe you have to be short 5%

Representative **Kempenich**: I am also adding an amendment to this, (see attachment 1) This amendment makes the special funds identify their reductions too. So they have to give it some though and see where they would make their cuts like everyone else.

Representative **Holman:** Give me an example if where that would apply.

Representative **Kempenich:** Anyone that is 100% special fund, make them look at their budget as a total instead of just the general fund side. Makes them look for efficiencies to make sure. It might even highlight some of the issues that could be showing up.

Chairman **Delzer** Have you thought about, like human services, they have a large amount of special funds and federal funds, this is only applying to state special funds. What about the one that are collecting tax dollars?

Representative **Kempenich:** Make them look at their budget, we used 60 days because we thought that was already in there.

Representative **Monson:** When we are talking about special funds, I think WSI, those are 100% special funds, insurance premiums, paid by employers, what happens if you give them an allotment? Can they pay their claims?

Chairman **Delzer:** This would not make anyone do it, it is just having them look at it shows how they would have if they had to. That way the legislature could look at it and review it.

Representative **Kempenich:** It would affect how we would look at their budget. Their administrative cost, right now everything is shrinking, make them identify where they would have to go to get the budget down if they did have to.

Representative **J. Nelson**: Seems like most of the discussion is on the amendment, I am still trying to figure out the need for the bill? Why allotments and not reductions. Representative **Kempenich**: Reduction mean reduce; allotment mean to share. Representative **Boe**: Allotment; the amount of something allocated to a particular person Representative **Schmidt**: Allotment is money that we give to them and when ask for it back it's called a rescission, because we're rescinding it.

Representative **Brandenburg:** There are a lot of agencies that are upset because other agencies that are special funded are safe from these budget cuts.

Chairman **Delzer:** The bill doesn't change any of the actions that would happen anywhere, it does change the words, the amendment does change some of the actions.
