(3:30) Chairman Poolman: You stated that you are not allowed to carry a Taser at the capitol; do we need to put some sort of an emergency clause so that you can do that immediately upon passage of the bill?

**Major Brandon Solberg:** That would be great if an emergency clause could be added. Currently our civilian capitol security officers are not carrying Tasers.

**Senator Meyer:** With the youth academy, you said that there was some risk management issues; what were some of those concerns?

Major Brandon Solberg: The concerns from Risk Management were mainly that we did not have any authority in law to hold such an academy and so there were risks involved such as exposing students to fire arms training for example. Risk Management just wasn't comfortable with that unless there was some authority provided in law. This verbiage change was proposed to Risk Management and we worked with them to make sure that this would cover it.

**Chairman Poolman:** I would imagine that in our environment it is difficult to get people to want to go into law enforcement at this point. Do you have other things that you have been working on for promotion? I think this youth academy is a great idea.

Major Brandon Solberg: This is one of the things that we thought of that would be new to us. We have always focused on recruitment through advertising, social media, and

Facebook- we have over 20,000 likes on our webpage. We have been very fortunate in ND where, unlike many areas around the nation, we have such strong community support. We don't take the negative hit like some areas of the nation where law enforcement is viewed as an evil profession. We really have not had a negative effect on our ability to recruit. It is certainly not easy and it is not a profession that people are excited to get into and this would allow us to try and target the younger generations. Then if they share that information with family and friends it puts a positive light on the highway patrol.

**Chairman Poolman:** I do think that since we are seeing increased security measures that this certainly would be part of that. I think it is an easy sell.

Chairman Kasper opened the hearing on SB 2097.

Major Brandon Solberg, Chief of Staff for the North Dakota Highway Patrol, appeared in support. Attachment 1. (:01:10-:04:45)

**Rep. Laning:** Can you give me a definition of differences between public and private security personnel?

**Major Brandon Solberg:** That is mainly who your employer is, if you are working for a government, public entity versus a private security company. If they just hire private individuals to provide security at facilities, they would be allowed to carry a dangerous weapon.

**Rep. Laning:** Are there any training differences?

**Major Brandon Solberg:** I couldn't speak to what is required privately. Publicly, we provide our own level of training to our own security officers. Taser has requirements and courses. Taser itself really bumps up the requirements specific to what we are trying to address here.

**Rep. Rohr:** Are those the new badges that you are wearing?

**Major Brandon Solberg:** These are our current badges. The conflict is that the way our current badges set, we are not in compliance with Century Code. We are trying to adjust the language to match our current look of the badge.

**Rep. Rohr:** I think the youth academy is great idea. Would the children under 18 have to go through background checks, immunization records, etc.?

**Major Brandon Solberg:** I would say we would probably do some sort of limited background check. This is the upper high school level that we are trying to target. We talked with risk management and legal counsel. We provided a draft agenda as to what we would be looking at doing. We would have to come to some sort of agreement with both of those entities. Initially, the answer is no, you can't do this at all because you don't have the authority to do so in law.

Rep. Steiner: How many children do you think that you would be trying to bring in a year?

**Major Brandon Solberg:** I could see starting out by hosting one class a year with no more than 20 students.

**Chairman Kasper:** Is the Code preventing from you doing your job?

**Major Brandon Solberg:** If anyone is going to try and comply with the law, we should set the example. That is mainly cleanup language in that case. In the instance of a youth academy, we are very careful to following the rules and trying to stay out of trouble, so we run a lot of things through our legal counsel and risk management and get their feedback.

**Chairman Kasper:** I would suggest for the next legislative session that the Highway Patrol consider looking at the code that applies to you and your department, and look at areas that you think should be updated or cleaned up or amended to be able to do your job better and be able to make decisions that I think are really minor and get us out of micromanaging what you can and cannot do.

Major Brandon Solberg: I appreciate the advice and support, and we can definitely do that.

Chairman Kasper closed the hearing.

Rep. Laning made a motion for a DO PASS on SB 2097.

**Rep. Olson** seconded the motion.

### Senate Bill 2097 Government and Veterans Affairs Committee Senator Nicole Poolman, Chairman January 12, 2017

Ms. Chairman and members of the Government and Veterans Affairs Committee, my name is Major Brandon Solberg, chief of staff for the North Dakota Highway Patrol. I am here to provide testimony in support of Senate Bill 2097.

First of all, this bill would bring our current issued highway patrol badges into compliance versus buying all new badges. Our current badges use the term "North Dakota patrol", instead of "North Dakota highway patrol." Due to the size of our badge, it is difficult to incorporate any more wording on them without making the font smaller. This bill also provides an update to allow the officers unit number or symbol of rank to be displayed at the bottom of the badge instead of a serial number.

Secondly, this bill adds a subsection to the powers of the highway patrol. This subsection gives the highway patrol the power "to promote public trust and an understanding of law enforcement through education, community outreach, and job shadowing programs." The highway patrol continually looks to promote the agency and build public trust.

One such avenue would include the use of a youth academy. Youth academies are conducted by law enforcement agencies nationwide, but they are new to our agency. A youth academy would expose high school age students to several aspects of law enforcement, which not only helps with potential recruitment in the future, but also with building trust among up and coming generations. While researching this option in the past, risk management issues were identified concerning our authority to host such an academy. This bill would help clear up those concerns.

The third update is a simple verbiage change to subsection 3 of North Dakota Century Code 39-12-02. Interstate permits are now available for purchase online so this language change would remove a reference to a system of self-issuing cards that is no longer used.

The last update this bill would provide is an addition to the list of individuals allowed to possess a firearm or dangerous weapon at a public gathering. Currently, the law allows private security personnel while on duty to possess a firearm or dangerous weapon, but there is no such authority for public security personnel. Because the definition of a dangerous weapon was changed to include a Taser, Capitol Security officers are no longer allowed to carry them. Adding language to cover both private and public security personnel would address the highway patrol's concern about preventing Capitol Security officers from carrying a Taser while on duty.
