Explanation or reason for introduction of bill/resolution:

A concurrent resolution authorizing the Budget Section of the Legislative Management to hold the required legislative hearings on state plans for the receipt and expenditure of new or revised block grants passed by Congress.

Minutes:

Legislative Council: Levi Kinnischtzke OMB: Becky Deichert

Chairman Holmberg called the committee to order on SCR 4001. Roll call was taken. All members were present. (microphone checks were being done)

Levi Kinnischtzke, Fiscal Analyst, North Dakota Legislative Council

He is neither for nor against the resolution and only providing information.

In August 2016, the Legislative Council staff contacted state agencies receiving federal funds to determine which agencies received block grants that require legislative hearings. The results which were presented to Budget Section in September 2016 revealed that only one block grant required a public hearing to be heard by the legislative assembly which was the community service block grant administered by the Dept. of Commerce, Division of Community Services. That hearing was held by the committee on January 10, 2017 as part of the appropriations hearing for the Department of Commerce.

The Community Services Block Grant provides funds for services and activities for the poor, particularly the elderly, homeless individuals and migrants. Services include housing, health, nutritious food and self-sufficiency. The Department of Commerce anticipates receiving approximately \$7.12M of federal funds through the community services block grant program during the 2017-19 biennium which is approximately \$333,000 more than received during the 2015-17 biennium.

SCR 4001 authorizes the budget section of the legislative management to hold the required legislative hearings on state plans for the receipt and expenditure of new or revised block grants passed by congress. This would run through September of 2019 and this resolution is the same as has been passed for the last five bienniums.

Explanation or reason for introduction of bill/resolution:

A concurrent resolution authorizing the Budget Section of the Legislative Management to hold the required legislative hearings on state plans for the receipt and expenditure of new or revised block grants passed by Congress.

Chairman Delzer: We'll be taking up SB 4001 it's the concurrent resolution authorizing the budget section of legislative management. Levi is here from council.

2:10-4:30 Levi Kinnischtzke, Fiscal Analyst for Legislative Council: I am here to present on Resolution 4001, testifying neither for or against this resolution. In August 2016 the legislative council staff contacted state agencies receiving federal funds to determine which agencies received block grants that require legislative hearings. The results which were presented by the section in September of 2016 reviled that only one block grant required public hearing to be held by legislative assembly. That grant was the community services block grant which is administered by the department of commerce division of community services. This meeting was held by senate appropriation committee on January 10th 2017 as part of their appropriation meeting with the department of commerce. The community services block grant provides funds for services and activities for the poor, the elderly, homeless individuals and migrants. Services include housing, health, nutritious food and self-suffices. The department of commerce anticipates receiving approximately 7.12 million of federal funds during the 2017/19 biennium. That about 333 thousand less then was estimated to be received during the 2015/17 biennium. Concurrent resolution 4001 authorizes the budget section of the legislative management to hold the required legislative hearings on state plans for the receipt or expenditure of new or revised block grants passed by congress, so this would run through September of 2019. This is similar to how it was passed the last 5 biennium.
