Chairman K. Koppelman: Opened the hearing on HB 1117.

Rep Devlin: (Attachment #1) Read testimony.

Representative Jones: What about the last sentence on the bill. What does that mean?

Steve Andrist, Executive Director of ND News Paper Association: (Attachment #2) I would like to answer the previous question. Sometimes newspapers make mistakes so that is why the disclaimer is on there. That is a catch all.

Chairman K. Koppelman: Had you had any issues with that?

Steve Andrist: We do have a standard form letter from the Newspaper Association when we place public notice adds in multiple papers and one forgets and publishes on the wrong day so we tell them there was a mistake, but it is not fatal to the process so you are able under the law to go forward with the process. Read Testimony. (6:00-8:30)

Rep. Paur: Would it be wise to have them required to be posted on that site?

Steve Andrist: That would be a good idea. We do not have universal consciences on that so as a compromise to those people you can use the statewide website. It does require that if it is posted on a newspaper's individual website that it be put in front of a paywall and the place is accessible to anyone who wants to search it without cost. We will on our website link those sites can be found.

Rep. Rick Becker: Are you not able to do this now?

Steve Andrist: Yes we do this now. We don't have universal participation and we view this as a state law as a way to insure that we get as wide a distribution of this as we possibly can.

Rep. Rick Becker: I am surprised by that last sentence. If you make a mistake the hearing is still good? This is surprising that if you make a mistake it is still considered to be good? You said because it is not fatal it would still be considered good. Are there two tiers of mistakes?

Steve Andrist: There is still the decision of the publishing entity to decide that it is fatal; and if they chose to determine that it is a date of a meeting, yes we need to start this process over and redo it. If it is just a misspelling of a name; they would be held liable for doing it that way. It is just an out for a government entity.

Chairman K. Koppelman: The discussion has been that the long standing requirement be sent in a local newspaper. Some say they are a thing of the past. We have not changed the law in ND, but we are aware that the younger generation may read them on line so this is a response to that situation.

Steve Andrist: | agree.

Representative Jones: Sometimes the legal notices can get too lengthy. Is it going to be easy to go on the site and read it for just New Town and go quickly to the New Town portion and not have to read through everyone else's?

Steve Andrist: On the front page of the website there is a map and you can refine your search down and find it that way.

Rep. Vetter: Is there an amendment we can add to determine what is an acceptable error?

Steve Andrist: Yes we could look at that with the legislative counsel.

Chairman K. Koppelman: Maybe we can create a term and look at this. Rep. Paur said this website you can go to but when you want to know the location of a meeting in a county. This could be an issue in respect to the public getting the information. I think it would be in the interest of the association and newspapers in general if the goal is to keep newspapers as the gold standard with respect to public notices and the modernization of that is website presence it would make sense to be part of the game.

Steve Andrist: I do agree with you. I am more than willing to go back and to those who have resisted that the weight of the committee is against them and see if we can make some changes.

Donnell Preskey, NDAC: Support this bill. No counties have problems with this.

A probable amendment on line 9, if we were to eliminate the word either after notice; line 10 instead of the word or use and; and then on line 11 after the word public insert the words if the newspaper maintains such a website.

Rep. Paur: I brought this up but now I am having second thoughts. A lot of the smaller newspapers are doing well because they do not have a web presence. You have to get their newspaper because if they want the local news or you want the local postings. We would be hurting them is this because they would not have to buy a newspaper.

Chairman K. Koppelman: The legal notices are a good source of money for a newspaper. General public does not do that. Discussed pros and cons on this change and how it would affect all newspapers. The day will come where the state law changes and says you don't have to publish in your local newspaper. The city could have a website and then they bypass the newspapers altogether.

Rep. Paur: But now I can go to the Forum and probably look up the legal, but I can't do this for Northwood?

Mr. Steve Andrist, **Executive Director of the North Dakota Newspaper Association**, represent the 78 weekly newspapers and 10 daily newspapers across the state of North Dakota. **Written attachment #2**. (4:00-6:18)

Senator Diane Larson: This sounds like a really great idea. What kind of or how will you get this information, this web-site information out to people? Is that going to be in your printed newspapers or something like that so that more people know that they can access this information this way?

Mr. Steve Andrist: You're right. Having the information online is only half the battle. The other half is telling people that it's there so they know where to look for it. We will do a campaign within our newspapers to promote it that way. The website actually exists now. But it is the voluntary sort of thing. So we'll also do some public service type of announcements to try to make it available. We will put it on our social media, as well as in our newspapers.

Senator Anderson: Do you think there's a problem with telling these private businesses that they have to do something and they can't charge for it?

Mr. Steve Andrist: Our members agree that this is an important thing to do, and they are willing to do it. For them just to give you a little background, it requires them to post these notices so it's something that each newspaper has to do on its own. But it's going to take them probably 10 minutes a week to do it. So we really have seen no objection to it from our members.

Senator Anderson: Maybe next session somebody will come forward and say that because it's a public spirited thing that people need to know they should publish the notices in the newspaper but they shouldn't charge for it.

Mr. Steve Andrist: We realize that might be something that someone would suggest and we are willing to do it in that way as soon as the IT services and the other services that are purchased by the state are offered free of charge.

Senator Dotzenrod: There's a reference in here to their own newspapers website if the newspaper maintains a website. I don't suppose we can assume that every of your 78 members that they all have websites. I would think that most of them would.

Mr. Steve Andrist: Most do, but not all. There are still some that don't have websites and there are still some that believe they're market is in print and not online.

Senator Dotzenrod: You have 78 members, are there newspapers in North Dakota that are not members?

Mr. Steve Andrist: No there are none, that I know of.

Senator J. Lee: So this isn't going to be an option for the newspaper is it? It is going to be something that they will all be expected and required to do? So if I run the ABC Judy Lee newspaper I don't have to do it or do I have to do it?

Mr. Steve Andrist: You would be required under the law to do it.

Senator J. Lee: I know for sure that there are newspapers that don't have a website because every once in a while, as one of the rural papers that I occasionally read there will be something that I like to save and I can't get it. So I wish that they would have a website.

Mr. Steve Andrist: The key for us really is to have a centralized website the NDNA so that it's in one central location. The House decided to add as an amendment the section that says "and in the newspapers website if it has one". So we have no objection to that, so that is where that amendment came from.
