**Senator Marcellais:** Initially it was just for that biennium, and we would like to continue.

**Lonnie Wangen, Commissioner of Veterans' Affairs,** appeared in support. After last session we did the fundraising, purchased 5,000 coins, and the concern we had during session was where is our authority to spend the money that we received. We did end up going to the emergency commission and received permission for last biennium to spend money on the coins. We are asking here as we need to purchase new coins or other things to get the coins mailed out, that we can do so without going to the emergency commission. It has been a very good thing giving out that one coin at the funeral, and then the follow up with them purchasing the coins was a lot higher than I had expected. We sold about 500 coins and make a profit of \$7 a coin. Hopefully by the time we get close to needing to replenish, we will have enough funds back there and will not have to do as much soliciting for funds. Section 3 puts in law sales tax exemption.

Good Morning Mr. Chairman and members of the GVA committee. I'm Rep. Vernon Laning from District 8 and am here to introduce HB 1131.

HB 1131 is a bill that for the most part I thought had been taken care of during the last legislative session. Some of you may remember discussions regarding a veteran's commemorative coin that was to be given to family members upon a veteran's death.

The Department of Veterans Affairs was given the authority to collect money to fund the initial design and purchase of the coin. Then additional coins could be sold to family members at a price the DAV was to determine that would actually fund future purchases of the coin.

This was done, but if I could direct you to the bill itself, section 1 paragraph 1 has language at the end that says, "with the approval of the emergency commission." This was not the intent with the coin program and so we'd like to revise the code.

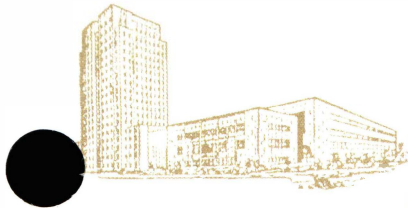
Paragraph 2 is actually an expansion of the expenditure provision in that it gives the DAV the authority to expend funds given to it for a specific cause as long as it is spent for that cause only. Plus it would be on a continuing appropriation basis, meaning they would not have to obtain emergency commission permission to spend donated funds for a specific cause such as the commemorative coins.

What that means is, if I want to contribute toward the commemorative coin fund or some other specific cause, that money could be accumulated and spent by the DAV to purchase more coins or other specifically identified cause anytime it deemed necessary without waiting for the quarterly meeting of the emergency commission.

Additionally, the DAV has had numerous requests from persons around the country wanting to fill out coin collections and purchase the commemorative coin. After discussion the DAV has decided open sales of the coin would not deter from its commemorative value and proposes under section 2 para 2 to change the language to "Any person" may purchase.....

The section 3 of the bill exempts the sale of the coin from sales tax which would greatly simplify the paperwork involved in coin sales.

That is essentially the bill Mr. Chairman and with that I'll stand for any questions and I may be followed by others wishing to testify, but we would ask for your do pass recommendation.

The 2017 Legislature approved a ND COMMEMORATIVE COIN. As the bill was being discussed in appropriations and about to die the then coordinating council decided to recommend passage of the bill without funding. This resulted in it being assigned to the ND Department of Veterans Affairs for implementation. Due to the lack of staffing the Department was unable to devote much time to this project. I believe it was in August of 2107 that the Veterans Affairs Commissioner asked if I would take the reins. Funding and seeking a design for the coin began. On January 24, 2018 The ACOVA approved the design and immediately coin manufacturers were requested to submit bids. In late spring 2018, a very successful fund-raising campaign secured approximately \$12,000. Based on what we felt we wanted in the coin a bid of slightly over \$2 per coin was accepted. We than bought 5000 coins which was 1000 more than the mandate of 4000 coins. The list of those donors is included in my packet.

All the policies and procedures necessary for release of the coin were approved on June 28, 2018, including the Tax Commissioner ruling that the coin was exempt from sale tax. The first coin was presented at the ND Veterans Cemetery the following day.

The memorial coin, commonly called the "Funeral Coin" is presented free of charge to a family member of a deceased veteran. Multiple coins may be purchase for \$10 a piece through the Department of Veterans affairs. Since June some issues arose that prompted this bill.

1. Only family members are eligible to purchase. And as I was pre planning my departure from this world that became problematic. As you see by the coin display being passed down, you see it is from me to my grandson. I wanted to provide a coin as my gift to my children and step-children along with my grandsons and step-grandchildren. When I went to purchase them, I was told I could not. I needed to be a family member of a deceased member. Fortunately, my Father was a WWII Veteran, so I purchased coins under my Father's name. I felt a little uncomfortable about doing it this way. When my brother-in-law

passed away this fall, I had to do the same. I wanted his children and grandchildren to have a coin.

My concern is what about the veteran who is preplanning and wants to include the coin as a final gift to his family members.

2. The ND Century Code allows the Department of Veterans Affairs to accept and expend funds from any source. The Department works with many entities and we believe that all donations should be appropriated and expended for the purpose they are donated on continuing basis. Currently all these funds require prior approval from the Emergency Commission to expend those funds. The Emergency Commission only meets quarterly with no set dates.

Since NDCC 37-18-12 allows us to accept funds from any source ask the that this section of code should be amended to allow the Department of Veterans affairs to accept and expend funds in the same manner or for the purpose for which they where donated, on a continuing basis. As pertaining to the coin, this is on-going process with monies coming in and monies going out for postage, packaging, etc. We believe the Emergency Commission should be used for Emergencies and not ongoing programs utilizing outside monies from donors

The North Dakota Veterans Legislative Council supports this bill and asks for a do pass. Thank You

**The coin is a gold coin 1.75 inches in circumference.**

**On the front of the coin is a white banner representing "Righteousness,"**

**The banner surrounds a sky-blue background representing the blue of heaven and the skies of North Dakota along with "Vigilance"**

**"Perseverance" and "Justice". On the white banner is written "NORTH DAKOTA MILITARY FUNERAL HONORS\*ON BEHALF OF A GRATEFUL STATE"**

**The emblems of the five branches of the military are linked together surrounding a crossed US and North Dakota Flag signifying a unified defense of both the nation and the state.**

**The back side of the coin is solid gold in color representing "Achievement and Honor and has the familiar "Battle Cross" or Soldiers Cross in the middle. Surrounding the Battle Cross are phrases from the familiar song Taps played at all military and veterans funerals.**

**On both sides are shafts of wheat representing "the Divine Harvest: and the base of the Soldier Cross may be engraved as well as the sides of the coin.**

Since NDCC 37-18-12 allows us to accept funds from any source ask the that this section of code should be amended to allow the Department of Veterans affairs to accept and expend funds in the same manner or for the purpose for which they where donated, on a continuing basis. As pertaining to the coin, this is on-going process with monies coming in and monies going out for postage, packaging, etc. We believe the Emergency Commission should be used for Emergencies and not ongoing programs utilizing outside monies from donors

The North Dakota Veterans Legislative Council supports this bill and asks for a do pass. Thank You

## **Coin Description**

The coin is a gold coin 1.75 inches in circumference.  
On the front of the coin is a white banner representing "Righteousness,"  
The banner surrounds a sky-blue background representing the blue of  
heaven and the skies of North Dakota along with "Vigilance"  
"Perseverance" and "Justice". On the white banner is written "NORTH  
DAKOTA MILITARY FUNERAL HONORS\*ON BEHALF OF A GRATEFUL  
STATE"

The emblems of the five branches of the military are linked together  
surrounding a crossed US and North Dakota Flag signifying a unified  
defense of both the nation and the state.

The back side of the coin is solid gold in color representing "Achievement  
and Honor and has the familiar "Battle Cross" or Soldiers Cross in the  
middle. Surrounding the Battle Cross are phrases from the familiar song  
Taps played at all military and veterans funerals.

On both sides are shafts of wheat representing "the Divine Harvest: and  
the base of the Soldier Cross may be engraved as well as the sides of the  
coin.
