Generals tend to have favorites & other subcontractors wanted the same opportunity for the subcontractors. Subcontractors could bid individually their segment. The bids get open & become public information. The law is not clear on this, so it opens the door for the subcontractors' opportunity to participate in larger public improvement projects. Now you would have two options, the general with the subs & the subs collectively.

**Rep Adams:** I sit on the political subdivision committee & they have a similar bill. Can we combine the bills?

**Chairman Keiser:** It's one of the frustrations of the legislative process. If they want to combine them, they can come to us. Unfortunately, we are hearing this bill here & we have to deal with it.

**Rep M Nelson:** Is it your intention that the political subdivision could take the overall bid, since the whole project is bid, we don't know the price of the bidding the whole project under the subdivision.

**Chairman Keiser:** The auditor said that "I can't take your bid because I don't have the complete bid of the subs". Therefore, they determined that they would not accept the bids because the law says we have the two forms of bids & we take the lowest, best price.

**Chairman Keiser:** If it's rebid, does it still have to be added in with the other subs & that has to be less than the general bid. We could would kill the project in that case.

**Mike Krumwiede~American Counsel of Engineering Companies:** I stand before you in support. The more tools we give the owners, that a good move.

Bill Kalanek~ND Association of Plumbing, Heating Mechanical Contractors & National Electricat Contractors Association: I want to voice our support of the bill. It's a nice tool to add allow some more flexibility for the political subs in our state.

Chairman Klein: Opened the hearing on HB 1136. All members were present.

Russ Hanson, Associated General Contractors of North Dakota: Testified in support of the bill. This bill was introduced at our request. We believe this bill will address a problem that we have seen several times over the last couple of biennium that have slowed or delayed projects. The bill adds additional language and it gives the owners on public bids, under North Dakota Century Code, Chapter 48 which has the three separate prime bids (mechanical, electrical, general). In instances where there have been multiple bids that are received for two of the three portions, and the third portion, the smaller portion, receives none. There have been instances where governmental officials have read the code to state that all of the bids need to be thrown out and everything rebid. This would propose to allow the two portions that receive the competitive bids to either be awarded, and the third portion can either negotiate a contract with the larger of the other two for up to \$150,000 or they have the option to rebid the third portion. I have a contractor here that can give you actual examples here to testify.

(2:45) Tom Todd, owner, Northwest Contracting of North Dakota, past president, Associated General Contractors of North Dakota: See Attachment #1 for testimony in support.

**(5:35) Chairman Klein:** This seems pretty simple. If you're lacking one of the three, we can move ahead with just rebidding the one?

**Tom Todd:** That is what we are asking.

**Senator Burckhard:** If a bid happened where there were several bids for the general and electrical portion, and only one bid for the mechanical portion, would that company automatically get the bid for the mechanical portion.

Tom Todd: I believe so, yes.

**Bill Kalanek, Dakota's Chapter, National Electrical Contractors Association, and North Dakota:** Testified in support of the bill. We worked with Russ and the AGC in the interim to put this together and I think it is a reasonable solution to a problem that has occurred a couple of times. It has affected my members as well. The opportunity to bid is a good thing, and under the current scenario, if you were low the first time and a rebid is forced, you were not low the second time. We support the whole heartedly.

Mike Krumwiede, American Council of Engineering Companies, and the American Institute of Architects: Testified in support of the bill. We also worked with Russ on this bill to make sure that we were ok with everything in there. We have also had some engineers that have had this issue, and we think this will resolve one of those issues.

**Stephanie Dasinger, North Dakota League of Cities:** Testified in support of the bill. We support this change, and we believe it adds flexibility and ability to get projects done in a short construction period.

**Chairman Klein:** No further testimony. Closed the hearing.

Vice Chairman Vedaa: Moved a DO PASS.

**Senator Roers:** Seconded.

Chairman Klein: Any discussion?

**Senator Roers:** In my 40 years, I have never seen this happen. Where there has not been one of those spots filled. However, if it did happen, we would be furious about that fact that our numbers are in but you would have to rebid to get the same project that you once had as a result of this law. I think it is a great change.

**Senator Kreun:** I have seen that happen and this would make it much simpler for the process.

A Roll Call Vote Was Taken: 6 yeas, 0 nays, 0 absent.

- (2:52) Senator Piepkorn: If you have three biddable aspects of the project and one is competitive and has been bid on, leaving two that are left vacant, does that one bid get accepted and the remaining two get rebid? Or, is it only if two of the aspects are covered and one is left open?

**Tom Todd, Northwest Contracting of North Dakota:** I believe if there was two, it would be completely rebid.

**Chairman Klein:** That is the way that I understood you answering my question. We have been concentrating on the one open bid.

**Tom Todd:** We only stated the one, so I believe that is the only way that it would be able to be negotiated. We did not go that direction on it.

**Chairman Klein:** Asked Russ Hanson to clarify the intent in the draft.

Russ Hanson, Associated General Contractors of North Dakota: On line 2, page 2, the word portion is singular, so I believe that would mean one as opposed to if there were two that were left open.

**Chairman Klein:** So, if two were open then all three would be put out for bid again?

**Russ Hanson:** We believe so. Just to comment; the reason that we had this bill drafted the way that we did is that four or five times we have seen this it has always been one portion that is significantly less than the other two. That is why we wrote the bill this way.

**Chairman Klein:** And it is generally which portion?

Russ Hanson: It depends on the project.

**Senator Piepkorn:** Page 2, Line 1; "award a contract for each portion", it does not say "the portion", so that each is meaningless.

**Russ Hanson:** That "each" does not mean anything. Samantha from legislative council took our concept and drafted this to achieve what we were wanting.

**Senator Vedaa:** I look at that award of contract for "each" as being more than one. So that would mean that at least more than one portion of responsible bids. You would rebid the portion which is singular. That is how I see it.

**Russ Hanson:** That is how we see it. There has always only been one missing. If there are issues we can fix this in two years.






