Rep. Schauer: Correct.

Jim Nelson, ND Veterans' Legislative Council, appeared in support. Attachment 2. (12:59-16:13)

Lonnie Wangen, Commissioner of ND Veterans' Affairs, appeared in support. This is a great way to remember the wars that we have had in the past. The education and knowledge of our history is very important. I ask the committee to add a proclamation from the governor.

Chairman Kasper closed the hearing.

A subcommittee was formed consisting of Reps. Schauer, Schneider, and Hoverson to add a proclamation.

Chairman Kasper: I think we also need to address another amendment to this bill to make it clear whether it is open or closed with pay. Seth, the law intern, just handed out Attachment 3 which is the chapter in the code on holidays.

Rep. Laning: The reality is holidays are very expensive if they have closed doors with pay for employees. I personally think we are jeopardizing the success of this bill if we try to make a paid holiday out of this.

Thank you Mr. Chairman and members of the Government and Veterans Affairs Committee.

My name is Austen Schauer representing West Fargo, District 13.

It is my pleasure today to speak with you about House Bill 1169 and I seek your support.

If approved, House Bill 1169 would create and enact a new State Holiday called **Patriots' Day**.

Patriots' Day would be to commemorate the start of the American Revolutionary War and the battles of Lexington and Concord.

Those battles, the first in our 8-year war against the British, began on April 19th, 1775. The date some have described as the birth of liberty and union.

Why establish a State Holiday for Patriots' Day?

1. To honor the sacrifice of our courageous Patriots who fought and died for our freedom. **25 thousand** Revolutionary soldiers were killed during the war.
2. To honor our first veterans. **80 thousand** Militia and Continental Army soldiers served at the height of the war.
3. **Education.** Did you know how much Gen. George Washington was paid for his military service? Did you know the age of the youngest member of the Continental Army?

What a terrific opportunity for educators throughout the State to focus on this historical event. It is my feeling (and maybe yours too) we need to **double down** in our efforts to teach children about the birth of our country and what it took to become a country.

4. **Community Events.** Patriots' Day will provide a vehicle for communities to celebrate the Revolutionary war with programs, events, re-enactments, lectures, town halls, symposiums and film festivals.

In fact, Emily Beck, (the director of the Fargo Theatre), says she loves the idea and would look forward to showing movies on the war followed by a panel discussion.

5. **Economic Development.** Patriots Day weekend will give businesses a new theme to build on similar to July 4th and other holidays.

Currently, Connecticut, Massachusetts, Wisconsin and Maine celebrate Patriots' Day as a State Holiday. It is officially observed in Florida.

Patriots' Day is an effort to **instill the spirit** of what it took to establish this country in the hearts and minds of people. The spirit of **determination** of our forefathers and mothers who truly believed in the words of Patrick Henry, "**Give me liberty or give me death.**"

If approved, Patriots' Day would be observed on the **third Monday in April**. Business and schools would stay open. It would be an unpaid holiday.

Dear Representative Schauer,

I write to express my support for the upcoming bill to make Patriot's Day a state holiday in North Dakota. As both an expert on the Revolutionary period and as an educator in North Dakota, I believe that understanding the American Revolution is more essential now than ever before, and instituting Patriot's Day as a state holiday would bring a much-needed awareness of the legacy of the founding era and the modern-day civics that it has inspired.

As a historian of popular politics during the American Revolution, I believe understanding the era is more essential now than ever. As our state and national political discourse degenerates into chaos, Revolutionary legacies such as freedom of expression, checks and balances, and even equality under the law have come under attack. For this reason, a renewed emphasis on the Revolutionary period is necessary to enrich and correct the course of our endangered commonweal. Celebrating Patriot's Day would help to bring about such a resuscitation of the Revolutionary legacy.

Further, as an Assistant Professor of early American history at North Dakota State University, I have taught North Dakota's young men and women about the American Revolution for the past four years. Each time I cover the Revolution in my introductory US History course, or in my upper-level courses period, I am gratified at the connections that our students make to the Revolutionary era and the present day - without fail, each time students come away with a more nuanced and complex understanding of our country's founding, and the legacies of the founders. Most importantly, students learn that the republic that emerged from the Revolution was a fragile, contingent one, and one that should not be taken for granted. Celebrating Patriot's Day would instill this understanding earlier, and among a much greater swath of the state's population.

In short, I believe instituting Patriot's Day as a North Dakota holiday would expand awareness of the Revolutionary legacy at a time when it is most needed. I urge you and your colleagues to pass this bill.

Noted Sociologist C. Wright Mills writes and I quote " Neither the life of an individual nor the history of a society can be understood without understanding the past" end quote.

Tomorrow is shaped by what we did yesterday and do today. I believe nothing happens without some connections to the past. Essentially, we learn from our mistakes and our successes. I am sure much of what you do daily for the people of North Dakota is based on some past history or precedent.

So why have another holiday?

I am going to tell a personal story if I may. During the downturn in the 80's I suddenly one morning didn't have a job because the company I worked for locked its doors. Faced with an unknown future friends in my church convinced me I should be a teacher. I was a Sunday school teacher, and many said I was a natural. So, at age 49, I went back to school and completed two bachelors' degrees and a Master degree. I began teaching for Minot State and Adjunct for BSC in the mid 90's. It was this experience that opened my eyes to how little young people really knew about history. What I learned in school, what my children learned in school and what my grandchildren are learning in school in many cases are as different as night and day.

They can whiz through their smartphones and computers leaving grandpa in the dust, yet they do not understand why we say the Pledge to the flag, why do we certain laws, what is really in the Constitution and Bill of Rights in sort just plain old Civics that the majority in the room we taught in grade school.

Back to this bill, A couple years ago I was asked to speak to a class at a middle school here in Bismarck around Veteran's Day. After my presentation I asked if there were any questions. I am a proud Viet Nam Veteran and that day wore my Vietnam hat. I never had one question about Vietnam. It was all about WWII. While walking out with the teacher I asked about that and his response shocked me. He said our history text books only go into WWII and just briefly mention Vietnam and other wars.

1-03-01. Holidays.

Holidays are as follows:

1. Every Sunday.
2. The first day of January, which is New Year's Day.
3. The third Monday of January, which is Martin Luther King Day, in recognition of the life, legacy, and dream of Martin Luther King, Jr.
4. The third Monday in February, in recognition of the birthday of George Washington.
5. The Friday next preceding Easter Sunday and commonly known as Good Friday.
6. The last Monday in May, which is Memorial Day.
7. The fourth day of July, which is the anniversary of the Declaration of Independence.
8. The first Monday in September, which is Labor Day.
9. The eleventh day of November, which is Veterans' Day.
10. The fourth Thursday in November, which is Thanksgiving Day.
11. The twenty-fifth day of December, which is Christmas Day.
12. Every day appointed by the President of the United States or by the governor of this state for a public holiday.

Nothing in this section may be construed to prevent the holding of legislative sessions or the taking of final action on any legislative matter upon any of such holidays other than Sunday. Any action heretofore taken upon any legislative matter upon any such holiday is valid and legal for all purposes.

1-03-01.1. Closing of state offices - Christmas Eve.

State offices must be closed at twelve noon on December twenty-fourth, Christmas Eve day, unless it is a weekend or holiday pursuant to section 1-03-02.1.

1-03-02. When day following holiday shall be a holiday.

If the first day of January, the fourth day of July, the eleventh day of November, or the twenty-fifth day of December falls upon a Sunday, the Monday following shall be the holiday.

1-03-02.1. When holiday falls on a Saturday.

If any of the holidays enumerated in section 1-03-02 fall on a Saturday, the Friday immediately before shall be the holiday.

1-03-03. Sports on Memorial Day - Penalty.

No person, prior to the hour of two p.m. of the day set apart as Memorial Day, may engage in organized or commercial ball games, horseracing, sports, or any entertainment which will interfere with the proper observance of such day. Any violation of this section is an infraction.

1-03-04. Business days.

All days other than those mentioned in sections 1-03-01, 1-03-02, and 1-03-02.1 are to be deemed business days for all purposes. However, any bank may remain closed on any one business day of each week, as it may from time to time elect. Any day upon which a bank is so closed shall be, with respect to such bank, a holiday and not a business day. Any act authorized, required, or permitted to be performed at or by or with respect to such bank on such day, may be performed on the next succeeding business day, and no liability or loss of rights shall result from such delay.

Notice of intention on the part of any bank to remain closed on a business day of the week shall be posted in a conspicuous place in the lobby of the bank at least ten days prior to the establishment of such practice and similar notice shall be given when a bank elects to change the day of the week on which it remains closed. Any state bank establishing the practice, as hereinbefore provided, of closing one day a week shall give ten days' notice in writing to the commissioner of financial institutions, in addition to posting the notice in the lobby. However, any

bank may elect to remain closed on a business day of the week without any prior notice in the event of the following emergencies: any act of God, death of an officer, or a robbery.

1-03-05. Act due on Saturday or holiday performed on next day.

Whenever an act of a secular nature, other than a work of necessity or mercy, is appointed by law or contract to be performed upon a particular day, that falls upon a Saturday or a holiday, the act may be performed upon the next business day with the same effect as if it had been performed upon the day appointed.

1-03-06. Mothers' Day.

The governor each year shall designate the second Sunday in May as Mothers' Day. The governor shall issue a proclamation requesting the people of the state to assemble on that Sunday in their churches, or at such other place or places as may be most convenient and proper, for the purpose of paying respect and tribute to our mothers.

1-03-07. Arbor Day.

In order to promote and encourage the planting of trees in this state, the first Friday in May of each year is hereby designated and established as "Arbor Day" for the state of North Dakota.

1-03-08. Bird Day.

To promote and encourage the conservation and enjoyment of one of nature's most attractive features, and to honor the birth and work of naturalist John James Audubon who made America's birds known to the world through his drawings and vivid prose, April twenty-sixth of each year is hereby designated as "Bird Day" in the state of North Dakota.

1-03-09. Martin Luther King Day.

Repealed by S.L. 1991, ch. 55, § 2.

1-03-10. Workers' Memorial Day.

The twenty-eighth day of April of each year is designated as Workers' Memorial Day in remembrance of American workers who have been killed, injured, or diseased on the job.

1-03-11. Gold Star Mothers' Day.

Each year the governor shall issue a proclamation designating the last Sunday of September as Gold Star Mothers' Day in honor of mothers whose sons or daughters served and died in the line of duty in the armed forces of the United States of America or its allies, or died as a result of injury sustained in such service.

1-03-12. Four Chaplains Sunday.

Each year the governor shall issue a proclamation designating the first Sunday of February as Four Chaplains Sunday in honor of the four United States army chaplains, George L. Fox, Alexander D. Goode, Clark V. Poling, and John P. Washington, who sacrificed their own lives to save the lives of other servicemen on the Dorchester, a United States army troop transport ship that was sunk off the coast of Greenland on February 3, 1943.

1-03-13. First Nations Day.

To recognize the indigenous peoples of the State of North Dakota and their contributions to the state and to the United States, the governor shall issue a proclamation each year designating the Friday before the second Monday in October as First Nations Day.

1-03-14. Vietnam Veterans' Day.

March twenty-ninth of each year is Vietnam Veterans' Day. Each year the governor shall issue a proclamation on March twenty-ninth in honor and remembrance of surviving and departed Vietnam veterans, including the one hundred ninety-eight individuals from North

Dakota whose names are listed on the Vietnam Veterans Memorial wall in Washington, District of Columbia, and those veterans who are or were missing in action or prisoners of war.

1-03-15. Women Veterans' Month.

March of each year is Women Veterans' Month. Each year the governor shall issue a proclamation on March first in honor and remembrance of surviving and departed women veterans who have served honorably and with courage on behalf of the United States of America since the American Revolutionary War.

1-03-16. Firefighters memorial weekend.

Each year the governor shall issue a proclamation designating the dates of the national fallen firefighters memorial weekend as the North Dakota fallen firefighters memorial weekend and require that flags at state buildings be flown at half staff.

I write to express my support for the upcoming bill to make Patriot's Day a state holiday in North Dakota. As both an expert on the Revolutionary period and as an educator in North Dakota, I believe that understanding the American Revolution is more essential now than ever before, and instituting Patriot's Day as a state holiday would bring a much-needed awareness of the legacy of the founding era and the modern-day civics that it has inspired.

As a historian of popular politics during the American Revolution, I believe understanding the era is more essential now than ever. As our state and national political discourse degenerates into chaos, Revolutionary legacies such as freedom of expression, checks and balances, and even equality under the law have come under attack. For this reason, a renewed emphasis on the Revolutionary period is necessary to enrich and correct the course of our endangered commonwealth. Celebrating Patriot's Day would help to bring about such a resuscitation of the Revolutionary legacy.

Further, as an Assistant Professor of early American history at North Dakota State University, I have taught North Dakota's young men and women about the American Revolution for the past four years. Each time I cover the Revolution in my introductory US History course, or in my upper-level courses period, I am gratified at the connections that our students make to the Revolutionary era and the present day - without fail, each time students come away with a more nuanced and complex understanding of our country's founding, and the legacies of the founders. Most importantly, students learn that the republic that emerged from the Revolution was a fragile, contingent one, and one that should not be taken for granted. Celebrating Patriot's Day would instill this understanding earlier, and among a much greater swath of the state's population.

In short, I believe instituting Patriot's Day as a North Dakota holiday would expand awareness of the Revolutionary legacy at a time when it is most needed. I urge you and your colleagues to pass this bill.

Noted Sociologist C. Wright Mills writes, and I quote “Neither the life of an individual nor the history of a society can be understood without understanding the past” end quote.

Tomorrow is shaped by what we did yesterday and do today. I believe nothing happens without some connections to the past. Essentially, we learn from our mistakes and our successes. I am sure much of what you do daily for the people of North Dakota is based on some prior history or precedent.
