Chairman Kasper opened the hearing on HB 1265.

Minutes:

Rep. Blum appeared in support. HB 1265 would provide for a simple and concise study of our state park system. If taken up by legislative management, the study would provide for a determination of the purpose, value, and benefits of each state park. The study must include a review of each state park's usage, annual attendance figures, and overhead and the cost to operate and maintain, and the market value of the land and structures of each state park. Upon meeting with Director Baker, I have come to the understanding that an appraisal for the market value of the land has the potential to be highly costly and difficult to undertake. Therefore, I am recommending an amendment striking that portion of the proposed study. (2:02)

Rep. B. Koppelman: Should this information be reported back to this legislature interim, or should we have hearings during the interim on it?

Rep. Blum: Director Baker would be better suited to tell which way would be more appropriate.

Rep. Vetter: Would we be studying sectional lines?

Rep. Blum: Not to my knowledge.

Rep. Laning: Line 4 has the word "shall." Are you opposed to changing that to "may"?

Rep. Blum: We could change it to "may".

Vice Chair Steiner: Are you aware we have some state park land up by Pick City that is unused at this time? Are you aware that it should include additional land that is undeveloped and could be used as campground?

Rep. Blum: I was not aware of that. I would be interested on that from Director Baker as well.

Melissa Baker, Director of ND Parks and Recreation, appeared in a neutral position and to answer some questions.

Rep. B. Koppelman: Would this information be compiled in a report that would be reviewed? Is this something that there would be some advantage to having all the stakeholders come testify before an interim committee? Which would be the most constructive way of going about this?

Melissa Baker: We do have much of this data available, so reporting it out would be very easy for most of it. We would welcome testifiers.

Rep. B. Koppelman: It wouldn't be an arduous request to report back at the end of the biennium?

Melissa Baker: We would be happy to do that.

Rep. Schauer: What are you trying to accomplish with this study? Who actually does the study?

Melissa Baker: This bill actually originated outside the agency. We had our first conversations with Rep. Blum yesterday afternoon. We are not sure of the purpose. We are just happy to provide it if it is asked of us.

Rep. Rohr: Line 5, the purpose, value, and benefits of each state park, has not been accomplished?

Melissa Baker: Most of our parks have management plans that identify purpose and values. We haven't done any scientific measure of benefits. We do have a visitors' study included in our appropriation request for this year that would give us some of that information. As part of our strategic plan this year, one of the things we will be focusing on over the next five years starting this calendar year is reenergizing and adding some rigor to our planning processes within the department.

Rep. C. Johnson: Where does the state parks and recreation get their funding?

Melissa Baker: The budget of the department in the current biennium is around 42% general fund, 42% special fund largely with visitors' fees, and the remainder of that is about 17% federal grant monies.

Rep. P. Anderson: How many state parks do we have?

Melissa Baker: We have 13 state parks. We have 15 destination properties, the 13 state parks of which one is Icelandic. We also have the Pembina Gorge State Recreation area which we have been developing over the last few years. We have the Lewis and Clark Interpretive Center in Ft. Mandan which came under our management two biennium ago.

Chairman Kasper: Do you have some data about your department that you could provide.

Melissa Baker: Yes, I can provide that tomorrow. Attachment 1

Chairman Kasper closed the hearing.

Rep. Vetter: Could we combine what Rep. Nelson presented with this?

Chairman Kasper: It would be two totally different items. We are not going that route.

Rep. Hoverson: Did Rep. Blum say why they should do this study?

Chairman Kasper: I just heard him say it was a good idea.

Rep. Rohr: What language did Rep. Blum want to change?

Chairman Kasper: He wanted to get rid of the market value of the land and changing the word shall to may on Line 4. I think the word consider makes it okay.

Rep. C. Johnson made a motion to adopt the amendment.

Rep. Schauer seconded the motion.

Rep. Rohr: I would like to know the reason.

Chairman Kasper: If you are going to try to come up with a market value of all of the parks in the state of North Dakota, you are going to spend a whole lot of money.

Voice vote. Motion carries.

Rep. B. Koppelman: It appears there must have been some interest in knowing whether the state parks' usage was efficient or whatever. If we really wanted to see this information, I would suggest that they report back to legislative management.

Chairman Kasper: If the study is picked up, then they will do it anyway.

Rep. Schauer: It just sounds like we are not aiming at what we are trying to accomplish.

Rep. P. Anderson: I didn't understand when he said he did it for legislative oversight and authority.

Chairman Kasper: I think there might have been a little bit of curiosity if they are worth the expense to maintain.

Rep. C. Johnson: If legislative management isn't going to do the study, is there a way to put in language that ND Parks and Recreation should do the study?

Chairman Kasper: If we are going to ask them to do a study on their own, that might be a little bit redundant.

Rep. B. Koppelman: If we leave it up to a report back to legislative management from a group justifying what they are already doing, that probably isn't going to be a non-partial point of view. I make a motion for a made a motion for a DO PASS AS AMENDED.

Rep. Laning seconded the motion.

Rep. Schauer: I am going to vote no, and the reason is it is not directed, not aimed, and these people didn't know about it until a couple days ago.

A roll call vote was taken. 8-5, 1 absent.

It would take up the benefits and purpose of each state park and study costs and revenue. How we can help and examine our states prize parks system; depending on what we discover from the study.
