Representative Thomas Beadle, Dist 27: Introduces HCR 3014. This bill may be a year delayed when it would have been optimally introduced, but our not having annual sessions, prohibits the timing of this. This is just a nice little resolution congratulating one of ND's favorite sons - someone who has brought a tremendous amount of success and recognition to ND and a lot of attention on a national scale. That individual is Bismarck's own Carson Wentz. We like to claim him in Fargo, but for Senator Oban's sake, we will continue to reference him as Bismarck's son. This resolution is congratulating the Philadelphia Eagles on winning the 2018 Super Bowl. It is also congratulating Carson Wentz on a number of his accomplishments including the rookie of the year during his rookie season, as well as the accolades he had when he was a front runner for the MVP award in 2017 prior to going down with an ACL injury. That was not due to me by any stretch of the imagination, that we fully due to Representative Mock how had a lot freer time on his hands and really wordsmith this thing quite a bit. He has been in conversation with some individuals from the governor's office in the hopes that when this thing passes that we would be able to present it to him personally.
