Explanation or reason for introduction of bill/resolution:

A concurrent resolution urging North Dakota to continue strengthening the sister-state ties between North Dakota and the people of the Republic of China (Taiwan); supporting the signing of a Bilateral Trade Agreement between the United States and Taiwan; and reaffirming support for increasing Taiwan's international profile.

Minutes:

Chairman Klein: Opened the hearing on HCR 3032. All members were present.

Chairman Klein: Representative Vigesaa was going to be here. Just so you all know, we've already signed this bill with the Taiwanese delegation when they were here last Wednesday. This is that bill. It just talks about our support for Taiwan and that we've been a sister state for many years. The stockmen are supportive and they want to do more trade. And Taiwan generally eats the things we don't. some of the inside parts Americans throw away are sent over there.

Julie Ellings, North Dakota Stockman's association: testified in support of the resolution. Taiwan is an important US beef customer. Not only in volume but in terms of value because they have different cultural preferences for different types of beef so that drives the value of our carcass and ultimately puts more dollars in cattle producers' pockets and fuels our economy.

Chairman Klein: Could you speak to the value it brings us to have those parts we don't want go somewhere else?

Julie: Sure, for instance beef tongue is something that doesn't drive a lot of value here, as much as Taiwan and places in the Pacific Rim, that would otherwise just be thrown or sold into a pet food market. Ground in some cases, but again considered a delicacy and has higher value.

Chairman Klein: Same with the tripe? The stomach?

Vice Chairman Vedaa: From the grocery meat business, when mad cow was going around and prices went so high because the offals couldn't be sold. So selling those overseas it really keeps our prices of beef down.

Senator Roers: Can you tell us how much dollars we export to Taiwan or how much they are buying or anything along those lines?

Julie: I didn't come prepared with those numbers but they are amongst our top tier.

Senator Burckhard: Do we send processed beef or live animals?

Julie: We're talking processed beef. Transporting live animals is extremely expensive and less common.

Vice Chairman Vedaa: Moved a Do Pass.

Senator Piepkorn: Seconded.

A Roll Call Vote Was Taken: 6 yeas, 0 nays, 0 absent.

Chairman Klein will carry the bill.

Testimony to the House Industry, Business, and Labor Committee House Concurrent Resolution 3032

Andrew Alexis Varvel February 4, 2019

Chairman Keiser and Members of the Committee:

My name is Andrew Alexis Varvel, District 47.

I heartily endorse House Concurrent Resolution 3032. We should be passing this resolution as a matter of course. Given the shifts in trading relationships we have been having in the last couple of years, we should be focusing more of our trade and sister state ties on Southeast China.

To this end, we should consider promoting study of the Hokkien dialect of the Chinese language. Hokkien is a conservative dialect that is common to Taiwan, Malaysia, Singapore, the Philippines, and Fujian province. After being suppressed for the past forty years, Hokkien is enjoying something of a resurgence. I think North Dakota could benefit from being an overseas center for Hokkien's educational renaissance, and this ought to strengthen existing sister-state ties with Taiwan.

I ask the House Industry, Business, and Labor Committee to give House Concurrent Resolution 3032 a **DO PASS** recommendation, preferably unanimously, so we can express our solidarity as fellow free republics.
