Chairman Kasper opened the hearing on HCR 3047.

Rep. B. Koppelman appeared in support. This resolution was put together to study the overall veterans' programs, services, and delivery of those items. I think there has been questions as to whether or not there are disconnects between the different generations of veterans and how they are served and by whom. After having this resolution drafted, I did speak with a couple of individuals who compared it to the task force that the governor is doing on veterans. This resolution is in front of all legislators on a committee. I think the perspective would be different and more likely to full _ if it came out of interim legislative committee than out of the governor's task force. (3:50)

Rep. Rohr: Is it a may or shall study?

Rep. B. Koppelman: I do believe it has the same meaning-to consider

Rep. Rohr: They have three piles there--may, shall, and consider. This might be No. 3.

Rep. B. Koppelman: I figure this would be the shortest pile, so it would get picked.

Rep. Karls: How is this different from the last time we were asked to study veterans' benefits?

Rep. B. Koppelman: This is my fourth session on GVA. Over that time, we have made studies in place of a bill, and I don't think they have been broad. I don't think they have been selected either. The point of this is to make this important enough to make the list.

Rep. P. Anderson: Are you aware of the high suicide rate of veterans? Is this the middle of what you are talking about?

Rep. B. Koppelman: I admit I don't have a vet study on any specific topic. I am very aware of the concern and the problem that we have in the area of suicide and suicide on younger aged veterans.

Rep. Laning: I am also a member of the governor's task force on veterans' affairs. We have similar goals. The task force is made up of four legislators, two senators and two reps. The national guard and ACOVA is there. There are 14 members. I think this is unnecessary.

Rep. B. Koppelman: The way the executive branch and the legislature solves problems are different. I think the outcomes are different.

Vice Chair Steiner: It troubles me to see governors setting up task forces and putting a few legislators on. Wouldn't you agree that the whole point of having a legislative study is to educate a wider range of legislators rather than four selected?

Rep. B. Koppelman: I believe the success rate is better for a legislative study versus a task force outcome. I do think there is a little bit of a mission creep when the task forces are trying to establish policy.

Neutral

Sean Cleary, Policy Advisor, Office of the Governor, appeared in a neutral position. He stated he would provide the committee with an overview of the executive order and members of the governor's task force. Attachments 1-2. One of the reasons we decided to form the task force is we thought that it would be good to get buy in from the veterans throughout the process.

Rep. P. Anderson: Do you know if suicide is part of this task force's objectives?

Mr. Cleary: The task force has two primary objectives, and that is to look at the services provided to veterans by the state and how those coordinate with the veterans' services available in the state. It also is looking at the government structure that oversees ND veterans' affairs. Suicide is certainly something that the task force will be looking at.

Chairman Kasper: He read Line 24, Page 1. Wouldn't you perceive that as probably considering if the interim _ suicide and probably health when you use the words "care, assistance, and benefits"? Would that be broad enough?

Mr. Cleary: Yes.

Rep. Laning: There was a gentleman who spoke on suicide amongst veterans at this first meeting as well as the human services people. That was one of their major focuses. Exactly who sits on this task force?

Chairman Davison: Open the hearing on HCR3047.

Rep. Ben Koppelman, Dist. 16, W. Fargo: This resolution is calling for a comprehensive review of our veterans programs. We want to review the efficiencies. We also want to review the past and future things that will effect veterans. When you look at the needs for veterans in post-Vietnam and present, there are challenges. I hope we would find the efficiencies, but not change cultures. How can we include members better in the new conflicts? It took a while for the Vietnam vets to get involved, like they are now. We diagnose PTS now more than in the Vietnam timeframe. I did ask when this had been studies last. (3.23) There was a study during 2013-2014-time frame. It was not as comprehensive as this one. There was a study in 2007-08. Before that, it was 1983-4. This is not a witch hunt by any means. The younger veteran's groups were excited about this study.

Sen. Erin Oban: Are we the best to study these things? Who would you have at the table.

Rep. Koppelman: The governor has a task force that is looking into similar. I believe we are the right people to study this issue. The people making the decision about this study will be the same people that come back next session and attempt to put into law. With a governor's task force, some members could be partial they are used to or the way of doing things they are used to. May not reflect the balance changes from an outsider looking in. (6,19) As an independent juror is more like a legislative process. These could complement each other. The same groups may testify in both groups. What is the success rate of recommendations that come out of a commission vs one that come out of a legislative committee? Who will carry that torch in the legislature?

Sen. Kristin Roers: How much of this is generational and how much is stage of life? My dad got a purple heart in Vietnam and wanted nothing to do with vet organizations when he was

younger. Now, he loves being involved in many vet groups. He is in 70's and looking back more. (8.00) Some people are just not in their right place in their phase of life right now.

Rep. Koppelman: My intention is to make sure that our delivery is taking care of the veterans. Regardless of the age of the administrators and outreach, does not matter to me. The service needs to be there no matter what phase of life they are in. The younger generation are not joining American Legion or Am Vets. Pretty soon the young vets will be outnumbering the Korean and Vietnam vets. We need to be prepared.

Sen. Richard Marcellais: (11.17) I serve on the governor's task force. I agree with you and most don't know what benefits are state and what are federal benefits. We have 700 vets in our district. We only have two part-time service officers. You may have a bigger county with a bigger mill levy, so they have a full-time vets service officer. This is what I would like to be addressed out of this study. We need to share resources between counties to serve all veterans. Homelessness is a big issue. We have over 1500 veterans in N.D. that are homeless. We need to look at that. There is a program that the VA works with HUD (VASH). It is federal. It finds low rent housing for vets but they have to agree to counseling. (13.14)

Chairman Davison: Any more in support? Agency? Opposition?

Lonnie Wangen, Commissioner of Veterans Affairs (ACOVA: I am here opposed. I was not able to testify when it was in the House. (see att # 1) (16.00)

Chairman Davison: I am sorry to interrupt. We are trying to understand with this study. These are things we want to know how the vet's groups are doing to help. How so we make better decisions to create a better quality of product.

Lonnie: These studies that were done, result in bills that came before you over the years. (18.49)

Chairman Davison: How do we know that they improved quality?

Lonnie: You can talk to the CVSO's about that. Our latest audit had a questionnaire for services officers, and they ranked things quite high. He kept going through the history.

Chairman Davison: Rep. Koppelmann's point is that we do lots of things and we day 'yes', 'no' randomly and asking if we are making an impact. (20.03) Are we providing the tolls to make an impact. His intent is not a witch hunt. It is to say are we making right decisions and on the right kinds of data.

Lonnie: Since I have been here we have been studies and audited. We responded to lots of questions. Right now we have a task force for veteran's affairs. Last session the governor asked we take a 10% cut in staff across the board for all agencies. We ended up losing 30% of our staff as a small agency. This study takes time away from my agency. This study is not necessary. Three years ago, suicides were 22 per day. Now we are at 20 a day. 69% of suicides result in fire arm injury. Females in the military are 1.8 times higher than non-adult females to commit suicide. Male vets 55 years and older are the highest count for suicide.

Only 6 of the 20 suicides are in the VA system. (26.00) We are serving the younger veterans. (28.00)

EXECUTIVE ORDER 2018-07

WHEREAS, North Dakota is home to more than 50,000 military veterans – men and women who have provided, and continue to provide, extraordinary service to our country and our state; and

WHEREAS, there is an array of specific services and benefits available to veterans across federal and state agencies and nonprofit organizations; and

WHEREAS, North Dakota is committed to providing coordinated, high-quality services to veterans and ensuring they are able to effectively access the benefits and services which they earned and deserve; and

WHEREAS, the Administrative Committee on Veterans Affairs was established by the forty-second legislative assembly in 1971 to oversee the general administration of veterans affairs in North Dakota; and

WHEREAS, proper organization of the State's services and resources is critical to effectively support veterans and their dependents in North Dakota; and

WHEREAS, convening a task force to examine the communication, collaboration, governance and delivery systems for veterans services, with input from a variety of interested stakeholders, will facilitate meaningful enhancements to accessibility and delivery of services to North Dakota's veterans and their dependents.

NOW, THEREFORE, Doug Burgum, as Governor of the State of North Dakota, hereby establishes the Task Force for Veterans Affairs. The Task Force shall consist of no less than eleven and no greater than fifteen members, appointed by the Governor, representing the interests of veterans and their dependents, members of State government and other applicable stakeholders. The Governor or his designee will serve as a non-voting member of the Task Force. The Governor shall designate the Chair of the Task Force.

- I. The Task Force for Veterans Affairs shall:
 - a. Examine the current structure of veterans affairs governance and service delivery, evaluating strengths and weaknesses in the current system.
 - b. Identify areas for increased collaboration, communication and efficiencies in and among existing programs, state agencies and other resources utilized for the service of veterans in the state.
 - c. Provide recommendations to improve the current governance structure and services for veterans in North Dakota.

- II. The Task Force shall meet at the call of the Chair. A simple majority of the Task Force shall constitute a quorum for purposes of taking any official action.
- III. The Task Force may create working groups to increase input from veterans and other stakeholders throughout the State.

The Governor is vested with executive authority to issue this Order pursuant to Article V, Section 1 of the North Dakota Constitution.

The Order is effective immediately and shall remain in effect until further notice.

BISMARCK, N.D. – Gov. Doug Burgum today signed an executive order creating a task force to assess the current system for supporting military veterans in North Dakota and comprehensively examine how the state's current resources can be organized to serve veterans most effectively.

The Task Force for Veterans Affairs also will examine the current governance structure for the North Dakota Department of Veterans Affairs (NDVA), which is overseen by the Administrative Committee on Veterans Affairs (ACOVA).

In addition to the NDVA and ACOVA, there are a variety of nonprofit, federal, state and local organizations and programs that provide services to veterans in North Dakota. The North Dakota National Guard provides support to veterans through ND Cares, which was established by Gov. Jack Dalrymple in 2015, as well as other programs. The North Dakota Veterans Home, first established in 1893, provides long-term and basic care to veterans and their spouses. North Dakota is home to more than 50,000 veterans along with their families.

"We are deeply grateful for our service members and military veterans and the sacrifices they and their families have made for our state and country," Burgum said. "We greatly appreciate the work that has been done in North Dakota to serve veterans, and this task force is an opportunity to work with veterans to review our current system and ensure we are best positioned to support them."

The ACOVA consists of 15 voting members appointed by the Governor and nominated by the Z - ZS - 19 AMVETS, American Legion, Disabled American Veterans, Veterans of Foreign Wars and Vietnam Veterans of America, which are the five largest veterans service organizations in the state.

"We would like to thank the Governor for convening this task force to examine how we can best work together to support veterans in North Dakota," ACOVA chairman Dean Overby said.

"We look forward to working with this task force to build on the work we have been doing to serve veterans in North Dakota," said NDVA Commissioner Lonnie Wangen, who also serves as a member of the federal VA's Veterans Rural Health Advisory Committee.

Burgum has appointed North Dakota National Guard Brig. Gen. Robert Fode to chair the Task Force. Fode has served in the North Dakota National Guard for 40 years and is set to retire on Oct. 30. Fode most recently led the National Guard's Land Component Command.

"Ensuring that the state's services are effectively organized and delivered is a crucial part of making sure we're prepared to best serve all our veterans as we encounter new challenges in the 21st century," Fode said.

The Task Force will consist of 11 to 15 members representing veterans and their families, officials from state government and other interested community stakeholders.

59th Legislative Assembly SB 2218 Commissioner and CVSO duties

Sponsors: Senators Syverson, Dever, Gary Lee. Representatives Belter, Bernstein, S. Kelsh

AN ACT to create and enact two new sections to chapter 37-18 of the North Dakota Century Code, relating to funding and veterans' records; to amend and reenact sections 37-14-18 and 37-18-04 of the North Dakota Century Code, relating to supervision of county veterans' service officers and duties of the commissioner of veterans' affairs; and to provide a continuing appropriation.

This bill:

- Removed from Commissioners duties:
 - o Assist, supervise, advise, and direct the work of county service officers.
 - formation of county service to veterans' committees and to outline, assist, and direct the activities of such committees
- Added to Commissioners duties:

2017:

AUDITS in 2017: 6 total audits on NDDVA: Highly Rural Transportation Grants Audit, VA OGC Audit, ND SAO bi-annual fiscal audit and two audit checks by OMB. All very satisfactory results. Also had Performance Audits.

Performance Audits: Legislative Audit and Fiscal Review committee directed ND State Auditors office to conduct a performance audit on ND Veterans Home, NDDVA and Oversight Structure (ACOVA). Audit conducted July 2017-March 2018.

Objective of the oversight Audit

The Office of the State Auditor established two objectives for this performance audit of the Administrative Committee on Veterans Affairs and the Department of Veterans Affairs. The objectives were:

"Are there opportunities to improve the way the Administrative Committee on Veterans Affairs and the Department of Veterans Affairs carry out their duties and responsibilities?"

"How does the organizational structure of the veterans affairs in North Dakota compare to other states?" Results:

- Conducted confidential survey of County Veteran Service Officers on the NDDVA performance.
 - Over 95% of the CVSO responses were positive. (2 CVSO's not positive)
- State Auditors report had NO RECOMMENDATIONS formal or informal

**Auditors addressed many of the possible future concerns brought up in HB 1057 (2009) now 10 years later and the "Possible future concerns" have not happened.



HCR 3047 3-29-19 AH#1 <u>2018:</u>

Task Force Veterans Affairs: October 26,2018 Governor Burgum signs executive order creating a task force to examine current "governance structure for the North Dakota Department of Veterans Affairs. (ACOVA) HCR 3047 duplicates this task force.

Chairman Davison and Senate GVA committee members,

NDDVA and the ACOVA have been studied, audited and re-studied and re-audited. Changes have been recommended and implemented in the distant and recent past. The ACOVA is a hard-working knowledge base of ND Veterans who refuse to accept compensation for their services and have only improved the lives of ND Veterans.

I was out of the state when HCR 3047 was introduced and heard by the House GVA. In listening to the House GVA audio and reviewing the minutes of the hearing the issues brought up have been studied and addressed in the recent past and could be answered by reviewing our website or asking myself. Issues such as...

- Disconnects between the different generations of veterans
- High Suicide rates among veterans
- Suicide on younger aged veterans

Answer to disconnect:

- This a perceived disconnect. ACOVA and NDDVA are working hard to reach out to the current "younger" veterans.
- Recent war veterans are entering veteran services at a much higher rate than any of the past war veterans did upon returning home.
- Historically veterans have not joined or participated in veteran service organizations until later in life-10-20 years after return.

Answer to Suicide rates:

3 years ago the average was 22 per day. Now the average is 20 per day

- 69% of all veterans suicide deaths result from a firearm injury
- Female Veterans: 1.8 times higher than non-veteran adult women
- Male Veterans:
 - o 1.4 times higher than non-veteran adult males
 - Males 55 and older had the highest count of suicides
- Of the 20 veteran suicides per day
 - o 3 are active duty military
 - o 2 are current members of National Guard or Reserve
 - o 6 out of the 20 are in VA system
 - 0
