## Explanation or reason for introduction of bill/resolution:

A concurrent resolution requesting the Legislative Management to study traffic fines and penalties imposed by state and local governments, including implementation of methods and mechanisms to improve traffic safety, decrease motor vehicle crashes, fatalities, and injuries, and discourage impaired driving, speeding, distracted driving, and lack of seatbelt use in North Dakota.

**Representative Mock, District 18**, introduced HCR 3052 and provided written testimony. See attachment #1. 4:38

**Chairman Ruby**: Would the risk in doing this would be the possibility that raising fines does not improve traffic safety?

**Representative Mock**: That could be a risk. We may be surprised in what we learn. From my experience more information will benefit the process.

**Chairman Ruby**: I do like the idea of an expansion of looking at Title 39. There have been some ambiguities.

**Major Tom Iverson, Chief of Operations for North Dakota Highway Patrol**, spoke in support of HCR 3052, provided written testimony. See attachment 2. An amendment was suggested that will be provided to committee.

**Chairman Ruby**: Is it possible to look over the whole Code in one interim or would it be better to focus on certain areas?

**Major Tom Iverson**: It would be a heavy task. In 2013 the Highway Patrol did work with the Department of Transportation and address quite a few areas that we saw as inconsistencies

and could be updated. So, a lot of the work on our end has been done. I would like to revisit it because a lot has changed from 2013 until now.

Representative Corey Mock, District 18, Grand Forks: Please see Attachment #1 for testimony.

**Senator Bakke:** We had a similar study that was on a bill that came out of the Senate, do you know if it passed?

**Representative Mock:** I know that this is a study that is very unique, especially as a result of the amendment that would do the title 39 review. I don't know if there was any existing study language that would review our traffic fines and safety practices, if there were any overlap what would happen is, when Legislative Management would have the list of authorized studies they would likely merge or accept concepts of each. Really what this is, is just giving Legislative Management the ability, the authority to conduct this study; but they can make any modifications as deemed necessary.

**Major Tom Iverson:** Please see **Attachment #2** for testimony.

(7:04) Donnell Preskey, North Dakota Association of Counties, North Dakota Sheriffs and Deputies Association: The North Dakota Associations of Counties has had a resolution for several years supporting the increase of traffic fines and fees. Acknowledging that they are extremely low in the state and really don't serve as a deterrent to our motoring public. This issue has been discussed many times with our law enforcement community as well as our commissioners. Just that they are almost a joke, because of how low they are.

**Chairman Rust:** Did we pass a law that allows, and I presume it's only cities, to increase fines beyond those imposed by the state? Because in the past we had a bill that was

passed, I believe, that the city could not have a fine greater than what the state has. I think the bill we had passed, had no restrictions to it really, right?

**Ms Preskey:** I was in the House chambers yesterday and that bill was voted on, I believe it passed. I could be wrong.

**Senator Fors:** Where do the traffic fines, what pot of money do they go into? If you want to increase all these fines, where does that money go?

**Chairman Rust:** The common schools trust fund. Sports education. So if you should happen to get a DUI, just remember that your money that you get fined goes to educate kids.

**Senator Fors:** All of it goes to...

Chairman Rust: If I remember right the fines that go into the common schools trust funds; I haven't looked at it lately, but at one point in time those funds were distributed the next year, it might be calendar year. They're actually distributed fairly quickly to schools. The fines went into the common schools trust fund, now why is that? The theory behind that, if I'm remembering correctly, is that we don't put those in the highway patrol's fund because then the highway patrol will deliberately go out there and stop as many as they can to increase their coffers. I think that was the theory. I think the one with the city is different, I think that goes in the city's coffers.

Senator Bakke: I move a Do Pass

**Senator Dwyer: I Second** the motion

**Chairman Rust:** It has been a long time. Periodically we get these laws we keep passing them, we keep changing some and then all of a sudden after a period of time you've got some conflicts and you've got some things that just need to kind of be relooked at and shored up and removed. Again, the other with this is it that it does tell Legislative Management that they shall consider. Which means they can do with it as they seem fit.

**Senator Patten:** I think it's important to recognize that it's a review of both the fines and the charges I believe. To bring back Senator Larsen's comment about the failure to transfer a title in a timely manner resulting in being handcuffed and a misdemeanor. I think this is an appropriate place to deal with that. While it may be an increase in fines it may be a decrease or it may be a change in the charge that may be levied as well to make it more in line with what may be more appropriate as well.

**Chairman Rust:** To go along with that, obviously what will happen here is, if they come up with something there will be legislation that will be proposed. Again the Senate can either give a thumbs up or a thumbs down on it.

**Senator Dwyer:** I was just going to add, in addition to what Senator Patten said if you do a study, it's nice to have not only the highway patrol, but BCI and DOT and legislators so that you don't get a bill that there is no other input than just the sponsor.

**Chairman Rust:** When you look at the things they're supposed to study it is a fairly lengthy, it's nine lines.

Senator Fors: Who pays for this study?

Chairman Rust: These are studies that are done when you serve on an interim committee. When we get done Legislative Management will choose which studies will go to interim committees and interim committees study more than one thing. Chances are that there will not be an interim committee that will study just this. It may be one of five or six things they are charged with studying. What it is, it's legislators from both houses, both sides of the aisle, that are appointed by Legislative Management to meet. They'll meet anywhere from a few times, three, four times to sometimes you meet ten, twelve times if it's a large charge. It's a real education process for the legislators that are on that committee. It does a good job a lot of times of studying an issue, the unfortunate thing about interim committees is, they have a rather poor history of getting things through the legislature.

This resolution originated at the request of a constituent in Grand Forks who contacted her legislator -- former Rep. Rich Becker -- who put her in touch with me. This individual was concerned that North Dakota had not updated our traffic fines and regulations much over the last several years.

Instead of introducing legislation to increase specific fines or modify certain penalties, I worked with former Rep. Becker to study all traffic fines and safety measures during the next interim session.

HCR 3052 is very simple in its purpose: give legislative management the option to not only study traffic fines, but also the efficacy of our laws and safety programs.

Upon introducing the measure, I was able to speak with members of the ND Highway Patrol. They indicated they'd be supporting the resolution, but also informed me they had reviewed sections within Title 39 of the North Dakota Century Code that may be in need of updating or further review.

According to NDHP, ambiguity, inconsistency, and need for general study could benefit several sections within Title 39. Some of those inquiries and suggestions include, but are not limited to:

I am supportive of any amendments NDHP may offer that would extend the scope of this study to give legislative management the authority to review additional sections within Title 39, as it would be germane and within our intention to review traffic fines, safety, and laws governing the operation of motor vehicles in North Dakota.

As mentioned in the beginning, this resolution was designed to give legislative management the ability to take a closer look in Title 39 of NDCC and, if necessary, make recommendations to the 67<sup>th</sup> Legislative Session.

I hope you will review the scope of this study, make any adjustments you believe are necessary, and extend the option to study our traffic laws to legislative management with favorable passage of HCR 3052.
