Eric Delzer, Program Manager for the pesticide and fertilizer division of the North Dakota Department of Agriculture: See attachment #1 for testimony in support of SB 2152.

**Senator Hogan:** Do you have any idea how many mobile storage containers there are in the state?

**Eric Delzer:** We do not have an accurate estimate. However, could be up to 24 of these operating currently.

**Senator Larsen:** Are these the ones that look like big propane tanks driving down the highway?

Eric Delzer: You are correct.

Senator Larsen: And does the farmer haul that tank to get it filled?

**Eric Delzer:** To the best of our knowledge, all of the farmers using this setup are getting it delivered to them.

Senator Klein: So do the nurse tanks need to be inspected?

**Eric Delzer:** Yes. There are some regulations concerning the hoses and plumbing; they are DOT trailers so everything has to be maintained.

Senator Larsen: What is the fee structure on those?

**Eric Delzer:** There is no fee structure on nurse tanks. However there is an inspection process; we randomly inspect them at fill locations.

**Senator Hogan:** Do you actually have a sense of percentage of nurse tanks you actually see? Because there can be lots you haven't seen, right?

**Eric Delzer:** That is a pretty accurate statement. I'm sure there are a number of tanks we have never seen. I will say that as far as compliance goes, when we started this program in 2012 it was a pretty much 0 percent compliance rate, the tank of there were in really bad condition. Over the years with a focus on them and doing a live out reach, we've seen the compliance rate come up significantly. Before they were high risk violations such as expired safety valves, now to bulk of the violations we see out there are low risk violations like faded paint and peeling decals.

Senator Larsen: How in-depth is the inspection process?

**Eric Delzer:** We do not go that deep in detail with them. We have an inspection check list that goes over all the important details.

Senator Klein: The registration is pretty cheap; you never envisioned this as a money, right?

Eric Delzer: That is correct.

**Senator Larsen:** If a person has one of these outfits, are they exempt from the HazMat endorsement on their license?

**Eric Delzer:** I would say no, as far as I know they are not exempt from having the HazMat endorsement on their license.

Senator Larsen: Do you know what the fee is to retain that endorsement?

Eric Delzer: I do not.

Pete Hanebutt, NDFB: We support this bill.

Gary Knutson, ND Ag Association: So do we.

**Senator Larry Luick, Sponsor:** This bill addresses some safety issues. This will allow a larger supply tank to be taken out to the field and fill nurse tanks there. There is an application fee.

It is a good opportunity to make the roads safer and be more cost effective for farmers.

Representative Satrom: Are any other states using this size?

**Senator Larry Luick:** There are two states using a larger size.

Chairman Dennis Johnson: Are we talking semi- trailers?

Senator Larry Luick: Yes.

Eric Delzer, Pesticide and Fertilizer Division Director, North Dakota Department of Agriculture: (Attachment #1)

#### (7:40)

**Representative Tveit:** Semi-trailers can be moved on the road by the farmer with the product in it?

**Eric Delzer:** Yes. These are being used already. They usually stage it where there is easy access and bring their nurse tanks to that area. They are required to have current DOT certification on them.

**Representative Satrom**: Does a farmer need a special license or training beyond nurse tank training.

**Eric Delzer:** They would have a CDL and a HAZMAT and would not be exempt. The exemption is 3,000 gallons or less so that is why they get by with nurse tanks. With a semi-trailer they would have to have that endorsement.

Training has been discussed. Any employee filling nurse tanks has to have initial training and then annual refresher training. That is in administrative rule which would be updated if this passes.

Representative Satrom: Is it against the law to unload along a road?

**Eric Delzer:** It is legal to unload anywhere. It would come down to local authority and zoning.

**Representative Satrom:** The one-time fee to cover licensing and inspection, is that enough to cover the true cost of inspections?

**Eric Delzer:** No, it is not enough. When we wrote this, we mirrored the existing fee structure that is in Century Code for storage facilities. Currently under existing law, a storage facility for private on-farm storage is \$25 for a license. It is a one-time fee. For a commercial it is only \$100. That has not been changed since the law was written in 1986. The legislature can set the fee structure.

Representative Skroch: The fee could be amended to cover the cost.

**Eric Delzer:** We would have no problem to have the committee amend the fee structure. \$25 doesn't pay for an hour's time for an inspector.

**Representative Skroch:** In order to prevent theft of anhydrous, will the semis have the same protective devices?

Eric Delzer: Yes. The valves on the tank will have to be locked up when unattended.

Representative Satrom: Can we estimate to true cost?

**Eric Delzer:** It should be in the fiscal note. It could be anywhere from \$200 to over \$1,000 in actual cost.

**Representative Skroch:** These would be the same type unit that is currently filling storage units in rural settings?

**Eric Delzer**: Yes. It is the same. These would just have to be set up a little differently with some safety features for filling nurse tanks. It would have break away protection.

**Representative Tveit:** On the fiscal note, for the 2019-21 biennium you are showing revenues of \$1,000 and expenditures of \$11,200. Is that the actual fee?

**Eric Delzer:** That was from the estimate of how many of these were operating currently. The revenue was based off of 25 units. This program is funded by EARP (Environmental and Rangeland Protection) fund. It would not be coming out of the general fund

**Chairman Dennis Johnson:** Can I move this trailer to get it filled in town or does it have to be filled in the field?

**Eric Delzer:** You would be able to pull it to a terminal.

**Chairman Dennis Johnson:** What about liability insurance when moving it? It would be difficult to find an insurance company to insure the farmer.

**Eric Delzer:** Commercial haulers have to carry very high insurance usually up to a \$5 million policy. From our experience the farmers are all having it delivered.

**Chairman Dennis Johnson:** When the farmer pulls it out of the yard to go to another location, he needs a background check, a HAZMAT endorsement, and a tanker endorsement to be legal. Has that all been considered?

**Eric Delzer:** That is a business decision by the farmer. We would inform them what they have to do.

**Gary Knutson, North Dakota Ag. Association:** We are concerned about the insurance. Whether it is the dealer or the farmer. You would have a hard time finding drivers.

Is this a partial solution to get loads out before load limits? We support the concept but safety is primary.

Representative Fisher: Is there something we can amend in this bill?

**Gary Knutson:** That is a legal question. It is difficult to find drivers. It will be difficult to move the tanks.

**Chairman Dennis Johnson:** It was hard to find drivers back in the 90s and they didn't need the endorsements required now.

**Representative Tveit:** That is something we need to leave up to the agriculture department.

**Gary Knutson:** We also wouldn't have a problem with the fee change. Between pesticide registration fees and fertilizer tonnage fees, there is about \$10 million in the agriculture department budget.

**Eric Delzer**: A way around the licensing, once the units are empty and depressurized they can be pulled on the road with a standard license.

**Emmery Mehlhoff, North Dakota Farm Bureau:** We are in support of this bill. This is a proactive idea for the needs of our producers. This is an option to get some nurse tanks off the road.

Vice Chair Wayne Trottier: When you inspect a large trailer that will be left on the farm, is there a question asked about the licensed driver?

**Eric Delzer:** We don't inspect very many of these. There is an administrative rule that they are supposed to give us a written notification 30 days prior to doing any downloading or by March 1 for the spring season and September 1 for the fall season. They are also required to give that notification to the county commissioners and the county emergency manager.

We haven't received those notifications. Unless we receive a complaint, we don't know where this is taking place. The driver's license is a DOT issue. We don't have authority to regulate that. We can ask for a recent DOT inspection? Under federal law the tanks have to be reinspected at least once every 5 years. That is one of our bigger concerns. These tanks aren't getting the internal inspection. By licensing them, that is a provision that we would check to make sure they have current certification.

**Chairman Dennis Johnson:** Does part of your inspection include pressure check or is that for the DOT?

**Eric Delzer:** That is part of the DOT inspection. Under our existing rule now along with that notification, they are supposed to submit a copy of their last DOT certification. But we are not receiving them.

Chairman Dennis Johnson: What is the penalty for not getting a tank inspected?

**Eric Delzer:** Depending on how out of compliance it is, we would issue a Cease and Desist Order until they obtained a license. Our law allows us to go from a warning up to \$5,000 per violation.

Representative Tveit: Do you need an emergency clause?

**Eric Delzer:** We didn't think we would get people trained and licensed before this season. If this passes, we would spend most of the summer getting the information out. Next year we would be ready to go by the time it is needed in spring.

Representative Satrom: Should we adjust the fees?

**Chairman Dennis Johnson:** The money that goes to the EARP fund comes from fertilizer and fees. Almost half of that money goes into the general fund. I have no problem leaving it the way it is.

Representative Schreiber-Beck: Moved Do Pass

Representative Skroch: Seconded the motion

**Representative Skroch:** I am alright with the fees now and we can look at it again in two years.

**Chairman Dennis Johnson:** I don't know if this will be used that much. I do appreciate getting the nurse tanks off the roads.



Chairman Luick, and members of the Senate Ag Committee. My name is Eric Delzer and I am the program manager for the pesticide and fertilizer division of the North Dakota Department of Agriculture (NDDA). I am here on behalf of Agriculture Commissioner Doug Goehring in support of Senate Bill 2152.

NDDA is responsible for inspecting all anhydrous ammonia storage facilities, as well as all anhydrous ammonia nurse tanks in the state. These inspections are statutorily required under the North Dakota Century Code. Our inspections ensure that the tanks follow the minimum code requirements outlined in our law and administrative rules and are in safe working order.

Over time, we have seen an increase in mobile downloading of anhydrous ammonia from semi transport trailers into nurse tanks in the field. By purchasing an anhydrous ammonia semitrailer, farmers can order anhydrous from a distributor and have it delivered directly to the field. The trucking company delivering the product will pump it directly into the farmer's semi-trailer, which they can then use to fill nurse tanks in the field. This process can be much more efficient and safer for farmers in remote areas as they do not have to tow nurse tanks at low speeds on increasingly crowded public roads, to retail storage facilities to get filled.

Anhydrous ammonia is a very safe and effective fertilizer when handled properly. However, an accidental release from improper handling or faulty equipment can very quickly have serious and deadly consequences. Over the past several years, we have heard concerns from citizens who have witnessed downloading from semi-trailers into nurse tanks along public roads and highways, and near occupied farm yards. Unless we get a complaint from the public, or
