Explanation or reason for introduction of bill/resolution:

To provide an appropriation for veterans' spouses & dependents burial fees at the veterans' cemetery.

Chairman Davison: Let's open SB2195.

Sen Marcellais, Dist 9, Belcourt.: I am here in support of SB2195. (see att#1)

Chairman Davison: Any questions? More in support?

Jim Nelson: I am here in support of this bill. (see att#2) I stand for questions. (6.00)

Chairman Davison: In Sen Marcellais testimony it has \$550 to be waived. Is that the cost?

Jim: The Veteran is buried free. That is the reopening fee if a spouse dies or dependent who is buried in the veteran's plot. (6.46)

Sen. Shawn Vedaa: Can you tell me the difference between this cemetery and the new national one in Fargo. Is anyone qualified to be buried there?

Jim: Any veteran or spouse or dependent. They have no fee in Fargo.

Sen. Shawn Vedaa: Why was the Fargo one built?

Jim: There is a difference between a federal and a state cemetery. Ours is state and Fargo is federal. (8.18) Whole different world.

Chairman Davison: More in support?

Mark Landis, Veterans Service Officer, Burleigh County: I am the president of the Professional Veterans Advocates of North Dakota. I come here in support of SB2195. (see att#3) (10.00-11.38) I stand for questions.

Chairman Davison: Any more in support? Agency testimony.

Brigadier General Robert Becklund, North Dakota National Guard: I am here in a neutral position to provide information to the committee on SB2195. (see att#4) We do not think \$168,000 will be enough as stated in this bill. We have \$14,900.00 funds of prepaid money in our fund. Standing Rock just got a grant to build an all nation veterans cemetery. (14.00) I will take questions.

Sen. Erin Oban: Do you have a breakdown of the \$166,000, \$196,000 are dependents vs spouses?

General Becklund: Spouses and dependents are covered in Fargo cemetery.

Sen. Shawn Vedaa: Thank you for your service. I noticed we have a free cemetery in Fargo. Could this bill loose families who would go to Fargo instead of ours? We have a beautiful vets cemetery here.

General Becklund: We have done some analysis and we do not feel there will be a major impact here. The \$550 may make a difference but we don't feel much. (17.41)

Sen. Erin Oban: Does that \$550 cover the cost?

General Becklund: That is the opening and closing cost. We don't make any money.

Sen. Erin Oban: Do you know when that rate was last increased?

General Becklund: Not sure. It started out at \$200 then went up to \$300. As things go I expect that rate to increase to keep up with labor rates.

Sen. Erin Oban: Do we have to authorize this?

General Becklund: I believe so. I think our special funds need to be appropriated. (18.45)

Sen. Shawn Vedaa: In 1989 when I came into the guard, I remember talk about the cemetery. How does the burial work?

General Becklund: We don't do services out there. No religious, so just burial. We do the military honors, present the flag to family. If you earned a rifle volley, we do that. May be up to 21-gun salute. There is a short graveyard ceremony. We did 80 funerals a month.

Sen. Shawn Vedaa: Are spouses buried next to each other?

General Becklund: I think there are options. On top of each other. Spouses have their information on the other side of monument.

Chairman Davison: Any more testimony? Any opposing testimony? Hearing is closed. Sen Marcellais, do you know why there is no fiscal note?

Sen. Richard Marcellais: This was from two sessions ago and this was the cost. It is an estimate. I just made a trip to Arlington Cemetery and they have over 200,000 graves. They are buying more land. There are 20-30 veterans buried a day out there. It is free to vet and spouse and dependents. Stand Rock is a federal cemetery. (22.49) Fargo is still in ground breaking mode.

Sen. Shawn Vedaa: What is a qualifying dependent?

Sen. Richard Marcellais: Any immediate dependents. No age limit.

Chairman Davison: General, could you come back up? Do you know why there is no fiscal note on this bill?

General Becklund: We did not introduce this bill. This bill would give us an additional \$168,000 off of our account. I believe this is driving a fiscal note.

Chairman Davison: Thank you. We will hold this for now and get an answer on fiscal note.

Chairman Holmberg: Called the committee to order on SB 2195. The bill came from GVA.

Senator Marcellais, District 9, Rolette County

Senator Bekkedahl: Your testimony talks about the spouses but the bill talks about eligible dependents as well. Do you have any feelings on the opportunities of dependents?

Jim Nelson: I would include them because there are special requirements for burial and I would stand with the same recommendation.

Senator Dever: If I precede, my wife has no expenses, but if she precedes, then, as the veteran, I'm the one who has those expenses. If I die first, the government is paying for the expenses of my burial, correct? If she dies first, then I'm paying the expenses.

Jim Nelson: That is correct.

Mark Landis, Burleigh County Veterans Service Officer

Senator Dever: Could you just tell us the qualifications for a dependent to be buried in the cemetery as well.

Mark Landis: The dependents are allowed to be buried there. The children prior to majority age are also.

Brigadier General Robert Becklund, Deputy Adjutant General, North Dakota National Guard:

Testimony in support of SB 2195 - Attached # 4.

Chairman Holmberg: That is some new information regarding the federal cemeteries.

Senator Hogue: Honor guard folks – do dependents have that honor guard and do those folks go on state active duty or is that part of their job allocation? What is their status when they do that?

Brigadier Becklund: The dependents don't get honor guard unless they were a member of the military themselves. As far as the National Guard goes, we have a team. Honor guard is an army team. Those are done on inactive duty training time.

Senator Mathern: I have a question regarding the refund. Are there people who would like to pay this? I am wondering why you wouldn't permit it or maybe even direct it to the non-profit organization. Some families might actually like to pay this. I am wondering why it would be an automatic refund.

Brigadier Becklund: I think this is the fiscally responsible policy right now. We do have a viable foundation set up for the cemetery. We do accept donations and many families do contribute even though their burials are paid for, even for the member. Following the internment ceremonies there are many cards with cash money donations. I would suspect that most people would donate their prepaid funds. However, having a policy like this is nice just in case they don't.

Senator Robinson: You mentioned the foundation. What is the asset base in foundation? You are doing internments year round, correct?

Brigadier Becklund: The foundation has been set up since the cemetery was founded. It has been fundraising ever since. We have about \$7M. The foundation is contributing to the maintenance of the cemetery. The internments are year round. We had a record year. There was about 70 in one month which was the high. The average is 40-50 a month.

Senator Robinson: How many internments have we had?

Brigadier Becklund: We have had about 8000.

Senator Dever: I was curious about the designation of the National Cemetery for Fargo and Standing Rock. The one south of Mandan is a State cemetery that receives federal dollars but operates under the requirements of the federal government because of those dollars regarding dependents and other things, correct?

Brigadier Becklund: It's a state cemetery, but we get grant funding from the federal government. At the end of the day it is a State cemetery. The ones in Fargo and Standing

Rock are federal cemeteries. That is why the spouses there would be buried at federal expense.

Senator Dever: If this had that designation, this wouldn't be an issue.

Brigadier Becklund: That is correct. The cemetery at Fargo will be much smaller than the one we have here. I am not sure about the one at Standing Rock. We do not see much of an issue there as far as competition other than equity. Many people might want their veteran buried close to where they live.

Senator Dever: It's beautiful. It almost makes me look forward to it.

Chairman Holmberg: Closed the hearing on SB 2195.

Senator Mathern: Moved a Do Pass on SB 2195.

Senator Robinson: Seconded the motion.

To provide an appropriation for veterans' spouses and dependents burial fees at the veterans' cemetery

Chairman Kasper opened the hearing on SB 2195.

Senator Richard Marcellais appeared in support. Attachment 1. (1:00-2:32)

Vice Chair Steiner: What is the definition of eligible dependent?

Senator Marcellais: I was told it was any disabled child that lives with the parents up until their death.

Rep. Rohr: Up to this point, it has been out of pocket expense?

Senator Marcellais: I understand they do have funding that has already been deposited for procedural burials.

Rep. Rohr: Is there another fund that would be paying for this? Which fund is it?

Senator Marcellais: They do have a fund separate from what has been paid already. I have heard they have \$7 million in that fund. I don't think \$550 is too bad.

Rep. Rohr: This is an appropriation of the \$250,000 coming out of the state budget?

Chairman Kasper: It is the general fund.

Senator Marcellais: It would be a fund that they wouldn't have any more if they didn't pay the \$550. It would be waived. The Adjutant General's Office could probably answer some of those questions about their budget. In the hearing in appropriations, they mentioned there was \$7 million in the cemetery fund.

Rep. Schauer: Can you explain the impact that a spouse has on a veteran.

Senator Marcellais: When I was in Vietnam for a year, I can imagine what my wife was going through. It was mentioned at the hearing in the senate that you never see the spouse in these parades. It is always the veteran. I feel that it is time for us to recognize our spouses.

Mr. Jim Nelson, Legislative Director for ND Veterans' Legislative Council, appeared. Attachment 2. (6:15-9:00)

Rep. Karls: Has any thought been given to the spouse who already has paid the \$550?

Mr. Nelson: I don't have that answer, but someone else here does.

Mark Landis, Burleigh County Veterans' Service Officer, appeared in support. Attachment 3. (9:51-11:44)

Neutral

Brigadier General Robert Becklund, Deputy Adjutant General for the ND National Guard, appeared in a neutral position. Attachment 4. (12:10-15:16)

Rep. Laning: Senator Marcellais referenced a \$7 million fund. That would not be for these burial expenses? The additional funding of \$250,000 is what you are looking for to cover these burial expenses?

General Becklund: The ND national guard cemetery foundation was created about the same time the cemetery was created, and it has been raising money right along to provide for the operations of the cemetery. This is quite independent of that. This is your general fund monies that would be added into the Office of the Adjutant General's general funds accounts for the sole purpose of covering the burials for the spouses.

Rep. B. Koppelman: Is the burial fee for the veteran currently paid by a general fund appropriation or by other foundation earnings?

General Becklund: The current \$550 is paid by the families. Those are private funds that come in and paid directly to the cemetery to cover that.

Rep. B. Koppelman: I believe we do not charge for the veterans to be buried, only for the spouses. I am talking about the part we already pay for.

General Becklund: The general fund.

Rep. B. Koppelman: If the salaries of those individuals involved with the burials are currently paid by the general fund, presumably they are somewhat subsidized by the \$550 that is currently being paid on behalf of the spouses. Is this really the magic number?

General Becklund: This bill adds \$250,000 to this next biennium. The \$550 was our best estimate at a cost to actually do a burial. When the cemetery first started, I think it was \$200.

Later it went to \$300. Now it is up to \$550. We would expect that the cost would go up over time.

Rep. B. Koppelman: Do you have any data showing how many total individuals are in the cemetery, veterans versus spouses, and what is the budget to do that?

General Becklund: I will have to get back to you on that. It had been asked if this was retroactive. This is not intended to be retroactive.

Attachment 5 was handed out by the law intern.

Chairman Kasper: How many veterans have been buried the last three or four years? How many spouses have been buried in that same period of time? Is this actual cost? Do you have full time employees who are part of the burial committee that digs the graves, etc.?

General Becklund: We have (five?) full-time people there. There are some temps too. In Senator Marcellais' original bill, it was \$160,000. It was based upon previous years' estimates and special funds coming in from private citizens.

Chairman Kasper: How do you come up with those estimates.

General Becklund: It is from our budget analyst and our executive director of the cemetery. We will get those to you.

Rep. Schauer: Has there been any discussions to partner with the ND guard foundation on this?

General Becklund: The ND guard foundation has contributed already to the operations and maintenance of the foundation for equipment purchases. They have not funded burials.

Chairman Kasper closed the hearing.

Chairman Kasper: We are going to wait until we get some data.

Rep. Louser: We had this bill four years ago. He gave the statistics on what happened. It is going to be crucial to have the information to present to appropriations assuming we pass it. (23:00-23:37)

Rep. B. Koppelman: The law intern handed out a copy of the appropriation bill. Attachment 6. The line item for the veterans' cemetery with \$881,000 for the base line, and it is proposed at \$972,000.

Chairman Kasper: I would assume that budget is for the maintenance of the cemetery. Is that correct?

General Becklund: It is the salaries for the personnel that work there.

Chairman Kasper: You have two sources of funds—general fund for that plus \$7 million is also subsidizing?

General Becklund: The effort is to grow that fund to provide continuous support there, but we are not quite there yet. We did receive request of the cemetery for funding for the sprinkler system, because that was important last year, and we did provide funds there.

Chairman Kasper: You should give us information about that foundation and some data on where you have been spending the money in the last two or three years.

Chairman Kasper opened the meeting on 2195.

Rep. B. Koppelman: Where is the priority list for the state for what we do for veterans? Was this on that list, or is there \$250,000 we should be spending somewhere else for veterans? That was the struggle I was having on this one.

Vice Chair Steiner: I thought the money was coming out of a trust fund that they had built up to \$7 million.

Rep. B. Koppelman: We were going to look at the copy of the appropriations bill that was handed out at the hearing. The veterans' cemetery is already proposing to get another \$91,000 which is more than a 10% increase in their appropriation. I wonder if some of this could be funded that way or not.

Chairman Kasper: Attachment 1 was handed out. (5:12-6:18) How many spouses were they estimating were going to be buried?

Rep. Laning: 163. It ranges from 130 to 205.

Chairman Kasper: 150 at \$550 is about ...

Rep. Laning: \$82,500.

Chairman Kasper: They are wanting \$250,000.

Rep. Rohr: We have to remember it is dependents as well.

Rep. Schauer: I don't know how we can't support it. I would have liked the cemetery people to come with some private funds or the foundation people alongside and make it a match. I make a motion for a DO PASS and rerefer to appropriations.

Rep. Hoverson seconded the motion.

Chairman Kasper: I suspect the \$250,000 might change when I get down to appropriations. Let them make the decision.

Rep. B. Koppelman: I think I am going to vote no. I think the amount is too much. I would be more comfortable if it was a smaller amount.

Chairman Kasper: What number could you support?

Rep. B. Koppelman: Around \$100,000.

Rep. Laning: They had 205 dependents during the year 2018. If you took that x \$550, you would come up with \$112,000 some odd dollars. \$100,000 may be on the light side.

Rep. Schauer and Rep. Hoverson withdrew their motion and second.

Chairman Kasper: Rep. Koppelman is thinking around \$125,000 for an amendment.

Rep. Schneider: Does that cover the biennium? Don't we have to double that?

Chairman Kasper: Yes, that's right.

Rep. Vetter: I would be down for \$125,000.

Rep. B. Koppelman: When you look at the testimony received, the bill started out with \$160,000 based on historical projections. They have had more in the last couple years. If we approved it at \$125,000, I think you would find they would make due and figure out where those static costs were and wouldn't be them running in the red. I make the motion to amend the amount to \$125,000.

Rep. Vetter seconded the motion.

Rep. Hoverson: It seems like we squished them right down to the absolute as if we know what the projections are, and we don't. I would think they would know better, so would you consider going up higher? If not, I am good with it too.

Rep. B. Koppelman: Some things to take into account is that they do have a foundation for the cemetery. They have paid out some money, but they are also letting some of the money build. There is also some sort of a trust fund that some of the funding comes from. I believe they should have proposed this with their budget. Being it is an add on, I want to err on the conservative side of things.

Rep. Laning: This is a biennial budget, and the numbers we are talking about with burials are annual. The numbers for the last four years are 190, 188, 191, and 205. You probably have to figure 400 people dying in two years.

Rep. B. Koppelman: According to General Becklund's testimony, the actual amount collected for the 15-17 biennium was \$166,000. The 17-19 biennium they are projecting \$196,000.

Rep. Schauer: I support Rep. Koppelman on this. To raise money for the burial of spouses is about as easy as it gets. For the cemetery foundation to come up with this extra money is not going to be difficult to do.

Rep. P. Anderson: I am going to resist the motion. I think the powerful appropriations can lower the burial cost and put the blame on them.

Rep. Schneider: I am for the easy and feel good way on this one too.

Voice vote. Motion carries.

Rep. Vetter made a motion for a DO PASS AS AMENDED and rerefer to appropriations.

Rep. Schauer seconded the motion.

Rep. Laning: Should the cemetery need it, there is nothing in this bill that prevents them from continuing to charge some amount is there?

Chairman Kasper: No.

Rep. B. Koppelman: That is a good point. I think as it was presented to us, this was supposed to end the charging for spouses. It may be prudent for us to add something to the bill that says here is an appropriation for this purpose and some sort of language that says for the veteran, the spouse, and dependent child provided at no cost.

Chairman Kasper: I don't think we want to go that far.

Rep. B. Koppelman: What happens if they continue to charge \$550 for all spouses and children? What is the point of putting this money in then?

Chairman Kasper: No. The bill says paying the costs of interring veterans' spouses and dependents who are eligible. It doesn't say any other costs.

Rep. B. Koppelman: Is the way this is worded then going to stop them for charging spouses?

Chairman Kasper: It is not going to stop them. It could certainly soften the charge. If the average charge is \$500 and we are giving 60% of the cost here, then they can choose what to do with the rest of it. Think about it. It is pretty cheap cost compared to what the average family would pay when there is a death.

4:30 Chairman Delzer: Called the meeting to order for SB 2195. Representative Kasper is here to present the bill.

Representative Kasper: This is an appropriation to fund the burial of spouses in the veterans' cemetery. It came to the committee with an appropriation of 250,000 from the Senate and as we got it in front of our committee we reduced it down by 50% and there are other sources of funds. There will also be other general expenses, but we wanted to focus on the expenses for the spouses.

Representative Bellew: Did they tell you how much it would cost per spouse? And how many this would cover?

Representative Kasper: They did, they figured the cost of 550 dollars per burial per spouse, and they gave us a chart that showed the number of spouses that had passed away dating back to 2010 which was at 125 in 2015 and it was up to 191 in 2015 and at 205 at 2018. That was there estimate.

Chairman Delzer: Did you ask them what they charge right now? And will they continue to charge or would this take care of the whole charge?

Representative Kasper: I don't know if it will take care of the whole charge because we don't know how many will pass away in the next year or 2. They do charge right now and I think it was \$550 per spouse. They have burial fees that vary from 0-762 dollars at the state veteran's cemetery. Generally speaking, a private cemetery in ND charges in excess of the \$550, and their fee is set at this number.

Chairman Delzer: So this is supposed to replace that charge?

Representative Kasper: All or part of it.

Chairman Delzer: Do you remember how many times we have heard this before?

Representative Kasper: It has been more than once.

Representative Brandenburg: The veteran's cemetery is supposed to be a place for vets, but if the family member wants to be there, it is a privilege and I don't think we should be paying for this. They should have to be paying for it. I would struggle with this because for me this is sacred ground for the vets, and if the family members want to be there they should have to pay a cost for it.

Representative Kasper: The committee struggled with the number, currently there is \$14,900 prepaid fees for future burials of spouses already there. There is a \$7million memorial fund for the entire cemetery foundation. We felt there are other sources to cover those other expenses.

Chairman Delzer: Representative Vigesaa or Representative Brandenburg, have you guys had the discussion on how much we have in the budget for the veteran's cemetery?

Representative Vigesaa: We have had this discussion on this bill, and this is what we talked about as well.

Chairman Delzer: How much are we currently contributing in the budget?

Representative Brandenburg: I think that it is somewhere around 5-600,000.

Representative Nathe: I know that they run the veteran's cemetery closely to how they run the VA (veteran's affairs) cemetery, was there any mention as to what the VA does? Does the VA pay for spouses?

Representative Kasper: No that never came up.

Representative Nathe: I know we had this bill last session and we killed it. I can tell you, \$550 for an opening and closing of a grave is pretty cheap. In Bismarck it is somewhere between 800-1000. That is regardless of if it's a casket or an urn, they charge the same amount.

Brady Larson, Legislative Council: In the current version of this bill we have \$972,000.

Chairman Delzer: Can you look at what we had last time?

Mr. Larson: Yes.

Representative Beadle: Last biennium the budget was \$881,284 for the Veterans cemetery.

Chairman Delzer: Anything further to add?

Representative Kasper: No that was it.

I can't imagine you would ever wait until you were done, I would imagine it would be free until they run out of money and then they would start charging. You can't wait until the end of the 2 years and the prorate it.

Representative Nelson: So it would be to your benefit to die early.

Representative Vigesaa: They take the 250,000 and divide it by 550, which would be about 454 burials over a biennium. This would cover about 200 and some per year. So I think the

original request of 250,000 would have covered everybody. There are funds in the veteran's cemetery fund and they probably would have just covered it.

Representative Beadle: The bill was originally introduced in the Senate with 160,000 and the Senate committee is what upped it to 250,000.

Chairman Delzer: Further discussion?

Representative Boe: I would think that the 550 dollars isn't enough to cover those expenses. I think this is a sign of the upcoming influx of more burials in the future as we go on for the next decade or so.

Representative Nathe: We cover this now I know it'll be way more expensive in the future when we subsidize it. More people are choosing to be buried at the veteran's cemetery because it is more expensive to buy a lot on a private cemetery. It is expensive to pay for that opening and closing or 800-1000 dollars. It is twice as much for a head stone. These numbers will keep going up significantly down the road. If we pass this, I guarantee within a couple of sessions this is going to be much higher.

Chairman Delzer: I certainly think that we have no problem respecting the veteran's but I'm not sure we should go to the point of subsidizing a spousal burial.

Sen. Vedaa: I recall in the hearing, that the original money was lower, so we raised it. We were told the original money would not be enough. Does the House have anything to add?

Sen. Richard Marcellais: The initial bill I introduced was \$160,000. You make a motion to amend it to \$250,000. (1.34)

Rep. Schauer: How did you come up with \$160,000?

Sen. Richard Marcellais: I introduced this last session, and that is what the cost was at that time.

Sen. Vedaa: We will call someone up to explain.

Al Dohrmann, Major General, National Guard: (2.48) (see att # 1) The cemetery falls under me. We projected a cost of \$211,000. The time line is going up. One chamber looked at the past nine years. That average came to \$160,000. The spouses had to track with the vets to some extent. We feel our numbers will go up as Korean vets pass and then the Vietnam vets are next. We may have a lull in between war conflicts, I guess.

Rep. Karls: This is a two-year appropriation. If we pass the bill with the \$125,000 as House amended, your department will have to come up with the rest of the money? Or will you prorate it?

AI: At this amount, I project I will be in front of the emergency commission within the first quarter of the biennium. The bill right now, would require me to pay and we would have to

find that money somewhere. The law requires that we pay. The adjutant general's office is responsible.

Rep. Schauer: Who has paid this in the past? Has it been from the families? Are there any public dollars or from your budget?

Al: I have heard people comment that the workers are already there, so why can't you just do more burials. This is the budgeting process, and we set a fee of \$550 fee for eligible dependents and spouses. We worked that into our budget. If that revenue source is not coming in, then we need another source of revenue to cover it. The fee has covered the cost. The fee is part of our base budget. (6.37)

Rep. Schauer: This is a onetime \$125,000 allocation to you and your budget. What happens if this is not renewed in two years and what happens to those who pre-paid? (7.00)

Al: We are struggling what to do with pre-paid. We would at least make them aware that this is available in the next biennium. If you want us to refund, we will do that. There is a foundation that is for the veterans' cemetery. (7.43) The legislature can't appropriate money from that foundation. The foundation already has committed \$350,000 for us in the coming biennium. That is part of our budget forecast. The governor had \$127,000 in their budget for cemetery. I think now the package will be \$125,000 in general funds for the next biennium to support the cemetery. This is a program that you don't start and then stop. You have a moral obligation to keep this going once started. You may want to change the word 'pay' to 'defray' in the bill. That is a suggestion. It may mean a decrease in fee for burial, which is now \$550. From a policy perspective, if we brought this fee to \$200, I bet in three years we would have it back to \$550. (11.13)

Sen. Vedaa: Sounds like you expect the burial numbers to increase in the next two years. Could this be addressed in the next biennium? Could those numbers go down?

AI: Generally, the trend lines go up. That will continue with Vietnam people. Could there be a decline in 10-15 years when you have a war gap. Maybe, but there is global war on terrorism that has come of age. Those numbers steadily increase. (12.52)

Sen. Richard Marcellais: Do you get any federal money for the cemetery? (13.17)

Al: Yes. There are federal grants that covered some construction in the past through the Veterans' Affairs. We get \$750 from federal VA for burial of vets.

Sen. Richard Marcellais: I am concerned because we have two federal cemeteries coming to N.D. and spouses don't have to pay anything. I think that will hurt the cemetery in Mandan. We have a beautiful cemetery in Mandan, don't get me wrong. I am planning on being buried in Mandan cemetery. Cost does not matter to me, but I know there are vets out there that cost does matter. (14.34)

AI: Totally agree. This was not in our budget nor the governor's budget recommendation. We did research this time and found that more and more state cemeteries are covering the cost of dependents and spouses. From a policy stand point, if this bill passes, I have to have a

discussion with OMB and the governor next session to get it in the base budget. The discussion will have to include the nationwide trend of covering the cost of spouses and dependents. (15.30)

Rep. Schauer: We understand the need for burial for spouses. But this is one-time allocation. If we kick it up more than \$125,000, we run the risk of it not passing in the House. Also, we need this in your base budget for continuing appropriation. (16.12) How do we do that strategically? We have to look at this long term and this is the dilemma.

Sen. Richard Marcellais: Why don't we just wave it and not consider the money. How's that?

Al: We learned lots through the process this session. I did not know the federal government was waving the cost and this is a movement.

Rep. Schauer: I do like defraying the cost language. That helps in the process. I want to at least get the \$125,000 through the House.

Sen. Vedaa: I like this bill. I would hate to tell a family that we did not have the money to bury their spouse. I am holding firm at the \$250,000. (18.24)

Rep. Johnston: My concern is that spouses have to go through lots when their spouse serves in the military. I do want to send something back to the House that will pass. We funded a cactus green house for crying out loud. What is that priority? This is a priority. I would be in favor of defraying the cost. (19.09)

Sen. Vedaa: If this was \$1.25 million I would have heart burn, but this is \$125,000 and veterans' spouses. I think we need to be at \$250,000.

Rep. Schauer: Do you think that amount will fly in the House?

Sen. Vedaa: Probably not.

Rep. Schauer: That is why we are here.

Rep. Johnston: To clarify, everything flies on your side.

Sen. Vedaa: Let's think about this and meet again. Adjourned. (20.14)

There could be an issue down the road with the \$250,000 two years from now because that money would be part of the adjutant general's budget. Will the appropriation add \$200,000 on to that budget? I know we need to take care of now. If we kick it up to \$220 which this amendment proposes, would that go through on the House side. I would say, no. Senate Bill 2195 would allow for the spouse or eligible dependents burial fees of \$550.00 to be waved.

The North Dakota Veterans Cemetery was established by an act of the 2989 Legislative Assembly and is operated by the Office of the Adjutant General of North Dakota.

Any Veteran wartime or peacetime service is eligible for burial in the North Dakota Veterans Cemetery. Present and past National Guard members and present and past Army, Air Force, Navy, Marine Corps and Coast Guard Reserve Forces.

I was the chaplain for the Bismarck AMVETS for a few years and served as the Chaplain for the North Dakota Department of AMVETS. During my tenure as Chaplain I attend many burials at the Veterans Cemetery and others around the Bismarck Mandan area.

I same caskets and burial urns that would be the envy of anyone, and burial urns and caskets that broke my heart. I will give a few examples. In most instances the caskets are general relatively modest, the enviable ones are some not that common. Once in a while you will see some that speak volumes to the financial status of the deceased and his or her family. I will never forget the first time I saw a cardboard casket. It was painfully obvious that this family this was all they could afford. When it comes to cremation urns, I have seen brown paper bags, a coffee can, numerous urns given by the funeral home, one in particular, had a photo copied picture of the loved one tape to the container. While there may be other reasons for the use of these containers, the obvious reason to me is the just can't afford any better.

This bill would, along with helping all veterans, would be especially welcomed by those of low income or other hardships. While 550 may not seem like much to most of us, there are many veterans' families that this help might make the difference between a coffee can and a nice simple urn.

Speaking with Pam at the Cemetery she told me of a situation currently she has. A veteran is buried at the cemetery currently and the spouse passed away in a different state. Family members sent the ashes and death certificate to the Cemetery. Pam notified the family of the fee and they replied they did not have the money and would time to raise it. That was two months ago. She also informed me that the new National Cemetery in Fargo does it for free.

The Veterans Legislative Council supports this bill



The Administrative Committee on Veterans Affairs (ACOVA) is responsible for the organization, policy, and general administration of all veterans' affairs in North Dakota. The Administrative Committee is comprised of 15 voting members, each appointed by the Governor, representing the five major patriotic veteran organizations in the state.

Each year, the Governor is to appoint one member from a list of two names submitted by the following North Dakota veteran organizations: American Legion, Veterans of Foreign Wars, Disabled American Veterans, AMVETS, and Vietnam Veterans of America. The ACOVA is also comprised of three nonvoting members who are to serve in an advisory capacity—the North Dakota Adjutant General, the Center Director of the Federal Veterans Affairs, and the Executive Director of Job Service of North Dakota. The Governor also appoints the ACOVA's Chairman and Secretary.

The ACOVA has several activities they monitor on behalf of the Governor and the state's veterans.

North Dakota Veterans Home:

The ACOVA appoints a seven member governing board for administration of the North Dakota Veterans Home located in Lisbon, ND. It assists in creating the management and not in the day to day management of the Veterans Home.

Post War Trust Fund:

The veterans' postwar trust fund (PWTF) is a permanent trust fund of the state of North Dakota and consists of moneys transferred or credited to the fund under NDCC 37-14-14 and other laws. All income received from investments is to be utilized only for programs of benefit and service to veterans or their dependents, and all income earned in a biennium is appropriated to the (ACOVA) on a continuing basis.

ND Department of Veterans Affairs:

The committee shall appoint the commissioner of the department of veterans' affairs. The commissioner of veterans' affairs shall serve as the executive secretary for the subcommittee. The commissioner has no vote in the affairs of the sub-committee.



SENATE BILL 2195

First, we would like to provide you with some data to help you better estimate the amount of general funds required to off-set the loss of special funding we currently receive for the burial of our veteran's spouses and/or dependents. The \$160,000 amount in the bill was based on historical projections prior to 2015 and will not be enough for us to provide the required burials should this bill pass as written. For example, during the 2015-17 biennium the actual amount was just over \$166,000; and for the 2017-19 biennium the actual amount is projecting to be approximately \$196,650. Based upon this increasing trend of spouse/dependent burials per year at the current rate of \$550 each, we project the amount in the 2019-21 biennium to be closer to \$210,000. And, if we have higher than average burials of spouses and/or dependents, or if rates increase, it is possible that we would not have enough funding under this bill to cover actual costs forcing us to re-role funding from our existing Operations and Maintenance accounts to cover costs of burials.

Also, the authority of this bill expiring on June 30, 2021 presents some concerns. For example, once a program such as this is created it will have to be maintained in order to not break trust with any future veterans who have gained an expectation that the costs associated with the burial of their spouse or dependents will be provided by the state. So, if this bill is passed, funding requirements are anticipated to be included in all Office of the Adjutant General future budget requests.

Additionally, we currently have \$14,900 in prepaid burial fees for the future burials of spouses and/or dependents of some of our veterans. If this bill becomes law we would be prepared to refund the prepaid money received from any of those that pass during the 2019-21 biennium. As this bill covers only the 2019-21 biennium, our intention would be to not refund any other prepaid funds received until future years funding for this program is assured.

Finally, there is a new national Veteran's Cemetery coming to Fargo and the Standing Rock Sioux Tribe has recently received a grant to construct the national All Nations Veterans Cemetery near Fort Yates. As federal rules allow for no-cost burial services for a spouse and dependents of veterans in national cemeteries, this bill would provide the North Dakota Veterans Cemetery with comparable equity to these local national veteran's cemeteries.

Chairman Kasper, members of the Government Veteran Affairs Committee, for the record my name is Richard Marcellais, Senator from District 9, of Belcourt I am here today to provide testimony on Senate Bill 2195.

Senate Bill 2195 would allow for the spouse or eligible dependents burial fees of \$550.00 to be waved.

The North Dakota Veterans Cemetery was established by an act of the 2989 Legislative Assembly and is operated by the Office of the Adjutant General of North Dakota.

Any Veteran wartime or peacetime service is eligible for burial in the North Dakota Veterans Cemetery. Present and past National Guard members and present and past Army, Air Force, Navy, Marine Corps and Coast Guard Reserve Forces.

There is no cost to the Veteran for burial. If a spouse or eligible dependent is buried the fee is \$550.

In honor of all those who have served & especially to those Veterans who have protected our countries freedoms, may they rest in peace.

I believe that our North Dakota Veterans spouses and dependents are entitled to have their burial fees of \$550 should be waved.

The sacrifice of our military personnel is acknowledged and appreciated by most Americans. From huge send offs to packed airport terminals upon coming home our veterans are given robust applause and standing ovations. The exception to this story was those of us who came back from Vietnam.

There is another group that receive no robust applause and standing ovations: the spouses of our veterans. Most of the time, spouse is left on the sidelines, unrecognized for his or her sacrifice, courage and commitment to the nation. Military and veteran spouses are truly the unsung heroes, often putting their careers on hold, often to the detriment of their financial wellbeing, while the other spouse is gone serving the Nation. The spouse at home is trying to raise a family, have a career, balance the finances, fix the car, call the plumber being two parents at once yet never complaining. All too often the spouse becomes a caregiver to a disabled veteran, suffering from PTSD, loss of limbs or who is slowly dying from the effects of Agent Orange and other toxins.

We all know that the veteran is interred free of charge in any Federal or State Veteran Cemetery. The spouse is provided free internment in a Federal Cemetery. It is time to honor the spouse whose sacrifice, courage and commitment is no less telling. We have an opportunity to honor the sacrifices, commitments and courage of the spouse who held things together at home. Currently during the 50th Commemoration of the Vietnam War, spouses of Vietnam Veterans are presented a "Blue Star" to commemorate their marriage to a Vietnam Veteran. The accompanying citation states in part "On behalf of a grateful Nation and the Department of Defense we honor your service and sacrifice. Our Nation is forever indebted to you and extends its deepest respect and admirations." With the Passage of this bill we would be saying a small way "On behalf of a grateful State we honor your service and sacrifice."

Please give a do pass to this bill and lets us as a state honor these unsung heroes, The spouse of a veteran.

Mister Chairman, members of the committee, good morning. My name is Mark Landis. I have been the veterans service officer in Burleigh County for 15 years and currently serve as president of the Professional Veterans Advocates of North Dakota.

I am here to support Senate Bill 2195, which would offset burial fees for eligible non-veteran family members at the North Dakota Veterans Cemetery. Burleigh County has the highest number of veterans at the cemetery. At this time, I would also like to thank Senator Marcellais for bringing this bill forward.

We often discuss benefits and programs for veterans and military personnel, and rightfully so. I know you are well aware of the sacrifices they make for our country. Family members also make sacrifices, although that fact does not always receive the proper level of recognition.

Spouses and children must often endure long periods of separation from family members deployed to combat zones. They offer strong moral support for the troops while dealing with their own anxiety and increased responsibilities. In that respect they are also integral to our country's war effort.

When a military member returns home, there is often a period of adjustment as roles are reestablished. In many cases, veterans are dealing with permanent disabilities that resulted from military service, but they are not alone. Spouses and children also deal with it, often for a lifetime. It could be physical limitations for the veteran. It could be mental health. Perhaps you know someone who lives with a veteran suffering from post-traumatic stress, and have witnessed the toll it takes on their family.

Providing a burial benefit for family members may be a small thank you compared to their sacrifices, but it would be a significant gesture of good will and recognition of their contributions to our state and nation.

TESTIMONY OF BRIGADIER GENERAL ROBERT BECKLUND NORTH DAKOTA NATIONAL GUARD BEFORE THE HOUSE GOVERNMENT AND VETERANS AFFAIRS COMMITTEE 01 MARCH 2019 SENATE BILL 2195

Good morning Mr. Chairman, members of the committee, I am Brigadier General Robert Becklund, Deputy Adjutant General for the North Dakota National Guard. I am here today to provide updated and additional information on Senate Bill 2195 on behalf of the Office of the Adjutant General.

First, we would like to provide you with some data to help you better estimate the amount of general funds required to off-set the loss of the special funding we currently receive for the burial of our veteran's spouses and/or dependents. The original \$160,000 amount in the bill was based on historical projections prior to 2015 and would not have been enough for us to provide the required burials should this bill pass as written. For example, during the 2015-17 biennium the actual amount was just over \$166,000; and for the 2017-19 biennium the actual amount is projecting to be approximately \$196,650. Based upon this increasing trend of spouse/dependent burials per year at the current rate of \$550 each, we project the amount in the 2019-21 biennium to be closer to \$210,000. And, if we have higher than average burials of spouses and/or dependents, or if rates increase, it is possible that we would not have enough funding under this bill to cover actual costs forcing us to re-role funding from our existing Operations and Maintenance accounts to cover costs of burials. We are comfortable with the \$250,000 now proposed.

Also, the authority of this bill expiring on June 30, 2021 presents some concerns. For example, once a program such as this is created it will have to be maintained in order to not break trust with any future veterans who have gained an expectation that the costs associated with the burial of their spouse or dependents will be provided. So, if this bill is passed, funding requirements are anticipated to be included in all Office of the Adjutant General future budget requests.

Additionally, we currently have \$14,900 in prepaid fees for the future burials of spouses and/or dependents of some of our veterans. If this bill becomes law we would be prepared to refund any prepaid money received from those that pass during the 2019-21 biennium. As this bill covers only the 2019-21 biennium, our intention would be to not refund any other prepaid funds received until future-years funding for this program is assured.

Finally, there is a new national Veteran's Cemetery coming to Fargo and the Standing Rock Sioux Tribe has recently received a grant to construct the national All Nations Veterans Cemetery near Fort Yates. As federal rules allow for no-cost burial services for the spouse and dependents of veterans in national cemeteries, this bill would provide the North Dakota Veterans Cemetery with comparable equity to these local national veteran's cemeteries.

37-03-14. North Dakota veterans' cemetery - Administration.

The adjutant general shall establish and operate the North Dakota veterans' cemetery, which the adjutant general shall I cate within or adjacent to Fort Abraham Lincoln state park. All moneys received from private or federal sources must be paid to the state treasurer for deposit into the veterans' cemetery maintenance fund. The training facility I ccated at Camp Grafton (South) is to remain a part of the overall Camp Grafton training complex but is designated as the Major General C. Emerson Murry regional live fire and maneuver training center.

37-03-16. Adjutant general - Provision of funding - Source.

The adjutant general shall pay all expenses incurred by the state to participate in the compact on educational opportunity for military children, including the reimbursement of actual and necessary expenses incurred by members of the state council, from the operating expenses line item in the appropriation bill for the adjutant general, as approved by the legislative assembly

37-03-17. North Dakota adjutant general and disaster response coin - Presented by whom - Qualifications.

The adjutant general may present an adjutant general coin to deserving individuals who have distinguished themselves through exceptional service to the mission of the North Dakota national guard or department of emergency services. Below are responses to your questions that came up during the hearing on SB 2195 regarding the burial costs for spouses and qualifying dependents. We have included some additional information that we thought may be helpful as well.

- 1. What does the \$550 cover? This is a burial fee for a spouse or qualified dependent and is used to support the operations and maintenance of the North Dakota Veterans Cemetery (NDVC). The NDVC does not charge a fee for eligible service members because it receives a payment of \$780 per service member (amount changes each 1 October) and a headstone from the Veterans Administration (VA). The \$780 is part of the base budget for the operations and maintenance of the cemetery.
- 2. How did we come to the amount of \$550? The fee is based upon what other states veterans' cemeteries charge as well as private cemeteries in North Dakota. Burial fees vary from \$ 0.00 to \$762 at state veteran's cemeteries. Generally speaking, a private cemetery in North Dakota charges in excess of our \$550 fee. Our fee was set to be consistent with other veterans' cemeteries and competitive with private cemeteries in North Dakota. Because this fee is part of our baseline budgeting process, any reduction in the fee would have to be off-set by another revenue source.
- 3. What is the \$550 used for? This fee provides funding for the operations and maintenance of the Cemetery such as equipment use, personnel salary costs, and consumables. As noted above, we are reimbursed from the VA at a rate of

\$780 for eligible veteran burials. This amount, coupled with spousal and eligible dependent burials (\$550 fee), along with state General and special funding, provide the funding needed to operate the cemetery.

We stand ready to provide more information and answer any further questions at future hearings.

SB 2195 - Government and Veterans Affairs Conference April 11th, 2019

Conference Committee Chairman and Government and Veterans Affairs Conference Committee Members,

I, Major General Al Dohrmann, North Dakota National Guard Adjutant General, want to provide additional information and clarification on SB 2195. My primary concerns are with funding of the burials and impacts of providing this benefit for a restricted period of time.

I have attached a spreadsheet that contains the last nine year average for burials at the ND State Veterans Cemetery with a specific breakout for the last three years. You will notice the number of burials have been on a steady increase over the years. In comparison to the nine year average, the average of the last three years shows an on average increase of 32 burials. We anticipate this trend will continue.

Additionally, the funding that is currently allocated in SB2195 is not sufficient to pay the costs of the projected burials for the 2019-21 biennium. Based on the three year average and the growth trend we forecast that the next biennium would require at least \$210K to fully fund the benefit.

If the funding cannot be increased an amendment to the language of the bill to change the term "paying" to "defraying" the costs is requested. This would allow me the ability to manage the benefit equitably without risk of exceeding the appropriated funds. If funding were to be exceeded it will require a request to the emergency commission to cover the above and beyond amount.

I am also concerned that the funding for this expires at the end of the 2019-21 biennium. I believe that if it is the intent of the legislature to offer this benefit to eligible spouses and dependents that the legislature should also make it enduring and not limited to the next biennium.

Finally, to clarify the Cemetery budget. Although the ND Veterans Cemetery has the authority for nearly \$1M most of those funds come from federal grants and reimbursements or special funds. In the OTAG budget for 2019-21, ND State Veteran's Cemetery will receive roughly \$127K in general funds. A more detailed budget is below.


