Chairman Ruby and members of the House Transportation Committee:

My name is Emily O'Brien, from District 42, in Grand Forks, North Dakota.

I had a constituent reach out to me with some concerns. He purchased a vehicle for his 16-year-old daughter from a local used car sales lot. He brought the vehicle in to get some work done. The gentleman working on the car asked if he was aware that there was a GPS tracker installed in the vehicle. He explained that he was not aware that the GPS tracker was installed in the vehicle – and was not disclosed when he was purchasing the vehicle. When he went to the car sales lot, the individual that owns the lot had explained to him that yes, he did have a GPS tracker installed on the car and has them installed on all of the vehicles in his lot. The individual expressed that the way the North Dakota Century Code is written, they do not need to disclose that they have installed a GPS tracker on the vehicle. The owner of the car sales lot expressed that the reason for putting the GPS tracker on the car is that they sell cars to individuals sometimes with little to no credit, sometimes those individuals' default in payments. Having the GPS tracker allows the car salesman to repossess the car if the buyer were to default. Additionally, if the buyer pays the vehicle off – the GPS tracker would remain on the vehicle without the buyer's knowledge or consent.

House Bill 1368 is addressing these concerns by looking for a requirement that the individual selling the vehicle must provide disclosure to the buyer that there is a GPS tracker on the vehicle and that they will remove the GPS tracker once the vehicle has been paid off.

I have worked on some amendments with the Automobile Dealers Association of North Dakota to do some wordsmithing on this bill, which you have in front of you. See amendments 21.0852.01002.

I hope the committee will give HB 1368 a favorable consideration.

3 BE IT ENACTED BY THE LEGISLATIVE ASSEMBLY OF NORTH DAKOTA:

4 SECTION 1. Section 51-07-28.1 of the North Dakota Century Code is created and enacted 5 as follows:

51-07-28.1. Tracking devices on motor vehicles - Disclosure - Removal - Penalty.

- As used in this section:
- "Dealer" means a person licensed under chapter 39-22 to engage in the business of buying, selling, leasing, or trading new or used motor vehicles.
- "Dealership" means the location from which a dealer buys, sells, leases, trades, stores, or in any other manner deals in new or used motor vehicles.
 - After the sale of a motor vehicle, a dealer Alender may not require a person to install or placemaintain a global tracking or positioning system or device on the motor vehicle for the purpose of locating or tracking the vehicle to repossess the vehicle in case of loan default, unless:
 - The dealer lender includes within the purchase financing contract, in a clear and a. conspicuous manner, information on the installation or placement of the system or device;
 - The system or device is installed at no cost to the buyer; and <u>b.</u>
 - <u>C.</u> The system or device is removed within sixty days of the loan for the motor vehicle being paid in full at:

- The dealer's dealership at no expense to the buyer of the lender; or and (1)
- (2)The expense of the dealer at a location agreed upon by the dealer lender and buyer.

House Bill 1368 Testimony before House Transportation Committee Matthew C. Larsgaard, MBA Automobile Dealers Association of North Dakota January 28, 2021

Mr. Chairman and members of the committee. My name is Matthew Larsgaard, and I am appearing in <u>support of the amendments</u> to HB 1368 on behalf of the Automobile Dealers Association of North Dakota.

The amendments help clarify who the responsible party is with respect to motor vehicle tracking devices. In some cases, that party is the dealership when a dealer facilitates a "buy here, pay here" sale. In most other cases, it is a traditional bank or lender. The amendment that replaces the word "dealer" with "lender" simply establishes that the responsible party is the same entity that is requiring the tracking device to be installed whether it is a lender, a dealer, or other third party.

The amendments also recognize that non-dealers may be involved in the installation of tracking devices. (line 12)

Finally, what if there is not a sale transaction involved? Although rare, it may be possible that an individual would like to extract equity out of the vehicle they currently own. The amendments address this issue as well. (*line 12*)

Chairman Clemens and members of the Senate Transportation Committee:

I am Representative Emily O'Brien, from District 42, in Grand Forks, North Dakota.

House Bill 1398 was brought forward from a constituent – who purchased a vehicle from a subprime used car dealership.

To understand what this bill does – i am going to explain the scenario that got us to this legislation.

An individual who was looking to purchase a vehicle – went to a subprime used car dealership.

A subprime lender is often referred to as bad credit auto lenders, since their expertise is in financing borrowers with less than perfect credit. Subprime lenders are third party lenders, meaning the dealer works with the lenders to get the buyer financed.

The buyer found the vehicle they wanted to purchase - they admitted to the dealer that their credit was poor. After running a credit check – indeed the individuals' credit was poor. The subprime used car dealer considers these buyers a 'high risk sale'.

The dealer told the buyer that they were going to detail the car for, and they could pick it up the next day.

Fast forward.

The buyer who purchased the vehicle was then notified by a gentleman who was doing some work on the vehicle a few months later that there was a GPS tracker installed in the vehicle. The buyer did not install the GPS tracker themselves and was not aware that one was on her vehicle. She contacted local law enforcement to report a GPS tracker that was located on her vehicle. After contacting the manufacturing company of the GPS tracker – law enforcement was able to locate the purchaser of this specific GPS tracker – which brought them to the subprime used car dealership.

The individual that sold the vehicle to the buyer – expressed that they did have a GPS tracker installed on the vehicle and put a GPS tracker on every 'high risk sale'. These trackers only cost \$100. Once the vehicle is paid off he does not remove the GPS tracker because he figures \$100 is the cost of doing business. According to the individual or dealer– this is a very common occurrence in the subprime used car dealerships. The

individual was able to show law enforcement real time tracking of the GPS tracking devices that is installed on what they considered 'high risk sales'.

Currently, the way the North Dakota Century Code is written, they do not need to disclose that they have installed a GPS tracker on the vehicle.

The committee understood the intention that the subprime used car dealerships are trying to accomplish by placing a GPS tracker on the vehicles.

HB 1368 provides the disclosure of installing and maintaining a GPS system. The removal of the GPS system and the penalty if it is not disclosed or removed from the motor vehicle.
