Testimony Senate Bill 2161 - Department of Human Services Senate Human Services Committee Senator Judy Lee, Chairman

January 18, 2021

Chairman Lee and members of the Human Services Committee, I am Pamela Sagness Behavioral Health Division Director for the Department of Human Services (Department). I appear today to provide testimony in support of Senate Bill 2161.

The Department supports the development of a mental health registry to improve access for the public to find and access mental health services across the state. Currently, the Department has access to this information for addiction programs in the state. This allows the Department not only to maintain and publish information about these programs to improve public access to services, but also provides the opportunity for two-way communication between these programs and state administrators. Mental health programs would be able to identify not only their contact information but also specialties. The Department has included a one-time cost as identified in the fiscal note, for the development of a mental health registry which would then be maintained by Behavioral Health Division.

The Department also supports the development of a behavioral health bed management system. A well implemented system would benefit the state by improving access to inpatient and residential beds for those needing these vital services across the state. Having a line of sight into program capacity also provides the legislature information to inform decisions surrounding state hospital capacity, identification of services gaps, and real time coordination. The implementation of a bed management system across public and private entities will provide opportunities to improve access for individuals, enhance coordination between providers, and reduce costs to local entities including law enforcement and counties.

Chairman Weisz and members of the Human Services Committee, I am Pamela Sagness Behavioral Health Division Director for the Department of Human Services (Department). I appear today to provide testimony in support of Engrossed Senate Bill 2161.

The Department supports the development of a mental health registry to improve the ability for the public to locate and access mental health services across the state. Currently, the Department provides this information for addiction programs in the state and this bill would allow the Department to do the same for mental health service providers. A mental health provider registry not only provides improved public access to services, but also provides the opportunity for two-way communication between these programs and state administrators. Having timely and direct communication allows providers to get information and for the state to receive timely feedback about needs or capacity, as seen during the pandemic. Mental health programs would be able to identify their contact information but also specialties. The Department has included a one-time cost as identified in the fiscal note for the registry development which would then be maintained by the Behavioral Health Division.

The Department also supports the development of a behavioral health bed management system. A well implemented bed management system would benefit the state by improving access to inpatient and residential beds for those needing these vital services across the state. Having a line of sight into program capacity also provides the legislature information to inform decisions surrounding state hospital capacity, residential addiction need, identification of services gaps, and more efficient coordination. The implementation of a bed management system

across public and private entities will provide opportunities to improve access for individuals, enhance coordination between providers, and reduce costs to local entities including law enforcement and counties.

Testimony of Ashley Revering in support

Mr. Chairman and Members of the Committee:

I offer testimony in support of SB 2161, which would add two new sections to chapter 50-06 of the North Dakota Century Code regarding a mental health provider registry and behavioral bed management system. Coming from a rural area of North Dakota, oftentimes it can be difficult to get the resources needed, especially when it comes to mental health. Growing up, I had friends and even family members that needed to seek help for their mental health, but they were unaware of their options of professionals who specialize in a certain area, much less where to find the specialist's contact information. By creating a state registry of mental health professionals, it will allow state residents to have ease of access to finding a mental health provider that can best suit their personal needs, especially for those in rural areas.

A behavioral health bed management system will also be beneficial to the state. A system of this sort will allow both mental health providers and individuals to be aware of their opportunity to be provided such services. It could also allow for effective and efficient communication between the private and public entities with the service and health care providers, along with the general public.

By inserting the two new sections to Chapter 50-06 of the North Dakota Century Code, it will be able to provide the public with essential information about services that are available to them. With the registry and the bed management system, it will allow ease of access to residents

and working professionals to get information without having to waste valuable time. I thank you for your time and urge a "do pass" recommendation on SB 2161.

NORTH DAKOTA THE VOICE OF THE STUDENTS

Chairman Weisz and committee members:

My name is Faith Wahl, and I am the Vice President of Communication for the North Dakota Student Association (NDSA). I am here today to provide support for SB 2161, relating to the creation of a mental health provider registry and behavioral bed management system.

The North Dakota Student Association is a statewide organization that represents the voices of approximately 45,000 students enrolled in the eleven public institutions throughout the state of North Dakota. The NDSA meets monthly to discuss different issues and topics that are relevant to students and votes on resolutions to express the NDSA's stance on different matters.

As Vice President of Communication for the NDSA, I chair our Student Affairs Committee (SAC) every month. On January 29th, 2021, the Student Affairs Committee met and discussed SB 2161. Students from across the state expressed how the unprecedented stressors and challenges brought on by the COVID-19 pandemic had affected them. I listed to stories of stress, anxiety, depression, and much more. According to data from an Inside HigherEd article titled *Pandemic Hurts Student Mental Health*, 66% of college students reported financial stressors as a result of COVID-19[1]. Additionally, the article reported that depression among college students has increased approximately 9%, with 30.5% of students reporting their mental health has been severely impacted by the pandemic. The NDSA has advocated for increased access to mental health providers and resources for students in the past and believes that those resources are of paramount importance to ensure student health and academic success.

SB 2161 proposes the creation of an online database that would list all mental health providers in the state along with their specialty, location, and contact information. While all students enrolled in the North Dakota University System (NDUS) have access to free counseling through their respective institutions, the NDSA believes that the creation of a mental health provider registry will increase access to mental health providers and resources for students that choose to seek care outside of their university. Furthermore, the proposed mental health registry would allow students to have expanded options for the treatment and care of more specialized needs that universities may not be able to provide.

The NDSA supports SB 2161 and the creation of a mental health provider registry in order to increase access to mental health providers and services for students. As North Dakota navigates through the COVID-19 pandemic, it is more important than ever to invest in students and their wellbeing.

I respectfully request a do pass on SB 2161 and am available to answer your questions. Thank you.
