Hello,

My name is Ashley Johnson I am the Sec./Treasurer for the ND State Board of Barber Examiners. I am providing testimony in support of HB 1112. HB1112 will update three of our current century codes to benefit the barbering trade in North Dakota.

The first update to NDCC 43-04-03 will further protect our trade name as barbers, barbershop owners, and the use of a Barber pole. As it stands now, exempt individuals from our century codes such as cosmetologists, can and have been advertising that they are barbers, barbershop owners or using the Barber Pole. Allowing the advertisement to continue devalues our current and future Barber License holders.

The second update is to NDCC 43-04-12 to allow us to allocate more money from our own funds to provide a better continuing education program for the Barbers in the state of North Dakota to use. The barber board in the last few years has seen a steady increase in the cost of providing a program to the barbers. We have been using five dollars from every Master Barber License and we want to use no less than ten dollars per license. We want to be able to put forth a program that can hire leading Barbers in the industry to teach us new and upcoming education in our trade.

The third update is to NDCC 43-04-41 regarding our hearing process. We were given legal counsel that changing this century code would help in future proceedings. We are updating this to use NDCC 28-32 to be more in line with the other boards in the state of North Dakota.

Thank you for taking the time to consider the changes we are asking to be made. Please vote in favor of these changes to better the ND Barbering trade.

My name is Lance Ekern. I am the president of the North Dakota Barber Board of Examiners as well as being a Master Barber since 2006. I regret I am unable to attend in person but wanted to make it known I am in support of HB 1112 with the proposed amendments related to exemptions from regulation of barbers, barber licensure fees, and disciplinary hearings for barbers.

Education of barbers is important to furthering and maintaining the integrity of this profession. Educational opportunities, as you can imagine, are becoming increasingly more expensive. Increasing the amount of \$5 from every licensing renewal to an amount not exceeding \$10 would help compensate for the rising costs to ensure that continuing education will be of high quality that will ensure that these standards are carried out to the public in a safe and sanitary manner.

The red, white, and blue striped pole has long been associated with the barbering profession. It is false advertising for a business that does not employ a licensed barber to hang a barber pole as it suggests to the public that they are receiving services from a barber. To maintain quality and the integrity of this profession it is imperative that the barber pole be reserved only for licensed barbers.

I am also in favor of the amendment changes to section 43-04-41. This ensures that the hearing is conducted and in accordance with North Dakota Century Code.

To the Committee Members

Thank you for your time today. My name is Ashley Johnson I am the Sec. Treasurer for the ND State Board of Barber Examiners and have been a licensed barber in North Dakota for 16 years. I am here to Discuss HB 1112. This bill was drafted to update three of our Barber century codes. The first century code we looked at updating deals with exempt individuals advertising they are a Barber or own a Barbershop without meeting the state criteria to do so. The second one we are asking to use more funds to help pay for our continuing education program that we offer to the licensed barbers in the state. The third is to try and use the language that other boards use in our hearing proceedings to bring it more up to date.

The first item deals with "exempt individuals advertising as barbers or barbershop owners without proper certification". The individuals listed are "doctors, nurses, medical professionals and cosmetologists". They are allowed to do a barber service, but they are not allowed to call themselves a barber. In their profession they might need to trim a beard or cut someone's hair but that does not mean they have met the criteria to call themselves a barber as they do it. Generally that is not an issue, not a lot of doctors are claiming to be Barbers. However, some cosmetologists are advertising they are a barber. We are simply trying to protect our trade name. In order to receive a barber license an individual must complete a Barber college program approved by the ND State Barber Board, pass our state barber exam, and pay the fees. Furthermore, there is not a cosmetology college in North Dakota that is approved by the board to offer a barber training program. The same applies to listing a salon as a barbershop. Unless you employ a licensed barber, you cannot operate or call yourself barbershop.

The second item we want to change is simpler we want to use more of our funds we receive from our licensing fees to put towards our continuing education program. We want to be able to give our barbers in the state the best possible program. We are asking to bring it from five dollars per license to a minimum of ten dollars per license.

The third item deals with our hearing procedures. It was brought to our attention that century code 28-32-21 is a code that is used when dealing with license holders. We hoped to add it to our language to help with hearing proceedings.

There is often confusion about the difference between a cosmetologist and a barber. While there are certainly many similarities between the two professions, they require different trainings and are governed by separate boards. The red, white, and blue striped pole has long been associated with the barbering profession and is deeply rooted in our history. Barbers would like to protect the integrity of the profession by ensuring that others are not advertising they are barbers or giving an impression they are a barber by hanging a barber pole and offering barbering services.

I am also in favor of the amendment changes to section 43-04-41. This ensures that the hearing is conducted and in accordance with North Dakota Century Code.

I would like to thank the committee for allowing me to testify in support of this bill that will continue to allow barbers to serve the public to the highest standards for years to come.
