TESTIMONY

HB 1334

Chairman Klemin and Members of the House Judiciary Committee,

My name is Amber Vibeto and I reside in District 3. I respectfully urge a 'do pass' recommendation on HB 1334.

- This bill clarifies and sets needed guidelines for our law enforcement officers at every level as to the difference between a domestic terrorist and a criminal.
- The passage of this bill will clear up public confusion from incidents in the recent past regarding what a domestic terrorist actually is. Ambiguous definitions of domestic terrorism at the federal level make it very difficult to understand who is an enemy of the state and who is a criminal. The passage of this bill will ensure due process is guaranteed for all North Dakotans.
- In September of 2021, the National School Board Association sent a letter to the Biden administration asking them to use the Patriot Act to look into "acts of malice, violence and threats against public school officials," which the association said "could be the equivalent to a form of domestic terrorism and hate crimes." The NSBA eventually apologized for threatening and labeling concerned parents as domestic terrorists, but this incident clearly underscores the need to protect citizens from the weaponization of federal agencies.
- Depending on the issue, it seems as if we are applying labels and definitions differently for similar offenses. Why is there a difference in the burning down of American cities in 2020 and the breaking of windows at the US Capital in 2021? This is an unequal application of our laws.

The thing that prompted this bill was a letter sent out from the National School Boards association asking the FBI and DOJ to investigate parents as Domestic terrorists. These parents were raising questions and concerns

t their local school board meetings. We see this in the media, terms like this being weaponized for merely articipating in the political process. This deadly label lynching has led to the weaponization of government against Americans. This gives us a solid definition, and says if you want to claim or prosecute someone as a domestic terrorist, you have to meet the 3 requirements laid out in this bill.

(1) It is done in cooperation with any federally designated international terrorist organization that threatens or appears to threaten the sovereignty of the

state or the United States of America;

(2) Is a violation of criminal law; and

(3) Either:

Involves violent acts or threats specifically intended to physically harm human life and:

Intimidate, coerce, influence, or disrupt other lawful activity within the state; or

Influence the policy of the state or any political subdivision of the state; or

Involves the use of weapons of mass destruction.

We need this bill for clarification for our law enforcement. The passage of this bill will protect parents, the citizens in our state, and will ensure due process is applied.

Madam Chair and members of the committee, for the record my name is Cole Christensen Representative from District 24. I am here to testify in support of HB 1334.

This bill's goal is to define the term "Domestic Terrorism" This creates a definition and gives guidelines on how one could be prosecuted as an enemy of the state. This raises it to a very serious threshold.

1.) You are working in cooperation with a federally designated terrorist organization that threatens or appears to threaten the sovereignty of the State or the United States of America

2.) Is a violation of criminal law

3.)

a. Involves violent acts or threats specifically intended to physically harm human life, or:

b. Intimidate, coerce, influence, or disrupt other lawful activity within the state; or

c. Influence the policy of the state or any political subdivision of the state

d. Involves the use of weapons of mass destruction.

There have been letters sent out from the National School Boards Association asking the FBI and DOJ to investigate parents as Domestic terrorists. These parents were raising questions and concerns at their local school board meetings.

We see this in the media, terms like this being weaponized against average Americans for merely participating in the political process. The deadly label lynching from the Media has led to the government being weaponized against the American people. Our federal delegation has a select subcommittee on the weaponization of the Federal Government that is looking into this very issue.

Parents are not domestic terrorists, and neither are average American citizens. Being an enemy of the state is a serious offense, and this definition raises it to that high benchmark. Let's stand by the citizens in our state, and push back against the weaponization of our federal government.

I would ask for a do-pass, and I will stand for questions.
