TESTIMONY

HB 1543

Joint Appropriations Committee October 23, 2023 HB1543

For the record, my name is Wayde Sick, I serve as the State Director for the Department of Career and Technical Education. I am here to provide testimony in support for HB1543, specifically Subsection 2, which sets aside \$26,500,000 to the Department of Career and Technical Education for the purpose of defraying inflationary costs of existing projects approved under the statewide area career center initiative grant program.

During the 68th Regular Session, the State Legislature approved the \$26.5 million to address the inflation costs of these projects. This funding was to be distributed proportionally based on the approved grant applications, which were approved in March 2022. This calculated to approximately thirty percent increase to each grant award.

The reason for the request for the inflationary funds was due to the delay in receiving the funds from the US Treasury. The grant applications were submitted in December 2021 and reviewed and approved in March 2021. We then had to wait for access for the funds, while the cost of materials, equipment and labor rose. To attempt to accomplish what was included in the approved applications, ND CTE and the approved applicants requested the additional dollars.

Since the session adjourned, projects moved forward with construction, bidding, etc. To date, \$6,003,882 dollars have already been disbursed to two projects, specifically the Minot Area Skills Center (Minot) and the Bakken Area Skills Center (Watford City). Others are close to requesting the inflationary funds. Others that are not as far in the process but have sought out bids with the new dollar amount, as approved in SB2015. Not having access to the inflationary funds would be detrimental. Some of the funds have already been spent. Other projects are close to requesting the funds and others have gone out for bids or accepted bids with a new dollar amount.

I appreciate the support for these projects during the regular session and again ask the Legislature to support this initiative and allow our projects to complete their work.

Mr. Chairman and members of the Committee, my name is Andrea Pfennig with the Greater North Dakota Chamber. GNDC is North Dakota's largest statewide business advocacy organization, with membership represented by small and large businesses, local chambers, and trade and industry associations across the state. We stand in **support** of House Bill 1543.

Access to workforce continues to be an issue impacting businesses in North Dakota. GNDC recently completed an economics and employer membership survey in which 74% of respondents indicated they were having trouble hiring employees.

Our members support maximizing the flexibility and responsiveness of K-12, two and four-year educational institutions, and other expanded educational opportunities to meet local training needs and demands.

The Department of Career and Technical Education's Statewide Area Career Center Initiative grant program is an important resource that will help train the next generation of North Dakotan workers learn high demand job skills.

SECTION 3. BOND ISSUANCE AUTHORIZATION - PURPOSE. The state board of higher education, in accordance with chapter 15-55, may arrange for the funding of projects authorized in this section, declared to be in the public interest, through the issuance of self-liquidating, tax-exempt evidences of indebtedness under chapter 15-55, beginning with the effective date of this Act and ending June 30, 2025. Evidences of indebtedness issued pursuant to this section are not a general obligation of the state of North Dakota. Any unexpended balance resulting from the proceeds of the evidences of indebtedness. The evidences of indebtedness may be issued to generate up to \$40,000,000, the proceeds of which are appropriated in section 2 of this Act and section 1 of House Bill No. 1003, as approved by the sixty-eighth legislative assembly, for the Bismarck state college multipurpose academic and athletic center.

SECTION 4. TRANSFER OF LAND AUTHORIZED - EXEMPTION. The state of North Dakota, by and through the state board of higher education, may convey certain real property consisting of twenty-four acres south of sixth avenue north in the northwest quarter of the southwest quarter, excluding the south third of the northwest quarter of the southwest quarter consisting of sixteen acres, of section 5-151-50 in the records of the city of Grand Forks, if determined appropriate by the state board of higher education.
