The lignite industry accounts for over 13,000 direct and indirect jobs, over \$5.4 billion in economic development and millions in state, county and local tax revenue.

This resolution describes the status of the lignite industry and its contributions to the State of North Dakota, and factors impacting its ability to continue providing reliable, environmentally responsible, and affordable power to the Upper Midwest.
